MONTHLY ANNOUNCEMENT ON CONVERSION OF THREE-YEAR ZERO COUPON CONVERTIBLE BONDS FOR MAY 2008

The Company made this announcement pursuant to the Company's undertaking set out in the Circular in relation to the conversion of the Convertible Bonds.

The Company announces that there has been no conversion of the Convertible Bonds during the month of May 2008.

Reference is made to the announcement of the Company dated 11 July 2007 and the circular dated 27 July 2007 (the “**Circular**”) issued by the Company to its shareholders relating to, among other matters, the CB Placing Agreement in respect of the placing of the Convertible Bonds. Unless the context herein otherwise requires, terms used in this announcement shall have the same meanings as in the Circular.

On 16 November 2007, the Company issued the Convertible Bonds with a principal amount of HK\$200,000,000 (which involve the allotment and issue of up to 800,000,000 Conversion Shares upon exercise in full of the conversion rights attaching to the Convertible Bonds, at the conversion price of HK\$0.25 per Share). Pursuant to the Company's undertaking set out in the Circular, the Company is required to make an announcement on or before the fifth Business Day following the end of each calendar month to provide the details as stated in the Circular.
