### **UNUSUAL PRICE AND TRADING VOLUME MOVEMENTS**

This announcement is made at the request of The Stock Exchange of Hong Kong Limited in accordance with Rule 17.11 of the Rules Governing the Listing of Securities on the Growth Enterprise Market of the Stock Exchange of Hong Kong Limited (the “**GEM Listing Rules**”).

Further to the announcements dated 15 August 2013 in relation to the signing of memorandum of understanding in relation to the proposed acquisition of 3 Dynamics (Asia) Limited, termination of memorandum of understanding in relation to the proposed acquisition of United Success Global Limited and the grant of share options and the announcement dated 27 August 2013 in relation to the lapse of share options (the “**Announcements**”), the board of directors (the “**Board**”) of Fairson Holdings Limited (the “**Company**”) has noted the recent increases in the price and trading volume of the shares of the Company. The Board wishes to state that the Board is not aware of any reason for such movements save and except that the Company is in preliminary negotiation with a company established in the People’s Republic of China (the “**PRC**”) (“**JV Party**”) regarding the potential establishment of a joint venture company (the “**Proposed Action**”) in Nanchang City, Jiangxi Province, the PRC for the development of liquefied natural gas (“**LNG**”), compressed natural gas (“**CNG**”) and clean energy business. As at the date of this announcement, no terms have been concluded and no agreements have been signed in relation to the Proposed Action.

The JV Party has been established in the natural gas industry for a number of years with experience in various LNG and CNG business including but not limited to city gas pipeline network, construction and operation of LNG stations, CNG stations and LNG liquefaction plants, provision of LNG and conversion of traditional oil fuel to LNG in transportation industry.

To the best knowledge, information and belief of the directors of the Company (the “**Directors**”) having made all reasonable enquiries, the JV Party and its ultimate beneficial owners are third parties independent of, and not connected with, the Company and its connected persons (as defined in the GEM Listing Rules).

The Proposed Action may constitute a notifiable transaction under Chapter 19 of the GEM Listing Rules. Further announcement will be made by the Company in compliance with the GEM Listing Rules as and when necessary.

Shareholders and potential investors of the Company should note that the Proposed Action may or may not proceed. Accordingly, shareholders and potential investors of the Company are advised to exercise caution when dealing in the shares of the Company.

Having made such enquiry with respect to the Company as is reasonable in the circumstances, save as disclosed above and in the Announcements, the Board confirms that it is not aware of any reasons for these price and volume movements or of any information which must be announced to avoid a false market in the Company's securities or of any inside information that needs to be disclosed under Part XIVA of the Securities and Futures Ordinance.
