COOPERATION FRAMEWORK AGREEMENT

The board (the "**Board**") of directors (the "**Directors**") of the Company is pleased to announce that on 6 November 2021, the Company entered into a non-legally binding cooperation framework agreement (the "**Cooperation Framework Agreement**") with Shendianneng Technology Group Co., Ltd. (深電能科技集團有限公司) ("**Shendianneng Technology**") in relation to possible business cooperation. Pursuant to the Cooperation Framework Agreement, Shendianneng Technology may refer projects related to electrochemical energy storage power plants to the Company for consideration of investment. If the investment in the projects related to electrochemical energy storage power plants are approved by the Company, the Group may invest in such projects and be entitled to the title and the revenue generated by such projects. The Company may also give priority consideration in engaging Shendianneng Technology for the design and construction of the electrochemical energy storage power plants on same terms offered by other parties. Upon the completion of construction of the electrochemical energy storage power plants, the Company may engage Shendianneng Technology in managing the operations of such plants.

The Group and Shendianneng Technology shall enter into separate legally binding agreements when the terms of the business cooperation materialises.
