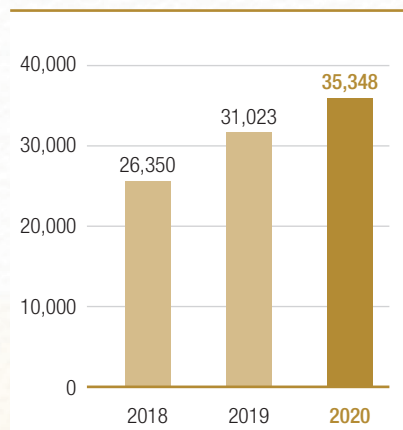

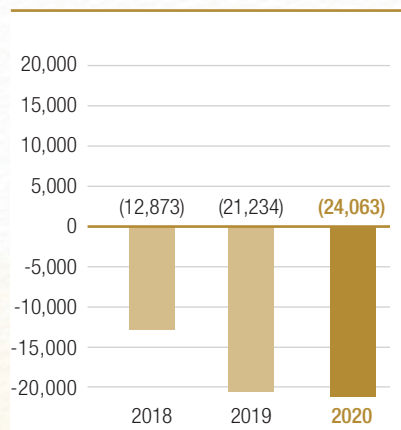

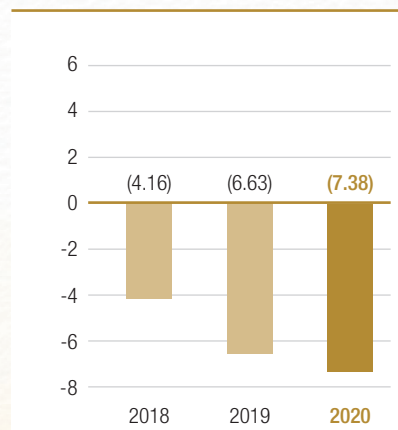


BASIC LOSS PER SHARE

MANAGEMENT DISCUSSION AND ANALYSIS

管理層討論及分析

OPERATION REVIEW

General Performance

2020 was a year of grim for many economies across the globe due to the devastating effects of COVID-19 resulting in a recession in majority of nations and in others a depression. International Monetary Fund estimated a 3.5% global economic contraction in 2020, the worst in decades except China which impressively still recorded a 2.3% GDP growth in the epidemic. In Hong Kong and Macau where the Group operates, both governments faced difficult trade-off between containing the spread of the COVID-19 and keeping its economy afloat. Notwithstanding the release from the governments various stimulus/relief packages to support businesses and individuals, GDP in Hong Kong and Macau contracted by 6.1% and 56.3% respectively. We have seen businesses large and small suffered with many requiring financial lifelines to survive. Looking back when COVID-19 was gaining momentum worldwide, the Group's various businesses like many others had been adversely affected and new business initiatives were put on hold.

During the year under review, the Group's net loss increased by 18% to approximately HK\$25,738,000 after netting the effects for (i) the absence in 2020 fair value gain on investment properties and gain on disposal of an investment property in aggregate at HK\$10,800,000 in 2019; (ii) unrealised RMB exchange gain of HK\$5,547,000 in the year under review instead of unrealised RMB exchange loss of HK\$4,375,000 in 2019; (iii) government pandemic subsidies received during the year under review amounted to HK\$2,167,000 and (iv) adjustment of deferred tax assets resulting in increased income tax expenses of HK\$2,402,000 for the year under review.

經營回顧

整體表現

二零二零年，COVID-19疫情肆虐，全球主要經濟體受到沖擊，導致不少國家陷入衰退，更有國家陷入蕭條。國際貨幣基金估計，二零二零年全球經濟萎縮3.5%，為數十年以來最差的表現，但中國GDP於疫情期間仍赫然錄得2.3%的增長。至於本集團業務所在的香港及澳門，兩地政府需處理權衡控制COVID-19疫情與保持經濟發展兩者的困難。儘管兩地政府推出多項刺激／紓困措施支援商界及市民，惟香港及澳門的GDP分別收縮6.1%及56.3%。我們眼見大大小小的企業遭遇困難，其中不少需要求存的資金。回顧COVID-19疫情席捲之際，本集團各項業務與其他企業無異，同樣受到負面影響，新訂業務計劃亦需暫停。

於回顧年內，本集團之純損增加18%至約港幣25,738,000元，扣除以下影響(i)於二零一九年投資物業之公平值收益及出售一項投資物業之收益合共港幣10,800,000元在二零二零年並無出現；(ii)於回顧年度之未變現人民幣匯兌收益為港幣5,547,000元，而於二零一九年之未變現人民幣匯兌虧損則為港幣4,375,000元；(iii)於回顧年度獲政府疫情補貼港幣2,167,000元；及(iv)調整遞延稅項資產導致於回顧年度之所得稅開支增加港幣2,402,000元。

MANAGEMENT DISCUSSION AND ANALYSIS • 管理層討論及分析

The Group's revenue increased by approximately 14% from HK\$31,023,000 in 2019 to approximately HK\$35,348,000 in 2020 as the business segments of hospitality services and property project management commencing businesses in December 2019 came in their full year operation. As the profit margin of hospitality business and property project management business is by industry reference lower than our other business segments, kicking off these two business segments in 2020 reduced our gross profit by 33% to HK\$12,256,000. In addition, the accounting treatment for better financial presentation of direct cost of businesses to the effect that the depreciation of leased properties held for the Group's hair styling services and hospitality service business as well as staff cost of hospitality business were reclassified from administrative expenses to cost of revenue further reduced gross profit ratio. Other income increased by 118% to HK\$11,426,000 after compensating the decrease in bank interest income of HK\$1,215,000 from the relatively lower interest rate in year under review with the received government pandemic subsidies of HK\$2,167,000 and accrued unrealised exchange gain on RMB deposits at HK\$5,547,000. The administrative expenses were substantially decreased by 20% to HK\$28,898,000 mainly due to the absence of non-recurring one off expenditure incurred in 2019 for (i) cost related to relocating our flagship hair salon; (ii) legal and professional estate agency fee for disposing and entering into new tenancies of our investment properties; (iii) the unrealised exchange loss on RMB bank deposits which turnaround to exchange gain in 2020; and (iv) bank charges for switching banking facilities between banks. At the same time the Group reviewed all the overheads in an attempt to control administrative cost and amongst the various endeavours taken included continuing freezing all payroll and discretionary year-end bonus of staff and management alike to keep the Group's sustainability in the adverse economy.

As at 31 December 2020, the Group's net asset value was approximately HK\$322,012,000 and net asset value per share was approximately HK\$0.99. The Group's total assets and total liabilities were approximately HK\$572,298,000 and HK\$250,286,000 respectively.

由於本集團在二零一九年十二月開展的旅店及款待服務以及物業項目管理的業務分部已營運一個完整年度，本集團收益由二零一九年之港幣31,023,000元增加約14%至二零二零年約港幣35,348,000元。按行業參考，旅店及款待服務以及物業項目管理業務之利潤率較我們其他業務分部的為低，於二零二零年開展該兩項業務分部使我們的毛利下降33%至港幣12,256,000元。此外，為改善業務直接成本的財務呈報而進行的會計處理，使本集團就髮型設計服務以及旅店及款待服務業務持有租賃物業折舊以及旅店及款待業務員工成本由行政開支重新分類至收益成本生效，毛利率因而進一步下降。其他收入增加118%至港幣11,426,000元，其中包括回顧年內利率相對較低使銀行利息收入減少港幣1,215,000元、獲授政府疫情補貼港幣2,167,000元以及應計未變現人民幣存款匯兌收益港幣5,547,000元。行政開支大幅減少20%至港幣28,898,000元，主要由於並無產生二零一九年錄得以下非經常性一次性支出(i)與旗艦髮型屋的搬遷相關的成本；(ii)出售投資物業及訂立投資物業的新租約之法律及專業房地產代理費；(iii)已於二零二零年轉為匯兌收益之未變現人民幣銀行存款匯兌虧損；及(iv)於銀行之間轉換銀行融資的銀行費用。同時，本集團已審閱所有營運費用以控制行政開支，並經過各種努力，包括繼續凍結僱員及管理層之所有薪金及酌情年終花紅，以於惡劣經濟下保持本集團的可持續性。

於二零二零年十二月三十一日，本集團之資產淨值約為港幣322,012,000元，而每股資產淨值約為港幣0.99元。本集團之總資產及總負債分別約為港幣572,298,000元及港幣250,286,000元。

MANAGEMENT DISCUSSION AND ANALYSIS • 管理層討論及分析

Property Investments Business

During the year under review, total rental income contributed from Hong Kong and Macau investment properties amounted to HK\$4,257,000, decreased by approximately 53% compared to the year before. Rental income from Hong Kong investment properties dropped substantially as the boutique hotel used to be the major contributor in the segment generating rental income of HK\$4,700,000 in 2019, was turned to self use when we took up the operation in December 2019. Return from leasing the investment properties was about 4.8% comparing the gross rental income and original cost of investments. The reduction in rental income as a whole coupling with the absence of valuation gain on the investment properties resulted in segment loss of HK\$4,161,000 for the year under review compared to a profit of HK\$1,948,000 the year before.

There is no acquisition or disposal of investment properties during the year under review. Total valuation of the investment properties remain the same as 2019 at HK\$130,100,000 despite some variances on individual properties.

In Hong Kong total rental income derived from the Group's investment properties portfolio comprised of a retail shop in Sheung Wan and residential units in Taikoo Shing decreased approximately 18% to HK\$1,313,000 with investment yield being approximately 4.7%. The decreased rental income was mainly due to cessation of income in 2020 from a residential investment property after disposal was completed in second quarter of 2019 plus vacancy of another residential property for five months in the latter half of 2020 before a new tenancy commenced early this year.

Rental income from Macau properties increased approximately 5% to HK\$2,944,000. Despite rental concessions granted to tenants during the year due to pandemic and the vacancy of our residential unit in the last quarter of the year as the tenancy expired, rental income from Macau properties increased due to (i) full occupancy in 2020 versus nine months' occupancy of the retail shop which was vacant in the first quarter of 2019 and (ii) higher rental rate commanded from renewed lease of our office investment properties commencing in the second half of 2019. An average yield of about 4.8% comparing the gross rental income and original cost of investments on Macau properties was recorded.

物業投資業務

於回顧年內，香港及澳門投資物業之租金收入總額為港幣4,257,000元，與上一年度相比減少約53%。由於精品酒店曾為此分部之主要貢獻來源，並於二零一九年產生租金收入港幣4,700,000元，在我們於二零一九年十二月接手經營後已轉為自用，故來自香港投資物業之租金收入大幅下降。若將租金收入總額與原投資成本進行比較，出租投資物業的回報率約為4.8%。整體租金收入有所下降，加上投資物業並無估值收益，導致於回顧年度之分部虧損為港幣4,161,000元，而上一年度則為溢利港幣1,948,000元。

於回顧年內並無收購或出售投資物業。儘管個別物業有所差異，投資物業之總估值維持與二零一九年的港幣130,100,000元相同。

香港方面，來自本集團由位於上環的一個零售店舖以及位於太古城的住宅單位組成之投資物業組合之租金收入總額減少約18%至港幣1,313,000元，而投資收益率約為4.7%。租金收入減少乃主要由於在二零一九年第二季度完成出售后，一項住宅投資物業終止於二零二零年產生收入，加上二零二零年下半年另一個住宅物業在空置五個月後才於今年初開始新租約。

澳門物業租金收入增加約5%至港幣2,944,000元。儘管已於年內因疫情向租戶授予租金寬減，年內最後一季隨我們住宅單位租約屆滿而出現空置情況，惟澳門物業的租金收入仍有增加，此乃由於(i)零售店舖於二零二零年全部租出，而二零一九年只有九個月租出，首季度有空置情況；及(ii)於二零一九年下半年開始我們辦公室投資物業的重續租約收取較高租金率。若將澳門物業的租金收入總額與原投資成本進行比較，所錄得之平均收益率約為4.8%。

MANAGEMENT DISCUSSION AND ANALYSIS • 管理層討論及分析

The property market sentiment in both Hong Kong and Macau is weak following the social protests in Hong Kong in the latter half 2019 and the combined impact of the ongoing US-China trade tension and the coronavirus outbreak which hits hard on the tourism/hospitality and retail sectors in which our tenants operate. However we believe the relevant sectors will likely rebound this year given last year's low base as the pandemic is better contained with the roll out of mass vaccine program, the eventual border reopening and the gradual relaxation in social distancing. The continued low interest environment as a result of global monetary easing policies adopted by major countries should help the property market to remain steady. It is no surprise that COVID-19 with its lingering unpredictable and sporadic outbreaks will continue to impact our economy in 2021 leading to uncertain business outlook and standing high unemployment rate and as such, upcoming lease renewal, occupancy and rental rate for our investment properties will inevitably come under pressure.

Hair Styling Business

Due to the negative impact of the pandemic on the business environment during the year, turnover of this segment amounted to HK\$15,236,000 representing an decrease of 16% as compared with 2019. Segment net loss in 2020 was HK\$22,000 compared to net loss of HK\$964,000 the year before. Decrease in segment loss was attributable to the combined effect of (i) the absence in 2020 of the one-off expenditure for relocating the salon to the new location and the reinstatement cost of yielding up the old salon to the landlord in 2019; and (ii) the rental concession savings and government subsidies received due to the pandemic in the year under review.

Retail products sales is a major focus in enhancing our income base after relocation of salon. Retail products sales increased 80% to HK\$834,000 compared to the year before. More new brands and co-operation with luxury hair and beauty brands were introduced during the year 2020 and we will continue to put in resources in further expanding our product sales in both retail and wholesale dimensions. Meanwhile the Group strictly follows government guidelines and implemented preventive measures to safeguard the well being of our customers and employees. To recalibrate our operations for ensuring long-term sustainability, strenuous effort is made to improve our service quality and as always strengthen operation with stringent measures to control costs and maintain liquidity while new marketing strategies are deployed to enhance business performance.

香港於二零一九年下半年發生社會運動之後，香港及澳門的物業市場情緒轉淡，再加上中美貿易談判關係持續緊張以及疫情爆發，嚴重打擊我們租戶經營的旅遊／款待及零售業。然而，隨著疫苗大規模接種，疫情將會受控、邊境最終重開以及社交距離逐步放寬，我們相信，相關行業本年極有可能從去年的谷底回升。主要國家採納的全球貨幣寬鬆政策使低息環境持續，應有助保持物業市場穩定。毫不意外COVID-19那揮不去之不可預測和零星的爆發仍會影響我們二零二一年的經濟，對業務前景帶來不明朗因素及失業率高企等，最終必然對我們投資物業未來的續約情況、出租率和租金水平構成壓力。

髮型設計業務

由於疫情於年內對營商環境構成負面影響，本分部的營業額為港幣15,236,000元，較二零一九年減少16%。二零二零年分部之純損為港幣22,000元，而上一一年之純損為港幣964,000元。分部虧損減少乃歸因於(i)二零二零年並無錄得二零一九年與髮型屋搬遷至新址有關的一次性支出以及將舊髮型屋交還業主的還原成本；及(ii)於回顧年度就疫情所收取之租金減免及政府補貼之綜合影響。

於搬遷髮型屋後，零售產品銷售為提高我們的收入基礎的重點。零售產品銷售較去年增長80%至港幣834,000元。於二零二零年內，引入了更多新品牌並與奢侈髮型及美容品牌合作，而且我們將繼續投入資源以在零售及批發兩方面進一步擴張我們的產品銷售。同時，本集團嚴格遵守政府指引，推出防疫措施，以保障我們客戶及僱員的健康。為重新調整我們的業務經營，確保長遠的可持續發展，我們透過不懈努力以提高我們的服務質量，並一如既往地通過嚴謹的措施加強營運以控制成本及維持流動資金，同時部署新的營銷策略以改善業績。

MANAGEMENT DISCUSSION AND ANALYSIS • 管理層討論及分析

Hospitality Service Business

Turnover of the segment was reported at HK\$8,976,000 with segment loss of HK\$1,869,000. The segment commenced business in late December 2019 when we took over the operation of the boutique hotel. During the year under review, the Group entered into leasing a hostel premises in North Point with 99 rooms in May 2020 to increase the number of rooms in operation and effectively gaining benefit from achieving better economies of scale. The North Point hostel is situated in the traditional community hub and proximate to the well-developed island east commercial area with steady demand in hospitality service from the locals.

Due to the outbreak of COVID-19 which brought travel to a standstill, devastating the tourism/hospitality industry with lockdowns and travel restrictions imposed across countries, results of the business segment in 2020 is far below our target performance. To survive the hardship and lift up the occupancy rate, the Group adopted the most flexible pricing strategy and shifted its focus to target the neighbouring and local community by offering staycation packages and flash sales. With an objective to building up a recurring income in the short term, the Group renovated and modified part of our facilities during the year to accommodate the needs of co-living tenants. The co-living business which targets at the local demand has brought forth positive market responses and value added to our operations. We always believe agility and innovation will help to survive in crisis and management will consider the feasibility to capture on the opportunities present from the emerging trend of co-working space concept with a rising market demand for “Work From Hotel” in echo to the “Work From Home” which has become a norm during the pandemic.

旅店及款待服務業務

有關分部錄得營業額港幣8,976,000元，而分部虧損則為港幣1,869,000元。本分部於我們在二零一九年十二月下旬接管精品酒店之營運後開始營業。於回顧年度，本集團於二零二零年五月訂約租賃位於北角並擁有99間客房的旅館物業，以增加在營的客房數量，並自達致更佳的規模經濟效益中有效地獲益。北角旅館處於傳統社區中心，且鄰近發展完善的港島東商業區，對旅店及款待服務有穩定的本地需求。

由於COVID-19的爆發使旅行停滯，各國實施封鎖政策及旅遊限制重創旅遊／款待業，因此導致該業務分部於二零二零年的業績遠低於我們的目標表現。為在困難環境中生存並提高入住率，本集團已採取最靈活的定價策略，並通過提供住宿套票及限時優惠將其重點定位轉移到鄰近及本地社區。為在短期內增加經常性收入，本集團已於年內翻新及裝修部分旅館設施，以滿足共同居住的租戶之需求。針對本地需求的共同居住業務為我們的業務帶來正面的市場反應及增值。我們始終相信敏捷及創新將有助於在危機中生存，管理層將考慮抓住共同工作空間概念的新興趨勢所帶來的機遇的可行性，以及不斷增長的「在酒店工作」的市場需求，呼應在疫情期間已成為常態的「在家工作」。

Despite the unprecedented challenges we faced with the rampant pandemic, we believe in the long-term prospect of the tourist industry in Hong Kong. Hong Kong tourism industry has its advantages and competitiveness where it could leverage on the completion of the cross-border infrastructure (the Guangzhou-Shenzhen-Hong Kong Express Rail Link and the Hong Kong-Zhuhai-Macau Bridge) to attract more Mainland visitors; the undergoing construction of the third runway of Hong Kong International Airport to expand its operation capacity as well as geographical coverage; the developing West Kowloon Cultural District to enhance the cultural elements of Hong Kong tourism and working closely with the Greater Bay Area to attract new and returned tourists for multi-destination travel. Hospitality business will be one of the key directions in our future business development and in particular, provision of accommodation in Hong Kong as well as Macau which today has developed into an international tourism resort city famous for the blend of Portuguese and Chinese culture. Through leveraging the management experience the Group has attained from previous hotel investment projects, we set path to become a promising operator in the modern hostel and guesthouse segment in Hong Kong, Macau and neighbouring cities. Projects explored and identified previously to add to our hospitality service operation portfolio were put on hold due to the uncertainties and downside risks of the pandemic but the management will closely monitor the market development as well as government policies and measures to catch the right timing to execute our expansion plan.

儘管我們在疫情中面臨前所未有的挑戰，但我們相信香港旅遊業的長遠前景。香港旅遊業有其優勢及競爭力，可以藉助跨境基礎設施(廣深港高速鐵路及港珠澳大橋)完工，以吸引更多內地遊客；正在興建當中的香港國際機場第三條跑道，以擴大其營運容量及地理覆蓋範圍；發展中的西九龍文化區，以提升香港旅遊的文化元素，並與大灣區緊密合作，以吸引新遊客及回訪旅客進行多目的地旅行。旅店及款待業務將成為我們未來業務發展的主要方向之一，尤其是在香港及澳門提供住宿。如今，澳門已發展成為一個以葡萄牙及中國文化匯聚而聞名的國際旅遊度假城市。通過利用本集團自過往的酒店投資項目中所獲得的管理經驗，我們為在香港、澳門及鄰近城市的現代旅舍及賓館分部成為有前景的營運商奠定基礎。由於疫情的不確定性及下行風險，先前已探索及已確定新增至我們的旅店及款待服務運營組合的項目被暫停，惟管理層將密切監察市場發展以及政府政策及措施，以抓住適當的時機執行我們的擴張計劃。

Securities Investments

As at 31 December 2020, the Group had financial assets at fair value through profit or loss of approximately HK\$69,946,000 (31 December 2019: HK\$88,836,000). The securities investments portfolio comprised of Hong Kong blue chips and REITs with adequate yield on dividend income and liquidity in secondary market. The Group recorded unrealised loss of HK\$11,958,000 on the securities investments held. Dividend income from securities investments amounted to HK\$2,969,000 was recorded in the reviewing year.

Against the backdrop of the global pandemic, escalating geopolitical tensions and economic fragility in 2020, the Hong Kong financial market was robust marked by record high trading volumes and the best year since 2010 in terms of IPO fund raising amount with new economy companies. In fact, Hong Kong is now the Asia's most thriving financial ecosystem for technology and new economy companies. However, share prices of traditional company whose business being adversely impacted to varying degrees by the pandemic plummeted from pre COVID-19 are under-performing. We anticipate that when the business environment in Hong Kong is restored and the present epidemic comes under control, prices of the securities investments will gradually reflect its intrinsic value.

證券投資

於二零二零年十二月三十一日，本集團按公平值計入損益之財務資產約為港幣69,946,000元(二零一九年十二月三十一日：港幣88,836,000元)。證券投資組合包括股息率充足而具二手市場流動性的香港藍籌股份及房託基金單位。本集團就持有的證券投資錄得未變現虧損港幣11,958,000元。於回顧年度，證券投資所得的股息收入錄得港幣2,969,000元。

即使二零二零年全球疫情、地緣政治緊張局勢升級和經濟疲弱，香港金融市場仍相當暢旺，成交量創新高，在新經濟公司首次公開招股集資方面為二零一零年以來最高的一年。事實上，香港現為亞洲科技和新經濟公司最蓬勃的金融生態系統。然而，因業務受到COVID-19疫情不同程度的嚴重打擊的傳統公司之股價較COVID-19疫情前暴跌而表現欠佳。我們預計當香港營商環境回復正常，且目前的疫情更為受控時，證券投資之價格將會逐漸反映其內在價值。

Property Project Management Business

The Group commenced its business of property project management at the end of 2019. From its property investments business, the Group has gained vast experience in increasing values of different types of property by ways of altering layout, reengineering technical input and output as well as change of use of the properties. We offer customers with a turnkey model solution and acting as representative of the property owner to source, liaise and coordinate with architect/designer as well as main contractor for better project management. During the year the Group completed projects focusing in residential properties generating HK\$3,908,000 total revenue with segment profit of HK\$84,000. As the economy revives, we strive to expand the scale of the business segment by collaborating with local renowned architect/interior designer to explore into new projects.

Other Business Segments

Money lending business recorded one personal loan with total revenue of HK\$2,000 and segment loss of HK\$19,000 for the year under review.

物業項目管理業務

本集團於二零一九年底前開始其物業項目管理業務。憑藉其物業投資業務，本集團在以修改佈局、改良技術投入及產出以及更改物業用途的方式提高各類型物業的價值方面已累積豐富經驗。我們向客戶提供「交鑰匙」模式的解決方案，作為業主的代表就改善項目管理與建築師／設計師及總承包商進行採購、聯絡及協調。年內，本集團完成多個針對住宅物業的項目，錄得總收益港幣3,908,000元，而分部溢利則為港幣84,000元。當經濟復甦，我們致力透過尋求與本地知名建築師／室內設計師合作以發掘更多新項目，以擴張本業務分部的規模。

FINANCIAL REVIEW

I. Liquidity and Financial Resources

As at 31 December 2020, the Group had cash and bank balances including pledged bank deposits of HK\$118,794,000 in aggregate and net current liabilities of HK\$28,256,000. The current ratio (calculated as the current assets to the current liabilities) of the Group as at 31 December 2020 was approximately 0.87 times (31 December 2019: 0.97 times).

The sales and purchase of the Group are mainly denominated in Hong Kong dollars. The Group has substantial amount of Renminbi deposits on hand and the exchange rate of which are becoming volatile. The Directors consider that the Group may expose to fluctuations on Renminbi exchange rates.

During the year, the Group's investment properties, property, plant and equipment and certain bank deposits were pledged to two banks to secure the bank borrowings of approximately HK\$204,371,000, which is denominated in Hong Kong dollars and bearing interest at floating rate. The Group did not have significant contingent liabilities as at 31 December 2020 (31 December 2019: Nil) and there is no capital commitments as at 31 December 2020 (31 December 2019: Nil).

財務回顧

I. 流動性及財務資源

於二零二零年十二月三十一日，本集團之現金及銀行結餘(包括已抵押銀行存款)合共為港幣118,794,000元，而流動負債淨額則為港幣28,256,000元。本集團於二零二零年十二月三十一日之流動比率(以流動資產除以流動負債計算)約為0.87倍(二零一九年十二月三十一日：0.97倍)。

本集團之買賣主要以港幣計值。本集團手頭持有巨額人民幣存款，其匯率將較為波動，而董事認為本集團或會面臨人民幣匯率波動的風險。

年內，本集團之投資物業、物業、廠房及設備以及若干銀行存款已抵押予兩家銀行以取得約港幣204,371,000元之銀行借貸，該借貸以港幣計值並按浮動利率計息。於二零二零年十二月三十一日，本集團並無重大或然負債(二零一九年十二月三十一日：無)，於二零二零年十二月三十一日，本集團並無資本承擔(二零一九年十二月三十一日：無)。

II. Capital Structure of the Group

As at 31 December 2020, the Group had total equity of HK\$322,012,000, fixed rate liability of HK\$18,738,000, floating rate liability of HK\$204,371,000 and interest-free liabilities of HK\$27,177,000, representing 6%, 64% and 8% of the Group's total equity respectively. The gearing ratio (calculated as the total long-term loan to the total shareholders' equity) of the Group as at 31 December 2020 was approximately 5.7% (31 December 2019: 3.4%).

III. Significant Investments, material Acquisition and Disposal

During the year ended 31 December 2020, the Group had not made any significant investments or material acquisition or disposal.

IV. Employment Information

As at 31 December 2020, the Group employed approximately a total of 47 employees (2019: 37), an increase due to launching of the new hospitality business. The Group's emoluments policies are formulated on the performance of individual employee and are competitive in the market. During the year ended 31 December 2020, total staff costs (excluding Directors' emoluments) amounted to approximately HK\$11,396,000 (2019: HK\$9,871,000).

V. Final Dividend

The Directors do not recommend the payment of final dividend for the year ended 31 December 2020 (2019: Nil).

PROSPECTS

COVID-19 will continue to impact the major global economies in 2021 but Aisa is expected to lead in global economic recovery post COVID-19. China could be amongst the first country in the world to recover its economy and as unveiled by the latest economic data, recovery will be fast notwithstanding that in the near term US-China trade relations remain strained under the Biden administration which seems to retain a tough stance with China similar to Trump. China will continue to rebalance its economy and push out structural reforms including the “dual circulation strategy” which refers to a parallel emphasis on “internal” and “international” circulation. China’s steady economic growth and the Greater Bay Area initiatives to promote coordinated regional economic development will have a ripple effect on our economy and give new impetus to the Group’s business development in the region.

For over a year since the coronavirus outbreak, the roll out of vaccines across the globe is considered by many as game changer in the battle against the virus and brings light and hope to the tourism/hospitality and retail sectors that have been so severely battered. The Group had to put on hold projects which the Group explored and identified to add to our hospitality service operation portfolio after weighing on the pros and cons. The reopening of borders and return to travel will ultimately depend on the success of mass vaccinations not only in our home base but in Europe, US and to some degree China which is a key source market for many destinations across Asia Pacific not to mention Hong Kong where we operate our hostels. We are confident travel will return which is not a matter of if but rather when. The inherent wanderlust in human nature, relatively cheap cost of travel and pent-up demand all add up to support the expectation of a V-shaped recovery for the tourism/hospitality sector in the near term with due caution as borders re-open and the mechanism to facilitate mass travel is formalized between governments like administering digital health pass/vaccination travel ID.

前景

COVID-19將會於二零二一年內繼續影響全球主要經濟體，惟預期亞洲將於COVID-19疫情後引領全球經濟復甦。儘管拜登執政似乎對中國採取與特朗普相若的強硬立場，令中美貿易關係於短期內仍然緊張，但中國將可能成為世界第一個經濟復甦的國家，而根據最新的經濟數據表明復甦速度將會相當快。中國將繼續調整經濟結構及推行結構改革，當中包括「雙循環」戰略，即平衡「國內」及「國外」的經濟循環。中國的穩定經濟增長及促進區域經濟協調發展的大灣區計劃將對我們經濟產生連鎖反應，並為本集團在該區的業務發展注入新動力。

自新型冠狀病毒疫情爆發以來的一年多時間內，全球多個國家展開疫苗接種計劃被許多人視為可扭轉抗疫局勢，為遭受重創的旅遊／旅店及款待業和零售業帶來曙光及希望。經本集團權衡利弊後，本集團已暫停原定已發掘及物色作加入我們旅店及款待服務業務組合的項目。重開國際邊境及恢復旅遊活動與否，最終將不僅取決於本地能否成功大規模接種疫苗，亦視乎歐洲、美國及(在某程度上)中國的接種情況，原因是中國乃亞太地區許多目的地之主要客源市場，更遑論我們經營旅館的香港。我們對重啟旅遊業充滿信心，惟問題在於「何時」。隨著邊境重開及各國政府之間正式制定推動大眾旅遊的機制(如落實電子健康通行證／疫苗護照)，人類熱愛旅遊的天性、相對較低的旅遊成本及被壓抑已久的需求預期將可支持對旅遊／款待業短期內呈V型復甦的審慎期望。

It is everybody's wishful thinking that the vaccination campaigns being rolled out globally, the pandemic will eventually be brought under control. We envisage the world would be somewhat different after COVID-19. Many trends are already underway globally like the acceleration of digital economy due to the pandemic and certain structural changes such as remote working and learning, telemedicine, virtual meetings etc are more widely adopted and embraced. Digital capabilities will certainly become an increasingly important factor for majority businesses to respond to changing customers' needs and maintain a competitive edge for sustainable growth. Looking ahead, the global economy is generally expected to recover from the second half of 2021 onwards but not without the volatilities from the uncertainty associated with coronavirus or new variants of coronavirus status quo, evolving China/US relations, escalating geopolitical tensions, profound changes in the international landscape. With a pragmatic mindset backed by expertise and experience in our business, the Group will make timely adjustments or reforms including application of digital technologies to improve operational efficiency and achieve further growth at the time when people's daily lives somewhat return to normal and our economy recovers from the epidemic.

CORPORATE SOCIAL RESPONSIBILITY

The Group always strives for being a responsible member of the communities in the territories it operates, Hong Kong and Macau. As such, each year the management would set targets to achieve goals of community care and environment protection by actively participating in various social services. In the future the Group shall continue to seek innovative and meaningful ways to engage its employees and associates in building stronger and more vibrant communities.

RELATION WITH EMPLOYEE, CUSTOMERS AND SUPPLIERS

Remuneration packages are generally structured with reference to prevailing market terms and individual qualifications. Salaries and wages are normally reviewed on an annual basis based on performance appraisals and other relevant factors like the business performance of the Company and the annual inflation rate in Hong Kong. Apart from salary payments, there are other staff benefits including mandatory provident fund, medical insurance and performance related bonus.

Customer relationship plays a very important role in the operation of the company. The Company fully understands this principal and thus maintains close relationship with the customers with a watchful eye for service improvement to fulfill their immediate and long-term need.

CORPORATE GOVERNANCE PRACTICES

The Board is committed to upholding a high standard of corporate governance practices and business ethics in the firm belief that they are essential for maintaining and promoting investors' confidence and maximizing shareholders' returns. The Board reviews its corporate governance practices from time to time in order to meet the rising expectations of stakeholders and comply with increasingly stringent regulatory requirements, and to fulfill its commitment to excellence in corporate governance.

Throughout the year of 2020, the Company has complied with all Code Provisions in the Code of Corporate Governance Practices (the "CG Code") contained in Appendix 14 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the "Listing Rules") except for certain areas of non-compliance that are discussed below.

THE BOARD AND THE MANAGEMENT

The Board lays down corporate strategies, approves overall business plans and, on behalf of the shareholders, supervises the Company's financial performance, its management and organization. The Board is also responsible for overseeing the preparation of financial statements of each financial period, which give a true and fair view of the state of affairs the Group and of the results and cash flow of that period. The Board defines the scope within which the management team carries out day-to-day management tasks. Each of executive directors oversees specific areas of our business. The Board is also responsible for developing and reviewing the Company's policies and practices on corporate governance duties as defined under the CG Code.

The Board determines the Company's overall objectives, strategies and business plans based on the recommendations of the management team and approves the key figures underlying the budgets prepared by the management team.

董事會根據管理層之建議，釐定本公司之整體目標、策略及業務計劃，以及批准管理層編製之預算的主要數字。

The Board reviews and approves the Company's budgets and checks to see if the targets are being achieved. It also monitors the Company's liquidity and cash positioning. It approves the Company's significant transactions.

The Board and management team handle material price sensitive information with strict confidence. Public announcements are made in a timely manner to keep shareholders and the public abreast with the latest developments.

BOARD COMPOSITION

As at 31 December 2020, the Board comprises six Directors, three of them are women, half of the Directors are non-executive and independent of management, thereby promoting critical review and control of the management process. The Board is collectively responsible for promoting the success of the Company by directing and supervising the Company's affairs. The Board has a balance of skill and experience appropriate for the requirements of the Group's businesses. Three of the Directors are executive, namely Mr. TSANG Chiu Mo Samuel, Executive Chairman, Ms. TSANG Chiu Yuen Sylvia and Ms. CHU Ming Tak Evans Tania, and three of the Directors are independent non-executive, namely Mr. HUI Yan Kit, Mr. Lau Pui Wing and Ms. Ho Ting Mei. Each of Directors' respective biographical details is set out in the "Biographical Details of Directors and Senior Management" of this annual report. It is the opinion of the Directors that the Board has the necessary skills and experience appropriate for discharging their duties as Directors in the best interest of the Company.

During the year ended 31 December 2020, the Board at all time met the minimum requirements of the Listing Rules relating to the appointment of at least three independent non-executive Directors, and complied with the requirement that these should include one such director with appropriate professional qualifications of accounting or related financial management expertise. Mr. Lau Pui Wing has the appropriate professional qualifications and experience in financial matters required. Pursuant to the requirement in the Listing Rules, the Company has received a written confirmation from each of the independent non-executive Directors of his/her independence to the Company.

Board Diversity Policy

The Board adopted board diversity policy (the “Board Diversity Policy”) in September 2013. The Company recognizes and embraces the benefits of diversity of Board members. While all Board appointments will continue to be made on a merit basis, the Company will ensure that the Board has a balance of skills, experience and diversity of perspectives appropriate to the needs of the Company’s business. Selection of candidates will be based on a range of diversity perspectives, including but not limited to gender, age, cultural and educational background, experience (professional or otherwise), skills and knowledge.

BOARD PRACTICES

The Board meets at least four times each year at approximately quarterly intervals to discuss the Group’s business development, operation and financial performance. Notice of at least 14 days is given to all Directors for all regular Board meetings to give all Directors an opportunity to attend. All regular Board meetings adhere to a formal agenda in which a schedule of matters is addressed to the Board. All Directors have access to board paper and related materials, and are provided with adequate information which enables the Board to make an informed decision on the matters to be discussed and considered at the Board meetings. Minutes of Board meetings are kept by the Company Secretary and are open for inspection at any reasonable time on reasonable notice by any Director.

To facilitate the decision-making process, the Directors are free to have access to the management for enquiries and to obtain further information, when required and the Directors can obtain independent professional advice at the Company’s expense.

DIRECTORS' TRAINING

According to the code provision A.6.5 of the CG code, all directors should participate in a programme of continuous professional development to develop and refresh their knowledge and skills to ensure that their contribution to the board remains informed and relevant. The Company should be responsible for arranging and funding training, placing an appropriate emphasis on the roles, functions and duties of the Directors of the Company.

During the year and up to the date of this report, the Company provided to all Directors related articles on regulatory updates, management skills and corporate governance from The Journal of The Hong Kong Institute of Chartered Secretaries, Hong Kong Institution of Certified Public Accountants and the Association of Chartered Certified Accountants and materials from The Stock Exchange of Hong Kong Limited website. Each of the Directors had noted and studied the above mentioned documents and that the Company had received from Directors the confirmations on taking continuous professional training.

APPOINTMENT AND RE-ELECTION OF DIRECTORS

Each of the executive Directors has entered into a service contract with the Company for an initial fixed term of 2 years and will continue thereafter unless and until terminated by either party giving not less than six months' prior notice in writing to the other. All Directors are subject to retirement from office by the rotation at each annual general meeting as required by the bye-laws of the Company ("Bye-laws").

Service contracts have been entered between the Company with each of the independent non-executive Directors providing, amongst other things, their term of offices for a period of one year until terminated by either party giving not less than one month's prior notice in writing to the other. Moreover, they would also be subject to retirement by rotation at each annual general meeting of the Company.

In accordance with the Bye-laws, all Directors are subject to retirement by rotation and re-election at annual general meetings of the Company. Directors appointed by the Board during the year are required to retire and submit themselves for re-election at the first general meeting immediately following their appointments. Further, at each annual general meeting, one-third of Directors, or, if their number is not a multiple of three, then the number nearest to but not less than one-third are required to retire from office.

Each newly appointed Director is provided with a package of orientation materials setting out the duties and responsibilities of Directors under the Listing Rules, related ordinances and relevant regulatory requirements of Hong Kong. Orientation meeting with newly appointed Director would be held for briefing on business and operations of the Company.

DIRECTORS' SECURITIES TRANSACTIONS

The Company has adopted the Model Code for Securities Transactions by Directors (the "Model Code") set out in Appendix 10 of the Listing Rules as its own code of conduct regarding securities transactions by the Directors. Having made specific enquiry with all Directors, the Company confirmed that all the Directors have complied with the required standard of dealings set out in the Model Code throughout the year ended 31 December 2020.

CHAIRMAN AND CHIEF EXECUTIVE OFFICER

The CG Code stipulates that the roles of Chairman and Chief Executive Officer should be separate and should not be performed by the same person. Mr. TSANG Chiu Mo Samuel is the Executive Chairman of the Company and no Chief Executive Officer has been appointed. The responsibilities of Chief Executive Officer have been carried out by Mr. TSANG Chiu Mo Samuel. The Board believes that it is in the best interest of the Company and the shareholders as a whole for Mr. TSANG Chiu Mo Samuel, who is knowledgeable in the business of the Group and possesses the essential leadership skills to guide discussions of the Board in an effective manner, to continue to carry out the responsibilities of Chief Executive Officer, which ensures on the effectiveness and efficiency of the decision making process of the Board.

COMMITTEES OF THE BOARD

Nomination Committee

The Nomination Committee was established on 16 September 2005 with a written terms of reference which are available from the Company Secretary at any time. The terms of reference of the Nomination Committee include making recommendations for all appointment, re-designation and re-appointment of Directors to the Board. As at 31 December 2020, the Nomination Committee comprises of three members, two of whom are independent non-executive directors, namely Ms. HO Ting Mei, Mr. Hui Yan Kit and one is executive director, Ms. Chu Ming Tak Evans Tania. Ms. Ho Ting Mei is the Chairman of the Committee.

The Nomination Committee is also responsible for determining the independence of each Director and conducting formal assessment of the effectiveness of the Board as a whole and the contribution of each Director to the effectiveness of the Board. In evaluating the Board's performance, the Nomination Committee considers a number of factors, including those set out in the CG Code.

The Nomination Committee meets at least once a year. During the year, the Nomination Committee has held one meeting, to review the structure, size and composition (including the skills, knowledge and experience) of the existing Board members of the Company to enhance the effectiveness of the Board to run the business of the Group steadily.

In accordance with Bye-law 87(1) of the Bye-laws, Ms. Tsang Chiu Yuen Sylvia, Ms. Chu Ming Tak Evans Tania and Mr. Hui Yan Kit will retire by rotation at the forthcoming annual general meeting of the Company and, being eligible, offer themselves for re-election. Mr. HUI Yan Kit was appointed as independent non-executive Directors of the Company in July 2004. He has been the independent non-executive Director of the Company for over 16 years.

Remuneration Committee

The Remuneration Committee was established on 16 September 2005 with written terms of reference no less exacting terms than the CG Code. The terms of reference of the Remuneration Committee are available from the Company Secretary at any time. As at 31 December 2020, the Remuneration Committee comprises two independent non-executive Directors, namely Mr. HUI Yan Kit, Ms. HO Ting Mei and one executive Director, Ms. Chu Ming Tak Evans Tania. Mr. HUI Yan Kit is the Chairman of the Committee.

The duties of the Remuneration Committee includes making recommendations to the Board on the remuneration policy and structure of the Directors and senior management, reviewing and approving the management's remuneration proposals, making recommendations to the Board on the remuneration packages of individual Executive Directors and senior management, approving the compensation payable to Directors and senior management on termination or dismissal to ensure they are consistent with contractual terms and also ensure that no Director was involved in deciding his/her own remuneration. Remuneration package for executive Directors are as follows:

1. The remuneration for the executive Directors comprises basic salary and pensions.
2. Salaries are reviewed annually. Salary increases are made where the Remuneration Committee believes that adjustments are appropriate to reflect performance, contribution, increased responsibilities and/or by reference to market/sector trends.
3. In addition to basic salary, executive Directors and employees of the Company and its subsidiaries are eligible to receive a discretionary bonus taking into consideration factors such as market conditions as well as corporate and individual performances.
4. Details of the amount of Directors' emoluments during the financial year ended 31 December 2020 are set out in note 13 to the consolidated financial statements in this annual report.

The emolument policy of the employees of the Group is set up on the basis of their merit, qualifications and competence. The emoluments of the Directors are determined with reference to the Company's operating results, individual performance and the prevailing market rates.

The Remuneration Committee meets at least once a year. Executive Committee

The Executive Committee was established on 28 December 2015 with written terms of reference setting out the duties and responsibilities. The Executive Committee consists of five members, namely, Mr. TSANG Chiu Mo Samuel (Executive Chairman), Ms. TSANG Chiu Yuen Sylvia (Executive Director), Ms. CHU Ming Tak Evans Tania (Executive Director), Ms. SZE Tak On (Financial Controller) and Ms. WONG Yim Tsui Amy (Vice President of Human Resources & Corporate Affairs). The Executive Committee shall normally meet on a monthly basis and in any event no less than quarterly.

For more efficient operation of the Board, the Executive Committee was established mainly (i) to make recommendations to the Board on the strategic aims, objectives and risk management of the Company; and (ii) to consider and approve matters relating to the day-to-day operations of the Group.

The Executive Committee was also delegated by the Board to perform the corporate governance functions set out in Code Provision D.3.1 of the CG Code including (i) to develop and review the Company's policies and practices on corporate governance and make recommendations to the Board; (ii) to review and monitor the training and continuous professional development of Directors and senior management; (iii) to review and monitor the Company's policies and practices on compliance with legal and regulatory requirements; (iv) to develop, review and monitor the code of conduct and compliance manual applicable to employees and Directors; and (v) to review the Company's compliance with the code and disclosure in the corporate governance report.

Audit Committee

The Audit Committee was established with written terms of reference which are available from the Company Secretary at any time. The Audit Committee currently comprises of three members, all of whom are independent non-executive Directors. As at 31 December 2020, the members are Mr. Lau Pui Wing (the Chairman of the Committee), Mr. HUI Yan Kit and Ms. HO Ting Mei all of whom are not involved in the day-to-day management of the Company.

The Audit Committee convenes meetings at least twice a year. The Audit Committee is responsible for reviewing the Company's financial information (including the Company's financial statements, annual reports, interim reports and major comments on financial reporting contained in the financial statements and reports), reviewing the adequacy and effectiveness of the Company's financial reporting system, risk management and internal control systems and associated procedures, and making recommendations to the Board on matters regarding the appointment of external auditors and auditing fee etc.

During the year under review, the Audit Committee held two meetings, during which the annual report for the year ended 31 December 2019 and the interim report for the six months ended 30 June 2020 were reviewed. Please refer to the table set out in the section "Board Practices" of this report for the attendance record of individual Audit Committee members. All these meetings were convened in accordance with the Bye-laws.

Save as disclosed above, the Audit Committee has reviewed the audited financial statements of the Company for the year ended 31 December 2020.

The Audit Committee has recommended to the Board that BDO Limited, Certified Public Accountants ("BDO"), be nominated for re-appointment as external auditor of the Company at the forthcoming annual general meeting of the Company.

SHAREHOLDERS' RIGHTS AND INVESTOR RELATIONS

In order to develop and maintain a continuing investors' relationship with the Company's shareholders, the Company has established various channels of communications with its shareholders such as publication of interim and annual reports, press release and announcement of the latest development of the Company in a timely manner. The annual general meeting provides an opportunity for shareholders to exchange views with the Board. The Chairman as well as Chairmen of different Committees are available to answer shareholders' questions. Moreover, resolutions are proposed at annual general meeting on each substantially separate issue, including the election of individual Directors. In addition, details of the poll voting procedures and the rights of shareholders to demand a poll are included in the circular to shareholders despatched together with the annual report. Details of the proposed resolutions are also set out in the circular.

In accordance with the Bye-laws, any shareholder holding not less than one-tenth of the paid-up capital of the Company carrying the right of voting at a general meeting shall have the right, by written requisition served to the Board or the Company Secretary, to require a special general meeting to be convened by the Board for transaction of any business specified in such requisition. Any vote of shareholders at a general meeting must be taken by poll. The chairman of meeting will explain the poll voting procedures at the relevant general meeting.

Valuation of investment properties

Management estimated the fair value of the Group's investment properties to be HK\$130,100,000 at 31 December 2020.

Independent external valuations were obtained for all the investment properties to support management's estimates. The valuations are dependent on certain key assumptions that require significant management judgment, including recent market information about prices for comparable properties with potentially significant adjustments for any differences in the characteristics of the Group's properties.

Our procedures in relation to management's valuation of investment properties included:

- evaluating the independent external valuers' competence, capabilities and objectivity;
- assessing the methodologies used and the appropriateness of key assumptions based on our knowledge of the property industry; and
- checking, on a sample basis, the accuracy and relevance of the input data used and the resultant calculations.

1. GENERAL INFORMATION

Century Legend (Holdings) Limited (the “Company”) was incorporated as an exempted company with limited liability in Bermuda and its shares are listed on the Main Board of The Stock Exchange of Hong Kong Limited (the “Stock Exchange”). The Company’s registered office is at Clarendon House, 2 Church Street, Hamilton, HM 11, Bermuda and its principal place of business is at Unit 906, 9th Floor, Capital Centre, 151 Gloucester Road, Wanchai, Hong Kong.

The consolidated financial statements are presented in Hong Kong Dollars (“HK\$”), which is also the functional currency of the Company and all amounts are rounded to the nearest thousand (“HK\$’000”) except when otherwise indicated.

The Company is principally engaged in investment holding. Details of the principal activities of its subsidiaries are set out in note 31. The Company and its subsidiaries are referred to as “the Group” hereinafter.

The consolidated financial statements on pages 63 to 182 have been prepared in accordance with all Hong Kong Financial Reporting Standards (“HKFRSs”) which collectively includes individual Hong Kong Financial Reporting Standards, Hong Kong Accounting Standards (“HKASs”) and Interpretations issued by the Hong Kong Institute of Certified Public Accountants (the “HKICPA”). The consolidated financial statements also include the applicable disclosure requirements of the Hong Kong Companies Ordinance and the Rules Governing the Listing of Securities on the Stock Exchange.

The depreciation of leased properties held for the Group’s hair styling services for the year ended 31 December 2020 in the consolidated statement of comprehensive income has been reclassified from administrative expenses to cost of revenue. The Group considered that the current presentation is more appropriate for the results of the Group following the development of the Group’s hospitality services. The comparative amounts in the consolidated statement of comprehensive income for the year ended 31 December 2019 are re-presented accordingly.

The consolidated financial statements for the year ended 31 December 2020 were approved and authorised for issue by the directors on 30 March 2021.

1. 一般資料

載於第63至182頁之綜合財務報表乃根據香港會計師公會(「香港會計師公會」)頒佈之香港財務報告準則(「香港財務報告準則」)(此統稱包括個別香港財務報告準則、香港會計準則(「香港會計準則」)及詮釋)編製。綜合財務報表亦包括香港公司條例及聯交所證券上市規則之適用披露規定。

The concentration test is met if substantially all of the fair value of the gross assets acquired is concentrated in a single identifiable asset or group of similar identifiable assets. If the concentration test is met, the set of activities and assets is determined not to be a business. If the concentration test is failed, the acquired set of activities and assets is further assessed based on the elements of a business.

The Group elected to apply the amendments prospectively to acquisitions for which the acquisition date is on or after 1 January 2020.

3. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The significant accounting policies that have been used in the preparation of the consolidated financial statements are summarised below. These policies have been consistently applied to all the years presented unless otherwise stated.

3.1 Basis of preparation and going concern assumption

The consolidated financial statements have been prepared on the historical cost basis except for investment properties and certain financial instruments which are stated at fair value. The measurement bases are fully described in the accounting policies below.

During the year ended 31 December 2020, the loss of the Group amounted to approximately HK\$25,738,000. As at 31 December 2020, the Group's current liabilities exceeded its current assets by approximately HK\$28,256,000. Out of which, secured bank borrowings of approximately HK\$157,706,000 would be due for repayment in 2021 in accordance with the repayment dates of the respective agreements and a shareholder loan of HK\$15,000,000 without fixed term of repayment, while the Group maintained the pledged bank deposits and cash and bank balances of approximately HK\$92,469,000 and HK\$26,325,000 respectively.

Notwithstanding the above, the consolidated financial statements have been prepared on a going concern basis as the directors considered that the Group will have sufficient financial resources to meet in full its working capital requirements and financial obligations during the next twelve months. The events that have been considered include the following:

- (i) A shareholder has confirmed to provide financial support to the Group to finance its operations and not to recall the shareholder loan until the Group has the ability to repay;

3.1 編製基準及持續經營假設

除投資物業及若干金融工具以公平值列賬外，該等綜合財務報表乃根據歷史成本法編製。有關計算基準於下文會計政策全面描述。

截至二零二零年十二月三十一日止年度，本集團虧損約為港幣 25,738,000 元。於二零二零年十二月三十一日，本集團流動負債超出流動資產約港幣 28,256,000 元。其中約港幣 157,706,000 元之有抵押銀行借貸按照各自協議之還款日期須於二零二一年內償還，以及一項港幣 15,000,000 元之股東貸款並無固定還款期限。而本集團的已抵押銀行存款及現金及銀行結餘分別約為港幣 92,469,000 元及港幣 26,325,000 元。

儘管存在上述狀況，綜合財務報表乃按持續經營基準編製，原因是董事考慮到本集團將擁有足夠財務資源完全滿足其未來十二個月內之營運資金需求及財務責任。已考慮的事項包括：

- (i) 一名股東已確認將向本集團提供財務援助以為其營運提供資金，並且在本集團有能力償還債務前不會要求償還股東貸款；

- (ii) The Group has been in the process of renewing with its banker the bank facilities of approximately HK\$155,120,000. As a result of the outbreak of COVID-19, the bank agreed to extend the expiry date of these facilities to 30 June 2021 for having more time to process the renewal. The Group considered that the renewal would be completed based on its credit history and fair value of the collateral; and
- (iii) The Group would consider disposing of certain investment properties to provide further funding when the liquidity needs arise.

3.2 Business combination and basis of consolidation

The consolidated financial statements comprise the financial statements of the Company and its subsidiaries (see note 3.3 below). Inter-company transactions and balances between group companies together with unrealised profits are eliminated in full in preparing the consolidated financial statements. Unrealised losses are also eliminated unless the transaction provides evidence of impairment on the asset transferred, in which case the loss is recognised in profit or loss.

3.2 業務合併及綜合基準

該等綜合財務報表包括本公司及其附屬公司(見下文附註3.3)之財務報表。集團內公司間之交易及結餘及未變現溢利於編製綜合財務報表時悉數撇銷。除非交易提供轉讓資產之減值證明，否則未變現虧損亦撇銷，在此情況下，虧損於損益賬確認。

Where necessary, adjustments are made to the financial statements of subsidiaries to bring their accounting policies in line with those used by other members of the Group.

Acquisition of subsidiaries or businesses is accounted for using the acquisition method when the acquired set of activities and assets meets the definition of a business and control is transferred to the Group. In determining whether a particular set of activities and assets is a business, the Group assesses whether the set of assets and activities acquired includes, at a minimum, an input and substantive processes and whether the acquired set has the ability to produce outputs. The cost of an acquisition is measured at the aggregate of the acquisition-date fair value of assets transferred, liabilities incurred and equity interests issued by the Group, as the acquirer. The identifiable assets acquired and liabilities assumed are principally measured at acquisition-date fair value. The Group's previously held equity interest in the acquiree is re-measured at acquisition-date fair value and the resulting gains or losses are recognised in profit or loss. The Group may elect, on a transaction-by-transaction basis, to measure the non-controlling interest either at fair value or at the proportionate share of the acquiree's identifiable net assets. All other non-controlling interests are measured at fair value unless another measurement basis is required by another HKFRSs. Acquisition-related costs incurred are expensed unless they are incurred in issuing equity instruments, in which case the costs are deducted from equity.

當已收購的一組活動及資產符合業務的定義並轉移至本集團控制，收購附屬公司或業務便會採用收購法列賬。就本集團釐定該組活動及資產是否一項業務，其必須至少包括投入能力及實質性進程，並擁有產出的能力。一項收購成本是按所轉讓資產，所產生負債及本集團(作為收購方)發行之股權於收購日期之公平值總額計量的。所收購可識別資產及所承擔負債則主要按收購日期公平值計量。本集團先前所持被收購方之股權以收購日期公平值重新計量，而所產生之收益或虧損則於損益賬內確認。本集團可按逐筆交易基準選擇以被收購方之可識別資產淨值之公平值或應佔比例計算非控股權益。所有其他非控股權益按公平值計量，除另一香港財務報告準則規定另一計量基準則另作別論。所產生之收購相關成本列作開支，除非該等成本於發行股本工具時產生，在此情況下，該等成本自權益扣減。

Any contingent consideration to be transferred by the acquirer is recognised at acquisition-date fair value. Subsequent adjustments to consideration are recognised against goodwill only to the extent that they arise from new information obtained within the measurement period (a maximum of 12 months from the acquisition date) about the fair value at the acquisition date. All other subsequent adjustments to contingent consideration classified as an asset or a liability are recognised in profit or loss.

Changes in the Group's interests in subsidiaries that do not result in a loss of control are accounted for as equity transactions. The carrying amounts of the Group's interest and the non-controlling interests are adjusted to reflect the changes in their relative interests in the subsidiaries. Any difference between the amount by which the non-controlling interest is adjusted and the fair value of the consideration paid or received is recognised directly in equity and attributed to owners of the Company.

When the Group loses control of a subsidiary, the profit or loss on disposal is calculated as the difference between (i) the aggregate of the fair value of the consideration received and the fair value of any retained interest and (ii) the previous carrying amount of the assets (including goodwill), and liabilities of the subsidiary and any non-controlling interest. Amounts previously recognised in other comprehensive income in relation to the subsidiary are accounted for in the same manner as would be required if the relevant assets or liabilities were disposed of.

倘若本集團於附屬公司之權益變動並無導致失去控制權，則入賬列作權益交易。本集團權益及非控股權益之賬面價值乃調整以反映其各自於附屬公司之相應權益變動。非控股權益之調整金額與已付或者已收代價公平值之間之任何差額，於權益直接確認，並歸屬於本公司擁有人。

Subsequent to acquisition, the carrying amount of non-controlling interests that represent present ownership interests in the subsidiary is the amount of those interests at initial recognition plus the non-controlling interest's share of subsequent changes in equity. Total comprehensive income is attributed to non-controlling interests even if this results in the non-controlling interest having a deficit balance.

3.3 Subsidiaries

A subsidiary is an investee over which the Company is able to exercise control. The Company controls an investee if all three of the following elements are present:

- power over the investee;
- exposure, or rights, to variable returns from the investee; and
- the ability to use its power to affect those variable returns.

Control is reassessed whenever facts and circumstances indicate that there may be a change in any of these elements of control.

In the Company's statement of financial position, investments in subsidiaries are stated at cost less impairment loss, if any. The results of the subsidiaries are accounted for by the Company on the basis of dividends received and receivable.

3.4 Foreign currency

In the individual financial statements of the consolidated entities, foreign currency transactions are translated into the functional currency of the individual entity using the exchange rates prevailing at the dates of the transactions. At the end of the reporting period, monetary assets and liabilities denominated in foreign currencies are translated at the foreign exchange rates ruling at that date. Foreign exchange gains and losses resulting from the settlement of such transactions and from the end of the reporting period retranslation of monetary assets and liabilities are recognised in profit or loss.

Non-monetary items carried at fair value that are denominated in foreign currencies are retranslated at the rates prevailing on the date when the fair value was determined and are reported as part of the fair value gain or loss. Non-monetary items that are measured in terms of historical cost in a foreign currency are not retranslated.

In the consolidated financial statements, all individual financial statements of foreign operations, originally presented in a currency different from the Group's presentation currency, have been converted into HK\$. Assets and liabilities have been translated into HK\$ at the closing rates at the end of the reporting period. Income and expenses have been converted into HK\$ at the exchange rates ruling at the transaction dates, or at the average exchange rates for the reporting period provided that the exchange rates do not fluctuate significantly. Any differences arising from this procedure have been recognised in other comprehensive income and accumulated separately in the translation reserve in equity.

On disposal of a foreign operation, the cumulative exchange differences recognised in the translation reserve relating to that operation up to the date of disposal are reclassified to profit or loss as part of the profit or loss on disposal.

於合併實體之個別財務報表中，外幣交易按交易日期之適用匯率換算為個別實體之功能貨幣。於報告期末，以外幣列值之貨幣資產及負債乃按當日之適用外幣匯率換算。因清償該等交易及因報告期末重新換算貨幣資產及負債而產生之外幣兌換盈虧於損益賬中確認。

按公平值以外幣列賬之非貨幣項目按釐定公平值當日適用之匯率重新換算，並作為公平值之盈虧部份列報。以外幣按歷史成本法計量之非貨幣項目不會重新換算。

於綜合財務報表中，所有原來採用不同於本集團呈報貨幣之貨幣所呈報之境外業務之個別財務報表均已轉換成港幣。資產及負債已按報告期末之收市匯率兌換為港幣。收入及支出已按交易日期適用之匯率，或報告期間之平均匯率(假設該期間之匯率並無重大波動)轉換為港幣。因該程序導致之任何差異已於其他全面收入確認及於權益之換算儲備中分開累計。

當出售境外業務，與該業務相關並於截至出售日期為止在換算儲備內確認之累計外匯差額，會重新分類至損益賬以作為出售之損益部份。

3.5 Revenue and other income recognition

Revenue from contracts with customers is recognised when control of goods or services is transferred to the customers at an amount that reflects the consideration to which the Group expects to be entitled in exchange for those goods or services, excluding those amounts collected on behalf of third parties. Revenue excludes value added tax or other sales taxes and is after deduction of any trade discounts.

Depending on the terms of the contract and the laws that apply to the contract, control of the goods or service may be transferred over time or at a point in time. Control of the goods or service is transferred over time if the Group's performance:

- provides all of the benefits received and consumed simultaneously by the customer;
- creates or enhances an asset that the customer controls as the Group performs; or
- does not create an asset with an alternative use to the Group and the Group has an enforceable right to payment for performance completed to date.

If control of the goods or services transfers over time, revenue is recognised over the period of the contract by reference to the progress towards complete satisfaction of that performance obligation. Otherwise, revenue is recognised at a point in time when the customer obtains control of the goods or service.

貨品或服務的控制權可隨時間或於某一時點轉移,取決於合約的條款與適用於合約的法律規定。倘本集團於履約時滿足下列條件,貨品或服務的控制權可隨時間轉移:

- 倘客戶同時收到及消耗所有利益;
- 本集團履約時創建或提升客戶所控制之資產;或
- 並未產生讓本集團有替代用途之資產,且本集團對至今已完成履約之付款具有可強制執行之權利。

倘貨品或服務的控制權隨時間轉移,本集團按在整個合約期間已完成履約義務的進度確認收入。否則,收入於客戶獲得貨品或服務控制權之該時點確認。

When the contract contains a financing component which provides the customer a significant benefit of financing the transfer of goods or services to the customer for more than one year, revenue is measured at the present value of the amounts receivable, discounted using the discount rate that would be reflected in a separate financing transaction between the Group and the customer at contract inception. Where the contract contains a financing component which provides a significant financing benefit to the Group, revenue recognised under that contract includes the interest expense accreted on the contract liability under the effective interest method. For contracts where the period between the payment and the transfer of the promised goods or services is one year or less, the transaction price is not adjusted for the effects of a significant financing component, using the practical expedient in HKFRS 15 *Revenue from Contracts with Customers* ("HKFRS 15").

The Group recognised revenue as the following basis:

- (a) Revenue from rendering of hair styling services is recognised when the relevant services are rendered and transferred over time. There is only one performance obligation. In general, there is no credit term offered to the customers which is consistent with market practice.
- (b) Rental income under leases arrangements is recognised on a straight-line basis over the term of the relevant lease.
- (c) Service fee income in relation to hospitality services is recognised when the relevant services are provided to the customers.
- (d) Interest income is accrued on a time basis on the principal outstanding at the applicable interest rate.

- (e) Commission and management fee income is recognised when the agreed services are provided.
- (f) Dividend income is recognised when the right to receive payment is established.

(g) Revenue from rendering of property project management services

The Group has determined that there are significant integration of different elements underlying a property management contract and thus such contracts are considered to contain only a single performance obligation. In addition, the Group's performance creates or enhances an asset that the customer controls as the asset is created or enhanced. Accordingly, the revenue from these contracts are recognised over time.

When the outcome of a performance obligation in the property management contract can be reasonably measured, contract revenue and the associated contract costs are recognised over time based on the progress of the respective contract at the end of the reporting period. The progress toward complete satisfaction of the performance obligation of a property management contract is determined by reference to the contract costs incurred to date as a proportion of the total estimated contract costs. Contract costs and contract progress are highly correlated for property management contract.

當物業管理合約之履約責任的結果能夠合理計量時，合約收益和相關的合約成本會隨著時間的推移而根據截至報告期末的各自合約。完全滿足物業管理合約之履約責任的進展參照到目前為止所產生的合約費用佔估計合約總費用的比例。物業管理合約之合約成本與合約進度為高度相關。

When the outcome of a performance obligation in the property management contract cannot be reasonably measured, revenue is recognised only to the extent of contract costs incurred that are expected to be recovered.

Contract modification (i.e. variation order) are recognised when they are approved by customer. Generally modification to a property management contract is not accounted for as a separate contract. Contract modification is accounted for as if it were a part of the existing contract and, therefore, form part of a single performance obligation that is partially satisfied at the date of the contract modification. The effect that the contract modification on the contract sum and on the Group's measures of progress towards complete satisfaction of the performance obligation, is recognised as an adjustment to revenue (either as an increase in or a reduction of revenue) at the date of the contract modification (i.e. the adjustment to revenue is made on a cumulative catch-up basis). For approved modifications where a change in price has not been agreed and other claims, they are accounted for following the requirements in relation to variable consideration that the amount of consideration is estimated to which the Group will be entitled in exchange for transferring the goods or services to the customer. The variable consideration is constrained until it is highly probable that a significant revenue reversal in the amount of cumulative revenue recognised will not occur.

當物業管理合約之履約責任的結果無法合理計量，收益僅在預計將收回的合約成本的範圍內確認。

合約修改(即更改訂單)在客戶批准時予以確認。通常，對物業管理合約的修改不作為單獨的合約進行核算。合約修改視為現有合約的一部分，因此構成單一履約責任的一部分，在合約修改之日部分履行。合約修訂對合約金額以及對本集團計量達致完全履行履約責任的進度之影響，在合約的約定下被確認為對收益的調整(作為收益的增加或減少)修改(即對收益的調整是在累積追趕的基礎上進行的)。對於尚未商定價格變動的批准修改和其他債權，它們按照與可變對價相關的要求進行會計處理，即代價金額按本集團就向客戶轉移貨品或服務而有權獲得者估計。可變代價受到限制，直至已在已確認之累計收益金額中極不可能出現重大收益回撥為止。

If at any time the costs to complete the contract are estimated to exceed the remaining amount of the consideration under the contract, a provision is recognised in accordance with the accounting policy for onerous contracts as set out in note 3.18.

Contract assets and liabilities

A contract asset represents the Group's right to consideration in exchange for services that the Group has transferred to a customer that is not yet unconditional. In contrast, a receivable represents the Group's unconditional right to consideration, i.e. only the passage of time is required before payment of that consideration is due.

A contract liability represents the Group's obligation to transfer services to a customer for which the Group has received consideration (or an amount of consideration is due) from the customer.

Contract asset is recognised when the Group completes the property project management works under such services contracts but yet certified by architects, surveyors or other representatives appointed by customers. Any amount previously recognised as a contract asset is reclassified to trade receivables at the point at which it is certified and invoiced to the customer. If the considerations (including advances received from customers) exceeds the revenue recognised to date, then the Group recognises a contract liability for the difference.

倘若在任何時候完成合約的成本估計超過合約下的代價餘額，則按照附註3.18中規定的虧損性合約會計政策確認撥備。

合約資產及負債

合約資產指本集團就換取本集團已轉移至客戶的服務收取代價的權利(尚未成為無條件)。相反，應收款項指本集團收取代價的無條件權利，即代價到期付款前僅需時間推移。

合約負債指本集團就其已向客戶收取的代價(或已到期收取代價金額)而須向該客戶轉移服務的責任。

合約資產於本集團根據該等服務合約完成物業項目管理工程但尚未由客戶委聘的建築師、測量師或其他代表認證時確認。先前確認為合約資產的任何金額在向客戶認證及出具發票時重新分類為貿易應收賬項。如有關代價(包括向客戶收取的預付款)超出迄今確認的收益，則本集團會就有關差額確認合約負債。

3.6 Borrowing costs

Borrowing costs attributable directly to the acquisition, construction or production of qualifying assets which require a substantial period of time to be ready for their intended use or sale, are capitalised as part of the cost of those assets. Income earned on temporary investments of specific borrowings pending their expenditure on those assets is deducted from borrowing costs capitalised. All other borrowing costs are recognised in profit or loss in the period in which they are incurred.

3.7 Property, plant and equipment

Property, plant and equipment are stated at acquisition cost less accumulated depreciation and impairment losses, if any. The cost of property, plant and equipment includes its purchase price and the costs directly attributable to the acquisition of the items.

Property, plant and equipment are depreciated so as to write off their cost net of expected residual value over their estimated useful lives on a straight-line basis. The assets' residual values, depreciation methods and useful lives are reviewed, and adjusted if appropriate, at the end of each of the reporting period. The useful lives are as follows:

收購、建造或生產合資格資產(須耗用較長時間方可作擬定用途或銷售)直接產生的借貸成本均撥充資本,作為該等資產成本的一部份。如為日後支付該等資產的支出而借入若干指定借貸,並因短暫投資於該等借貸而賺得任何收入,該等收入將從資本化的借貸成本中扣除。所有其他借貸成本乃於產生之期間內在損益確認。

3.7 物業、廠房及設備

物業、廠房及設備是按收購成本減累計折舊及減值虧損(如有)列賬。物業、廠房及設備之成本包括其購買價以及收購項目之直接應佔成本。

物業、廠房及設備於其估計可使用年期內按直線基準折舊,藉此撇銷其成本(扣除預期剩餘價值)。資產之剩餘價值、折舊方法及可使用年期於各報告期末未予以審閱,並在適當情況下調整。可使用年期如下:

Leased assets are depreciated on a straight-line basis over their expected useful lives on the same basis as owned assets, or where shorter, the term of the relevant lease.

An asset is written down immediately to its recoverable amount if its carrying amount is higher than the asset's estimated recoverable amount (See note 3.9).

Assets held under finance leases are depreciated over their expected useful lives on the same basis as owned assets or, where shorter, the term of the relevant lease.

The gain or loss on disposal of an item of property, plant and equipment is the difference between the net sale proceeds and its carrying amount, and is recognised in profit or loss on disposal.

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Group and the cost of the item can be measured reliably. All other costs, such as repairs and maintenance are charged to profit or loss during the financial period in which they are incurred.

3.8 Investment properties

Investment property is property held either to earn rentals or for capital appreciation or for both, but not held for sale in the ordinary course of business, use in the production or supply of goods or services or for administrative purposes.

倘資產賬面值高於其估計可收回金額，則該資產即時撇減至其可收回金額(見附註3.9)。

據融資租賃持有的資產按與自有資產相同的基準於其預期可使用年期(或如較短，有關租賃之年期)內折舊。

因出售物業、廠房及設備項目產生之盈虧為銷售所得款項淨額與其賬面值之差額，於出售時在損益賬中確認。

只有當與資產相關之日後經濟利益有可能流向本集團且該資產之成本能可靠計量時，該資產之其後成本方可列入資產之賬面值中或確認為獨立資產(倘適用)。所有其他成本(例如維修及保養費用)於產生財政期間計入損益賬。

3.8 投資物業

投資物業是為了賺取租金或實現資本增值或為兩者兼得而持有之物業，但並非為於一般業務過程中出售、用於生產或供應貨品或服務或為行政用途而持有之物業。

On initial recognition, investment property is measured at cost, including any directly attributable expenditure. Subsequent to initial recognition, investment property is stated at fair value. Fair value is determined by external professional valuers, with sufficient experience with respect to both the location and the nature of the investment property. The carrying amounts recognised at the end of the reporting period reflect the prevailing market conditions at the end of the reporting period.

Gains or losses arising from either changes in the fair value or the sale of an investment property are included in profit or loss in the period in which they arise.

For a transfer from investment properties to owner-occupied properties or inventories, the deemed cost of property for subsequent accounting is its fair value at the date of change in use.

3.9 Impairment of non-financial assets

Prepaid land lease payments, property, plant and equipment, right-of-use assets and the Company's interests in subsidiaries are tested for impairment whenever there are indications that the asset's carrying amount may not be recoverable.

An impairment loss is recognised as an expense immediately for the amount by which the asset's carrying amount exceeds its recoverable amount. The recoverable amount is the higher of fair value, reflecting market conditions less costs to sell, and value-in-use. In assessing value-in-use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessment of time value of money and the risk specific to the asset.

因公平值變動或出售投資物業而產生之盈虧於其產生期間計入損益賬中。

由投資物業轉往自置物業或存貨，作為物業日後會計之被認定成本為在改變用途日期之公平值。

當有跡象顯示資產之賬面值不可收回時，預付土地租賃款項、物業、廠房及設備、使用權資產及本公司於附屬公司之權益須進行減值測試。

減值虧損按資產之賬面值超出其可收回金額之部份即時確認為開支。可收回金額為反映市況之公平值減銷售成本及使用價值兩者中較高者。在評估使用價值時，會使用除稅前貼現率將估計未來現金流量貼現至其現值。該貼現率為反映現行市場所評估之貨幣之時值及該資產之特定風險。

For the purposes of assessing impairment, where an asset does not generate cash inflows largely independent from those from other assets, the recoverable amount is determined for the smallest group of assets that generate cash inflows independently (i.e. a cash-generating unit). As a result, some assets are tested individually for impairment and some are tested at cash-generating unit level.

An impairment loss is reversed if there has been a favourable change in the estimates used to determine the asset's recoverable amount and only to the extent that the asset's carrying amount does not exceed the carrying amount that would have been determined, net of depreciation or amortisation, if no impairment loss had been recognised.

3.10 Leases

(a) Accounting as a lessee

All leases (irrespective of they are operating leases or finance leases) are required to be capitalised in the statement of financial position as right-of-use assets and lease liabilities, but accounting policy choices exist for an entity to choose not to capitalise (i) leases which are short-term leases and/or (ii) leases for which the underlying asset is of low-value. The Group has elected not to recognise right-of-use assets and lease liabilities for low-value assets and leases for which at the commencement date have a lease term less than 12 months. The lease payments associated with those leases have been expensed on straight-line basis over the lease term.

Initial direct costs incurred in negotiating and arranging an operating lease are added to the carrying amount of the leased asset and recognised as an expense on the straight-line basis over the lease term.

All regular way purchases and sales of financial assets are recognised on the trade date, that is, the date that the Group commits to purchase or sell the asset. Regular way purchases or sales are purchases or sales of financial assets that require delivery of assets within the period generally established by regulation or convention in the market place.

Financial assets with embedded derivatives are considered in their entirety when determining whether their cash flows are solely payment of principal and interest.

Subsequent measurement of debt instruments depends on the Group's business model for managing the asset and the cash flow characteristics of the asset. There are three measurement categories into which the Group classifies its debt instruments:

Amortised cost: Assets that are held for collection of contractual cash flows where those cash flows represent solely payments of principal and interest are measured at amortised cost. Financial assets at amortised cost are subsequently measured using the effective interest method. Interest income, foreign exchange gains and losses and impairment are recognised in profit or loss. Any gain on derecognition is recognised in profit or loss.

Fair value through other comprehensive income ("FVOCI"): Assets that are held for collection of contractual cash flows and for selling the financial assets, where the assets' cash flows represent solely payments of principal and interest, are measured at FVOCI. Debt investments at FVOCI are subsequently measured at fair value. Interest income calculated using the effective interest method, foreign exchange gains and losses and impairment are recognised in profit or loss. Other net gains and losses are recognised in other comprehensive income. On derecognition, gains and losses accumulated in other comprehensive income are reclassified to profit or loss.

Fair value through profit or loss (“FVTPL”): Financial assets at FVTPL include financial assets held for trading, financial assets designated upon initial recognition at FVTPL, or financial assets mandatorily required to be measured at fair value. Financial assets are classified as held for trading if they are acquired for the purpose of selling or repurchasing in the near term. Derivatives, including separated embedded derivatives, are also classified as held for trading unless they are designated as effective hedging instruments. Financial assets with cash flows that are not solely payments of principal and interest are classified and measured at FVTPL, irrespective of the business model. Notwithstanding the criteria for debt instruments to be classified at amortised cost or at FVOCI, as described above, debt instruments may be designated at FVTPL on initial recognition if doing so eliminates, or significantly reduces, an accounting mismatch.

On initial recognition of an equity investment that is not held for trading, the Group could irrevocably elect to present subsequent changes in the investment's fair value in other comprehensive income. This election is made on an investment-by-investment basis. Equity investments at FVOCI are measured at fair value. Dividend income are recognised in profit or loss unless the dividend income clearly represents a recovery of part of the cost of the investments. Other net gains and losses are recognised in other comprehensive income and are not reclassified to profit or loss. All other equity instruments are classified as financial assets at FVTPL, whereby changes in fair value, dividends and interest income are recognised in profit or loss.

(b) Impairment loss on financial assets

The Group recognises loss allowances for expected credit losses ("ECLs") on trade receivables, contract assets, financial assets measured at amortised cost and debt investments measured at FVOCI. The ECLs are measured on either of the following bases: (i) 12 months ECLs: these are the ECLs that result from possible default events within the 12 months after the end of the reporting period; and (ii) lifetime ECLs: these are ECLs that result from all possible default events over the expected life of a financial instrument. The maximum period considered when estimating ECLs is the maximum contractual period over which the Group is exposed to credit risk.

ECLs are a probability-weighted estimate of credit losses. Credit losses are measured as the difference between all contractual cash flows that are due to the Group in accordance with the contract and all the cash flows that the Group expects to receive. The shortfall is then discounted at an approximation to the assets' original effective interest rate.

The Group has elected to measure loss allowances for trade receivables and contract assets using simplified approach under HKFRS 9 Financial Instruments ("HKFRS 9") and has calculated ECLs based on lifetime ECLs. The Group has established a provision matrix that is based on the Group's historical credit loss experience, adjusted for forward-looking factors specific to the debtors and the economic environment.

For other debt financial assets, the ECLs are based on the 12-months ECLs. However, when there has been a significant increase in credit risk since origination, the allowance will be based on the lifetime ECLs.

When determining whether the credit risk of a financial asset has increased significantly since initial recognition and when estimating ECLs, the Group considers reasonable and supportable information that is relevant and available without undue cost or effort. This includes both quantitative and qualitative information analysis, based on the Group's historical experience and informed credit assessment and including forward-looking information.

預期信貸虧損乃信貸虧損的概率加權估計。信貸虧損按本集團根據合約應付本集團的所有合約現金流量與本集團預期收取之所有現金流量之間的差額計量。該差額其後按接近資產原有的實際利率貼現。

本集團已選用香港財務報告準則第9號財務工具(「香港財務報告準則第9號」)項下簡化法對貿易應收款項及合約資產的虧損撥備進行計量，並已根據全期預期信貸虧損計算預期信貸虧損。本集團已設立根據本集團過往信貸虧損經驗計算的撥備矩陣，並按債務人特定的前瞻性因素及經濟環境作出調整。

就其他債務財務資產而言，預期信貸虧損以12個月預期信貸虧損為基礎。然而，倘信貸風險自產生以來大幅增加，則撥備會以全期預期信貸虧損為基礎。

倘釐定財務資產之信貸風險是否自初始確認後大幅增加及於估計預期信貸虧損時，本集團會考慮在毋須付出不必要成本或努力情況下即可獲得的相關的合理可靠資料。該等資料包括定量和定性資料及分析，並根據本集團過往經驗及已知信貸評估以及包括前瞻性資料。

The Group assumes that the credit risk on a financial asset has increased significantly if it is more than 30 days past due.

The Group considers a financial asset to be credit-impaired when: (i) the borrower is unlikely to pay its credit obligations to the Group in full, without recourse by the Group to actions such as realising security (if any is held); or (ii) the financial asset is more than 90 days past due.

Interest income on credit-impaired financial assets is calculated based on the amortised cost (i.e. the gross carrying amount less loss allowance) of the financial asset. For non credit-impaired financial assets interest income is calculated based on the gross carrying amount.

(c) Financial liabilities

The Group classifies its financial liabilities, depending on the purpose for which the liabilities were incurred. Financial liabilities at FVTPL are initially measured at fair value and financial liabilities at amortised cost are initially measured at fair value, net of directly attributable costs incurred.

Financial liabilities at amortised cost

Financial liabilities at amortised cost including trade payables, other payables and accruals, amount due to non-controlling interests, lease liabilities and bank borrowings are subsequently measured at amortised cost, using the effective interest method. The related interest expense is recognised in profit or loss.

Gains or losses are recognised in profit or loss when the liabilities are derecognised as well as through the amortisation process.

(c) 財務負債

本集團視乎負債產生的目的將其財務負債分類。按公平值計入損益的財務負債初步按公平值計量，按攤銷成本計量的財務負債初步按公平值減所產生的直接應佔成本計量。

Effective interest method

The effective interest method is a method of calculating the amortised cost of a financial asset or financial liability and of allocating interest income or interest expense over the relevant period. The effective interest rate is the rate that exactly discounts estimated future cash receipts or payments through the expected life of the financial asset or liability, or where appropriate, a shorter period.

Equity instruments

Equity instruments issued by the Company are recorded at the proceeds received, net of direct issue costs.

Financial guarantee contracts

A financial guarantee contract is a contract that requires the issuer to make specified payments to reimburse the holder for a loss it incurs because a specified debtor fails to make payment when due in accordance with the original or modified terms of a debt instrument. A financial guarantee contract issued by the Group and not designated as at FVTPL is recognised initially at its fair value less transaction costs that are directly attributable to the issue of the financial guarantee contract. Subsequent to initial recognition, the Group measures the financial guarantee contract at the higher of: (i) the amount of the loss allowance, being the ECLs provision measured in accordance with principles of the accounting policy set out in note 3.11(b); and (ii) the amount initially recognised less, when appropriate, cumulative amortisation recognised in accordance with the principles of HKFRS 15.

股本工具

本公司發行之股本工具按已收取之所得款項減直接發行成本入賬。

財務擔保合約

Derecognition

The Group derecognises a financial asset when the contractual rights to the future cash flows in relation to the financial asset expire or when the financial asset has been transferred and the transfer meets the criteria for derecognition in accordance with HKFRS 9.

Financial liabilities are derecognised when the obligation specified in the relevant contract is discharged, cancelled or expires.

Where the Group issues its own equity instruments to a creditor to settle a financial liability in whole or in part as a result of renegotiating the terms of that liability, the equity instruments issued are the consideration paid and are recognised initially and measured at their fair value on the date the financial liability or part thereof is extinguished. If the fair value of the equity instruments issued cannot be reliably measured, the equity instruments are measured to reflect the fair value of the financial liability extinguished. The difference between the carrying amount of the financial liability or part thereof extinguished and the consideration paid is recognised in profit or loss for the year.

3.12 Inventories

Inventories comprise finished goods and consumable stocks and are carried at the lower of cost and net realisable value after making due allowance for obsolescence on slow moving items. Cost, calculated on the first-in, first-out basis, comprises invoiced value of goods and other costs incurred in bringing the inventories to their present locations and conditions. Net realisable value represents the estimated selling prices in the ordinary course of business less the estimated costs of completion and the estimated costs necessary to make the sale.

3.13 Accounting for income taxes

Income tax for the year comprises current tax and deferred tax.

Current income tax assets and/or liabilities comprise those obligations to, or claims from, tax authorities relating to the current or prior reporting period, that are unpaid at the end of the reporting period. They are calculated according to the tax rates and tax laws applicable to the fiscal periods to which they relate, based on the taxable profit for the year. All changes to current tax assets or liabilities are recognised as a component of income tax expense in profit or loss.

Deferred taxes are calculated using the liability method on temporary differences. This involves the comparison of the carrying amounts of assets and liabilities in the consolidated financial statements with their respective tax bases at the end of the reporting period. Deferred tax liabilities are generally recognised for all taxable temporary differences. Deferred tax assets are recognised for all deductible temporary differences, tax losses available to be carried forward as well as other unused tax credits, to the extent that it is probable that taxable profit, including existing taxable temporary differences, will be available against which the deductible temporary differences, unused tax losses and unused tax credits can be utilised.

Deferred tax assets and liabilities are not recognised if the temporary difference arises from goodwill or from initial recognition (other than in a business combination) of assets and liabilities in a transaction that affects neither taxable nor accounting profit or loss.

Deferred tax liabilities are recognised for taxable temporary differences arising on investments in subsidiaries, except where the Group is able to control the reversal of the temporary differences and it is probable that the temporary differences will not reverse in the foreseeable future.

Deferred tax is calculated, without discounting, at tax rates that are expected to apply in the period the liability is settled or the asset realised, provided they are enacted or substantively enacted at the end of reporting period.

An exception to the general requirement on determining the appropriate tax rate used in measuring deferred tax amount is when an investment property is carried at fair value under HKAS 40 *Investment Property*. Unless the presumption is rebutted, the deferred tax amounts on these investment properties are measured using the tax rates that would apply on sale of these investment properties at their carrying amounts at the end of the reporting period. The presumption is rebutted when the investment property is depreciable and is held within a business model whose objective is to consume substantially all the economic benefits embodied in the property over time, rather than through sale.

Changes in deferred tax assets or liabilities are recognised in profit or loss, or in other comprehensive income or directly in equity if they relate to items that are charged or credited to other comprehensive income or directly to equity.

Current tax assets and current tax liabilities are presented in net if, and only if, the Group:

- (a) has the legally enforceable right to set off the recognised amounts; and
- (b) intends either to settle on a net basis, or to realise the asset and settle the liability simultaneously.

The Group presents deferred tax assets and deferred tax liabilities in net if, and only if:

3.14 Cash and cash equivalents

Cash and cash equivalents comprise cash at banks and in hand as well as short-term bank deposits with original maturities of three months or less which are subject to insignificant risk of changes in value.

3.15 Share premium

Share premium includes any premiums received on the issuance of shares over the par value. Any transaction costs associated with the issuance of shares are deducted from share premium (net of any related income tax benefit) to the extent they are incremental costs directly attributable to the equity transaction.

3.16 Retirement benefit costs and short-term employee benefits

(a) Short-term employee benefits

Short-term employee benefits are employee benefits (other than termination benefits) that are expected to be settled wholly before twelve months after the end of the annual reporting period in which the employees render the related service. Short-term employee benefits are recognised in the year when the employees render the related service.

Non-accumulating compensated absences such as sick leave and maternity leave are not recognised until the time of leave.

(b) Defined contribution retirement plan

Contributions to defined contribution retirement plans are recognised as an expense in profit or loss when the services are rendered by the employees.

3.17 Share-based employee compensation

The Group operates equity-settled share-based compensation plans to remunerate its employees and directors.

All employee services received in exchange for the grant of any share-based compensation are measured at their fair values. These are indirectly determined by reference to the share options awarded. Their value is appraised at the grant date and excludes the impact of any non-market vesting conditions.

(b) 界定供款退休計劃

Share-based compensation is recognised as an expense in full at the grant date when the share options granted vest immediately, with a corresponding increase in share options reserve. If vesting periods or other vesting conditions apply, the expense is recognised over the vesting period, based on the best available estimate of the number of share options expected to vest. Non-market vesting conditions are taken into account by adjusting the number of equity instruments expected to vest at the end of each of the reporting period so that, ultimately, the cumulative amount recognised over the vesting period is based on the number of options that eventually vest. Market vesting conditions are factored into the fair value of the options granted. As long as all other vesting conditions are satisfied, a charge is made irrespective of whether the market vesting conditions are satisfied. The cumulative expense is not adjusted for failure to achieve a market vesting condition.

At the time when the share options are exercised, the amount previously recognised in share option reserve will be transferred to share premium. When the share options are later forfeited or are still not exercised at the expiry date, the amount previously recognised in share option reserve will be transferred to retained profits/accumulated losses.

3.18 Provisions and contingent liabilities

Provisions are recognised for liabilities of uncertain timing or amount when the Group has a legal or constructive obligation arising as a result of a past event, which it is probable will result in an outflow of economic benefits that can be reliably estimated. Where the time value of money is material, provisions are stated at the present value of the expenditure expected to settle the obligation. All provisions are reviewed at the end of each of the reporting period and adjusted to reflect the current best estimate.

Where it is not probable that an outflow of economic benefits will be required, or the amount cannot be estimated reliably, the obligation is disclosed as a contingent liability, unless the probability of outflow of economic benefits is remote. Possible obligations, whose existence of which will only be confirmed by the occurrence or non-occurrence of one or more future events, are also disclosed as contingent liabilities unless the probability of outflow of economic benefits is remote.

Onerous contracts

An onerous contract exists when the Group has a contract under which the unavoidable costs of meeting the obligations under the contract exceed the economic benefits expected to be received from the contract. Provisions for onerous contracts are measured at the present value of the lower of the expected cost of terminating the contract and the net cost of continuing with the contract.

3.19 Segment reporting

The Group identifies operating segments and prepares segment information based on the regular internal financial information reported to the chief operating decision maker i.e. the executive directors for their decisions about resources allocation to the Group's business components and for their review of the performance of those components.

Individually material operating segments are not aggregated for financial reporting purposes unless the segments have similar economic characteristics and are similar in respect of the nature of products and services, the nature of production processes, the type or class of customers, the methods used to distribute the products or provide the services, and the nature of the regulatory environment. Operating segments which are not individually material may be aggregated if they share a majority of these criteria.

3.20 Government grant

Government grants are not recognized until there is reasonable assurance that the Group will comply with the conditions attaching to them and that the grants will be received. Grants that compensate the Group for expenses incurred are recognized as income or deducted in the related expenses, as appropriate, in profit or loss on a systematic basis in the same periods in which the expenses are incurred.

Grants that compensate the Group for the cost of an asset are recognized as deferred income in the consolidated statement of financial position and transferred to profit or loss on a systematic and rational basis over the useful lives of the related assets.

Government grants that are receivable as compensation for expenses or losses already incurred or for the purpose of giving immediate financial support to the Group with no future related costs are recognized in profit or loss in the period in which they become receivable and are recognized as other income, rather than reducing the related expense.

3.21 Related parties

- (a) A person or a close member of that person's family is related to the Group if that person:
- (i) has control or joint control over the Group;
 - (ii) has significant influence over the Group; or
 - (iii) is a member of key management personnel of the Group or the Company's parent.

In the application of the Group's accounting policies, the directors are required to make judgements, estimates and assumptions about the carrying amounts of assets and liabilities that are not readily apparent from other sources. The estimates and associated assumptions are based on historical experience and other factors that are considered to be relevant. Actual results differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period or in the period of the revision and future periods if the revision affects both current and future periods.

Critical judgment in applying accounting policies

The following is the critical judgment, apart from those involving estimations (see below), that the directors of the Company have made in the process of applying the Group's accounting policies and that have the most significant effect on the amounts recognised in the consolidated financial statements.

Going concern basis

These consolidated financial statements have been prepared on a going concern basis, the validity of which depends upon the financing plan assessed as detailed in note 3.1 to these consolidated financial statements. However, because not all future events or conditions can be predicted, this assumption is not a guarantee as to the Group's and Company's ability to continue as a going concern.

Key sources of estimation uncertainty

The estimates and assumptions that have a significant risk of resulting a material adjustment to the carrying amounts of assets and liabilities within the next financial reporting period are as below:

(a) Provision for expected credit losses of trade receivables

The Group uses a provision matrix to calculate ECLs for trade receivables. The provision rates are based on days past due for grouping of various customers that have similar loss patterns. The provision matrix is initially based on the Group's historical observed default rates taking into consideration forward-looking information that is reasonable and supportable available without undue costs or effort. At the end of each of the reporting period, the historical observed default rates are reassessed and changes in forward-looking information are considered. For the assessment on the ECLs on the trade receivables, refer to note 36.5 for details.

(b) Estimated fair value of investment properties

As disclosed in note 15, the Group's investment properties were revalued at the end of the reporting period by independent professional valuers. Such valuations were based on certain assumptions which are subject to uncertainty and might materially differ from the actual results. In making the judgment, the Group considers latest completed transactions and information from current prices in an active market for similar properties and uses assumptions that are mainly based on market conditions existing at the end of each of the reporting period.

For more detailed information in relation to fair value measurement of investment properties, refer to note 15.

(c) Estimated impairment of property, plant and equipment

The Group assesses whether there are any indicators of impairment for property, plant and equipment. If such an indication exists, the recoverable amount of property, plant and equipment is estimated using the higher of its fair value less costs of disposals and its value-in-use. If the carrying amount of property, plant and equipment exceeds its recoverable amount, an impairment loss is recognised to reduce the asset to its recoverable amount. Such impairment losses are recognised in profit or loss. The determination of recoverable amount based on value-in-use calculation incorporates a number of key estimates and assumptions about future events and therefore, are subject to uncertainty and might materially differ from the actual results. In making these key estimates and judgments, the directors take into consideration assumptions that are mainly based on market conditions existing at the end of the reporting period and appropriate market and discount rates. These estimates are regularly compared to actual market data and actual transactions entered into by the Group. Future changes in the events and conditions underlying the estimates and judgements would affect the estimation of recoverable amounts and result in adjustments to their carrying amounts.

Under the Mandatory Provident Fund Schemes Ordinance regulated by the Mandatory Provident Fund Schemes Authority in Hong Kong, with effect from 1 December 2000, the Group participates in a Mandatory Provident Fund retirement benefits scheme (the “MPF scheme”) operated by an approved trustee in Hong Kong and makes contributions for its eligible employees. Under the MPF scheme, the employer and its employees are each required to make contributions to the scheme at 5% of the employees’ relevant income, subject to a cap of monthly relevant income. The cap of monthly relevant income is increased from HK\$25,000 to HK\$30,000 from 1 June 2014. Contributions to the scheme vest immediately.

Total contributions paid by the Group into the MPF Scheme and recognised as an expense during the year, including contributions for the directors, amounted to HK\$576,000 (2019: HK\$522,000). No forfeited contribution is available for reducing the Group’s existing level of contributions (2019: nil).

A share option scheme (the “Existing Share Option Scheme”) was adopted by the Company pursuant to a resolution passed at the annual general meeting held on 22 May 2009 and 30 May 2019 for the primary purpose of providing incentives or rewards to the participants who have contributed to the Group and encouraging participants to work towards enhancing the value of the Company and its shares for the benefit of the Company and its shareholders as a whole. Sensitivity analysis

The sensitivity analysis of the Group's exposure to foreign currency risk at the end of the reporting period has been determined based on the assumed percentage changes in foreign currency exchange rates taking place at the beginning of the financial year and held constant throughout the year.

36.3 Interest rate risk

Interest rate risk relates to the risk that the fair value or cash flows of a financial instrument will fluctuate because of changes in market interest rates. The Group's exposure to market risk for changes in interest rates relates primarily to the Group's bank borrowings arranged in floating interest rates. The Group currently does not have any interest rate hedging policy. However, the directors monitor interest rate change exposure and will consider hedging significant interest rate change exposure should the need arise.

36.4 Equity price risk

Equity price risk relates to the risk that the fair values of equity securities decrease as a result of changes in the level of equity indices and the value of individual securities. The Group is exposed to change in market prices of listed equity securities in respect of its investments in listed equity securities classified as financial assets at FVOCI (note 16) and financial assets at FVTPL (note 18).

The directors manage this exposure by maintaining a portfolio of investments with different risk and return profiles and will consider hedging the risk exposure should the need arise. The Group is not exposed to commodity price risk.

At 31 December 2020, if the quoted market price for the financial assets at FVOCI had been 10% (2019: 10%) higher/lower while all other variables were held constant, the Group's equity will increase/decrease by approximately HK\$445,000 (2019: HK\$930,000).

Whereas, if the quoted market price for listed equity securities classified as financial assets at FVTPL had been 10% (2019: 10%) higher with all other variables remain unchanged, the Group's loss for the year and accumulated losses would decrease by HK\$6,995,000 (2019: HK\$8,884,000). A 10% (2019: 10%) lower in the quoted market price for listed equity securities classified as financial assets at FVTPL, with all other variables held constant, would have the same magnitude on the Group's result for the year and equity but of opposite effect.

36.5 Credit risk

Credit risk refers to the risk that the counterparty to a financial instrument would fail to discharge its obligation under the terms of the financial instrument and cause a financial loss to the Group. The Group minimises its exposure to the credit risk by rigorously selecting the counterparties, performing ongoing credit evaluation on the financial conditions of its debtors and tightly monitoring the ageing of the receivables. Follow-up actions are taken in case of overdue balances. In particular for granting loans to customers, the directors will initially assess the background and financial position of each of the new and existing customers and will request for collateral when necessary in order to minimise credit risk. The directors will also review regularly the repayment pattern of the customers. Monitoring on credit risk of loans receivable is performed by the directors on on-going basis.

The Group measures loss allowances for trade receivables at an amount equal to lifetime ECLs, which is calculated using a simplified approach. The Group's exposure to credit risk is influenced mainly by the individual characteristics of each debtor. The default risk of the industry and country in which debtors operate also has an influence on credit risk but to a lesser extent.

The Group's exposure to credit risk is primarily attributable to its trade and other receivables, deposits and amount due from non-controlling interest, also including pledged bank deposits and bank balances. The maximum exposure to credit risk in respect of the financial instruments are their carrying values.

36.5 信貸風險

信貸風險指金融工具之交易方未能履行其於金融工具條款項下之責任，致使本集團蒙受財務虧損之風險。本集團透過審慎挑選交易方、就其債務人之財務狀況進行持續信貸評估，以及密切監控應收賬款之賬齡，以降低其所承受之信貸風險。本集團已採取跟進措施收回逾期結餘。尤其就授出貸款予客戶而言，董事將初步評估各名新客戶及現有客戶之背景及財務狀況，以及在有需要情況下要求抵押品，務求將信貸風險減至最低。董事亦將定期檢視客戶之還款模式。對應收貸款之風險，由董事按持續基準監察。

本集團按相等於全期預期信貸虧損(採用簡化方法計算)之金額就營業應收賬款計量虧損撥備。本集團面臨之信貸風險主要受各債務人個別特徵的影響。債務人所在行業及國家之違約風險亦較少程度上影響信貸風險。

The Group assumes that the credit risk on a financial asset has increased significantly if it is more than 30 days past due unless the Group has reasonable and supportable information that demonstrates otherwise. The Group considers a financial asset to be in default when: (i) the debtor is unlikely to pay its credit obligations to the Group in full, without recourse by the Group to actions such as realising security (if any is held); or (ii) the financial asset is more than 90 days past due, unless the Group has reasonable and supportable information to demonstrate that a more lagging default criteria is more appropriate.

The Group measures loss allowance for trade receivables at an amount equal to lifetime ECLs, which is calculated using a provision matrix by reference to past default experience of the debtor and current market condition in relation to each debtor's exposure and time value of money where appropriate. The ECLs also incorporate forward looking information with reference to general macroeconomic conditions that may affect the liability of the debtors to settle the trade receivables. Trade receivables have been grouped based on shared credit risk characteristics and the days past due.

The Group has assessed that the expected loss rate was not significant as at 31 December 2020 and 2019. Accordingly, no loss allowance for trade receivables was recognised.

Trade receivables that were past due but not impaired relate to customers that have a good payment record with the Group. Based on past experience, the management believes that no impairment allowance is necessary in respect of these balances as there has not been a significant change in credit quality and the balances are still considered fully recoverable.

除非本集團有合理及可提供充分證據的資料另作說明，本集團假設財務資產倘逾期超過30天則信貸風險會大幅增加。本集團認為財務資產於下列情況下為違約：(i)在本集團並無進行追索(例如變現抵押(如持有))的情況下債務人不大可能向本集團悉數支付其信貸責任；或(ii)該財務資產逾期超過90天，除非本集團有合理及可提供充分證據的資料顯示較後的違約標準更為適合。

本集團按相等於全期預期信貸虧損之金額就營業應收賬款計量虧損撥備，該金額乃採用撥備矩陣，參照債務人過往違約紀錄及與各債務人風險敞口有關的現行市況以及金錢時間值(如適用)計量。預期信貸虧損亦經考慮可能影響債務人結算營業應收賬款能力的一般宏觀經濟狀況後載入前瞻性資料。營業應收賬款已根據攤估信貸風險特點及逾期天數分類。

本集團已評估預期虧損率於二零二零年及二零一九年十二月三十一日並不重大。因此，並無就營業應收賬款確認虧損撥備。

In respect of other receivables, deposits and amount due from non-controlling interest, the Group considers the background and regularly monitors the financial condition of the counterparties to assess the recoverability of the outstanding balances. The management does not expect any loss allowance from non-performance by the counterparties and assessed that the ECLs in respect of these balances were immaterial at the end of the reporting period.

The credit risk on pledged bank deposits and cash and bank balances is limited because majority of the bank balances are deposited in reputable banks, for which the Group consider to have low credit risk. There was no history of default in relation to these financial institutions.

The credit policy has been followed by the Group since prior years and is considered to have been effective in limiting the Group's exposure to credit risk to a desirable level.

36.6 Liquidity risk

Liquidity risk relates to the risk that the Group will not be able to meet its obligations associated with its financial liabilities. In the management of liquidity risk, the directors monitor and maintain a level of cash and cash equivalents deemed adequate to finance the Group's operations, investment opportunities and expected expansion. The Group finances its working capital requirements mainly by the funds generated from operations and investing activities.

The amounts include interest payments computed using contractual rates. As a result, these amounts were greater than the amounts disclosed in the “on demand” time band in the maturity analysis above. Taking into account the Group’s financial position, the directors do not consider that it is probable that the banks will exercise its discretion to demand immediate repayment. The directors believe that such bank loans will be repaid in accordance with the scheduled repayment dates set out in the loan agreements.

37. CAPITAL MANAGEMENT

The Group's objectives when managing capital are:

- (a) to safeguard the Group's ability to continue as a going concern, so that it continues to provide returns and benefits for shareholders and other stakeholders;
- (b) to support the Group's stability and growth; and
- (c) to provide capital for the purpose of strengthening the Group's risk management capability.

The Group actively and regularly reviews and manages its capital structure to maintain a balance between the higher shareholder returns that might be possible with higher levels of borrowings and the advantages and security afforded by a sound capital position, and makes adjustments to the capital structure in light of changes in economic conditions.

Management regards total equity as capital for capital management purpose. The amount of capital as at 31 December 2020 amounted to approximately HK\$322,012,000 (2019: HK\$349,370,000), which the management considers as satisfactory having considered the projected capital expenditures and the forecast strategic investment opportunities.

38. IMPACTS OF COVID-19

The outbreak of COVID-19 in January 2020 has created certain impact on the business of the Group.

The Group estimated that the degree of COVID-19 impact would depend on the pandemic preventive measures and the duration of the pandemic. Given the dynamic circumstance and uncertainties of COVID-19 situation, the Group will keep continuous attention on the development of COVID-19 situation and react actively to its impacts on the operation and financial position of the Group, and in the event that there are any significant financial impacts, the Company will reflect it in the Group's 2021 financial statements.

37. 資本管理

本集團管理資本之目標為：

- (a) 保障本集團持續經營之能力，使其繼續為股東及其他持份者提供回報及利益；
- (b) 支持本集團之穩定及增長；及
- (c) 為加強本集團之風險管理能力提供資金。

本集團積極及定期對資本架構進行檢討及管理，以在較高水平借貸可能產生較高股東回報與良好資本狀況帶來的優勢及保障之間維持平衡，並針對經濟狀況變動對資本架構作出調整。

管理層視權益總額為資本管理之資本。於二零二零年十二月三十一日，資本金額約為港幣322,012,000元（二零一九年：港幣349,370,000元），其中管理層已考慮到預期之資本開支及預期策略性投資機會，並認為處於令人滿意之狀況。

38. COVID-19之影響

COVID-19疫情於二零二零年一月爆發對本集團業務帶來一定影響。
