ANNOUNCEMENT OF OFFER PRICE AND ALLOTMENT RESULTS

SUMMARY

Offer Price and Net Proceeds from the Global Offering

- The Offer Price has been determined at HK\$2.99 per Offer Share (exclusive of brokerage fee of 1%, SFC transaction levy of 0.0027% and Hong Kong Stock Exchange trading fee of 0.005%). Based on the Offer Price of HK\$2.99 per Offer Share, the net proceeds from the Global Offering to be received by the Company, after deduction of the underwriting fees and commissions and estimated expenses payable by the Company in connection with the Global Offering, are estimated to be approximately HK\$252.3 million, assuming the Over-allotment Option is not exercised. The Company intends to apply such net proceeds in accordance with the purposes as set out in the section headed “Future Plans and Use of Proceeds” in the Prospectus and as follows:

In order to further highlight and enhance core competitiveness, to improve profitability and subsequent development capacity, and to achieve the Company’s strategic goals, the Company currently intends to apply the net proceeds toward the development of its pipeline projects and provide further liquidity for itself, details of which are as follows (assuming the Over-allotment Option is not exercised):

- approximately HK\$214.4 million, or 85% of the total estimated net proceeds, is expected to be used for expanding the Company’s market share in the PRC water industry and diversifying its project portfolio and creating synergies;
- approximately HK\$25.2 million, or 10% of the total estimated net proceeds, is expected to be used for enhancing the Company’s core technologies through innovative research and development initiatives and acquisitions of advanced technologies; and
- approximately HK\$12.7 million, or 5% of the total estimated net proceeds, is expected to be used for working capital and other general corporate purposes.

Applications and Indication of Interest Received

- The Hong Kong Public Offer Shares initially offered under the Hong Kong Public Offering have been moderately oversubscribed. The final number of Offer Shares allocated to the Hong Kong Public Offering is 10,398,000 Offer Shares, representing approximately 10% of the total number of Offer Shares initially available under the Global Offering. A total of 4,999 valid applications have been received pursuant to the Hong Kong Public Offering on **WHITE** and **YELLOW** Application Forms and through giving **electronic application instructions** to HKSCC via CCASS for a total of 25,315,000 Hong Kong Public Offer Shares, representing approximately 2.43 times of the total number of 10,398,000 Hong Kong Public Offer Shares initially available for subscription under the Hong Kong Public Offering.
- As the over-subscription in the Hong Kong Public Offering is less than 15 times, no reallocation procedure as disclosed in the section headed “Structure of the Global Offering — The Hong Kong Public Offering” in the Prospectus has been applied and no International Offer Shares have been reallocated from the International Offering to the Hong Kong Public Offering.
