INSIDE INFORMATION ANNOUNCEMENT — COMPLETION OF ISSUANCE OF THIRD TRANCHE SUPER & SHORT-TERM COMMERCIAL PAPERS IN MAINLAND CHINA

This announcement is made by China Everbright Water Limited (the “**Company**”) pursuant to the Inside Information Provisions under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong), Rule 13.09(2) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited and Chapter 7 of the Listing Manual of the Singapore Exchange Securities Trading Limited.

The board of directors of the Company (the “**Board**”) refers to the announcements released by the Company on 23 December 2020, 12 March 2021, 6 August 2021, 10 August 2021, 1 December 2021, 11 January 2022, 13 January 2022, 6 June 2022 and 15 September 2022 relating to (i) the proposed issuance of RMB-denominated Super & Short-term Commercial Papers (“**SCPs**”) with a registered principal amount of RMB2,500,000,000 to institutional investors (the “**Institutional Investors**”) in the national inter-bank bond market of mainland China; (ii) the issuance of the first tranche of SCPs with a principal amount of RMB800,000,000 to the Institutional Investors, of which the principal amount and accrued interest had been fully repaid; (iii) the issuance of the second tranche of SCPs with a principal amount of RMB1,000,000,000 to the Institutional Investors, of which the principal amount and accrued interest had been fully repaid; and (iv) the proposed issuance of the third tranche of SCPs.

The Board is pleased to announce that the Company has completed the issuance of the third tranche of SCPs with a principal amount of RMB1,000,000,000 and a maturity period of 180 days (the “**Third Tranche SCPs**”) to the Institutional Investors.
