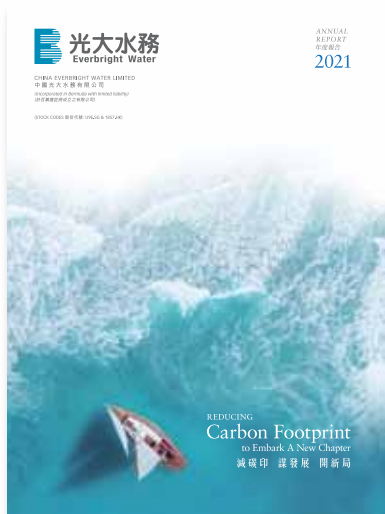

An Environmental Protection Company focusing on Water Environment Management

China Everbright Water Limited (“**Everbright Water**” or the “**Company**” together with its subsidiaries, the “**Group**”) is an environmental protection company focusing on water environment management. It is listed on the Mainboard of Singapore Exchange Securities Trading Limited (“**SGX**” or “**SGX-ST**”) and the Main Board of The Stock Exchange of Hong Kong Limited (the “**SEHK**”) (stock codes: U9E.SG & 1857.HK), with its direct controlling shareholder being China Everbright Environment Group Limited (stock code: 257.HK, “**Everbright Environment**”).

Everbright Water has developed a full-fledged business coverage, which includes raw water protection, water supply, municipal waste water treatment, industrial waste water treatment, reusable water, river-basin ecological restoration, and sludge treatment and disposal. Meanwhile, the Company has formed a full industry chain in the water business, including project investment, planning and design, technology research and development, engineering and construction, operations management, among others. Its geographical footprint spans across East, Central, South, North, Northeast and Northwest China, covering 12 provinces, municipalities and autonomous regions in China, namely Beijing, Tianjin, Hebei, Jiangsu, Zhejiang, Shandong, Shaanxi, Henan, Hubei, Guangxi, Liaoning and Inner Mongolia. The Company also has overseas business presence in Mauritius. As at 31 December 2021, the Company invested in and operated water treatment projects with a designed daily water treatment capacity of over 7 million m³.

With the leadership of its experienced management team, the Company will seize opportunities and strive to emerge as a leader in the water industry of China.

中國光大水務有限公司（「光大水務」或「本公司」，連同其附屬公司統稱「本集團」）是以水環境綜合治理業務為主業的環保集團，為新加坡證券交易所有限公司（「新交所」）及香港聯合交易所有限公司（「聯交所」）主板上市公司（股份代號：U9E.SG及1857.HK），直接控股股東為中國光大環境（集團）有限公司（股份代號：257.HK，「光大環境」）。

光大水務目前已實現原水保護、供水、市政污水處理、工業廢水處理、中水回用、流域治理及污泥處理處置等全業務範圍覆蓋，精專於項目投資、規劃設計、科技研發、工程建設、運營管理等業務領域，形成水務行業全產業鏈佈局。業務分佈於中國華東、華中、華南、華北、東北及西北地區，涵蓋北京、天津、河北、江蘇、浙江、山東、陝西、河南、湖北、廣西、遼寧、內蒙古共計12個省市自治區，海外業務佈局毛里求斯。於二零二一年十二月三十一日，本公司投資建設及運營管理的水處理項目設計規模逾700萬立方米/日。

在經驗豐富的管理團隊的帶領下，本公司將緊抓行業機遇，全力以赴，致力成為中國水務行業的翹楚。

Dear Shareholders,

The year 2021 marks an exceptional year for countries across the world. Amidst the ongoing novel coronavirus (“COVID-19”) pandemic, supply chain disruption and frequent extreme weather events, the global economy experienced a slow recovery and was full of uncertainties. Facing the unprecedented change in a century, the People’s Republic of China (the “PRC” or “China”) has once again delivered remarkable results in terms of the COVID-19 pandemic control and economic development. This marks a good start to the country’s “14th Five-Year Plan”.

In the opening year of the “14th Five-Year Plan”, China continued with the tough battle against pollution to serve the overall national economic development. Adhering to the commitments of “Peaking Carbon Dioxide Emissions” and “Achieving Carbon Neutrality” (“Dual Carbons”), China has also made “Carbon Emission Reduction” a key strategy in its ecological conservation progress, actively promoted “Reducing Pollution and Carbon Emission” and “Boosting Synergy and Efficiency”, and carried out comprehensive green transformation in economic and social development. This reflects China’s commitment as a big country in “putting words in action”. These initiatives opened up new ideas, new requirements and new challenges for the water environment management sector and the entire environmental protection industry.

二零二一年是世界各國發展無比尋常的一年。在新型冠狀病毒引發的疫情（「新冠疫情」）反覆、供應鏈失衡、極端氣候頻發等因素的衝擊下，全球經濟復甦步履蹣跚，不確定性突顯。面對百年未有之變局，中華人民共和國（「中國」）在新冠疫情防控、經濟發展等方面再次交出靚麗答卷，實現國家「十四五」規劃的良好開局。

在「十四五」規劃的開局之年，中國繼續深入開展污染防治攻堅戰，積極服務國家經濟發展大局。圍繞向國際社會做出的「碳達峰」、「碳中和」（「雙碳」）莊嚴承諾，中國亦將「碳減排」作為生態文明建設的重點戰略方向，積極推動「減污降碳」、「協同增效」相關部署，促進經濟社會發展全面綠色轉型——彰顯了「言行並重」的大國擔當。相關部署也給水環境綜合治理乃至整個環保行業開啟新思路、提出新要求、帶來新挑戰。

The year 2021 represents a fruitful year for Everbright Water. Facing the severe and complex external environment and the inherent needs of strategic transformation, Everbright Water remained committed to its original aspiration and strategic focus, and worked hard with strong cohesion. As such, the Group has achieved remarkable results in growing market presence, improving management efficiency, enhancing “Innovation-Driven” development, and solidifying its financial position. It ventured into the water markets of Tianjin Municipality, Hebei Province and Mauritius successively; gained recognitions from authoritative organisations for its technology research results, indicating a strong momentum in application and commercialisation of technologies; continuously improved management efficiency through measures such as optimising relevant systems and introducing innovative methods; and developed more flexible financial resources by solidifying its diverse financing channels that provide for long- and short-term financing tools. As at 31 December 2021, the Group had invested over RMB28 billion in projects and recorded total assets of approximately HK\$33 billion. The Group’s projects have an aggregate designed daily water treatment capacity of over 7 million m³, with water treatment service covering 12 provinces, municipalities and autonomous regions across China, in addition to 1 overseas market.

Thanks to its excellent operation, the Company was shortlisted as one of the “Top 10 Influential Enterprises in China’s Water Industry” for the fourth consecutive year and received the “ListCo Excellence Award” for the second consecutive year. The Company also, for the first time, won awards conferred by authoritative organisations in Hong Kong such as the Chamber of Hong Kong Listed Companies and Hong Kong Institute of Certified Public Accountants. Such awards included: the “Award of Excellence in Corporate Governance”, the “Award of Excellence in Environmental, Social and Governance” (category for newly-listed companies) and a Special Mention for Environmental, Social and Governance (“**ESG**”) in the Non-Hang Seng Index (small market capitalisation) category. In addition, the Group’s Jiangsu Zhenjiang Sponge City Construction Public-Private Partnership (“**PPP**”) Project was shortlisted as a Top 5 and an Honorary Mention in the “Building Back Better Infrastructure Award” of the United Nations Economic Commission for Europe (“**UNECE**”). A technological and application project, in which the Company’s subsidiary joined as a key participant, received the second prize of the 2020 State Scientific and Technological Progress Award. It was a challenging yet rewarding journey. On behalf of the board (the “**Board**”) of directors (the “**Directors**”) and the management team of the Company, I would like to extend my sincere gratitude to all staff who remained at their posts with hard work, as well as the people from all social circles who have given their long-term support to the Group’s development.

二零二一年是光大水務發展成果豐碩的一年。面對嚴峻複雜的外部環境與戰略轉型的內在需求，光大水務堅守初心、保持定力、上下一心、奮力拼搏，在拓展市場寬度、挖潛管理效能、強化創新引領、鞏固財務保障等方面收獲好成績；先後突破天津市、河北省、毛里求斯的水務市場；科技成果獲得多項權威認可，技術應用轉化勢頭強勁；通過加強制度優化、引入創新手段等方式，帶動管理效能持續提升；鞏固長短期兼備的多元化融資手段，打造更加靈活的資金保障。截至二零二一年十二月三十一日，本集團累計項目投資額超過280億元人民幣，總資產約330億港元；旗下項目設計日水處理規模超過700萬立方米，水處理服務遍及國內12個省市自治區以及1個海外市場。

憑藉出色的經營，本公司不僅連續第四年入選「中國水業十大影響力企業」榜單、連續第二年獲得「傑出上市公司大獎」，更首次獲得香港上市公司商會、香港會計師公會等香港權威機構授予的各類獎項，包括：新上市公司類別「公司管治卓越獎」、「環境、社會及管治卓越獎」以及非恒指成份股公司類別（小市值企業組別）「環境、社會及管治特別提名獎」；本集團旗下江蘇鎮江海綿城市建設政府和社會資本合作（「**PPP**」）項目入圍聯合國歐洲經濟委員會（「**聯合國歐經會**」）「更好重建」基礎設施獎項評選五強並獲得榮譽提名獎；本公司附屬公司作為主要單位之一參與的技術及應用項目獲得二零二零年度「國家科學技術進步獎」二等獎。征途充滿汗水，成績來之不易。我謹代表本公司董事（「**董事**」）會（「**董事會**」）及管理層，感謝全體同仁的勤勉敬業以及各界人士對本集團的長期支持。

In October 2021, myself and Mr. Tao Junjie were appointed by the Board as Executive Director and Chairman, and Executive Director and Chief Executive Officer, respectively. The Group strives to create sustainable and good returns for the Shareholders and other stakeholders, and to contribute to China's green and low-carbon development process.

Business Review and Prospects

Operating Results

During FY2021, the ongoing COVID-19 pandemic has caused increasing challenges and complexity to the global macroeconomic environment. Despite various external pressure, China's economy continued demonstrating strong resilience and navigating through the new development outlook to pursue "high-quality development". This marked a good start to the "14th Five-Year Plan" period.

In the first year of the "14th Five-Year Plan", China successfully achieved all the eight binding targets in the areas of ecology and environment as set out in the national economic and social development plan. This demonstrates good progress in terms of the domestic ecological and environmental protection work and shows China's full attention and firm determination on environmental protection tasks. As the global sense of crisis and voices on climate change are getting stronger, promotion of green and low-carbon development has also become an important task in China's tough battle against pollution and climate change. Following China's strategic goals of Dual Carbons, "Reducing Pollution and Carbon Emission" and "Boosting Synergy and Efficiency" have become key development themes for the water environment management sector and even the whole environmental protection industry.

業務回顧及前景

經營業績

二零二一財政年度，伴隨著新冠疫情持續反覆，全球宏觀經濟環境更加趨於複雜嚴峻。在重重外部壓力之下，中國經濟持續展現出強大的韌性，一路乘風破浪，在高質量發展進程中構建新發展格局，實現了國家「十四五」規劃階段的良好開局。

在「十四五」階段的起步之年，中國國民經濟和社會發展計劃中生態環境領域涉及的八項約束性指標全部達成，標誌著國內生態環境保護工作取得良好進展，彰顯著國家對於生態環保工作的高度重視和堅定決心。隨著全球應對氣候變化的危機感越來越強、呼聲越來越高，推動綠色低碳發展也已成爲中國污染防治攻堅戰及應對氣候變化的重要任務，圍繞國家雙碳戰略目標，「減污降碳」、「協同增效」成爲了水環境治理領域乃至整個環保行業的重要發展趨勢。

Chief Executive Officer's Report

Amidst the new landscape, new opportunities and new challenges, the Group, during the year under review, made steady progress with unremitting effort. Moreover, with the hard work and concerted effort, the Group has achieved fruitful results in the areas of market expansion, technological innovation, engineering and construction, operations management, safety and environmental management, among others. In the meantime, the Group has further developed its strategies which emphasise the “Innovation-driven Development” in various aspects such as business, management and research and development (“R&D”) to nurture competitive businesses. During the year under review, the Group achieved steady operating results and continued solidifying its competitive advantages and market position in the water environment management sector.

As at 31 December 2021, the Group invested in and held 153 environmental protection projects, with a total investment of approximately RMB28.43 billion. In addition, it undertook 4 engineering, procurement and construction (“EPC”) projects and 3 operation and management (“O&M”) projects (including 1 overseas O&M project). A summary of the number of projects and water treatment/supply capacity is set out below:

面對新形勢、新挑戰、新機遇，本集團於回顧年度內圍繞市場拓展、科技創新、工程建設、運營管理、安全與環境（「安環」）管理等方面，凝聚共識、真抓實幹、奮力拚搏，各項工作亮點紛呈；同時進一步明確了要從業務、管理、研究與開發（「研發」）等多維度「創新引領發展」，打造優勢產業。回顧年度內，本集團整體經營狀況穩步向好，持續鞏固本集團於水環境綜合治理領域的競爭優勢與市場地位。

截至二零二一年十二月三十一日，本集團投資並持有153個環保項目，涉及總投資約284.3億元人民幣，另承接4個工程總包（「EPC」）項目與3個委託運營（「委託運營」）項目（包括1個海外委託運營項目）。項目個數及水處理/供水規模摘要如下：

In terms of operating results for FY2021, with its stable operating momentum, the Group recorded revenue of HK\$6.91 billion, representing an increase of 22% from HK\$5.66 billion for FY2020; earnings before interest, taxes, depreciation and amortisation (“**EBITDA**”) was HK\$2.25 billion, representing an increase of 16% from HK\$1.93 billion in FY2020; profit attributable to equity holders of the Company reached HK\$1.20 billion, representing an increase of 17% from HK\$1.02 billion in FY2020; basic earnings per share were HK41.96 cents, indicating an increase of HK6.16 cents or 17% from HK35.80 cents in FY2020; overall gross profit margin was 41%, up 2 percentage points (“**ppt**”) compared to FY2020. The Group has ready access to diverse financing channels with comprehensive long- and short-term financing tools, holds quality assets and sufficient funds with a reasonable gearing ratio, and is in a healthy financial position.

With respect to market development, the Group, during the year under review, firmly pursued “high-quality development” and made its first entry into the water markets in Tianjin Municipality, Hebei Province and Mauritius. Thereby, the Group has solidified its business footprint in China’s strategic regions such as the Beijing-Tianjin-Hebei region, and successfully entered the water market along the “Belt and Road” route, further expanding its business outlook. During the year under review, the purchase of 65% equity interest in Tianjin Binhai New Area Huantang Sewage Treatment Co., Ltd. (“**Tianjin Huantang**”) helped the Group tap into Tianjin’s water market and gain valuable experience in pursuing opportunities under the mixed-ownership reform of China’s state-owned enterprises; securing Hebei Cangzhou Huanghua Waste Water Treatment Plants PPP Project enabled the Group to achieve comprehensive development in the Beijing-Tianjin-Hebei market; and securing the O&M project in relation to the Mauritius St. Martin Waste Water Treatment Plant, through the Company’s 80%-owned subsidiary E+B Umwelttechnik GmbH, marked an important milestone and a good start of the Group in developing overseas markets. Additionally, the Group, during the year under review, signed a framework agreement for Shandong Qingdao Maidao Waste Water Treatment Plant Expansion and Upgrading Project, as part of its effort to transform the Group’s Qingdao Waste Water Treatment Project (Maidao Plant) into an iconic “community-friendly” project that integrates high-quality water treatment facilities and a neighbourhood-friendly park. In FY2021, the Group secured 14 waste water treatment projects and 1 reusable water project, commanding a total investment of approximately RMB3.76 billion. The Group also undertook 1 EPC project and 1 overseas O&M project. These newly-secured projects contribute an additional designed daily waste water treatment capacity of 489,000 m³ (including capacity of the O&M project) and an additional designed daily reusable water supply capacity of 54,000 m³.

經營業績方面，二零二一財政年度，本集團經營勢頭穩健，錄得收入69.1億港元，較二零二零財政年度之56.6億港元增長22%；除利息、稅項、折舊及攤銷前盈利22.5億港元，較二零二零財政年度之19.3億港元增長16%；本公司權益持有人應佔盈利12.0億港元，較二零二零財政年度之10.2億港元增長17%；每股基本盈利41.96港仙，較二零二零財政年度之35.80港仙增加6.16港仙，增幅17%；整體毛利率為41%，較二零二零財政年度上升2個百分點（「**百分點**」）。本集團融資渠道多元暢通，融資工具長短期兼備，資產質優，資金充裕，負債合理，財務狀況健康。

市場拓展方面，回顧年度內，本集團堅持推動業務高質量發展，在天津市、河北省、毛里求斯水務市場實現突破，完善了本集團於京津冀等國家戰略區域的業務佈局並成功進入「一帶一路」沿線國家的水務市場，發展格局更加廣闊。回顧年度內，本集團購買天津濱海新區環塘污水處理有限公司（「**天津環塘**」）65%股權，藉此進入天津水務市場，並為本集團參與國有企業混合所有制改革業務提供寶貴的實踐經驗；簽署河北滄州黃驊污水處理廠PPP項目，實現了京津冀市場的全面佈局；依託本公司持股80%的附屬公司E+B Umwelttechnik GmbH取得毛里求斯聖馬丁污水處理廠委託運營項目，標誌著本集團的海外業務取得重要突破，為進一步探索海外市場開啟良好開端。此外，本集團於回顧年度內簽署山東青島麥島污水處理廠品質提升工程項目框架協議，致力於將本集團旗下青島污水處理項目（麥島廠）打造成為集高標準水處理設施和友好社區公園為一體的示範型「鄰利」項目。二零二一財政年度，本集團先後取得14個污水處理項目及1個中水回用項目，涉及總投資約37.6億元人民幣；另承接1個EPC項目及1個海外委託運營項目。新增設計規模為日處理污水489,000立方米（含委託運營項目規模）、日供中水54,000立方米。

Chief Executive Officer's Report

Against the backdrop of China's "Dual Carbons" strategic goals, the Group has carried out the relevant research and pilot programmes relating to "Reducing Pollution and Carbon Emission" and "Boosting Synergy and Efficiency", by leveraging on its own business characteristics and competitive strengths. The Group, during the year under review, proactively established working teams that specialised in six different areas, such as reusable water, in-plant solar energy and waste water source heat pump, to provide the necessary support for its future strategic development. Among them, the Group launched the in-plant solar energy pilot programme at its Shandong Zibo Waste Water Treatment Project. The solar energy facilities were successfully connected to the power grid in August 2021, which are expected to generate electricity to satisfy 9% of the project's power consumption. This enables the Group to accumulate valuable experience to further promote such programmes in the future. In addition, the Group, during the year under review, participated in the first batch of pilot projects for monitoring and evaluation of greenhouse gas emissions, which was organised by the Ministry of Ecology and Environment of the PRC ("MEE"), to carry out water sample analysis and data collection for carbon calculation.

As for technological innovation, the Group continued focusing on the digital transformation which is driven by technological innovation, and has achieved good progress. The Group, during the year under review, further promoted its "Intelligent Water" management system. The application of various systems, such as smart inspection system and smart dosing system, has reduced the workload of frontline staff and enhanced the management proficiency of the water projects. In addition, the Group actively developed the "Intelligent Water" blueprint which covers various aspects including design and operations, and promoted the development of an information and supervisory system and the implementation of smart plants. The Group has widely applied the operations management system to more than 20 waste water treatment plants. In FY2021, the Group provided its in-house developed technological processes to its internal and external clients, with a total contract value of over RMB100 million. The Group, during the year under review, was granted 28 patents (including 1 invention patent, 25 utility models, and 2 software copyrights), and published 28 technical papers.

In terms of safety and environmental management, the Group is devoted to safeguarding the health and safety of individuals and the environment. It increases awareness of safety and environmental risk prevention and strictly complies with the requirements of "zero work safety accident, zero excessive discharge of pollutants, and zero case for violation of regulations or discipline". The Group, during the year under review, comprehensively fostered the accountability of safety and environment, carried out the specified rectification tasks on safe production, and enhanced management and training relating to project safety and environmental protection. A solid foundation has been built for safe production and operation and compliance with emission standards.

在國家雙碳戰略目標的大背景下，本集團從自身業務特點與優勢出發，積極圍繞「減污降碳」、「協同增效」開展相關研究和試點工作。回顧年度內，本集團積極開展中水回用、廠內光伏、污水源熱泵等六方面專項研究，為未來的戰略發展部署提供支撐。其中，本集團位於山東淄博的污水處理項目啟動了廠內光伏項目試點；該光伏設施已於二零二一年八月成功併網發電，預計發電量可滿足項目廠區用電的9%，為未來推廣廠內光伏試點積累良好經驗。本集團亦於回顧年度內參加中國生態環境部組織的首批溫室氣體排放監測評估試點，配合開展碳核算水樣分析與數據採集。

科技創新方面，本集團堅持科技創新引領數字化轉型，並取得良好進展。回顧年度內，本集團深入推廣「智慧水務」管理平台，通過應用智能巡檢、智能加藥等系統，減輕一線人員工作負荷，同時有效提升水務項目的管理水平；積極打造覆蓋設計、運營等多方位的智慧水務藍圖，推進信息化監管平台建設與智慧工廠建設落地；旗下超過20個污水處理廠完成了運營管理系統的推廣應用。二零二一財政年度，本集團向內部及外部客戶繼續提供多項自主創新技術工藝包，涉及合同總金額超過1億元人民幣。回顧年度內，本集團獲得新授權專利28項（包括發明專利1項、實用新型25項、軟件著作權2項），發表技術論文28篇。

安環管理方面，本集團以保障個人與環境的健康安全為使命，強調安環風險防範意識，嚴格執行「零安全事故、零超標排放、零違法違規」要求，於回顧年度內深入落實安環責任制，開展安全生產專項整治工作，加強項目安環管理和培訓，築牢安全生產運營和達標排放底線。

In relation to project construction, the Group, during the year under review, firmly implemented measures to ensure safety and quality of project construction as well as pandemic prevention and control for the smooth progress of its project construction works. In FY2021, the Group had 6 projects that commenced construction, which have an aggregate designed daily waste water treatment capacity of 130,000 m³; 5 projects that completed construction (including EPC projects), which have an aggregate designed daily waste water treatment capacity of 72,500 m³; and 11 projects that completed construction and commenced operation, which have an aggregate designed daily waste water treatment capacity of 249,000 m³. As at 31 December 2021, the Group had 13 projects in the preparatory stage, with an aggregate designed daily water treatment capacity of 396,000 m³.

In relation to operations management, the Group continued exploring various opportunities to boost its operations management efficiency. The Group, during the year under review, proactively explored energy structure optimisation of waste water treatment plants by leveraging on its projects in operation. The Group co-operated with its partners to participate in market-based electricity transactions in Jiangsu and Shandong Provinces, effectively reducing the electricity cost. In FY2021, 9 waste water treatment plants of the Group received regulatory approval for tariff hikes, ranging from 4% to 58%; and subsidies of approximately RMB71.35 million in total were granted to the Group.

In relation to the capital market, the Group, during the year under review, continued with its flexibility in selecting suitable financing tools to match with its business development plan and keep its finance costs within a reasonable range. In January 2021, the Company issued the second tranche of medium term notes (“MTN”), with a principal amount of RMB1 billion and a subscription rate of 1.97 times; and in August 2021, the Company issued the first tranche of super & short-term commercial papers (“SCP”), with a principal amount of RMB800 million. The funds raised from such financing arrangements effectively replenished the working capital of the Company's subsidiaries. While expanding its financing channels, the Group also reviewed its loan structure and finance costs on a regular basis, and made adjustments and improvements as and when appropriate, to provide solid capital protection for “high-quality development” in the future.

工程建設方面，回顧年度內，本集團緊抓各在建項目的建設安全、工程品質和防疫保障，確保各項目工程建設有序推進。二零二一財政年度，本集團共有6個項目新開工建設，設計規模為日處理污水130,000立方米；5個項目建成完工（含EPC項目），設計規模為日處理污水72,500立方米；11個項目建成投運，設計規模為日處理污水249,000立方米。截至二零二一年十二月三十一日，本集團共有13個籌建項目，設計日水處理規模396,000立方米。

運營管理方面，本集團持續挖潛，帶動運營管理效能提升。回顧年度內，本集團以旗下運營項目為依託，積極探索污水處理廠的能源結構優化，並於江蘇省、山東省通過合作方式參與電力市場化交易，有效節約電力成本。二零二一財政年度，本集團旗下共有9個污水處理廠獲批上調水價，幅度介乎4%至58%；獲得各類資金補貼合共約7,135萬元人民幣。

資本市場方面，本集團於回顧年度內繼續靈活調用各類融資渠道，以配合業務發展節奏，將財務成本維持於合理區間。二零二一年一月，本公司發行了本金為10億元人民幣的第二期中期票據（「中期票據」），認購倍數為1.97倍；二零二一年八月，本公司發行了本金為8億元人民幣的首期超短期融資券（「超短期融資券」）。兩次融資安排募得的資金都已有效補充了本公司附屬公司的營運資金。在拓寬融資渠道種類的過程中，本集團亦定期檢討其貸款結構與融資成本，適時調整優化，為今後的高質量發展提供堅實的資金保障。

The Group highly values the concurrent enhancement of economic, social and environmental benefits as part of its business development, and therefore incorporating social and environmental responsibility initiatives into its day-to-day work. The Group, during the year under review, actively organised various online and offline charitable environmental protection activities in conjunction with several environmental protection-themed days, such as the “World Water Day”, “Earth Day” and “World Environment Day”. These activities have enhanced the local communities’ knowledge and concepts on treasuring water resources and fostered a positive and interactive relationship with the local communities. In addition, the activities increased the local residents’ understanding and recognition of environmental protection facilities. During the year under review, the Group’s projects received more than 400 batches of visitors from all walks of life.

In view of its outstanding performance in business development, operations management and sustainability, the Group, during the year under review, received a number of awards from various well-known domestic and international organisations. The major awards are summarised as below:

Business Prospect

In 2022, the global macro-economic situation is expected to remain fluid and keep changing, due to the impact brought by several global issues, such as the COVID-19 pandemic, inflation and monetary policy adjustments. Notwithstanding the slowdown in the global economic recovery momentum and divergent recovery trajectories, China will continue responding to various changes with its stability. This is to ensure that its domestic social-economic development will move forward steadily, with the fundamentals remaining positive in the long term.

Despite the divergence in the economic recovery and policy tightening of different countries, governments around the world are firmly determined to promote “Carbon Emission Reduction” in response to climate change, which is a pressing global issue. Following China’s proposal of “Dual Carbons” strategic goals, “Carbon Emission Reduction” has been regarded as a strategic key task of ecological conservation. “Reducing Pollution and Carbon Emission” and “Boosting Synergy and Efficiency” will remain the key missions for the water environment management sector and the whole environmental protection industry. As the traditional water market gradually becomes saturated and more competitive and the industry has higher expectations for innovative developments, there is a pressing need for businesses to transform their development model. “Intelligent Water”, pipe network construction, sludge utilisation and other sub-sectors will open up new space for development and drive the industry to enhance its core competitiveness through technological upgrades, management optimisation and other measures. This will bring steady progress in terms of green and low-carbon transformation.

Marching into 2022, with both opportunities and challenges presenting, the Group is determined to adhere to the national strategies and overall industry trends, focus on stability, explore opportunities, be innovative, and work exceptionally hard. Focusing on “Carbon Emission Reduction”, the Group will proactively carry out pilot programmes, develop landmark projects, and explore industry-leading operation models, all of which are relating to low carbon. Focusing on the key areas such as the Yangtze River Economic Belt, Guangdong-Hong Kong-Macau Greater Bay Area, Beijing-Tianjin-Hebei region and the “Belt and Road” route, the Group will solidify its strength in the existing markets, actively expand its business footprint, and enhance the coordination and synergy among different regions. Following the consolidation and extension of the industrial chain, the Group will actively explore new businesses and new business models to expand new sources of business growth, while enhancing its competitiveness along the existing industry chain. The Group will work diligently and continuously to achieve its goals. In 2022, the Group will strive and forge ahead with determination towards the goal of becoming a water environment management company that is driven by green innovation.

業務前景

二零二二年，受到新冠疫情、通貨膨脹、貨幣政策調整等全球性主題的影響，全球宏觀經濟形勢料將繼續以「變」為主線。在全球經濟復甦動能放緩、復甦進程分化的大環境中，中國以「穩」應「變」的發展基調將繼續保障國內社會經濟發展穩步前行，國家長期向好的基本面不會改變。

儘管全球各國在經濟復甦步伐、政策收緊節奏等方面的分化格局料將延續，但在面對氣候變化這一與人類永續發展休戚相關的議題之時，各國對於推進「碳減排」的態度堅定一致。自中國提出雙碳戰略目標以來，「碳減排」一直被視為國家生態文明建設的戰略重點。「減污降碳」、「協同增效」將繼續成為水環境治理及整個環保行業的重要發展主題。此外，隨著傳統水務市場逐漸飽和、行業競爭加劇，行業對於創新發展的期待更高，從業企業謀求轉型發展的需求也更加迫切。「智慧水務」、管網建設、污泥資源化利用等細分領域料將促進市場空間的持續釋放，推動從業企業通過技術升級、管理優化等方式提升內在競爭力，逐步向綠色低碳轉型升級。

步入機遇與挑戰並存的二零二二年，本集團將堅持與國家戰略同向，與行業大勢同行，穩字當頭、探索創新、奮發有為。圍繞「碳減排」主題，本集團將積極開展低碳試點，打造低碳示範項目，探索行業領先的低碳運營模式；圍繞長江經濟帶、粵港澳大灣區、京津冀、「一帶一路」等重點區域，本集團將鞏固現有市場，積極拓展業務版圖，加強區域聯動與協同；圍繞產業鏈鞏固和延伸，本集團在提升現有產業鏈優勢的同時，將積極探索新業務、新模式，培育新的業務增長點。追風趕月莫停留，平蕪盡處是春山。二零二二年，本集團將朝著成為綠色創新型水環境治理企業的目標全力以赴，堅定前行。

Financial Results

In FY2021, the revenue of the Group increased by 22% to HK\$6,912.37 million compared with the revenue of HK\$5,663.29 million in FY2020. Gross profit of the Group increased from HK\$2,200.54 million in FY2020 to HK\$2,801.59 million in FY2021, representing an increase of 27%. The profit of the Group increased from HK\$1,086.36 million in FY2020 to HK\$1,282.99 million in FY2021, representing a rise of 18%. The profit attributable to equity holders of the Company in FY2021 amounted to HK\$1,200.33 million, representing an increase of 17% over FY2020.

Financial Position

As at 31 December 2021, the Group's total assets amounted to approximately HK\$32.97 billion with net assets amounting to HK\$13.16 billion. Net asset value per share attributable to equity holders of the Company was HK\$4.15 per share, representing an increase of 13% as compared to HK\$3.68 per share as at the end of 2020. As at 31 December 2021, the gearing ratio (total liabilities over total assets) of the Group was 60.1%, which increased by 2.5 ppt from 57.6% at the end of 2020.

Liquidity and Financial Resources

The Group adopts a prudent approach to cash and financial management to ensure proper risk control and low cost of funds. It finances its operations primarily with internally generated cash flow and loan facilities from banks, supplemented by funds raised from issuance of corporate bonds, asset-backed securities ("ABS"), MTN and SCP. As at 31 December 2021, the Group had cash and bank balances of HK\$2.28 billion, representing an increase of HK\$562.46 million as compared to HK\$1.72 billion at the end of 2020. Most of the Group's cash and bank balances, representing approximately 99%, was denominated in HK\$ and RMB.

財務業績

於二零二一財政年度，本集團的收入由二零二零財政年度的56.6329億港元增加22%至69.1237億港元。本集團的毛利由二零二零財政年度的22.0054億港元增加27%至二零二一財政年度的28.0159億港元。本集團的盈利由二零二零財政年度的10.8636億港元增加18%至二零二一財政年度的12.8299億港元。本公司權益持有人於二零二一財政年度應佔盈利為12.0033億港元，較二零二零財政年度增加17%。

財務狀況

於二零二一年十二月三十一日，本集團的總資產約為329.7億港元，淨資產為131.6億港元。本公司權益持有人應佔每股資產淨值為每股4.15港元，較二零二零年底每股3.68港元增加13%。於二零二一年十二月三十一日，本集團資產負債比率（以總負債除以總資產計算所得）為60.1%，較二零二零年底的57.6%增加2.5個百分點。

流動性及財務資源

本集團對現金及財務管理採取審慎的原則，以確保妥善管理風險及降低資金成本。項目運營的資金來源主要為內部現金流及往來銀行提供之貸款，並以發行公司債券、資產支持證券（「資產支持證券」）、中期票據及超短期融資券籌集的資金補充。於二零二一年十二月三十一日，本集團持有現金及銀行結餘22.8億港元，較二零二零年年底之17.2億港元增加5.6246億港元。本集團大部分現金及銀行結餘均為港元及人民幣，約佔比99%。

The Group is dedicated to improving financing methods and increasing banking facility limit to reserve funding for developing the water environment management business. As at 31 December 2021, the Group had outstanding borrowings of HK\$14.44 billion, representing an increase of HK\$3.36 billion as compared to HK\$11.08 billion as at the end of 2020. The borrowings included secured interest-bearing borrowings of HK\$2.51 billion and unsecured interest-bearing borrowings of HK\$11.93 billion. The borrowings are mainly denominated in RMB, representing approximately 69% of the total, and the remainder is denominated in HK\$, United States dollars ("USD") and euros ("EUR"). Most of the borrowings are at floating rates. As at 31 December 2021, the Group had bank loan facilities of HK\$15.36 billion, of which HK\$6.26 billion have not been utilised. The bank loan facilities are of 1 to 17 years terms.

本集團致力完善融資方式及提升銀行貸款額度，儲備資金以發展水環境治理業務。於二零二一年十二月三十一日，本集團尚未償還借貸為144.4億港元，較二零二零年年底之110.8億港元增加33.6億港元。借貸包括有抵押之計息借貸25.1億港元及無抵押之計息借貸119.3億港元。本集團的借貸主要以人民幣為單位，佔總額約69%，其餘則以港元、美元（「美元」）及歐元（「歐元」）為單位。本集團的大部分借貸均按浮動利率計息。於二零二一年十二月三十一日，本集團之銀行融資額度為153.6億港元，其中62.6億港元為尚未動用之額度。銀行貸款融資為一至十七年期。

Foreign Exchange Risks

The Group mainly operates in the PRC. Currency exposure arises within entities of the Group when transactions are mainly denominated in foreign currencies such as USD, EUR, Singapore dollars (“SGD”), HK\$ and RMB. In addition, the Group is exposed to currency translation risk upon translation of the new assets in foreign operations into the Group’s reporting currency of HK\$. During FY2021, the Group was affected by the changes in the exchange rates and did not adopt any formal hedging policies nor used any financial instrument for hedging purpose.

Although the Group was exposed to foreign currency exchange risks, the Board believes that the future currency fluctuations will not have any material impact on the Group’s operations.

Pledge of Assets

Certain bank loan facilities and ABS of the Group as at 31 December 2021 and 2020 were secured by certain revenue, contract assets, receivables and intangible assets in connection with the Group’s service concession arrangements and the equity interests in certain subsidiaries of the Company. As at 31 December 2021, the aggregate net book value of assets and equity interests in subsidiaries under pledge arrangements amounted to HK\$8.51 billion.

Commitments

As at 31 December 2021, the Group had outstanding purchase commitments of HK\$1.70 billion in connection with the construction contracts and an outstanding capital commitment of HK\$25.52 million in connection with an unlisted equity investment.

Contingent Liabilities

As at 31 December 2021, the Company provided financial guarantees to two subsidiaries. The Board does not consider it probable that a claim will be made against the Company under the guarantees. The maximum liability of the Company as at 31 December 2021 for the provision of the guarantees was HK\$934.70 million. Nonetheless, the Group did not recognise any contingent liabilities at the consolidated level as at 31 December 2021.

(the "Acquisition"). The purchase consideration for the Acquisition was RMB666.34 million (the "Purchase Consideration") and was determined through a competitive online bidding process. The Purchase Consideration has been paid in full in cash and funded entirely through internal resources. On 10 December 2021, the Company has, through its wholly-owned subsidiary, Everbright Water (Shenzhen) Limited, completed the disposal of 20% equity interest in Xiong'an Huashen to an independent third party (the "**Disposal**").

The sale consideration for the Disposal was RMB1.02 million (approximately HK\$1.22 million) (the "**Sale Consideration**") after taking into consideration the appraised value of 100% of the equity interest in Xiong'an Huashen as at 31 December 2020 using market-based approach, which was determined to be RMB5.09 million. The net asset value of the 20% equity interest in Xiong'an Huashen as at 31 December 2020 was RMB1.01 million. The Sale Consideration was received in full in cash.

Upon completion of the Disposal, the Company and its subsidiaries no longer held any equity interest in Xiong'an Huashen and therefore, Xiong'an Huashen ceased to be an indirect associate of the Company.

Future Plans for Material Investments or Capital Assets

Save as disclosed under the section headed “Future Plans and Use of Proceeds” in the listing document issued by the Company dated 24 April 2019, the Group did not have other future plans for material investments or capital assets during FY2021.

Internal Management

Corporate management and risk control are of paramount importance in ensuring efficient, healthy and sustainable corporate development. The Group has established a sound management structure with four committees under the Board (the “**Board Committees**”), comprising the Audit Committee, the Remuneration Committee, the Nominating Committee and the Strategy Committee. The Company has also established the Management Committee as the decision-making body for its daily management. The Management Committee holds a meeting at least once a month to deliberate the matters regarding the Group’s business and management, ensuring its sustainable development. The Company has also set up various functional departments, including the Legal & Risk Management Department, the Internal Audit Department, the Finance Management Department, the Budget Management Department, the Human Resources Department, the General Management Department, the Operations Management Department, the Safety & Environmental Management Department and the Investment & Development Department. Moreover, in response to business needs, the Group has also set up four regional management centres, in order to manage its projects by region and create favourable synergies. The Group has continuously improved the internal management, established complete management systems and emergency response capacity, and fully implemented the Environmental, Safety, Health and Social Responsibility (“**ESHS**”) Management System (“**ESHS Management System**”) and the Risk Management System at all levels in order to standardise the management of all aspects in the process of project investment, construction and operations, identify and control risks, and enhance the overall operational efficiency and profitability. The Group has continued to promote the establishment and improvement of corporate governance and integrated compliance management into its business activities and processes. During the year under review, the Group established an investigation mechanism, conflict of interest mechanism relating to family members, anti-corruption mechanism and accountability system, and clarified the relevant rules in the “Sunshine Declaration” signed with the suppliers. Accordingly, the suppliers can report the misconduct of the Group’s employees in accordance with the channels provided in the agreement in order to assist the Group to supervise the integrity of its employees. This has further regulated the operation of the Group and enhanced its corporate governance.

重大投資或資本資產的未來計劃

除本公司所刊發日期為二零一九年四月二十四日之上市文件內「未來計劃及所得款項用途」一節所披露者外，本集團於二零二一財政年度概無任何其他重大投資或資本資產的未來計劃。

內部管理

企業管理和風險管控是確保企業高效、健康和可持續發展的基礎。本集團建立了完善的管理架構，董事會下設了四個委員會（「**董事會委員會**」），包括審計委員會、薪酬委員會、提名委員會、戰略委員會。本公司亦建立了管理委員會作為其日常經營管理的決策機構，管理委員會每月至少召開一次會議，審議當期運營和管理情況，確保本集團的可持續發展。本公司設有法律及風險管理部、內審部、財務管理部、預算管理部、人力資源部、綜合管理部、運營管理部、安全與環境管理部、投資發展部等職能部門。此外，根據業務需求，本集團還設立了四大區域管理中心，按區域管理旗下項目，發揮良好的協同效應。本集團持續完善內部管理，建立了完善的管理體系和應急能力，並在各級全面實施環境、安全、健康及社會責任（「**ESHS**」）管理體系（「**ESHS管理體系**」）和風險管理體系，實現項目投資、建設及運營過程中各環節的規範化管理，識別和管控風險，促進整體運行效率和效益的提升。本集團持續推進企業管治建設和優化，將合規管理落實到業務活動及流程中。於回顧年度內，本集團建立了調查機制、親屬回避機制、防腐機制與問責制度，並在與供應商簽訂的《陽光宣言》中明確相關規則，供應商能根據協議內提供的渠道，舉報員工的不當行為，以協助本集團監查員工的誠信廉潔，進一步規範了本集團運作，提高了企業管治水準。

Human Resource Management

The Group highly values its employees and adheres to the “People-Oriented” philosophy and competency-based recruitment approach. Additionally, the Group evaluates its employees based on their integrity, knowledge, ability and performance, and establishes an open, competitive and merit-based recruitment mechanism. During the year under review, the Company has established an evaluation model assessing the employees’ competency level and ability to perform their duties. Such model is to effectively identify outstanding high-potential talents. Moreover, the Company continuously summarised its human resources (“HR”) management experiences, optimised HR management systems, established HR management information systems, and improved the proficiency of the management team. These measures assure the Company’s sustainable development.

The Group puts great emphasis on talent training. Based on its strategic development goal, the Company has organised comprehensive trainings to enhance the capability of its employees in all kinds of positions as well as the development courses and management courses to enhance their vocational skill. The Company has established its internal trainer team to enhance the professional skill and comprehensive quality of its employees by adopting diversified methods of online and offline training. The Company has steadily developed its talent pool comprising various professionals so as to provide internal assurance and support for its long-term development.

The Group cares for its employees and always puts employees’ personal safety as priority. Following the ongoing global pandemic, the Group quickly adopted prevention measures and actively coordinated various resources to provide its employees with adequate preventive and protective materials and conduct health testing to safeguard employees’ safety and health.

As at 31 December 2021, the Group had 2,318 employees, who are remunerated according to their qualifications, experience, job nature, performance and with reference to market conditions. Apart from discretionary bonuses, the Group also provides employees with other benefits such as setting up and maintaining a pension scheme pursuant to the laws and regulations in the relevant jurisdictions. During the year under review, in order to further enhance the employee’s sense of belongings and improve medical and health protection schemes, the Group purchased long-term medical insurance and health protection plan for eligible employees. In addition, the Group is committed to providing all employees with equal opportunities in various aspects and making efforts to employees’ continuous education to keep improving employees’ knowledge, skill and engagement. Details of the salaries and other benefits of the employees are set out in note 8 to the financial statements.

人力資源管理

本集團將員工視為企業的寶貴資源，堅持「以人為本」和「量才適用」，把品德、知識、能力和業績作為衡量人才的主要標準，建立起以公開、競爭、擇優為導向的選拔任用機制。於回顧年度內，建立以崗位勝任素質為基礎的管理人員勝任素質評價模型，有效識別優秀高潛人才；不斷總結本公司人力資源管理實踐經驗，優化人力資源管理制度、建立人力資源管理資訊系統、提升管理團隊的專業能力，為本公司的可持續發展提供良好保障。

本集團高度重視人才培養，基於其企業戰略發展目標，制定了針對各類崗位員工通用素質提升的綜合性課程和職業技能提升的發展培訓課程、管理培訓課程，建立了內部講師團隊，採用線上和線下多元化的培訓方式，提升了員工的專業技能及綜合素質，本公司各類人才隊伍穩步推進建設，為本公司長遠發展提供了內在保障支持。

本集團關愛員工，在任何情況下，始終將員工的人身安全放在首位。全球疫情肆虐，本集團快速建立防疫措施，積極協調各項資源，為員工提供充足的防護物資及做好健康檢測，保障員工的安全與健康。

Principal Risks and Uncertainties

During the year under review, the Group continued with the implementation of the risk management system, establishment of risk identification and assessment procedures, and the adoption and evaluation of risk control measures. Based on the requirements set out in its “Risk Management Policy” and “Risk Management Manual”, the Group has summarised and analysed the principal risks faced during the year under review including policy changing risk, new business investment and market competition risks, environmental compliance and safe production management risks, accounts receivable risk, engineering management risk, staffing risk, financing management risk, cost control risk, technology and innovation risks, and compliance risk.

During the year under review, the PRC government proposed its targets on “Peaking Carbon Dioxide Emissions” and “Achieving Carbon Neutrality”, and issued multiple policies on the eco-environment-oriented development (the “EOD”) model. Amidst the new opportunities and challenges presented to the domestic environmental water industry in China, seeking differentiated products and services and discovering new business growth points have become the common issues of major water enterprises. Therefore, the new business investment and market competition risks faced by the Group are on an upward trend. Given the effect of the implementation of internal controls throughout the Group during the year under review and the past years and taking into account the complexity and diversity of external factors of other key risks which are beyond the Group's control, the risk levels of other key risks remain unchanged during the year under review.

主要風險及不確定性

回顧年度內，本集團持續推進風險管理體系建設、風險識別與評估流程建立、風險管控措施落實和評價等相關工作。本集團基於其《風險管理制度》和《風險管理手冊》要求，已匯總及分析回顧年度內面臨的主要風險，包括政策變動風險、新業務投資與市場競爭風險、環境合規與安全生產管理風險、應收賬款風險、工程管理風險、人員配置風險、融資管理風險、成本控制風險、科技與創新風險、合法合規風險。

回顧年度內，中國政府提出「碳達峰」、「碳中和」目標，出台更多關於生態環境導向開發（「EOD」）模式的政策，中國國內環保水務行業面臨新的機遇與挑戰，尋求差異化的產品與服務、探索新的業務增長點成為主要水務企業面臨的共性問題。因此，本集團面臨的新業務投資與市場競爭風險呈上升趨勢；參考回顧年度及過往本集團內部控制的實施效果，並考慮到其他主要風險事項的外部影響因素複雜多樣且本集團不可控，本集團對回顧年度內其他主要風險的風險等級維持不變。

1. Policy Changing Risk

The Group is subject to risks associated with changes in regulations and policies in respect of waste water treatment, river-basin ecological restoration, sponge city construction, reusable water, water supply and waste water source heat pump projects in the PRC. During the year under review, the PRC government issued a number of policy documents on the EOD model. This has enabled the EOD model to become a new research headline in the environmental water industry after “Peaking Carbon Dioxide Emissions” and “Achieving Carbon Neutrality”. In order to maintain its leading position in the environmental water industry and maintain its stable business growth, the Group is required to continuously monitor the PRC government's environmental policies, and study changes in the market and new industry patterns. During the year under review, the Group actively responded to the PRC government's policies by setting up special teams to study topics such as reduction of pollutants and carbon and carrying out pilot projects such as water resource utilisation and solar energy, while closely monitoring the changes in government policies and market. The existing control measures are effective as a whole and the risk level remains unchanged.

2. New Business Investment and Market Competition Risks

With the intense market competition faced by traditional water projects, the Group needs to expand new business investments. Massive capital and numerous competitors are entering the environmental water industry where the Group operates. If the Group fails to effectively analyse and predict market trends and industry developments in the future, or fails to effectively integrate existing resources based on its own advantages, it will lead to unsatisfactory investment return or unapparent competitive advantages. During the year under review, the Group strengthened its efforts in research and expansion on new businesses and actively explored development opportunities, such as suitable merger and acquisition opportunities, overseas environmental water projects and new business models. The existing control measures are effective as a whole. However, the risk level is on an upward trend due to the intensifying competition of the environmental water industry in China and the direction of new policies issued by the PRC government during the year under review.

1. 政策變動風險

本集團面臨中國污水處理、流域生態修復、海綿城市建設、中水回用、供水及污水源熱泵項目的法規及政策變動有關的風險。中國政府於回顧年度內發佈多項關於EOD模式的政策文件，使其成為繼「碳达峰」、「碳中和」後環保水務行業新的研究熱點。為維持本集團在環保水務行業的領先地位，保持業務穩定增長，本集團需要持續關注中國政府環保政策走向，研究市場與新行業模式變化。回顧年度內，本集團積極響應中國政府政策號召，已成立若干專項團隊研究減污降碳等有關課題，開展水資源利用、光伏發電等項目試點，並密切關注政府政策與市場變化。目前管控措施整體有效，本項風險等級維持不變。

2. 新業務投資與市場競爭風險

傳統水務項目面臨激烈的市場競爭，本集團需要拓展新投資業務。大量資本和競爭對手正在進入本集團所在的環保水務行業，如本集團未來不能有效分析、預估市場趨勢和行業發展情況，或未能就自身優勢特點有效整合現有資源，則會導致投資收益不理想或者競爭優勢不明顯。回顧年度內，本集團加大新業務的研究與拓展力度，積極探索發展契機，如合適的併購機會、境外環保水務項目、新業務模式等。目前管控措施整體有效，但考慮到中國環保水務行業競爭態勢及回顧年度內中國政府新政策導向，本項風險呈上升趨勢。

3. Environmental Compliance and Safe Production Management Risks

During the year under review, the Group was able to control the environmental compliance and safe production management risks, and no major risk incident took place. During the year under review, the PRC government issued and revised various laws and regulations to strengthen the supervisory and enforcement power on environmental compliance and safe production management. This has resulted in the tightening of external regulations. As such and following the increasing number of its construction and operation projects, the Group was exposed to increasingly stringent pressure in environmental compliance and safe production management. If any incident (such as excessive discharge of pollutants or unsatisfactory safety management) caused by the external environment or any human factors occurs, the Group might be subject to liabilities such as administrative penalties, which might affect its reputation and revenue. The existing control measures are effective as a whole. However, the risk level remains unchanged since the Group has a large number of construction and operation projects.

4. Accounts Receivable Risk

Due to its business model, the business, financial condition, operating results and prospects of the Group are significantly affected by the revenue and creditworthiness of the customers of the Group's environmental water projects. If the customers' abilities to settle service charges are affected due to financial difficulties, or the customers delay their payment of service charges, the Group's capital management and profit may be affected. The major customers of the Group are local PRC governments of the places where the environmental water projects are located. During the year under review, the Group was still subject to high accounts receivable risk since the local PRC governments' financial capability was affected by the COVID-19 pandemic. The Group has put in place various measures to strengthen the recovery of accounts receivable. The existing control measures are effective as a whole. However, the risk level remains unchanged due to the uncontrollability of the relevant factors.

3. 環境合規與安全生產管理風險

回顧年度內，本集團環境合規與安全生產管理風險可控，未發生重大風險事件。回顧年度內，中國政府新增、修訂了若干環境合規與安全生產管理方面的法律法規，強化環境合規與安全生產管理的監管與處罰力度，外部監管日漸趨嚴。隨著本集團建設、投運項目日漸增多，本集團所面臨的環境合規和安全生產管理壓力也日趨嚴峻。一旦由於外部環境或個人為因素導致發生污染物排放超標、安全管理不到位等事件，本集團可能面臨行政處罰等法律責任，進而影響本集團的聲譽與收入。目前管控措施整體有效，但考慮到本集團建設、投運項目眾多，本項風險等級維持不變。

4. 應收賬款風險

受限於業務模式，本集團的業務、財務狀況、經營業績及前景受本集團環保水務項目客戶收入、客戶信用情況影響較大。若客戶財務緊張而造成其支付服務費用的能力下降，或者客戶較合同約定的時點延後支付服務費用，將對本集團的資金管理和利潤造成影響。本集團主要客戶為各環保水務項目所在地的中國地方政府。回顧年度內，由於新冠疫情的衝擊，中國地方政府財務能力受到不同程度的影響，本集團面臨的應收賬款風險等級仍然較高。本集團為加強應收賬款回款已採取各類措施，目前管控措施整體有效，但考慮到相關因素不為本集團所控，本項風險等級保持不變。

5. Engineering Management Risk

Engineering management risk refers to the mismanagement in different areas, such as the safety, quality, progress and budget of engineering constructions, that potentially leads to losses. Such mismanagement could be due to insufficient staff, tight timelines, and failure of contractors to supervise the participating units properly. In relation to the environmental water industry where the Group operates, engineering construction is the paramount factor in ensuring the subsequent stable and up-to-standard operation and cost control of projects. The Group has closely monitored the engineering management, and no major risk incident took place during the year under review. The existing control measures are effective as a whole. However, the risk level remains unchanged due to the large amount of business and a lot of construction units and staff involved as well as the continuity of the COVID-19 pandemic prevention and control.

6. Staffing Risk

The Group relies on the experience and capability of its key management team and qualified staff in managing different businesses. The training of key staff, management and technical personnel is a cyclical process. Due to its business development and the increasingly competitive conditions in the environmental water industry, the Group needs to bring in suitable management and technical talents as and when appropriate to ensure the stable development of the Group's businesses. During the year under review, the Group remained dedicated to talent training and recruitment, implemented management systems such as "Measures on Management of Reserve Talents" and "Measures on Assessment and Recruitment of Professional and Technical Staff", established and refreshed the talent pool, organised professional training regularly, and strengthened the effort on external recruitment for a few relatively remote projects. The existing control measures are effective as a whole, and during the year under review, the team was stable and all relevant works were carried out in an orderly manner. The risk level remains unchanged.

5. 工程管理風險

工程管理風險是指，由於人員配置不足、工期緊張、總承包方對參建單位管理不到位等原因，在工程安全、質量、進度、預算等方面可能存在管理缺陷，從而發生損失的風險。本集團所在的環保水務行業，項目相關工程建設對於項目後續穩定達標運行、成本控制有著重要影響。本集團一直就工程管理事項重點監控，回顧年度內未發生重大風險事項。目前管控措施整體有效，但考慮到相關業務金額較大、參建單位與人員眾多、新冠疫情防控的持續性，本項風險等級保持不變。

6. 人員配置風險

本集團依賴主要管理團隊及合資格人員的經驗與能力來管理各項業務。關鍵崗位和管理與技術人才的培養具有一定週期性，隨著本集團業務發展及其所在的環保水務行業競爭加劇，為確保本集團業務穩定發展，本集團需要適時補充合適的管理與技術人才。回顧年度內，本集團持續致力於人才培養與招聘工作，已執行《後備幹部管理辦法》和《專業技術職務評聘管理辦法》等管理制度，建立並更新後備人才庫，定期開展專業培訓，對於少量位置相對偏遠的項目已加大外部招聘力度。目前管控措施整體有效，回顧年度內本集團員工隊伍基本穩定、相關工作有序開展，本項風險等級保持不變。

7. Financing Management Risk

In order to maintain its competitiveness and implement growth strategies, the Group is required to have sufficient capital resources. In view of the industry model, the Group spends a large sum of monies in construction during the early stage of projects and gradually receives cash flow during the operation process at the later stage. If it fails to reasonably control the finance cost or fails to obtain a reasonable amount of financings from the financial market as and when needed, the Group may face difficulties in carrying out business and achieving its profit target. To ensure that the Group maintains a sufficient capital reserve and good control of finance cost, the Group, during the year under review, continued monitoring the domestic and overseas financing environment and the trend of the RMB exchange rate, adjusting the Group's borrowing structure as appropriate, and strictly controlling the use of capital. The existing control measures are effective as a whole and the risk level remains unchanged.

8. Cost Control Risk

The Group's business involves engineering construction and operation relating to environmental water projects. Substantial changes in the costs of relevant raw materials, energy, financing and labour would adversely affect the profit of the Group. During the year under review, due to the COVID-19 pandemic and relevant policy adjustments by the PRC government, the prices of certain raw materials and energy required for the Group's construction and operation substantially fluctuated. This led to an adverse impact on the Group's cost control. The Group continuously optimised the tender and procurement systems and procedures, and adopted various measures to control procurement costs and ensure procurement quality. In addition, it strengthened budget management, strictly controlled project investment and operation costs, and conducted regular evaluations. The existing control measures are effective as a whole and the risk level remains unchanged.

9. Technology and Innovation Risks

During the year under review, the competition in the environmental water industry in which the Group operates became very intense and the PRC government continuously promulgated new policy documents on environmental protection and ecological management. This has accelerated the Group's urgency in bringing technological innovation to drive business development. The Group, during the year under review, continuously strengthened its efforts and allocated resources in research and development of relevant technologies, proactively brought in technology specialists and facilitated the technological transformation and project application, with a view to pursuing technology-driven development. The existing control measures are effective as a whole. However, the risk level remains unchanged since the technology research and innovation is a time-consuming process and its outcome may not meet the expectation.

7. 融資管理風險

維持本集團的競爭力及實施發展戰略均要求本集團具備充足的資金資源。受限於行業模式，本集團業務一般需要在項目前期投入大量資金建設，並在後續運營過程中陸續取得現金流。如果本集團不能合理管控融資成本、不能適時在金融市場完成合理規模的融資，可能導致本集團相關業務開展與利潤籌劃目標難以實現。回顧年度內，本集團持續關注國內外融資環境，持續監測人民幣匯率變動走勢，適時調整本集團貸款結構，嚴控資金使用，確保本集團資金儲備充足與融資成本可控。目前管控措施整體有效，本項風險等級保持不變。

8. 成本控制風險

本集團業務涉及環保水務項目的工程建設、運營等事項，如相關原材料、能源、財務、人工等成本的市場價格發生較大變化，將對本集團的利潤造成不利影響。回顧年度內，由於新冠疫情和中國政府相關政策調整，本集團部分建設、運營所需原料以及能源價格有較大波動，對本集團成本控制造成一定影響。本集團已持續完善招標採購制度與流程，採取各項措施控制採購成本和確保採購質量；同時強化預算管理，嚴控項目投資與運營成本，並實施定期考核。風險管控措施整體有效，本項風險等級保持不變。

9. 科技與創新風險

隨著本集團所在的環保水務行業競爭加劇，中國政府於回顧年度內在環境保護與生態治理領域相關新政策文件的持續發佈，本集團對於科技創新以帶動業務發展的需求日益迫切。回顧年度內，本集團持續投入精力與資源研發業務技術，積極嘗試引進專業技術人才、推動技術成果轉化以及項目應用，堅持科技引領發展。目前管控措施整體有效，但由於相關科研與創新工作週期較長，科研成果可能未如預期理想，本項風險等級保持不變。

10. Compliance Risk

The Group has established a relatively comprehensive compliance procedure, including the provision of effective legal protection through internal legal personnel and external legal experts, to ensure relevant matters are effectively reviewed and handled. During the year under review, the Group strictly complied with the requirements of the relevant PRC laws and regulations, the Rules Governing the Listing of Securities on the SEHK (the “**SEHK Listing Rules**”), the listing manual of SGX (the “**SGX Listing Manual**”) and relevant industry specifications, and achieved a good compliance record. The existing control measures are effective as a whole and the risk level remains unchanged.

Environmental and Social Management

With a focus on environmental protection, the Group is committed to actively promoting national ecological civilisation and sustainable urban development through its high-quality water environment management business. The Group has been actively evaluating its environmental and social performance based on internationally recognised standards, including the World Bank Group's *Environmental, Health, and Safety Guidelines*, and has been submitting annual monitoring reports to International Finance Corporation since 2016. Such monitoring reports cover all projects of the Group, including projects in the preparatory stage, projects under construction, projects that completed construction and projects in operation. All of the Group's projects have obtained or are actively applying for international management standard certificates, including ISO 9001 Quality Management System, ISO 14001 Environmental Management System, and ISO 45001 Occupational Health and Safety Management System. In addition, the Group will identify and evaluate the project's environmental and social risks prior to investment so as to effectively control environmental and social risks, and ensure that the requisite administrative permissions and approvals, such as environmental impact assessment approvals, are duly obtained before commencing construction.

10. 合法合規風險

本集團已建立較為完善的法律合規實踐，通過內部法律人員與外聘法律專家兩方面提供有效法律保障，確保相關事項均能得到有效的審核與處理。回顧年度內，本集團一直嚴格遵守中國有關法律法規、聯交所證券上市規則（「**聯交所上市規則**」）、新交所的上市手冊（「**新交所上市手冊**」）、相關行業規範等要求，擁有良好的合規記錄。目前管控措施整體有效，本項風險等級保持不變。

環境與社會管理

本集團心繫環保，致力透過優質的水環境治理業務，積極推動國家生態文明建設與城市可持續發展。本集團積極按照世界銀行集團《環境、健康和安全管理指南》等國際認可的標準評估其環境及社會表現，並自二零一六年起每年向國際金融公司提交監測報告。該等監測報告涵蓋本集團的所有項目，包括籌建項目、在建項目、建成完工項目及運營項目。本集團旗下所有項目均已獲得或正在積極申請各類相關體系國際管理證書，包括ISO 9001質量管理體系、ISO 14001環境管理體系及ISO 45001職業健康安全管理体系。此外，本集團在投資項目之前均會識別和評估環境及社會風險，以有效控制環境及社會風險；並確保建設項目於施工前獲得環評批覆等必需的行政許可及批覆文件。

In order to protect the environment, prevent and control pollution and other public nuisances, protect public health and promote ecological civilisation, sustainable economic and social development, the Group strictly complies with the PRC's laws, regulations and standards related to environmental protection, safe production, occupational health and social responsibility. Key laws, regulations, and standards applicable to the Group include *Environmental Protection Law of the PRC*, *Water Pollution Prevention and Control Law of the PRC*, *Marine Environment Protection Law of the PRC*, *Law of the PRC on the Prevention and Control of Environmental Pollution by Solid Wastes*, *Law of the PRC on Environmental Impact Assessment*, *Law of the PRC on Prevention and Control of Environmental Noise Pollution*, *Atmospheric Pollution Prevention and Control Law of the PRC*, *Work Safety Law of the PRC*, *Labour Law of the PRC*, *Social Insurance Law of the PRC*, *Discharge Standard for Pollutants of Municipal Wastewater Treatment Plants* (GB18918-2002) and the relevant discharge standards for pollutants prescribed by local governments, etc. In addition, the Group is committed to continually improving the water environmental conditions of the places at which the Group's projects are located, with all the projects in operation complying with the Grade 1A or higher standard under the *Discharge Standard of Pollutants for Municipal Wastewater Treatment Plant* (GB18918-2002). The Group's projects greatly minimise the environmental damage caused by waste water discharge, protect public health and promote sustainable development of the water environment. No breach of these laws and regulations which resulted in any significant loss or impact to the Group was recorded in FY2021.

The Group implements and organically integrates the comprehensive ESHS Management System and Risk Management System into its daily operations management, and makes timely and comprehensive information disclosure. This will ensure that the Group's management structure and core values in social responsibility, as well as risk management, are safeguarded and applied across various business units at all times. In FY2021, the Group continued implementing the ESHS Management System at all levels, covering all of its employees, on-site third party contractors and subcontractors. This is to standardise the internal management and risk control in all aspects, continuously optimise the management system, and strengthen emergency response ability, for the purpose of sustainable development. The system also minimises the environmental, safety, health and social impacts on the project areas.

為保護和改善環境、防治污染和其他公害、保障公眾健康、推動生態文明建設以及經濟和社會的可持續發展，本集團嚴格遵守中國制定的環境保護、安全生產、職業健康與社會責任相關的法律、法規和標準，包括《中華人民共和國環境保護法》、《中華人民共和國水污染防治法》、《中華人民共和國海洋環境保護法》、《中華人民共和國固體廢物污染環境防治法》、《中華人民共和國環境影響評價法》、《中華人民共和國環境噪聲污染防治法》、《中華人民共和國大氣污染防治法》、《中華人民共和國安全生產法》、《中華人民共和國勞動法》、《中華人民共和國社會保險法》、《城鎮污水處理廠污染物排放標準》（GB18918-2002）以及地方政府制定的相關污染物排放標準等。同時，本集團致力持續改善項目所在地區的水環境狀態，各運營項目的出水各項指標均符合或優於《城鎮污水處理廠污染物排放標準》（GB18918-2002）的一級A標準，大幅度降低污水排放對環境造成的影響，保障公眾健康和水環境的可持續發展。於二零二一財政年度，本集團沒有因違反這些法律及規例而造成重大損失和影響的記錄。

本集團實施全面的ESHS管理體系和風險管理體系，並將其與日常經營管理有機結合，進行適時全面的信息披露，以此為本集團的管理架構保駕護航並確保本公司各項業務在社會責任和風險管理方面的核心價值始終如一。於二零二一財政年度，本集團持續在各級單位均實施ESHS管理體系，並涵蓋旗下所有員工、駐場第三方承包商及分包商，以規範各個環節的內部管理及風險管控，並持續優化完善管理體系和強化應急能力，推動可持續發展。該體系亦同時保障項目對當地環境、安全、健康和社會方面的影響被降至最低。

The Group is determined on disclosing transparent, reliable and consistent operation performance information to the public by proactively uploading such information to its corporate website or any other websites designated by the government authorities for public checking and scrutiny, including environmental impact assessment reports, annual environmental monitoring plans, environmental emergency preparedness and response plans, and monitoring results of effluent discharge/odour emissions/noise/sludge, etc. This demonstrates the Group's willingness to undertake greater social and environmental responsibilities and accept public scrutiny to actively promote sustainable development.

Furthermore, to respond to the national initiatives, the Group has been active at the forefront of environmental science popularisation and education enhancing the public awareness of water environmental protection and the soft power of community sustainable development. The Group continued opening up its waste water treatment facilities and plant areas to the public, enhancing its role as an environmental protection publicity base which integrates public visits, practice and training. Provided that the local requirements relating to pandemic prevention and control are complied with and all the safety measures are in place, certain projects have resumed physical visits by the public. In FY2021, a total of 31 projects of the Group had been officially opened to the public and received 9,430 visitors in 267 batches in aggregate. The Group continues actively organising public visits through both online and offline methods. In particular, the Group offered the public to virtually visit its waste water treatment facilities by using various methods, such as: uploading videos to the official media, playing pre-recorded videos and live streaming, for a wider outreach. Such methods attracted more than 550,000 online views during FY2021. At the same time, the Group, in collaboration with local environmental protection, technology associations and government organisation, encourages the public to treasure and conserve water and gain environmental protection knowledge. Such activities also aimed to enhance public awareness and responsibility relating to environmental protection. A total of 13 projects of the Group were awarded with the honorary titles of "Environmental Education Hub" or "Science Popularisation and Education Hub" at the national, provincial and municipal levels and 2 projects were awarded with the title of "Open Day Promotion and Education Centre".

本集團堅持為公眾披露透明、可靠和一致的運營表現，將相關項目運營環境信息上載到本公司網站或當地政府主管部門指定的網站供公眾查閱和監督，包括環評報告、年度環境監測計劃、突發環境事件應急預案、廢水/廢氣/噪聲/污泥監測結果等，展示出本集團勇於承擔更多社會及環境責任，接受來自公眾的監督，積極推動可持續發展。

此外，本集團積極響應國家號召，長期活躍在環保科普教育的前沿，增強公眾在水資源領域的環保意識，提升社區可持續發展軟實力。本集團將旗下污水處理設施及廠區打造集參觀、實踐、培訓為一體的環保宣傳基地，持續面向公眾開放。根據當地疫情防控政策要求，在確保安全的前提下，各公眾開放項目組織線下公眾開放接待參觀活動。於二零二一財政年度，本集團已有31個項目向公眾正式開放，這些項目共接待267批次公眾參觀，合計9,430人次。本集團繼續以線上線下相結合的方式積極實行公眾開放，通過官方媒體、視頻錄製播放、現場直播等多種方式進行污水處理設施「雲開放」，擴大線上參觀受眾面。於二零二一財政年度，線上參觀瀏覽人數超過55萬人次；同時聯同當地環保、科技協會及政府機構等展開環保教育活動，號召廣大民眾惜水愛水及增加環保科普知識，激發公眾參與環境保護的意識和責任感。本集團共有13個項目獲封為國家、省、市級「環境教育基地」或「科普教育基地」，另有2個項目榮獲「公眾開放宣傳教育中心」榮譽稱號。

ENVIRONMENTAL AND SOCIAL POLICIES

In response to the requirements on ecological environmental protection in the “14th Five-Year Plan” issued by the PRC government, and the commitment to progressively reduce carbon emissions after reaching its peak, the Group bears the important responsibility in promoting green development, ecological environmental protection and efficient water management. The Group has established a sound enterprise operations management system to enhance its operational efficiency and ensure the continuous provision of efficient and high-quality water environment management services, contributing to the country's ecological civilisation and sustainable development.

The Group has always been committed to fulfilling its corporate social responsibility. By actively and fully implementing the ESHS Management System and the Risk Management System at all levels, the environmental, occupational health and safety risks encountered by each project company are effectively managed. Comprehensive and standardised contingency plans have been established to ensure more stable operations. The Group has extended its corporate social responsibility management into its contractor management. In order to identify and control the relevant environmental, social and safety risks derived from the contracted work process, the Group has also specifically formulated and implemented the *Contractors ESHS Management Measures*. Such measures require the Group to review the contractors in different aspects, including background, qualifications, construction operations and environmental performance.

The Group firmly adheres to the concepts of corporate social responsibility and green operations. The Group has been actively evaluating its environmental and social performance against internationally recognised standards, including the World Bank Group's *Environmental, Health, and Safety Guidelines*, and has been submitting annual monitoring reports to International Finance Corporation since 2016. Such monitoring reports cover all projects of the Group, including projects in the preparatory stage, projects under construction, projects that completed construction and projects in operation. All of the Group's projects have obtained or are actively applying for international management standard certificates, including ISO 9001 Quality Management System, ISO 14001 Environmental Management System and ISO 45001 Occupational Health and Safety Management System.

SUSTAINABLE DEVELOPMENT STRATEGIES TO ADDRESS CLIMATE CHANGE

應對氣候變化的可持續發展戰略

Climate change affects all regions around the world. Storms, floods and droughts caused by extreme weather have occurred more frequently with higher magnitude in recent years. To improve the Group's resilience against climate change, the Group has included climate change risk into its Risk Management System to formulate more comprehensive emergency and natural disaster contingency plans.

The Group understands that climate change will bring various risks to the Group's business. Physical risks, such as water stress, floods and extreme weather, will cause damage and negative impacts on its assets and supply chains; transition risks, such as policy changes and reputation risk may also cause potential financial impacts to the Group. Everbright Water is proactively taking actions to address the impacts of climate change. The Group is committed to reducing and offsetting greenhouse gas emissions and enhancing the resilience of the Group and its projects against climate change. In addition, the Group seizes relevant opportunities to build a cleaner water environment in order to enhance cities' climate resilience and contribute to sustainable development.

Through a series of comprehensive water environment management services, the Group actively participates in constructing sustainable cities, creates a better ecological environment and enhances cities' overall resilience to floods. The Group's Jiangsu Zhenjiang Sponge City Construction PPP project was shortlisted as Top 5 in the Building Back Better Infrastructure Award by the United Nations Economic Commission for Europe and awarded an Honorary Mention during the year under review. This represents an affirmation of the Group's excellent performance in environmental sustainability and response and adaptation to climate change. By adopting the concept of "sponge city", such project controls surface runoff and relieves pressure on urban river channels, thereby improving the city's ability in absorption, infiltration, retention, release and purification of rainwater and enhancing the city as an urban ecosystem. The project was included in the PPP project database of the Jiangsu Provincial Department of Finance in 2015. It is one of the provincial-level pilot projects in Jiangsu Province and was successfully selected as a national PPP demonstration project as recommended by the Jiangsu Provincial Department of Finance.

Everbright Water actively implements carbon reduction strategy. During the year under review, the Group established special teams for various topics such as carbon reduction, in-plant photovoltaics and waste water source heat pumps, to carry out related policy studies, research and pilot projects. During the year under review, the Group's first in-plant photovoltaic facility started operation in Shandong Zibo Waste Water Treatment Project (Plant 1) and was connected to the grid for power generation. In addition, the Group's waste water treatment plants have become pilot projects for the monitoring of greenhouse gas emissions by the Ministry of Ecology and Environment of the PRC, contributing to the improvement of the energy structure and carbon emission reduction work plan of waste water treatment plants.

氣候變化影響全球，極端天氣引致的暴風雨、水災和旱災等近年在世界各地更頻密地發生，威力亦倍增。為提升本集團的氣候變化適應力，本集團將氣候變化風險納入現有的風險管理體系中，以制定更完善的緊急與自然災害應變方案。

本集團深明氣候變化對本集團的業務帶來多種風險，如用水壓力、洪水及極端天氣等實體風險，會對資產及供應鏈造成破壞和負面影響；政策變更及聲譽等轉型風險，亦會造成潛在的財務影響。光大水務積極採取行動應對氣候變化帶來的衝擊。本集團致力降低及抵銷溫室氣體排放、增強本集團及旗下項目對氣候變化的適應力，並抓住相關機遇，務求建立更清潔的水環境，為提升城市的氣候變化抵禦力及促進可持續發展做出貢獻。

本集團透過一系列的水環境綜合治理服務，積極參與建設可持續城市，創建更優質的生態環境，整體加強城市應付水患的抗禦能力。本集團旗下的江蘇鎮江海綿城市建設PPP項目更於回顧年度內入圍聯合國歐洲經濟委員會「更好重建」基礎設施獎項評選五強，並獲頒榮譽提名獎，充分肯定其應對環境可持續性、氣候變化及適應性等方面的優良表現。該項目採用「海綿城市」的理念，透過建立控制表面徑流和防洪排澇的系統，提升城市對雨水的吸納、蓄滲、緩釋和淨化能力，加強城市生態系統功能。此項目於二零一五年被列入江蘇省財政廳PPP項目庫，是江蘇省省級試點項目之一，並經江蘇省財政廳推薦成功入選國家PPP示範項目。

光大水務積極實踐減碳戰略，本集團於回顧年度內組建了碳減排、廠內光伏、污水源熱泵等專項小組，展開一系列政策學習、調查研究、試點項目等工作。回顧年度內，光大水務旗下首個廠內光伏設施於山東淄博污水處理項目（一廠）開始運行，並正式併網發電。此外，本集團旗下的污水處理廠已成為國家生態環境部溫室氣體排放監測試點，為完善污水處理廠能源結構和碳減排工作方案作出貢獻。

ENVIRONMENTAL PERFORMANCE

Amidst the increasingly challenging environmental issues, the Group has aligned itself with the national directions and strictly complied with the environmental regulations and discharge standards. Focusing on the water environment management, the Group's projects cover the entire industry chain in the water business, including raw water protection, water supply, municipal waste water treatment, industrial waste water treatment, reusable water, river-basin ecological restoration, and sludge treatment and disposal. The Group's projects are equipped with online effluent monitoring systems, and qualified third-party laboratories are commissioned to test the water discharge samples regularly to ensure their consistent compliance with the relevant discharge standards. The Group continued to improve China's waterbody conditions and facilitate enhancement on its sanitation standards through various business developments such as the implementation of "Intelligent Water" and enhancement of water resource protection measures, thereby significantly reducing the environmental impact caused by waste water effluent and safeguarding the health and well-being of the public.

Waste Water and Waste Management

The Group applies stringent discharge standards to its waste water treatment projects. Through continuous upgrading works, water discharged from all of the Group's waste water treatment projects complies with the requirements as stipulated in the environmental impact assessment reports approved by the local governments, whilst the effluent quality of projects in operation complying with or beyond Grade 1A standard of *Discharge Standard of Pollutants for Municipal Wastewater Treatment Plants* (GB18918-2002). During the year under review, the Group treated 1,698,710,000 m³ of waste water and reduced approximately 417,371 tonnes of chemical oxygen demand (COD) discharge.

In addition, the Group's reusable water projects purify effluent discharged from waste water treatment plants in accordance with the *Reuse of Urban Recycling Water-Water Quality Standard for Industrial Uses* (GB/T19923-2005) or equivalent standards. To reduce freshwater consumption in cities, reusable water produced by reusable water projects can be used as in-plant cooling water or for general industrial use by other corporations. During the year under review, the Group's reusable water projects produced 28,530,000 m³ of reusable water.

Sludge Management

Apart from treating the sludge produced by its waste water treatment plants in accordance with the national standards such as *Discharge Standard of Pollutants for Municipal Wastewater Treatment Plant* (GB18918-2002), the Group also adopts relevant international standards including the World Bank Group's *General Environmental, Health, and Safety Guidelines* and *Environmental, Health, and Safety Guideline for Water and Sanitation* to reduce environmental impacts of sludge treatment and disposal.

Most of the treated sludge with satisfactory testing results is sent to qualified third-parties for further treatment, reuse and/or utilisation, such as utilisation as construction materials and incineration. A small amount of sludge is sent to designated landfills for disposal after undergoing dewatering process for the reduction of water content and volume.

污水及廢物管理

本集團為旗下所有污水處理項目訂立嚴格的排放標準，透過持續的提標改造工程，在符合政府部門批准的環境影響評估報告相關要求的基礎上，各運營項目出水指標均符合或優於《城鎮污水處理廠污染物排放標準》(GB18918-2002)的一級A標準。於回顧年度內，本集團共處理了約1,698,700,000立方米污水，同時減少了大約417,371噸的化學需氧量排放。

此外，本集團將污水處理廠處理後的出水供給中水回用項目，將其按照《城市污水再生利用工業用水水質》(GB/T19923-2005)或同等標準淨化成回用水，用作廠區冷卻水或供其他企業作一般工業用途，從而減少城市的淡水消耗。於回顧年度內，本集團的中水回用項目共生產了約28,530,000立方米的回用水。

污泥管理

除嚴格按照《城鎮污水處理廠污染物排放標準》(GB18918-2002)等有關國家標準處理污水處理項目所產生的污泥外，本集團還將世界銀行集團的《通用環境、健康和安全管理指南》及《水與衛生環境、健康與安全管理指南》等相關國際標準納入考慮，以減少污泥處理與處置對環境的影響。

大部分經處理並檢測合格的污泥會被送到合資格的第三方污泥處理處置單位作進一步處理、循環再用及/或作綜合利用，如建材利用、焚燒等。小部分污泥則先進行脫水處理，在降低含水量及體積後再送到指定填埋場作填埋處理。

The Group emphasises the importance of innovation and transformation in corporate development, and having an excellent team is the key to achieving innovation and development. The Group has been adhering to the “People-Oriented” philosophy and pays great attention to talent development in achieving mutual success between the teams and leaders. Through a sound human resources management system, the Group provides employees with attractive career development opportunities and a caring working environment. The Group’s *Staff Handbook* and *Code of Conduct* cover topics including compensation and dismissal, recruitment and promotion, working hours, rest days, equal opportunity, diversity, anti-discrimination, the prevention of child labour and forced labour, and other benefits and welfare. The policies also advocate a fair and open workplace and ensure that employees are protected from all forms of discrimination against gender, age, race, nationality, marital status, religions, etc.

HEALTH AND SAFETY

健康與安全

With its priority on safe production, the Group is committed to avoiding non-compliance and ensuring each operational milestone of the Group are achieved, thereby safeguarding the health and safety of its employees and the public.

The Group has implemented a comprehensive ESHS Management System to monitor the operational safety and occupational health of employees at projects in operation and under construction. ESHS management teams have been established at every project company to ensure continuous management on safe production and enhance the awareness on risk prevention. Furthermore, the Group extends the ESHS Management System to its supply chain by clearly stating relevant occupational health and safety requirements in the supplier contracts, thus monitoring the health and safety performance of its key suppliers.

In order to further enhance the safety and environmental awareness of personnel in various positions, the Group is determined to carry out the “Safe Production Month” every year at the project level. To achieve the goal of “zero work safety accident, zero excessive discharge of pollutants, and zero case for violations of regulations and discipline” and enhance the safety and environmental awareness of the employees, the Group organised various online safety and environmental knowledge competitions, themed lectures, training, safety inspections, emergency drills, etc.

In addition, the Group protected its employees’ health by providing annual medical check-ups and occupational disease prevention inspections. Moreover, the Group set up an Employee Safeguard and Safety Fund, which can be disbursed upon application to support employees who suffer from accidents or diseases, relieving the financial burden of their families.

The Group achieved zero work-related injuries during the year under review.

As at 31 December 2021, a total of 31 projects of the Group had been officially opened to the public. In FY2021, these projects received 9,430 visitors in 267 batches in aggregate. The Group continued to launch various online and offline activities. Due to the pandemic restrictions, the Group offered the public to virtually visit its waste water treatment facilities through "Cloud Opening" by using various methods, such as: uploading videos to the official media, playing pre-recorded videos and live streaming, for a wider outreach. In FY2021, the online activities attracted more than 550,000 online views. At the same time, the Group, in collaboration with local environmental protection, technology associations and government organisation, organised environmental education activities to encourage the public to treasure and conserve water and gain environmental protection knowledge. Such activities also aimed to enhance public awareness and responsibility relating to environmental protection. The Group has achieved its goals in public education via opening its projects to the public. In line with the national strategies, the Group has also participated actively in domestic and international activities related to environmental technologies, established policies on open day activities and encouraged employees to practise low-carbon living.

China Everbright Water Limited (“**Everbright Water**” or the “**Company**”, together with its subsidiaries, the “**Group**”) is committed to achieving high standards of corporate governance to ensure investor confidence in the Company as a trusted business enterprise. The board (the “**Board**”) of directors (the “**Directors**”) and the management of the Company (the “**Management**”) will continue to uphold good corporate governance practices to enhance long-term value and returns for the shareholders of the Company (the “**Shareholders**”) and protect the Shareholders’ interests.

This report outlines the Company’s corporate governance practices for the financial year ended 31 December 2021 (“**FY2021**” or the “**year under review**”) with specific reference made to the principles and provisions of the Code of Corporate Governance 2018 (the “**SG CG Code**”), which forms part of the continuing obligations of the listing manual (the “**SGX Listing Manual**”) of Singapore Exchange Securities Trading Limited (“**SGX**” or “**SGX-ST**”). Throughout FY2021, the Company has complied with the principles and provisions of the SG CG Code unless otherwise specified herein.

Since the listing of the Company’s ordinary shares on the Main Board of the Stock Exchange of Hong Kong Limited (the “**SEHK**”) on 8 May 2019, the Company has adopted the principles and code provisions of the Corporate Governance Code (the “**HK CG Code**”) as set out in Appendix 14 to the Rules Governing the Listing of Securities on the SEHK (the “**SEHK Listing Rules**”) as part of its governance framework, in addition to the principles and provisions under SG CG Code. In the event of any conflicts between the SG CG Code and the HK CG Code, the Company will comply with the more stringent requirements. Throughout FY2021, the Company has complied with the principles and code provisions of the HK CG Code.

(A) BOARD MATTERS

The Board’s conduct of its affairs

The Board is collectively responsible for the long-term success of the Company. Its key responsibilities include providing leadership and supervision to the Management with a view to protecting the Shareholders’ interests and enhancing long-term Shareholders’ value.

All Directors recognise that they have to discharge their duties and responsibilities at all times as fiduciaries who act objectively in the best interest of the Company and hold the Management accountable for performance, and the Board is accountable to the Shareholders through effective governance of the business.

自本公司普通股於二零一九年五月八日在香港聯合交易所有限公司（「**聯交所**」）主板上市以來，除了新加坡企業管治守則的原則和條款，本公司已採納聯交所證券上市規則（「**聯交所上市規則**」）附錄十四所載企業管治守則（「**香港企業管治守則**」）中的原則和守則條文，作為其管治框架的一部分。若新加坡企業管治守則和香港企業管治守則有任何衝突，本集團將遵守更嚴格的要求。於二零二一財政年度內，本公司已遵守香港企業管治守則的全部原則和守則條文。

(A) 董事會的運作

- (6) reviewing the Management's performance;
- (7) approving annual budgets and investment and divestment proposals;

All Directors exercise due diligence and independent judgment, and are obliged to act in good faith and consider at all times the interest of the Company.

The Board meets regularly, at least on a quarterly basis (four times a year). Ad-hoc meetings are held at such times, as and when required, to address any specific significant matters that may arise. In FY2021, the Board held six meetings in total. In respect of the regular meetings of the Board, all Directors are given the opportunity to include matters in the agenda. In addition, formal notices and agenda are sent to all Directors at least 14 days before the respective meetings. For all other Board and Board Committee (defined below) meetings, a reasonable notice is generally given. In general, the detailed meeting materials for each agenda (including meeting papers and explanatory or background information) are sent to the Board or the Board Committees at least three days before the meeting to ensure that the Directors or the members of the Board Committees have sufficient preparation time for the meetings. The minutes of the Board and the Board Committee meetings are recorded with sufficient details regarding the matters considered and decisions reached. Draft and final versions of the minutes are sent to all Directors or Board Committee members for comments and records within reasonable time after the meetings. The minutes of the Board and the Board Committee meetings are confirmed at the subsequent meetings. The original signed minutes are properly kept at the registered office or principal business address of the Company as required under the relevant laws, rules and regulations, and the minutes are open for inspection by the Directors and the Board Committee members, as the case may be.

During the Board meetings, the relevant Management personnel may be invited to make presentation and answer the Directors' queries on the relevant agenda, and the Directors are free to discuss and openly challenge the views presented by the Management and other Directors. The Chairman of the Board ensures that each agenda is allocated sufficient time for discussion and each Director is given sufficient opportunity to express his/her opinions. Where necessary, the Company also engages external consultants to provide professional opinions on specific projects or corporate exercises to facilitate the Board's decision-making process. The Board's decision-making process is an objective one. The Directors are given separate and independent access to the Management to address any enquiries. When necessary, the Directors can seek independent professional advice, concerning any aspect of the Group's operations or undertakings in order to fulfill their roles and responsibilities as Directors, at the Company's expense.

The Company has subscribed appropriate and sufficient insurance coverage on Directors' liabilities in respect of legal actions taken against the Directors arising from corporate activities.

Below are (i) the number of meetings and the Directors' attendance at the meetings of the Board, the Audit Committee, the Remuneration Committee, the Nominating Committee, the Strategy Committee, and the annual general meeting of the Company (the "AGM"), held during FY2021; and (ii) the number of meetings and the Directors' attendance at the meetings of the Management Committee⁽¹⁾ held during the period from 1 January 2021 up to 11 August 2021.

Board Authority and Delegation

The Board approves a document, known as the Board Authority Matrix, with guidelines setting forth the matters reserved for the Board’s decision and clear directions to the Management on matters that must be approved by the Board. The Board Authority Matrix is reviewed by the Board at least once a year and revised accordingly when necessary. The matters reserved for the Board’s decision include but are not limited to changes in share capital, acquisitions and disposals of assets with value exceeding certain threshold, venturing into non-core business, setting up of joint venture with value or shareholding exceeding certain threshold, corporate or financial restructuring, obtaining borrowings exceeding certain threshold, appointment of key management personnel, decision on major legal actions, share issuance and dividends, financial results, annual budget and corporate strategies. The Board will provide directions to the management teams of the Group’s business divisions through presentations at Board and Board Committee meetings.

The Board sits at the top of the Company’s governance framework. To execute its responsibilities, the Board delegates specific functions to its committees (the “Board Committees”), currently comprising the Nominating Committee, the Remuneration Committee, the Audit Committee and the Strategy Committee. The Management Committee has ceased to be a Board Committee with effect from 11 August 2021. The Board Committees function within written terms of reference and operating procedures, which are reviewed on a regular basis. The terms of reference of each of the Board Committees are available on the SGXNet and the websites of the Company and Hong Kong Exchanges and Clearing Limited (“HKEX”). Each of the Board Committees reports its activities regularly to the Board. Please refer to the other sections of this Corporate Governance Report for further information on the activities of the Board Committees.

Directors' Orientations and Trainings

The current members of the Board are familiar with the Group's business operations and corporate governance practices. In particular, a majority of the Directors (including a majority of Independent Non-Executive Directors) have more than eight years' experience serving as an executive officer or a director of a company in the environmental protection industry. The Nominating Committee (the "NC") ensures that new Board appointees are provided with trainings and information to familiarise themselves with the Group's business, strategic goals and directions and corporate governance practices.

Upon the appointment of a new Director, the Company will provide a formal letter to the Director, setting out his/her duties and obligations. Such Directors are given appropriate briefings when they are first appointed to the Board. Appropriate orientations are conducted for all new Directors appointed to the Board to ensure that they are familiar with the Company's business, operations, governance practice and regulatory requirements. The Joint Company Secretaries or the external lawyers also provide trainings to the new Directors on his/her duties and responsibilities as a Director and the Company's ongoing obligations as a company listed on both SGX and SEHK. If the newly-appointed Director has no prior experience as a director of an SGX-listed company, he/she is also required to attend courses and training organised by institutions such as the Singapore Institute of Directors and the SGX-ST. During FY2021, as the newly-appointed Directors, Mr. Hu Yanguo and Mr. Tao Junjie have attended the trainings organised by Singapore Institute of Directors.

The Company provides ongoing education on Board procedures, corporate governance practices and industry developments to all Directors. The Company also invites external experts (such as auditors, lawyers, sustainability consultants, technical experts or other professionals) to provide regular trainings to the Directors and the Management on legal, financial, technical and business topics, depending on the Company's development needs. The Management further provides (i) monthly updates on the Group's performance, position and prospects; and (ii) regular updates on changes in the relevant laws, regulations and commercial risks, to enable the Directors to make well-informed decisions and to ensure that the Directors are competent in carrying out their respective roles and responsibilities. The Company also arranged project site visits for the Directors. At the same time, the Directors are encouraged to keep themselves abreast of the latest developments relevant to the business of the Group.

Company Secretaries

The Joint Company Secretaries are accountable to the Board for ensuring that Board policy and procedures are followed and Board activities are efficiently and effectively conducted. They also advise the Board on governance matters and facilitate the induction and professional development of the Directors. Ms. Peng Pei and Ms. Ho Wing Tsz Wendy have been appointed as the Company's Joint Company Secretaries. Ms. Peng Pei has been the Legal Counsel and Company Secretary of the Company since 20 January 2017, and she is a full-time employee of the Company. She is mainly responsible for the legal and company secretarial matters of the Group. Although she reports to the Chairman of the Board and the CEO, all the Directors may call for her assistance and advice at any time in respect of their duties, so as to ensure effective operation of the Board and the Board Committees.

Ms. Ho Wing Tsz Wendy, an executive director of corporate services division of Tricor Services Limited, which is a global professional services provider specialising in integrated business, corporate and investor services, has been engaged by the Company as one of its Joint Company Secretaries. Her primary contact person at the Company is Ms. Peng Pei, the Legal Counsel and Joint Company Secretary of the Company. During FY2021, Ms. Ho has undertaken not less than 15 hours of relevant professional training in compliance with Rule 3.29 of the SEHK Listing Rules.

At least one of the Joint Company Secretaries attends all Board meetings and Board Committee meetings and ensures that they are conducted in accordance with the Bye-laws and the relevant rules and regulations. The appointment and removal of any Joint Company Secretary are subject to the approval of the Board. The Joint Company Secretaries, under the direction of the Chairman of the Board, ensure good information flows within the Board and the Board Committees and between the Management and the Independent Non-Executive Directors.

聯席公司秘書向董事會負責，確保董事會的政策和程序得到遵守以及董事會工作得以有效開展。聯席公司秘書也向董事會提供關於所有管治事項的意見，協助為董事安排任職培訓及專業發展項目培訓。彭珮女士與何詠紫女士已獲聘任為本公司的聯席公司秘書。彭珮女士自二零一七年一月二十日起便擔任本公司的法律顧問兼公司秘書，她是本公司的全職僱員。她主要負責本集團的法律和公司秘書事宜。雖然她向董事長和總裁匯報工作，但所有的董事均可在任何時候聯絡她，讓她協助董事履行職務或對此提供意見，以確保董事會和董事會委員會的有效運作。

何詠紫女士是卓佳專業商務有限公司企業服務部門的執行董事。該公司是一家全球專業服務提供商，專注於提供商業、企業和投資者綜合服務。彼獲聘請為本公司的聯席公司秘書，其在本公司的主要聯繫人為本公司法律顧問兼聯席公司秘書彭珮女士。於二零二一財政年度內，何女士已接受不少於15小時的相關專業培訓，遵守了聯交所上市規則第3.29條的規定。

至少一名聯席公司秘書出席本公司的所有董事會會議和董事會委員會會議，以確保這些會議根據本公司章程和相關法律法規的規定召開。聯席公司秘書的任免須經過董事會批准。在董事長的指導下，聯席公司秘書確保董事會、董事會委員會、管理層和獨立非執行董事之間形成良好的信息流通。

Board Composition and Balance

The Company has a Board with a balanced composition of Executive and Independent Non-Executive Directors. The Board currently comprises seven Directors, with four Directors being Independent Non-Executive Directors. The Directors as at the date of this Annual Report are:

- (i) Mr. Hu Yanguo (Executive Director & Chairman of Board);
- (ii) Mr. Tao Junjie (Executive Director & CEO);
- (iii) Mr. Luo Junling (Executive Director & CFO);
- (iv) Mr. Zhai Haitao (Independent Non-Executive Director);
- (v) Mr. Lim Yu Neng Paul (Independent Non-Executive Director);
- (vi) Ms. Cheng Fong Yee (Independent Non-Executive Director); and
- (vii) Ms. Hao Gang (Independent Non-Executive Director).

An updated list of the Directors with their respective roles and functions is available on the SGXNet and the websites of the Company and HKEX. Independent Non-Executive Directors are identified in all corporate communications that disclose the names of Directors.

In addition, none of the members of the Board is related to one another during FY2021.

Below are the changes in the composition of the Board during FY2021:

- (1) Mr. Wang Tianyi resigned as an Non-Executive Director, the Chairman of the Board, the chairman of the Strategy Committee, a member of the Remuneration Committee and a member of the Nominating Committee with effect from 5 October 2021;
- (2) Mr. Hu Yanguo was appointed as an Executive Director, the Chairman of the Board, the chairman of the Strategy Committee, the chairman of the Management Committee, and a member of the Nominating Committee with effect from 5 October 2021;
- (3) Mr. An Xuesong resigned as an Executive Director, the CEO, the chairman of the Management Committee and a member of the Strategy Committee with effect from 5 October 2021; and
- (4) Mr. Tao Junjie was appointed as an Executive Director, the CEO, the vice-chairman of the Management Committee and a member of the Strategy Committee with effect from 5 October 2021.

董事會的組成和平衡

本公司由執行董事和獨立非執行董事均衡地組成其董事會。董事會目前由七名董事組成，其中包括四名獨立非執行董事。於本年度報告日，董事會由下列人員組成：

- (i) 胡延國先生（執行董事兼董事長）；
- (ii) 陶俊杰先生（執行董事兼總裁）；
- (iii) 羅俊嶺先生（執行董事兼首席財務官）；
- (iv) 翟海濤先生（獨立非執行董事）；
- (v) 林御能先生（獨立非執行董事）；
- (vi) 鄭鳳儀女士（獨立非執行董事）；以及
- (vii) 郝剛女士（獨立非執行董事）。

本公司之最新董事名單已載於SGXNet、本公司及港交所的網站上，其中明確了董事角色及職能。本公司在所有載有董事姓名的公司通訊中，已註明獨立非執行董事的身份。

此外，於二零二一財政年度內，董事會成員之間概無任何關聯關係。

以下是二零二一財政年度內董事會組成的變更情況：

- (1) 王天義先生自二零二一年十月五日起辭任非執行董事、董事長、戰略委員會主席、薪酬委員會委員及提名委員會委員；
- (2) 胡延國先生自二零二一年十月五日起獲委任為執行董事、董事長、戰略委員會主席、管理委員會主席及提名委員會委員；
- (3) 安雪松先生自二零二一年十月五日起辭任執行董事、總裁、管理委員會主席及戰略委員會委員；以及
- (4) 陶俊杰先生自二零二一年十月五日起獲委任為執行董事、總裁、管理委員會副主席及戰略委員會委員。

The Board has determined that it is of an appropriate size, structure and composition to facilitate effective decision-making, and to meet the objective of having a balance of skills and experiences, taking into account the size and scope of the Company's operations.

Independence of Directors

The independence of each Director is assessed and reviewed annually by the NC based on the definition of independence as provided in the SG CG Code, SGX Listing Manual and SEHK Listing Rules. The Board and the NC consider an independent director as one who is independent in conduct, character and judgement and has no relationship with the Group, its related corporations, its 5% shareholders or its officers that could interfere, or be reasonably perceived to interfere, with the exercise of the Director's independent business judgment in the best interest of the Company and the Group.

Each Independent Non-Executive Director is required to complete a Director's Independence Checklist annually to confirm his/ her independence based on the guidelines as set out in the SGX Listing Manual and SG CG Code. The Company has also received from each of the Independent Non-Executive Directors an annual confirmation on his/her independence as required under Rule 3.13 of the SEHK Listing Rules. For FY2021, the NC has determined that all the Independent Non-Executive Directors are independent.

In particular, Mr. Zhai Haitao is also an independent non-executive director of the Company's controlling shareholder China Everbright Environment Group Limited ("**Everbright Environment**"), but he is not involved in the daily management and operation of Everbright Environment. The NC and the Board determined that Mr. Zhai Haitao is independent in conduct, character and judgment and his role as independent non-executive director of Everbright Environment will not affect his judgment as Independent Non-Executive Director of the Company.

Mr. Lim Yu Neng Paul and Ms. Cheng Fong Yee were appointed as Independent Directors of the Company in July 2007. Since then, the Company experienced changes in controlling shareholders and the management teams twice. The current controlling shareholder, Everbright Environment, only gained control of the Company in December 2014 and the current management team and executive officers joined the Company following that change. Thus, although Mr. Lim Yu Neng Paul and Ms. Cheng Fong Yee served the Board beyond nine years from the date of their appointment, both the NC and the Board held the view that they remain independent in conduct, character and judgement.

董事會認為，考慮到本公司的經營規模和範圍，目前董事會的人數、結構和構成是適當的，這有利於董事會作出有效的決策並在各領域擁有平衡兼顧的技能和經驗。

董事的獨立性

提名委員會每年根據新加坡企業管治守則、新交所上市手冊和聯交所上市規則中的定義評估和審閱各名董事的獨立性。若一名董事在其行為、品格及判斷方面具獨立性且與本集團，或與本集團的關聯企業、擁有本集團5%股份的股東或其管理人員之間的關係不會干擾到或被合理認為不會干擾到該董事為本公司和本集團的最佳利益行使獨立商業判斷，則董事會和提名委員會視該董事為獨立董事。

每名獨立非執行董事須每年填寫董事獨立調查清單，以確認其按照新交所上市手冊和新加坡企業管治守則的要求具有獨立性。根據聯交所上市規則第3.13條的規定，本公司亦已收到每名獨立非執行董事關於獨立性的年度確認函。在二零二一財政年度，提名委員會認為所有的獨立非執行董事均是獨立的。

其中，翟海濤先生也是本公司的控股股東中國光大環境（集團）有限公司（「**光大環境**」）的獨立非執行董事，但他並不參與光大環境的日常經營管理。提名委員會和董事會認為，翟海濤先生在行為、品格和判斷方面具有獨立性，他作為光大環境獨立非執行董事的角色不會影響他作為本公司獨立非執行董事的判斷。

林御能先生和鄭鳳儀女士在二零零七年七月被任命為本公司的獨立董事。自那時起，本公司經歷了兩次控股股東和管理團隊的變化。目前的控股股東光大環境在二零一四年十二月才取得本公司的控制權，目前的管理團隊和執行人員也是繼該次變更之後才加入本公司。因此，雖然林御能先生和鄭鳳儀女士在董事會的任期自委任之日起已超過九年，但提名委員會和董事會認為他們在行為、品格和判斷方面仍具有獨立性。

In addition, Ms. Hao Gang, who was appointed in March 2018 as the Independent Director, has no relationship with the Group, its related corporations, its 5% shareholders or its officers that could interfere, or be reasonably perceived to interfere with the exercise of her independent business judgement in the best interest of the Company and the Group. Therefore, the NC and the Board considered Ms. Hao Gang to be independent.

The Board and the NC will undertake more rigorous review annually on the independence of any Director who has served the Board beyond nine years, and in doing so, the Board will also take into account the need for progressive refreshing of the Board. In addition, when a director who has served the Board beyond nine years seeks for continued appointment as an independent director, his/her re-appointment will also be subject to more stringent Shareholders' resolutions mechanism in accordance with the requirements under the SGX Listing Manual and SEHK Listing Rules. The continued appointment of Mr. Lim Yu Neng Paul and Ms. Cheng Fong Yee (both have served the Board beyond nine years) as the Independent Directors have been approved by the Shareholders during the AGM held in FY2021 in accordance with Rule 210(5)(d)(iii) of the SGX Listing Manual.

The Board is able to exercise objective judgment on corporate affairs independently from the Management. No individual or group of individuals is allowed to dominate the Board's decision-making. Currently, a majority of the Board members are Independent Non-Executive Directors. The Board has complied with the requirements of SG CG Code that the independent directors make up a majority of the Board where the chairman of the Board is not independent. The Company has also met the requirements of Rule 3.10 of the SEHK Listing Rules relating to the appointment of at least three Independent Non-Executive Directors with at least one of them possessing appropriate professional qualifications, accounting or related financial management expertise. The NC and the Board are thus of the view that there is sufficiently strong independent element on the Board to enable independent exercise of objective judgment on corporate affairs of the Group, taking into account factors such as the number of independent directors and the size and scope of the affairs and operations of the Group.

此外，郝剛女士自二零一八年三月獲委任為獨立董事，她與本集團或本集團的關聯公司、擁有本集團5%股份的股東或其管理人員之間不存在任何關係會干擾到或被合理認為干擾到她為本公司和本集團的最佳利益而行使獨立的商業判斷。因此，提名委員會和董事會認為郝剛女士也具有獨立性。

對於在本公司任職超過九年的董事，董事會在審閱其獨立性時採用更加嚴格的標準，也會考慮到董事會逐步更新其人員組成的需求。此外，在董事會累計任職超過九年的董事當尋求續聘為獨立董事時，也將根據新交所上市手冊及聯交所上市規則的要求受限於更嚴格的股東決議機制。林御能先生和鄭鳳儀女士（其董事任期自委任之日起已超過九年）已經於二零二一財政年度召開的股東週年大會上根據新交所上市手冊第210(5)(d)(iii)條的規定就其繼續擔任本公司獨立董事的事宜獲得股東批准。

董事會對公司事務能夠行使獨立於管理層的客觀判斷。任何個人或一組人均不可支配董事會的決策。本公司目前的董事會成員中超過半數為獨立非執行董事。董事會已遵守新加坡企業管治守則的要求，即：當董事長不是獨立董事時，半數以上的董事會成員需為獨立董事。本公司亦符合聯交所上市規則第3.10條的規定，即：聘有至少三名獨立非執行董事，其中至少一名擁有適當的專業資格、會計或財務管理相關的專業知識。提名委員會及董事會因此認為，鑒於獨立董事在董事會中所佔的人數以及本集團業務經營的規模和範圍，董事會目前的組成使董事會具有足夠的獨立性，並讓董事會的成員得以對本集團事務作出獨立客觀的判斷。

Furthermore, the Audit Committee (the “**AC**”), the Remuneration Committee (the “**RC**”) and the NC are chaired by Independent Non-Executive Directors. The AC and the RC currently comprise only Independent Non-Executive Directors and the majority of the NC members are also Independent Non-Executive Directors. The Company currently has no Lead Independent Director. Considering the Company’s current business operations and Board size of seven members with a majority being Independent Non-Executive Directors, the Company is of the view that the appointment of a Lead Independent Director for the year under review is not necessary. Nevertheless, the Board will annually examine the need for such appointment.

Independent Non-Executive Directors play an important role in the Board’s decision-making process. They constructively challenge and assist to develop proposals on strategy, review the performance of the Management in achieving targets and objectives, and monitor the reporting of performance. In particular, the Chairman of the Board ensures that each of the Independent Non-Executive Directors is given sufficient time to express his/her opinions during the Board meetings. During FY2021, the Chairman and the Independent Non-Executive Directors met at least once without the presence of the other Executive Directors and the Management.

Board Diversity

The Company recognises the importance of having a diverse Board in enhancing the Board effectiveness and corporate governance. Therefore, the Company has established the Board Diversity Policy to ensure the diversity of the Board members and balance of skills. A diverse Board will include and make good use of differences in the skills, industry knowledge and professional experience, cultural and education background and other qualities of the Directors and does not discriminate on the ground of race, age, gender or religious belief. These differences will be taken into account in determining the optimum composition of the Board and when possible should be balanced appropriately.

The NC has responsibility for identifying and nominating candidates for appointment to the Board and recommending the same to the Board for approval. It takes responsibility in assessing the appropriate mix of experience, expertise, skills and diversity required on the Board and assessing the extent to which the required skills are represented on the Board and overseeing the Board succession. The NC is also responsible for reviewing and reporting to the Board in relation to board diversity.

另外，審計委員會（「**審計委員會**」）、薪酬委員會（「**薪酬委員會**」）和提名委員會的主席均由獨立非執行董事擔任。審計委員會和薪酬委員會全部由獨立非執行董事構成，提名委員會的成員中超過半數是獨立非執行董事。本公司目前沒有聘任首席獨立董事。鑒於本公司目前的業務以及董事會七名成員中超過半數是獨立非執行董事，本公司認為在回顧年內並無必要聘任首席獨立董事。但董事會將每年審查是否需要作出該等聘任。

獨立非執行董事對於董事會的決策過程起到非常重要的作用。他們對戰略決策提出具有建設性的意見並協助擬定戰略方案，審閱管理層的表現是否達到預先設定的目標，並對其績效報告進行監督。具體而言，董事長將確保每名獨立非執行董事在每次董事會的會議中都擁有充足的時間表達其觀點。在二零二一財政年度內，董事長和獨立非執行董事在其他執行董事和管理層不在場的情況下進行了至少一次會面。

董事會多元化

本公司認可多元化的董事會對提高董事會效率和企業管治的重要性。因此，本公司制訂了董事會多元化政策，以確保董事會成員的多元化和技能的平衡性。多元化董事會應包括並充分利用董事們在技能、行業知識和專業經驗、文化和教育背景等方面的差異，不因種族、年齡、性別或宗教信仰而有所歧視。在決定董事會的最佳組成時，將考慮並盡可能地適當平衡這些差異。

提名委員會負責物色及提名董事會成員候選人，供董事會審批。提名委員會負責評估董事會所需要的經驗、專業知識、技能和多樣性，評估所需技能應在董事會所佔的比例，並監督董事會的繼任工作。提名委員會還負責審查董事會的多樣性並向董事會作出報告。

The current Board members comprise business leaders, industry experts, professionals and academia experts, with industry, accounting, financial, business, management and academic backgrounds. With two female Directors sitting on the Board, a majority of the Directors (including a majority of Independent Non-Executive Directors) have more than eight years' experience serving as an executive officer or a director of a company in the environmental protection industry. This composition and diversity of the Board enable the Management to benefit from a diverse and objective external perspective, on issues raised before the Board. Each Director has been appointed based on the strength of his/her calibre, expertise, experience and his/her potential contribution to the Group and its businesses. Profiles of the Directors are set out in the section entitled "Board of Directors" on pages 44 to 50 of this Annual Report.

Following a review of the Board's composition, expertise and experience, the NC and the Board are satisfied that the current Board composition is sufficiently diverse in terms of the gender, skills and experience. Therefore, the Board has not set any measurable objectives. Nonetheless, the NC will review the Board Diversity Policy and set any measurable objectives (if necessary) from time to time to ensure its diversity and effectiveness.

Chairman and CEO

The Board recognises the recommendation of SG CG Code and HK CG Code that the Chairman and the CEO should be separate persons to ensure that there is an appropriate balance of power and authority within the Company.

The Chairman of the Company is Mr. Hu Yanguo and the CEO is Mr. Tao Junjie. The Chairman bears the responsibility for the effective conduct of the Board whilst the CEO bears the executive responsibility for the operations of the Group's business. The Chairman and the CEO are not related to each other.

The Chairman is responsible for exercising control over the quality and timeliness of the flow of information between the Management and the Board and ensuring compliance with the Group's guidelines on corporate governance. The Chairman ensures that Board meetings are held regularly in accordance with the agreed schedule and sets the agenda of the Board meetings.

The Chairman also builds constructive relations within the Board and between the Board and the Management, and facilitates the effective participation of Independent Non-Executive Directors by promoting a culture of openness and debate of the Board. The Chairman further ensures effective communication with the Shareholders and promotes high standards of corporate governance.

目前的董事會成員由具有行業、會計、財務、業務管理和學術背景的商界領袖、行業專家、專業人士和學術界專家組成。本公司董事會擁有兩名女性成員，且超過半數的董事（包括超過半數的獨立非執行董事）在環保行業的公司擔任執行管理人員或董事的經驗超過八年。董事會的組成結構和多元化使管理層受益，提交到董事會的議題得以從多元客觀的外部視角接受審閱。每名董事均是按照其能力、專業知識、經驗及其對本集團、本集團的業務可能作出的貢獻而獲得聘任。各董事的背景介紹見本年度報告第44頁至第50頁所載的「董事會成員」一節。

在審閱了董事會的組成、專長和經驗後，提名委員會和董事會對目前的董事會在性別、技能及經驗方面的多元化感到滿意。因此，董事會並未針對董事會多元化制定任何量化指標。然而，提名委員會將不時審視董事會多元化政策以及訂定任何量化指標（如需），以確保其多元化及有效性。

董事長和總裁

董事會認可新加坡企業管治守則和香港企業管治守則中的建議，即董事長和總裁應由不同的人員擔任，以確保本公司內部在權力和授權方面達到適當平衡。

本公司的董事長是胡延國先生，總裁是陶俊杰先生。董事長負責董事會的有效運作，總裁負責本集團業務的具體經營。董事長和總裁彼此沒有關聯關係。

董事長負責控制管理層和董事會之間信息流通的質量和及時性，確保本集團遵守了其企業管治指引。董事長確保董事會按照擬定的會議時間表定期召開會議，並確定董事會會議的議程。

董事長也負責在董事會內部及董事會與管理層之間形成建設性的關係，通過坦率的溝通和董事會討論來鼓勵獨立非執行董事有效參與。董事長還會確保本公司與股東之間進行了有效溝通，並促進高水平的企業管治。

The duties of the CEO include taking responsibility for the Group's operation and management, implementing decisions and plans approved by the Board, making day-to-day operational and managerial decisions and coordinating overall business operations.

The Board is of the view that there are sufficient safeguards and checks to ensure that the process of decision-making by the Board is independent and based on collective decisions without any individual exercising any considerable concentration of power or influence.

Nominating Committee

The NC comprises:

- (i) Mr. Zhai Haitao (NC Chairman & Independent Non-Executive Director);
- (ii) Mr. Hu Yanguo (Executive Director & Chairman of Board); and
- (iii) Mr. Lim Yu Neng Paul (Independent Non-Executive Director).

Majority of the NC, including the NC Chairman, are Independent Non-Executive Directors.

The key terms of reference of the NC are as follows:

- (1) reviewing annually the structure, size and composition (including the skills, knowledge and experience) of the Board;
- (2) establishing procedures for, reviewing, assessing and making recommendations to the Board on the review of board succession plans for Directors, in particular, the Chairman, the CEO, and the key management personnel (as defined in the SG CG Code), the process and criteria for evaluation of the performance of the Board, the Board Committees and the Directors, the review of training and professional development programmes for the Board and the Directors, and the appointment and re-appointment of the Directors;
- (3) assessing the independence of Independent Non-Executive Directors while bearing in mind the circumstances set out in Rule 3.13 of the SEHK Listing Rules and Provision 2.1 of the SG CG Code and other salient factors;
- (4) deciding whether or not a Director is able to and has been adequately carrying out his/her duties as a Director, taking into consideration the Director's number of listed company board representations and other principal commitments;

總裁的職責包括負責本集團的運營和管理、執行董事會的決策及計劃、作出運營管理的日常決策及協調整體業務運營。

董事會認為，本公司具有充分的保障和檢查措施，以確保董事會的決策過程是獨立的，且其決策是經過集體討論而作出的，不受任何個人的嚴重干預或影響。

提名委員會

提名委員會由下列董事組成：

- (i) 翟海濤先生（提名委員會主席、獨立非執行董事）；
- (ii) 胡延國先生（執行董事兼董事長）；和
- (iii) 林御能先生（獨立非執行董事）。

提名委員會的大多數成員（包括提名委員會主席）是獨立非執行董事。

提名委員會的主要職權範圍如下：

- (6) reviewing training and professional development programmes for the Board.

The NC has adequate resources to perform and discharge its responsibilities properly. During FY2021, the members of the NC reviewed the (i) independence status of each of the Directors (including the Independent Non-Executive Directors); (ii) performance of each individual Director, each individual Board Committee and the Board as a whole; and (iii) re-election of the retiring Directors.

Board Membership

Where a vacancy arises under any circumstances, or where it is considered that the Board would benefit from the services of a new Director with particular skills, the NC, in consultation with the Board, determines the selection criteria and selects candidates with the appropriate expertise and experience for the position in accordance with its nomination policy. Besides the qualification and experience of each candidate, the NC takes into consideration the candidate's ability to increase the effectiveness and the diversity of the Board and to add value to the Company's business in line with its strategic objectives. Before appointment of any new Director, the NC conducts an interview with the candidate and holds a meeting to discuss the candidacy (and the independence, where applicable) of the candidate. If appropriate, the NC makes recommendation to the Board on the proposed appointment. The Board will then review and discuss the candidacy of the candidate, and if appropriate, approve the appointment of the new Director. The Company makes immediate announcement on any new appointment of Directors in accordance with the SEHK Listing Rules and SGX Listing Manual.

In considering the re-appointment of a Director, the NC evaluates such Director's contribution and performance, such as his/her attendance at meetings of the Board or the Board Committees (where applicable), participation, candour and any special contributions. Upon the NC's recommendation, the Board will review and if appropriate, approve the nomination of a Director for re-election for the Shareholders' approval at the AGMs.

Each Independent Non-Executive Director is appointed for a term of three years until 11 April 2022, subject to renewal.

All Directors (including the Chairman of the Board and the CEO) are subject to the provisions of the Bye-laws whereby:

- (a) each Director shall retire at least once every three years and shall be eligible for re-election (Bye-law 86(1)); and
- (b) any Directors appointed by the Board shall retire at the next AGM of the Company and shall be eligible for re-election (Bye-law 85(6)).

Mr. Hu Yanguo and Mr. Tao Junjie are subject to retirement pursuant to the Bye-law 85(6) at the forthcoming AGM. Mr. Luo Junling is subject to retirement pursuant to the Bye-law 86(1) at the forthcoming AGM. Following a review of their expertise, experience, overall contribution to the Company, the Board and/or Board Committee meetings, the NC and the Board recommended them be nominated for re-election at the forthcoming AGM and accordingly, the above-named Directors will be offering themselves for re-election. The relevant information on each of the above-named Directors can be found in the section entitled "Board of Directors" on pages 44 to 50 of this Annual Report and the Circular to Shareholders dated 22 March 2022.

All Directors are required to declare their board representations. When a Director has multiple board representations, the NC will consider whether he/she is able to adequately carry out his/her duties as a Director, taking into consideration such Director's number of listed company board representations, the efforts and time required for his/her other board representations and his/her other principal commitments.

The NC has reviewed and is satisfied that all Directors, who sit on multiple boards, have been able to devote sufficient time and attention to the affairs of the Company to adequately discharge their duties as Directors of the Company, notwithstanding their multiple board appointments. The NC did not recommend setting of limit as to the number of listed board representations that every Director can hold, as the time and efforts required for each board representation may vary, depending on the type of directorship (executive or non-executive). The Board will determine the maximum number of listed company board representations which any Director may hold as and when required.

There is no Alternate Director on the Board.

Board Performance

The Board and the NC have adopted a formal process for the assessment of the effectiveness of the Board as a whole, and of each Board Committee separately, as well as the contribution by the chairman and each individual Director to the effectiveness of the Board.

Following the end of each financial year, each of the Directors is requested to complete a Board Evaluation Questionnaire and a Director Self-Appraisal Form. Each of the NC members is also requested to complete a Board Committee Appraisal Form. The performance criteria for the Board as a whole include, amongst others, the Company's financial performance for that financial year, an evaluation of the size and composition of the Board, the Board's access to information, accountability, Board procedures and Board performance in relation to discharging its principal responsibilities. The assessment criteria for an individual Director include, amongst others, meeting attendance, adequacy in meeting preparation, generation of constructive ideas, leadership, keeping abreast of industry developments, and contribution in specific areas. The evaluation criteria for the Board Committees include, amongst others, committee composition, the contribution in assisting the Board for better decision-making, sufficiency of expertise of Board members, Board Committee chairman's performance in discharging responsibility, quality of Board Committee's communication with the Board. To facilitate the candour in providing feedback by the Directors in the appraisal process, all completed appraisal forms are sent to the Joint Company Secretaries directly for summarisation, and then the appraisal summaries (on a no-name basis) and findings are circulated to the NC for analysis and discussion during the NC meeting. The NC will then report its findings and recommendations to the Board for discussion with a view to enhancing the effectiveness of the Board. The Board discusses and determines the areas for improvement and enhancement relating to the Board's effectiveness as well as the implementation.

Following the review, the NC assessed the Board's performance as a whole, the Board Committees' performance and the contribution by individual Directors in FY2021, and is of the view that the Board's performance as a whole, the Board Committees' performance and the contribution by individual Directors are satisfactory.

No external facilitator was used in FY2021.

The key terms of reference of the RC are as follows:

- (1) reviewing and submitting its recommendation to the Board for endorsement by the entire Board, on the policy and general framework of remuneration for the Board and key management personnel (including senior management), and on the establishment of a formal and transparent procedure for developing remuneration policy;
- (2) reviewing and recommending to the Board for endorsement (or determining with delegated responsibility) the remuneration packages and terms of employment for each Director and the key management personnel (including but not limited to, Directors' and key management personnel's fees, salaries, allowances, bonuses and benefits-in-kind);
- (3) reviewing and approving compensation arrangement relating to dismissal or removal of Directors for misconduct to ensure that they are consistent with contractual terms and are otherwise reasonable and appropriate; and
- (4) reviewing and recommending to the Board in consultation with the Chairman of the Board for endorsement by the entire Board, share option schemes, share award plans or any long-term incentive schemes which may be set up from time to time, in particular to review whether Directors and key management personnel should be eligible for such schemes and also evaluating the costs and benefits of such schemes and doing all acts necessary in connection therewith.

The RC has adequate resources to perform and discharge its responsibilities properly. During FY2021, the members of RC reviewed the 2020 remuneration payment and 2021 remuneration framework for the individual Directors and the key management personnel (including senior management) of the Company.

Procedures for Developing Remuneration Policies

The RC is responsible for ensuring appropriate formality, transparency to the Shareholders and a formal and transparent procedure is in place for developing an appropriate executive remuneration policy and a competitive framework for determining the remuneration packages of Directors and key management personnel. The RC recommends for the Board's endorsement, a framework of remuneration, including but not limited to, fees, salaries, allowances, bonuses, options and benefits-in-kind for the Directors and key management personnel. No Director is involved in any decision-making relating to his/her own compensation.

The Company will also engage a third-party remuneration consultant, on a regular basis or as requested by the RC, to review and make recommendations on the remuneration framework and level for the Directors and key management personnel. The Company did not engage a third-party remuneration consultant in FY2021.

Level and Mix of Remuneration

Under the framework developed by the RC, the RC uses the following factors to determine the Directors' remuneration:

- (1) qualifications and experience of the Directors required by the Company;
- (2) for Independent Non-Executive Directors, the general level of fees earned by such Director in his/her professional capacity or billed by professionals in their industry;
- (3) time spent in preparing for meetings and actual attendance;
- (4) indirect costs and expenses incurred by the Directors;
- (5) such remuneration as may be considered fair and reasonable, having regard to the nature and size of the business of the Company;
- (6) level of remuneration which is directly linked to the extent of involvement and participation in and contribution to the business of the Company;
- (7) the level of commitment and the ability to devote sufficient time and attention to the business of the Company; and
- (8) where special circumstances justify, the payment of additional remuneration.

制定薪酬政策的程序

薪酬委員會負責向股東確保薪酬政策擁有正式性和透明性，即：本公司為董事和主要管理人員薪酬的釐定建立了正式透明的程序，並將以此為本公司的執行人員提供適當且具競爭力的薪酬配套。薪酬委員會對董事和關鍵管理人員的薪酬框架向董事會作出推薦供其確認，其中包括但不限於董事和關鍵管理人員的費用、薪金、津貼、獎金和實物福利。任何董事均未參與決定其本人的任何補償。

本公司也將定期或在薪酬委員會的要求下聘請第三方薪酬顧問，審閱董事及關鍵管理人員的薪酬框架和水平，並就此提供建議。本公司於二零二一財政年度內沒有聘請第三方薪酬顧問。

薪酬水平和薪酬組合

按照薪酬委員會制定的框架，薪酬委員會根據下列因素來決定董事的薪酬：

- (1) 本公司要求的董事資質及經驗；
- (2) 對於獨立非執行董事而言，各董事按照其專業能力可賺取的，或按照其領域的專業人士可收取的一般費用水平；
- (3) 為準備會議和實際出席會議所花費的時間；
- (4) 董事產生的間接費用和開支；
- (5) 按照本公司業務的性質和規模可視為公平合理的薪酬；
- (6) 按照對本公司業務參與和貢獻程度的不同而有不同的薪酬水平；
- (7) 對本公司業務投入足夠的時間和精力所需要花費的付出和具備的能力；和
- (8) 在特殊情況下需要支付的額外報酬。

Annual reviews are carried out by the RC to ensure that key management personnel are appropriately rewarded, giving due regard to the financial health and business needs of the Group without being excessive and thereby maximising the Shareholders' value. The Group's remuneration framework, remuneration packages and bonus distribution plans for the Directors and key management personnel for each financial year are reviewed and discussed by the RC, which comprises three Independent Non-Executive Directors, before submitting to the Board for endorsement.

The Executive Directors have entered into service agreements with the Company. Their compensation consists of basic salary, fixed allowance and performance-linked bonus. The bonus of the Executive Directors and the key management personnel are dependent on the Group's performance and such individual's performance and contribution to the Company in that year. In particular, the Company sets up a bonus pool and an objective bonus determination mechanism for the Executive Directors and the key management personnel at the beginning of each financial year, which is reviewed and approved by the RC as delegated by the Board. To incentivise the Executive Directors and the key management personnel to successfully manage the Company, the performance-linked bonus makes up a substantial portion of their total remuneration in a financial year. The amount of the performance-linked bonus for each Executive Director and key management personnel is linked to the achievement of certain key financial indicators of the Company in that financial year and his/her annual appraisal result.

The Group's remuneration policy is to provide remuneration packages appropriate to attract, retain and motivate the Directors and the key management personnel.

The Independent Non-Executive Directors receive directors' fees according to their level of contributions and other factors such as effort and time spent for serving on the Board and the Board Committees, as well as the responsibilities and obligations of the Directors. The Company recognises the need to pay competitive fees to attract, motivate and retain the Directors without being excessive to the extent that their independence might be compromised.

Directors' fees are recommended by the Board for approval by the Shareholders at the AGMs.

執行董事與本公司簽訂了服務協議。他們的報酬包括基本工資、固定津貼和績效獎金。執行董事和關鍵管理人員的獎金數額取決於本集團的表現以及該人員在當年的表現和對本公司的貢獻。具體而言，在每個財政年度初，本公司為執行董事和關鍵管理人員設立一個獎金池並確定一個客觀的獎金確定機制，隨後提交給薪酬委員會由其根據董事會的授權進行審議。為了激勵執行董事和關鍵管理人員成功地管理本公司，績效獎金構成了他們全年總薪酬中的重要組成部分。執行董事和每位關鍵管理人員的績效獎金都與本公司在該財政年度中是否實現了特定關鍵財務指標掛鉤，同時還取決於該人員在當年的年度考評結果。

本集團的薪酬政策是提供適當的薪酬配套以吸引、保留和激勵董事和關鍵管理人員。

獨立非執行董事按照他們的貢獻程度和其他因素（如任職董事會和董事會委員會所投入的精力和時間以及董事的責任和義務）來領取董事袍金。本公司認可有必要支付具有競爭力的董事袍金，以吸引、激勵和留住董事，但不會支付過高的董事袍金而影響他們的獨立性。

董事袍金由董事會建議並經由股東於股東週年大會上批准。

The Board believes that it is not in the best interest of the Company to fully disclose precise remuneration given the highly competitive industry conditions for the environmental water sectors, particularly in China. The Group's internal controls and management systems are designed to provide reasonable, but not absolute assurance to the integrity and reliability of the financial information and to safeguard and maintain the accountability of the assets. While no cost-effective internal control system can provide absolute assurance against loss or misstatement, the AC, with the participation of the Board, has reviewed the adequacy and effectiveness of the Group's internal controls and risk management systems to ensure that they are designed to provide reasonable assurance that assets are safeguarded, operational controls are in place, business risks are suitably managed, proper accounting records are maintained and the integrity of financial information used for business and publication is preserved. The AC reviews the risk management and internal control systems at least once a year.

The internal auditors conduct annual review of the adequacy and effectiveness of the Group's key internal controls including management of financial, operational, compliance, information technology and sustainability risks. The external auditors during the conduct of their normal audit procedures may also report on matters relating to internal control. Any material non-compliance and recommendation for improvements are reported to the AC. The AC also reviews and continues to monitor the effectiveness of the actions taken by the Management on the recommendations made by the internal and external auditors in this respect. Based on the work performed by the internal and external auditors, the AC reviews the findings from the internal and external auditors on the Group's internal controls and the Management's responses to the auditors' recommendations for improvement to the Group's internal controls and discussions with the auditors and Management. The Company may, from time to time, appoint external advisers to facilitate the Company to assess and identify the key risks and the related key controls established by the Company.

In addition, the Company has implemented two major management systems to address risks in different aspects of the Company, namely the Risk Management System and the Environmental, Safety, Health and Social Responsibility ("ESHS") Management System ("ESHS Management System"). The Risk Management System provides the procedures for risk identification and assessment, risk register compilation, risk tactics development, risk event management, risk event reporting, and the review and audit of such system. The Company updates its risk register on a quarterly basis. Any material findings on the risk management will be escalated to the AC and the Board. The ESHS Management System provides a series of standard operating procedures to address the environmental, safety, health and social responsibility risks.

The Board has received assurance from the CEO and the CFO that the financial records of the Company have been properly maintained and the financial statements give a true and fair view of the Company's operations and finances; and regarding the adequacy and effectiveness of the Company's risk management and internal control systems (including financial, operational, compliance and information technology controls).

The risk management is under the purview of the AC, and no other dedicated committee at the Board level is set up. Nonetheless, a Risk Assessment Committee is set up by the Company to assist the Management Committee in making decisions on new investment projects. In relation to the investment project which is subject to the Board's approval, the Risk Assessment Committee's findings and recommendations will also be submitted to the Board for consideration. More details about the Risk Assessment Committee are set out in this Corporate Governance Report under sub-section "Internal Management".

Ms. Peng Pei, the Legal Counsel and Joint Company Secretary, currently heads the Legal and Risk Management Department of the Company.

The Board, with the concurrence of the AC, is satisfied with the adequacy and effectiveness of the Group's risk management and internal control systems in addressing financial, operational, compliance and information technology controls and sustainability risks as at 31 December 2021.

Financial Reporting

The Directors acknowledge the preparation of the Group's financial statements. The Finance Management Department of the Company is supervised by the CFO. With the assistance of the Finance Management Department, the Directors ensure that the Group's financial statements have been properly prepared in accordance with relevant regulations and applicable accounting principles. The Directors are not aware of any material uncertainties relating to events or conditions that may cast significant doubt upon the Company's ability to continue as a going concern.

A statement by Ernst & Young LLP, the external auditor of the Company, about its reporting responsibilities on the financial statements of the Group is included in the "Independent Auditor's Report" on pages 136 to 144 of this Annual Report.

Majority of the AC members have accounting or finance background. The members of the AC, collectively, have recent and relevant accounting or related financial management expertise or experience to discharge the AC's responsibilities.

The AC does not comprise former partners or directors of the Company's existing auditing firm or auditing corporation: (a) within a period of two years commencing on the date of their ceasing to be a partner of the auditing firm or director of the auditing corporation; and in any case, (b) for as long as they have any financial interest in the auditing firm or auditing corporation.

The AC has explicit authority to investigate any matter within its terms of reference. It has full access to, and the co-operation of the Management and full discretion to invite any Director or any key executive to attend its meetings. The AC has adequate resources, including access to external auditors, to enable it to discharge its responsibilities properly.

The AC met twice in FY2021 and the relevant Directors and Management were invited to attend the meetings.

The AC is guided by the terms of reference which stipulate its principal functions.

The functions of the AC include:

- (1) reviewing the significant financial reporting issues and judgements and monitoring the integrity of the financial statements of the Group and annual reports and accounts, half-year reports and, if prepared for publication, quarterly reports, and any announcements relating to the Company's financial performance;

The Company has designated its Internal Audit Department to investigate whistle-blowing reports made in good faith. The Audit Committee, which is responsible for oversight and monitoring of the whistle-blowing policy and mechanism, will make decisions on further actions (if needed) based on the investigation made by the Internal Audit Department.

The Company is also committed to ensure protection of the whistle-blower against detrimental or unfair treatment.

Internal Audit

The Company has an Internal Audit Department (“IA”) to strengthen the internal audit function and promote sound risk management, including financial, operational, compliance, information technology controls, sustainability and good corporate governance. The AC approves the recruitment, removal and evaluation of the internal auditors.

The IA reports primarily to the AC and has full access to the documents, records, properties and personnel of the Company and of the Group, and has appropriate standing within the Company. The IA reports to the AC at least twice in a year regarding the progress and major findings of the internal audit process. The AC reviews at least annually the adequacy and effectiveness of the internal audit function of the Company and ensures that the Company’s internal audit team is formed by the sufficient number of personnel with relevant qualifications and experience.

The IA comprises employees whose roles and responsibilities are dedicated to carrying out the internal audit function for the Company. In FY2021, the IA was headed by Mr. Li Ke, who has nine years of working experience in internal audit. He was supported by a team of five employees, all of whom have finance, internal audit or project operation experience. None of the personnel of the IA had any relationship or conflict of interest that could impair their objectivity and independence in conducting their internal audit function. The AC is of the view that the Company’s internal audit function is independent, effective and adequately resourced.

The Board recognises that it is responsible for maintaining a system of internal control to safeguard the Shareholders’ investments and the Group’s businesses and assets, while the Management is responsible for establishing and implementing the internal control procedures in a timely and appropriate manner.

IA's main scope of work covers the review and evaluation of processes and areas of concerns identified. IA assists the Management in enhancing existing risk management initiatives and carrying out regular independent monitoring of key controls and procedures. The findings and recommendations in relation to the adequacy and effectiveness of internal controls and process improvements will be presented to the AC and the Management.

Material non-compliance and internal control weaknesses noted during reviews are reported together with recommended corrective actions to the AC on a regular basis. In particular, the Company had certain outstanding licenses and/or permits in relation to its business and operations as at November 2014 ("Licenses and/or Permits") as disclosed in the Company's circular dated 12 November 2014. Most of such Licenses and/or Permits had been obtained in the financial years ended 31 December 2015, 2016 and 2017, as disclosed in the relevant annual reports. During FY2021, the IA continuously followed up on the status of such Licenses and/or Permits and noted that the Company obtained the following additional Licenses and/or Permits:

The MC is responsible for the management of daily business operations, formulating and implementing annual work tasks and medium-term development plans for the Group. The MC is the decision-making authority for the day-to-day administration, operations, management and personnel matters.

The MC holds meetings on a regular and ad hoc basis. It holds meetings at least once a month and has a weekly communication mechanism. The MC reviews and discusses, the Group's investment proposals on new projects, appointment and removal of key executives at headquarters departments, regional management centres and project companies, performance appraisals, status of financial budget execution and the major works done and progress of the headquarters departments and regional management centres, etc.

To assist the MC in decision-making process, the Company also established a Risk Assessment Committee ("RAC") and an Engineering and Technology Committee ("ETC") to assess the risks and make recommendations in undertaking new investment projects and construction works. Any new investment project, before submitted to the MC for consideration, will be reviewed by the RAC and the ETC respectively. The MC will then take into account the findings and recommendations made by the RAC and the ETC. In relation to investment project with investment amount exceeding certain threshold, Board's approval will be sought before the definitive agreement is executed.

In relation to each meeting held by the MC, minutes duly signed by its chairman will be retained by the Company as records.

The MC has ceased to be a Board Committee with effect from 11 August 2021. Please refer to the Company's announcement entitled "Management Committee Ceasing to be a Board Committee" dated 11 August 2021 for further details.

(E) SHAREHOLDER RIGHTS AND ENGAGEMENT

Shareholder Rights and Conduct of General Meetings

The Company treats all Shareholders fairly and equitably, and recognises, protects and facilitates the exercise of the Shareholders' rights. Shareholders are informed of changes in the Company's business that are likely to affect their assessment of the Company's performance, position and prospects.

The Management supports the SG CG Code's principle to encourage shareholder participation. Shareholders are encouraged to attend the general meetings to ensure a high level of accountability and to stay informed of the Company's strategy and goals. The Shareholders are informed of general meetings through notices contained in annual reports or circulars sent to all Shareholders. In FY2021, the notice of AGM was despatched to the Shareholders, published in the Business Times as well as uploaded onto the SGXNet and the websites of HKEX and the Company. The Company also uploaded the Management's presentation slides to be used at the AGM in advance and the minutes of the AGM. The Board welcomes questions from Shareholders who have an opportunity to raise issues either informally or formally before or at the general meetings. To facilitate the Shareholders' communication with the Directors and the Management, a question and answer session is held at all the general meetings before voting is carried out.

Resolutions at general meetings are on each substantially separate issue. All the resolutions at the general meetings are single item resolutions.

The Company encourages all the Directors to attend its general meetings to address Shareholders' questions relating to the Company's development and the work of the Board Committees. For the AGM held in FY2021, all the seven Directors (including Mr. Wang Tianyi as the Chairman of the Board, Mr. An Xuesong and Mr. Luo Junjie as the two Executive Directors and the chairmen of all the Board Committees at the time when the AGM was held) attended such meeting. In view of the COVID-19 situation, all the Shareholders were allowed to participate the AGM held in FY2021 via electronic means, i.e. live audio-visual webcast or live audio-only webcast or live audio-only stream, submission of questions in advance of the AGM, submission of questions during the AGM via an online chat box, addressing of substantial and relevant questions at the AGM and voting by appointing the chairman of the AGM as proxy at the AGM and/or voting electronically during the AGM, pursuant to the *COVID-19 (Temporary Measures) (Alternative Arrangements for Meetings for Companies, Variables Capital Companies, Business Trusts, Unit Trusts and Debenture Holders) Order 2020*.

(E) 股東權利及與股東的互動

本公司公平、公正地對待全體股東，承認、保護和促進股東行使權利。對於可能影響股東對本公司業績、狀況和前景所作評估的業務發展，本公司也向股東作出及時披露。

管理層支持新加坡企業管治守則中關於鼓勵股東參與的原則。本公司鼓勵股東出席股東大會，以確保高水平的問責制並使其及時了解本公司的戰略和目標。股東大會的通知以年度報告和股東通函的形式發放給股東。在二零二一財政年度，股東週年大會的通知已寄發給股東，並刊登在商業時報、SGXNet、港交所及本公司網站上。本公司亦會提前將用於股東週年大會的管理層介紹資料及股東週年大會後準備的會議紀要上載至該等網站。股東有機會在股東大會召開前或會議中以正式或非正式方式提出問題，董事會歡迎股東提問。為了促進股東與董事會及管理層之間的溝通，本公司在其所有股東大會的投票環節前均設有問答環節。

股東大會上的決議都是針對各項單獨議題的決議。股東大會上的所有決議均為單項決議。

本公司鼓勵全體董事參加股東大會，討論與本公司發展和董事會委員會工作有關的問題。二零二一財政年度舉行的股東週年大會上，全部七位董事（包括股東週年大會舉辦當時的董事長王天義先生、兩位執行董事安雪松先生、羅俊嶺先生和所有董事會委員會的主席）均有出席。鑑於新冠疫情，根據《COVID-19（臨時措施）（公司、可變資本公司、商業信託、單位信託和債券持有人會議的替代安排）2020年法令》，所有股東可通過電子方式（即實時視聽網絡直播或實時音頻網絡直播或實時音頻直播）參加二零二一財政年度舉行的股東週年大會，在會議召開前遞交問題，於會議期間通過在聊天窗口遞交問題，於會議期間解答重大和相關問題，並委任股東週年大會主席為受委代表以代其投票及/或於會議期間以電子方式投票。

The Company's external auditor and the Legal Counsel and Joint Company Secretary are also invited to attend the general meetings and are available to assist the Directors in addressing any relevant queries by the Shareholders relating to the conduct of the audit and the preparation and content of the auditors' report.

The Company conducts poll voting for all resolutions to be passed in its general meetings. The rules, including voting procedures, will be explained by the scrutineers in the general meetings. If any Shareholder is unable to attend general meetings, Bye-laws allow each Shareholder to appoint up to two proxies to attend and vote at all general meetings on his/her behalf. Meeting minutes are prepared for all the general meetings (including the details of the question and answer sessions therein) and are uploaded on the Company's website and properly maintained as the Company's records.

Procedures for Shareholders to Convene a Special General Meeting and to Put Forward Proposals

The following procedures for the Shareholders to convene a special general meeting are prepared in accordance with Bye-law 57 of the Bye-laws.

- (1) One or more Shareholders holding at the date of deposit of the requisition not less than one-tenth of the paid up capital of the Company carrying the right of voting at general meetings of the Company shall have the right, by written requisition to the Board or the Joint Company Secretaries, to require a special general meeting to be called by the Board for the transaction of any business specified in such requisition.
- (2) The requisition must state the objects of the meeting, and must be signed by the Shareholder(s) concerned and may consist of several documents in like form, each signed by one or more of those Shareholders.
- (3) The requisition shall be made in writing to the Board or the Joint Company Secretaries.
- (4) The special general meeting shall be held within two months after the deposit of the requisition.
- (5) If within 21 days of such deposit the Board fails to proceed to convene such meeting, the requisitionists, themselves may do so in accordance with the provisions of Section 74(3) of the *Companies Act 1981 of Bermuda* (the "**Bermuda Companies Act**").

Dividend Policy

The Group has adopted a policy on payment of dividend (the “**Dividend Policy**”) since 2019 in compliance with the HK CG Code and SG CG Code, which establishes an appropriate procedure on declaring and recommending the dividend payment of the Company.

The Company will declare and/or recommend the payment of dividends to the Shareholders after the Board considering the factors, such as: the funding needs to the operation and business development of the Company from time to time; the market situation from time to time; the solvency requirements of the Bermuda Companies Act; cash flow and financial condition of the Company; the requirements of the Bye-laws and the relevant laws, rules and regulations applicable to the Company; and so on. When assessing the Company’s performance for each financial year or interim financial period, the Board shall seek to maintain a steady dividend depending on the capital expenditure and cash flow for each financial year or interim financial period, while smoothing the effect of any variation in the cash flow that may be due to one-off gains or losses in the same period. The Board shall have the full discretion on whether to pay a dividend, subject to the Shareholders’ approval, if applicable.

The Board shall review the Dividend Policy on a regular basis.

In accordance with the Dividend Policy, the Company declared and paid an interim one-tier tax-exempt dividend of 5.75 Hong Kong cents (equivalent to 1.01 Singapore cents (“**Sing cents**”)) per ordinary share for the six months ended 30 June 2021. In addition, the Board recommended a final one-tier tax exempt dividend of 6.83 Hong Kong cents (equivalent to 1.19 Sing cents) per ordinary share for FY2021, which will be subject to the Shareholders’ approval at the forthcoming AGM.

As announced by the Company on 15 January 2021, the Company had completed the issuance of second tranche of RMB-denominated medium term notes (the **"Second Tranche MTNs"**) to the institutional investors in the inter-bank bond market of mainland China (the **"Institutional Investors"**) with a principal amount of RMB1,000,000,000. The Second Tranche MTNs were fully subscribed for by the Institutional Investors, with a maturity period of 3 years and an interest rate of 3.75% per annum. The proceeds from issuance of the Second Tranche MTNs were used for replenishment of working capital for the subsidiaries of the Company. Details of the Second Tranche MTNs are set out in the Company's announcements dated 11 January 2021 and 15 January 2021.

As announced by the Company on 10 August 2021, the Company had completed the issuance of the first tranche of RMB-denominated Super & Short-term Commercial Papers (the **"First Tranche SCPs"**) to the Institutional Investors with a principal amount of RMB800,000,000. The First Tranche SCPs were fully subscribed for by the Institutional Investors, with a maturity period of 120 days and an interest rate of 2.40% per annum. The proceeds from issuance of the First Tranche SCPs were used for replenishment of working capital for the subsidiaries of the Company. Details of the First Tranche SCPs are set out in the Company's announcements dated 6 August 2021 and 10 August 2021.

The Group operates a Mandatory Provident Fund Scheme (the "MPF Scheme") under the *Hong Kong Mandatory Provident Fund Schemes Ordinance* for employees employed under the jurisdiction of the *Hong Kong Employment Ordinance*. The MPF Scheme is a defined contribution retirement scheme administered by independent trustees. Under the Group's MPF Scheme, the employer and its employees are each required to make contributions to the scheme at 5% of the employees' relevant income, respectively.

The employees of the subsidiaries of the Company in the PRC are members of the retirement schemes operated by the local authorities. The subsidiaries are required to contribute a certain percentage of their payroll to these schemes to fund the benefits.

The Group also makes contributions to the Central Provident Fund in Singapore. Pursuant to the *Central Provident Fund Act* (Chapter 36 of Singapore), both the employer and its employees are required to make regular contributions at certain rate based on the employees' income.

The Group's total contributions to these schemes charged to the consolidated statement of profit or loss during FY2021 amounted to approximately HK\$124,512,000 (FY2020: HK\$55,229,000).

The percentage of construction completed during the year is estimated based on the survey of work performed by independent surveyors with relevant qualifications and industry experience. Judgement is required in estimating the percentage of construction completed.

As at 31 December 2021, the Group had trade receivables amounting to HK\$2,296,652,000, net of expected credit losses ("ECL") allowance of HK\$252,045,000. The Group determines impairment losses by making debtor-specific assessment of ECL for credit impaired debtors and has established a provision matrix that is based on the Group's historical credit loss experience, adjusted for forward-looking factors specific to the debtors and the economic environment for the remaining group of debtors taking into consideration impact arising from the COVID-19 pandemic.

The estimation of impairment loss of trade receivables is based on the evaluation of collectability and ageing analysis of trade receivables as well as expectation of forward-looking factors. A considerable amount of judgement is required in assessing the ultimate realisation of these receivables, taking into consideration the current creditworthiness and the past collection history of each debtor. Accordingly, we identified this as a key audit matter. Disclosures of the trade receivables are included in notes 2.4, 3 and 23 to the financial statements.

We also requested direct confirmations and considered receipts subsequent to the year end.

IAS 36 *Impairment of Assets* requires goodwill to be tested annually for impairment or more frequently when there is an indication that the cash-generating unit ("CGU") may be impaired. This assessment requires the exercise of significant judgement about the future market conditions, including future cash flows to be generated from the continuing use of the waste water treatment plants over the service concession period. The determination of the recoverable amount requires judgement in both identification and valuation of the relevant CGU given the changes in the market and economic conditions brought on by the COVID-19 pandemic. Accordingly, we identified this as a key audit matter.

國際會計準則第36號 *資產減值* 要求對商譽每年進行減值測試，若有迹象表明現金產出單元（「現金產出單元」）可能出現減值時應更頻繁地進行減值測試。該測試要求對未來市場狀況作出重大判斷，包括在服務特許期內污水處理廠所產生的未來現金流量。可收回金額的釐定需要考慮由於新型冠狀病毒疫情帶來的市場及經濟環境的變化，進而對現金產出單元的識別及估值作出判斷。因此，我們將該事項認定為關鍵審計事項。

The Group determined that the water environment management segment was accounted for as a collective CGU for the purpose of impairment testing. The impairment assessment was determined using a value-in-use model based on the discounted cash flows projection. Assumptions such as estimated key financial data, the growth rate and discount rate used to determine the discounted cash flows required significant judgements by the Group.

We tested the reasonableness of key assumptions used in the cash flows forecast, which include growth rate, discount rate and long-term growth rate, and taking into account management's consideration of the potential impact that COVID-19 pandemic has on the Group's operations.

1. CORPORATE INFORMATION

- (1) All significant subsidiaries are audited by member firm of Ernst & Young Global in China for group consolidation purpose. For this purpose, a subsidiary or an associated company is considered significant, as defined under the Listing Manual of the Singapore Exchange Securities Trading Limited, if its net tangible assets represent 20% or more of the Group's consolidated net tangible assets, or if its pre-tax profits account for 20% or more of the Group's consolidated pre-tax profits. For the avoidance of doubt, the Group did not have any associated company which was considered significant for the year ended 31 December 2021.
- (2) The Company is committed to contributing 79.6474% of EB Water Nanning's registered capital. The remaining 20.3526% registered capital is contributed by three PRC joint venture partners. Except for one of the PRC joint venture partners, who is committed to contributing 0.0097% of registered capital and shall not be entitled to the net profit of EB Water Nanning, the Company and other two PRC joint venture partners share the net profit of EB Water Nanning on the basis of their respective proportions of registered capital contribution.
- (3) EW (Qingdao) Holdings, a wholly-owned subsidiary of the Company and the foreign joint venture partner of EB Water Qingdao, is committed to contributing 60% of EB Water Qingdao's registered capital. The remaining 40% registered capital is contributed by a PRC joint venture partner. EW (Qingdao) Holdings is fully entitled to the net profit of EB Water Qingdao for the first 14 years of the joint venture period. From the 15th year of the joint venture period onwards, the net profit of EB Water Qingdao is to be shared by EW (Qingdao) Holdings and the PRC joint venture partner on a 98:2 basis.
- (4) These subsidiaries of the Group entered into service concession arrangements with the local government authorities in the PRC (the "Grantors"). Pursuant to the service concession arrangements, the Group was granted rights to construct, operate and maintain waste water treatment related projects in the PRC for a period of 20 to 32 years. The Group has the obligation to maintain and restore the waste water treatment related projects in good condition. The service fees are based on the extent of services rendered and are subject to approvals from the relevant local government authorities. Upon expiry of the concession periods, the waste water treatment related projects and facilities will be transferred to the local government authorities.

The service concession arrangements do not contain renewal options. Both the Grantors and the Group have the rights to terminate the agreements in the event of a material breach of the terms of the agreements.

Operating rights of the waste water treatment related projects are recognised as "Intangible assets" in the statements of financial position.

- (5) These subsidiaries of the Group entered into service concession arrangements with the Grantors. Pursuant to the service concession arrangements, the Group has to design, construct and/or upgrade, operate and maintain waste water treatment related projects in the PRC for a period of 10 to 32 years. The Group has the obligation to maintain the waste water treatment related projects in good condition. The Grantors guarantee the Group will receive minimum annual payments in connection with the arrangements. Upon expiry of the concession periods, the waste water treatment related projects and facilities will be transferred to the local government authorities.

The service concession arrangements do not contain renewal options. The standard rights of the Grantors to terminate the agreements include the failure of the Group to construct, upgrade or operate the waste water treatment related projects and in the event of a material breach of the terms of the agreements. The standard rights of the Group to terminate the agreements include failure to receive payments for waste water treatment service from the Grantors and in the event of a material breach of the terms of the agreements.

Revenue relates to the construction services provided in constructing or upgrading the waste water treatment related projects is recognised as "Contract assets" in the statements of financial position.

2.1 BASIS OF PRESENTATION

The financial statements of the subsidiaries are prepared for the same reporting period as the Company, using consistent accounting policies. The results of subsidiaries are consolidated from the date on which the Group obtains control, and continue to be consolidated until the date that such control ceases.

All intra-group transactions and balances have been eliminated on consolidation.

2.2 BASIS OF PREPARATION

The financial statements have been prepared in accordance with International Financial Reporting Standards (“IFRSs”), which comprise all standards and interpretations approved by the International Accounting Standards Board (the “IASB”). All IFRSs effective for the accounting period commencing from 1 January 2021, together with the relevant transitional provisions, have been consistently applied by the Group in the preparation of the financial statements throughout the financial periods.

The principal effects of adopting these revised IFRS are as follows:

- (a) Amendments to IFRS 9, IAS 39, IFRS 7, IFRS 4 and IFRS 16 *Interest Rate Benchmark Reform – Phase 2*

The amendments provide temporary reliefs which address the financial reporting effects when an interbank offered rate (“IBOR”) is replaced with an alternative nearly risk-free interest rate (“RFR”). The amendments include the following practical expedients:

- A practical expedient to require contractual changes, or changes to cash flows that are directly required by the reform, to be treated as changes to a floating interest rate, equivalent to a movement in a market rate of interest
- Permit changes required by IBOR reform to be made to hedge designations and hedge documentation without the hedging relationship being discontinued
- Provide temporary relief to entities from having to meet the separately identifiable requirement when an RFR instrument is designated as a hedge of a risk component

These amendments had no impact on the consolidated financial statements of the Group. The Group intends to use the practical expedients in future periods if they become applicable

Subsidiaries

A subsidiary is an entity (including a structured entity), directly or indirectly, controlled by the Company. Control is achieved when the Group is exposed, or has rights, to variable returns from its involvement with the investee and has the ability to affect those returns through its power over the investee (i.e., existing rights that give the Group the current ability to direct the relevant activities of the investee).

When the Company has, directly or indirectly, less than a majority of the voting or similar rights of an investee, the Group considers all relevant facts and circumstances in assessing whether it has power over an investee, including:

- (a) the contractual arrangement with the other vote holders of the investee;
- (b) rights arising from other contractual arrangements; and
- (c) the Group's voting rights and potential voting rights.

The results of subsidiaries are included in the Company's profit or loss to the extent of dividends received and receivable. The Company's investments in subsidiaries are stated at cost less any impairment losses.

Investment in associates

An associate is an entity in which the Group has a long term interest of generally not less than 20% of the equity voting rights and over which it is in a position to exercise significant influence. Significant influence is the power to participate in the financial and operating policy decisions of the investee, but is not control or joint control over those policies.

The Group's investment in an associate is stated in the consolidated statement of financial position at the Group's share of net assets under the equity method of accounting, less any impairment losses.

The Group's share of the post-acquisition results and other comprehensive income of an associate is included in consolidated statement of comprehensive income. In addition, when there has been a change recognised directly in the equity of the associate, the Group recognises its share of any changes, when applicable, in the consolidated statement of changes in equity. Unrealised gains and losses resulting from transactions between the Group and its associate are eliminated to the extent of the Group's investment in the associate, except where unrealised losses provide evidence of an impairment of the assets transferred. Goodwill arising from the acquisition of associates is included as part of the Group's investment in associates.

If an investment in an associate becomes an investment in a joint venture or vice versa, the retained interest is not remeasured. Instead, the investment continues to be accounted for under the equity method. In all other cases, upon loss of significant influence over the associate, the Group measures and recognises any retained investment at its fair value. Any difference between the carrying amount of the associate upon loss of significant influence and the fair value of the retained investment and proceeds from disposal is recognised in profit or loss.

Service concession arrangements

The Group has entered into a number of service concession arrangements with the Grantors.

Under these service concession arrangements:

- the Grantors control or regulate the services the Group must provide with the infrastructure, to whom it must provide them, and at what price; and
- the Grantors control, through ownership, beneficial entitlement or otherwise, any significant residual interest in the infrastructure at the end of the term of the arrangement, or the infrastructure is used for its entire useful life under the arrangements, or both the Group's practical ability to sell or pledge the infrastructure is restricted and continuing right of use of the infrastructure is given to the Grantors throughout the period of the arrangements.

The Group's infrastructure includes leasehold land, buildings, plant and machinery that are acquired from the Grantors and/or are derecognised by the Group when the directors of the Company consider that the significant risks and rewards of these assets have been passed to the Grantors.

Consideration given by the grantor

A financial asset (receivable under service concession arrangement) is recognised to the extent that the Group has an unconditional right to receive cash or another financial asset from or at the direction of the grantor for the construction services rendered and/or the consideration paid and payable by the Group for the right to manage and operate the infrastructure for public service. The Group has an unconditional right to receive cash if the grantor contractually guarantees to pay the Group (a) specified or determinable amounts or (b) the shortfall, if any, between amounts received from users of the public service and specified or determinable amounts, even if the payment is contingent on the Group ensuring that the infrastructure meets specified requirements. The financial asset (receivable under service concession arrangement) is accounted for in accordance with the policy set out for "Financial assets and liabilities" below.

An intangible asset (concession right) is recognised to the extent that the Group receives a right to charge users of the public service. The intangible asset (operating concession) is stated at cost less accumulated amortisation and any accumulated impairment loss. Amortisation is provided on a straight-line basis over the operation phase of the concession periods.

If the Group is paid for the construction services partly by a financial asset and partly by an intangible asset, then each component of the consideration is accounted for separately and is recognised initially at the fair value of the consideration.

Construction of service concession related infrastructure

Revenue relating to construction services is accounted for in accordance with the policy for "Revenue recognition" below.

Operating services

Revenue relating to operating services is accounted for in accordance with the policy for "Revenue recognition" below.

Fair value measurement

The Group measures its contingent consideration receivable at fair value at the end of each reporting period. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value measurement is based on the presumption that the transaction to sell the asset or transfer the liability takes place either in the principal market for the asset or liability, or in the absence of a principal market, in the most advantageous market for the asset or liability. The principal or the most advantageous market must be accessible by the Group. The fair value of an asset or a liability is measured using the assumptions that market participants would use when pricing the asset or liability, assuming that market participants act in their economic best interest.

A fair value measurement of a non-financial asset takes into account a market participant's ability to generate economic benefits by using the asset in its highest and best use or by selling it to another market participant that would use the asset in its highest and best use.

The Group uses valuation techniques that are appropriate in the circumstances and for which sufficient data are available to measure fair value, maximising the use of relevant observable inputs and minimising the use of unobservable inputs.

All assets and liabilities for which fair value is measured or disclosed in the financial statements are categorised within the fair value hierarchy, described as follows, based on the lowest level input that is significant to the fair value measurement as a whole:

Level 1 - based on quoted prices (unadjusted) in active markets for identical assets or liabilities

Level 2 - based on valuation techniques for which the lowest level input that is significant to the fair value measurement is observable, either directly or indirectly

Level 3 - based on valuation techniques for which the lowest level input that is significant to the fair value measurement is unobservable

Impairment of non-financial assets

Where an indication of impairment exists, or when annual impairment testing for an asset is required (other than inventories, construction contract assets and financial assets), the asset's recoverable amount is estimated. An asset's recoverable amount is the higher of the asset's or cash-generating unit's value in use and its fair value less costs of disposal, and is determined for an individual asset, unless the asset does not generate cash inflows that are largely independent of those from other assets or groups of assets, in which case the recoverable amount is determined for the cash-generating unit to which the asset belongs.

An impairment loss is recognised only if the carrying amount of an asset exceeds its recoverable amount. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset. An impairment loss is charged to profit or loss in the period in which it arises in those expense categories consistent with the function of the impaired asset.

An assessment is made at the end of each reporting period as to whether there is an indication that previously recognised impairment losses may no longer exist or may have decreased. If such an indication exists, the recoverable amount is estimated. A previously recognised impairment loss of an asset other than goodwill is reversed only if there has been a change in the estimates used to determine the recoverable amount of that asset, but not to an amount higher than the carrying amount that would have been determined (net of any depreciation/amortisation) had no impairment loss been recognised for the asset in prior years. A reversal of such an impairment loss is credited to profit or loss in the period in which it arises.

Property, plant and equipment and depreciation

Property, plant and equipment, other than construction in progress, are stated at cost less accumulated depreciation and any impairment losses. The cost of an item of property, plant and equipment comprises its purchase price and any directly attributable costs of bringing the asset to its working condition and location for its intended use.

Expenditure incurred after items of property, plant and equipment have been put into operation, such as repairs and maintenance, is normally charged to profit or loss in the period in which it is incurred. In situations where the recognition criteria are satisfied, the expenditure for a major inspection is capitalised in the carrying amount of the asset as a replacement. Where significant parts of property, plant and equipment are required to be replaced at intervals, the Group recognises such parts as individual assets with specific useful lives and depreciates them accordingly.

Depreciation is calculated on the straight-line basis to write off the cost of each item of property, plant and equipment to its residual value over its estimated useful life. The principal annual rates used for this purpose are as follows:

Buildings	2.5% to 4%
Plant and machinery	2.5% to 20%
Leasehold improvements, furniture and fixtures	20% to 25%
Motor vehicles and office equipment	12.5% to 25%

Where parts of an item of property, plant and equipment have different useful lives, the cost of that item is allocated on a reasonable basis among the parts and each part is depreciated separately. Residual values, useful lives and the depreciation method are reviewed, and adjusted if appropriate, at least at each financial year end.

An item of property, plant and equipment including any significant part initially recognised is derecognised upon disposal or when no future economic benefits are expected from its use or disposal. Any gain or loss on disposal or retirement recognised in profit or loss in the year the asset is derecognised is the difference between the net sale proceeds and the carrying amount of the relevant asset.

Construction in progress is stated at cost less any impairment losses, and is not depreciated. Cost comprises the direct costs of construction and capitalised borrowing costs on related borrowed funds during the period of construction. Construction in progress is reclassified to the appropriate category of property, plant and equipment when completed and ready for use.

Business combinations and goodwill

Business combinations are accounted for using the acquisition method. The consideration transferred is measured at the acquisition date fair value which is the sum of the acquisition date fair values of assets transferred by the Group, liabilities assumed by the Group to the former owners of the acquiree and the equity interests issued by the Group in exchange for control of the acquiree. For each business combination, the Group elects whether to measure the non-controlling interests in the acquiree that are present ownership interests and entitle their holders to a proportionate share of net assets in the event of liquidation at fair value or at the proportionate share of the acquiree's identifiable net assets. All other components of non-controlling interests are measured at fair value. Acquisition-related costs are expensed as incurred.

When the Group acquires a business, it assesses the financial assets and liabilities assumed for appropriate classification and designation in accordance with the contractual terms, economic circumstances and pertinent conditions as at the acquisition date. This includes the separation of embedded derivatives in host contracts of the acquiree.

If the business combination is achieved in stages, the previously held equity interest is remeasured at its acquisition date fair value and any resulting gain or loss is recognised in profit or loss.

Any contingent consideration to be transferred by the acquirer is recognised at fair value at the acquisition date. Contingent consideration classified as an asset or liability is measured at fair value with changes in fair value recognised in profit or loss. Contingent consideration that is classified as equity is not remeasured and subsequent settlement is accounted for within equity.

Goodwill is initially measured at cost, being the excess of the aggregate of the consideration transferred, the amount recognised for non-controlling interests and any fair value of the Group's previously held equity interests in the acquiree over the identifiable net assets acquired and liabilities assumed. If the sum of this consideration and other items is lower than the fair value of the net assets acquired, the difference is, after reassessment, recognised in profit or loss as a gain on bargain purchase.

After initial recognition, goodwill is measured at cost less any accumulated impairment losses. Goodwill is tested for impairment annually or more frequently if events or changes in circumstances indicate that the carrying value may be impaired. The Group performs its annual impairment test of goodwill as at 31 December. For the purpose of impairment testing, goodwill acquired in a business combination is, from the acquisition date, allocated to each of the Group's cash-generating units, or groups of cash-generating units, that are expected to benefit from the synergies of the combination, irrespective of whether other assets or liabilities of the Group are assigned to those units or groups of units.

Impairment is determined by assessing the recoverable amount of the cash-generating unit (group of cash-generating units) to which the goodwill relates. Where the recoverable amount of the cash-generating unit (group of cash-generating units) is less than the carrying amount, an impairment loss is recognised. An impairment loss recognised for goodwill is not reversed in a subsequent period.

Where goodwill has been allocated to a cash-generating unit (or group of cash-generating units) and part of the operation within that unit is disposed of, the goodwill associated with the operation disposed of is included in the carrying amount of the operation when determining the gain or loss on the disposal. Goodwill disposed of in these circumstances is measured based on the relative value of the operation disposed of and the portion of the cash-generating unit retained.

Investment property

Investment properties are interests in land and buildings (including the leasehold interest under an operating lease for a property which would otherwise meet the definition of an investment property) held to earn rental income and/or for capital appreciation, rather than for use in the production or supply of goods or services or for administrative purposes; or for sale in the ordinary course of business. Such properties are measured initially at cost, including transaction costs. Subsequent to initial recognition, investment properties are stated at fair value, which reflects market conditions at the end of the reporting period.

Gains or losses arising from changes in the fair values of investment properties are included in the income statement in the year in which they arise.

Any gains or losses on the retirement or disposal of an investment property are recognised in the income statement in the year of the retirement or disposal.

Intangible assets (other than goodwill)

Intangible assets acquired separately are measured on initial recognition at cost. The cost of intangible assets acquired in a business combination is the fair value at the date of acquisition. The useful lives of intangible assets are assessed to be either finite or indefinite. Intangible assets with finite lives are subsequently amortised over the useful economic life and assessed for impairment whenever there is an indication that the intangible asset may be impaired. The amortisation period and the amortisation method for an intangible asset with a finite useful life are reviewed at least at each financial year end.

The following intangible assets are amortised from the date they are available for use and their estimated useful lives are as follows:

The useful life of the patents and trademarks of the Group is determined based on the shorter of their statutory validity periods and the expected benefit periods.

The useful life of the customer relationships of the Group is determined based on the expected benefit periods with reference to the historical customer attrition rate.

An intangible asset is derecognised on disposal or when no future economic benefits are expected from its use or disposal. Any gain or loss on disposal or retirement recognised in profit or loss in the year the intangible assets is derecognised is the difference between the net sale proceeds and the carrying amount of the relevant intangible asset.

Research and development costs

All research costs are charged to profit or loss as incurred.

Expenditure incurred on projects to develop new water environment technologies is capitalised and deferred only when the Group can demonstrate the technical feasibility of completing the intangible asset so that it will be available for use or sale, its intention to complete and its ability to use or sell the asset, how the asset will generate future economic benefits, the availability of resources to complete the project and the ability to measure reliably the expenditure during the development. Water environment technologies development expenditure which does not meet these criteria is expensed when incurred.

Leases

The Group assesses at contract inception whether a contract is, or contains, a lease. That is, if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration.

Group as a lessee

The Group applies a single recognition and measurement approach for all leases, except for short-term leases and leases of low-value assets. The Group recognises lease liabilities to make lease payments and right-of-use assets representing the right to use the underlying assets.

(i) Right-of-use assets

The Group recognises right-of-use assets at the commencement date of the lease (i.e., the date the underlying asset is available for use). Right-of-use assets are measured at cost, less any accumulated depreciation and impairment losses, and adjusted for any remeasurement of lease liabilities. The cost of right-of-use assets includes the amount of lease liabilities recognised, initial direct costs incurred, and lease payments made at or before the commencement date less any lease incentives received. Right-of-use assets are depreciated on a straight-line basis over the shorter of the lease term and the estimated useful lives of the assets, as follows:

Prepaid land lease payments under operating leases are initially stated at cost and subsequently recognised on the straight-line basis over the lease terms.

At the commencement date of the lease, the Group recognises lease liabilities measured at the present value of lease payments to be made over the lease term. The lease payments include fixed payments (including in-substance fixed payments) less any lease incentives receivable, variable lease payments that depend on an index or a rate, and amounts expected to be paid under residual value guarantees. The lease payments also include the exercise price of a purchase option reasonably certain to be exercised by the Group and payments of penalties for terminating the lease, if the lease term reflects the Group exercising the option to terminate. Variable lease payments that do not depend on an index or a rate are recognised as expenses (unless they are incurred to produce inventories) in the period in which the event or condition that triggers the payment occurs.

In calculating the present value of lease payments, the Group uses its incremental borrowing rate at the lease commencement date because the interest rate implicit in the lease is not readily determinable. After the commencement date, the amount of lease liabilities is increased to reflect the accretion of interest and reduced for the lease payments made. In addition, the carrying amount of lease liabilities is remeasured if there is a modification, a change in the lease term, a change in the lease payments (e.g., changes to future payments resulting from a change in an index or rate used to determine such lease payments) or a change in the assessment of an option to purchase the underlying asset.

It also applies the lease of low-value assets recognition exemption to leases of office equipment that are considered to be low value. Lease payments on short-term leases and leases of low-value assets are recognised as expense on a straight-line basis over the lease term.

Group as a lessor

Leases in which the Group does not transfer substantially all the risks and rewards incidental to ownership of an asset are classified as operating leases. Rental income arising is accounted for on a straight-line basis over the lease terms and is included in revenue in the statement of profit or loss due to its operating nature. Initial direct costs incurred in negotiating and arranging an operating lease are added to the carrying amount of the leased asset and recognised over the lease term on the same basis as rental income. Contingent rents are recognised as revenue in the period in which they are earned.

- (iii) 短期租賃和低價值資產租賃本集團將短期租賃確認豁免適用於其機械及設備的短期租賃（即租賃期自生效日期起12個月或更短，且不包含購買選擇權的租賃）。它還將低價值資產確認豁免租賃適用於被視為低價值的辦公室設備租賃。短期租賃及低價值資產租賃之租賃款項按直線法於租期內確認為開支。

集團作為出租人

本集團實質上沒有轉移資產所有權附帶的所有風險和報酬的租賃被歸類為經營租賃。產生的租金收入在租賃期內按直線法核算，並因其經營性質計入損益表的收入。在談判和安排經營租賃時產生的初始直接費用，計入租賃資產的賬面價值，並在租賃期內按與租金收入相同的基礎確認。或有租金在其賺取期間確認為收入。

Financial instruments

A financial instrument is any contract that gives rise to a financial asset of one entity and a financial liability or equity instrument of another entity.

(i) Financial assets

Initial recognition and measurement

Financial assets are classified, at initial recognition, as subsequently measured at amortised cost, fair value through other comprehensive income (OCI), and fair value through profit or loss.

The classification of financial assets at initial recognition depends on the financial asset's contractual cash flow characteristics and the Group's business model for managing them. With the exception of trade receivables that do not contain a significant financing component or for which the Group has applied the practical expedient, the Group initially measures a financial asset at its fair value plus, in the case of a financial asset not at fair value through profit or loss, transaction costs. Trade receivables that do not contain a significant financing component or for which the Group has applied the practical expedient are measured at the transaction price.

In order for a financial asset to be classified and measured at amortised cost or fair value through OCI, it needs to give rise to cash flows that are 'solely payments of principal and interest' on the principal amount outstanding.

The Group's business model for managing financial assets refers to how it manages its financial assets in order to generate cash flows. The business model determines whether cash flows will result from collecting contractual cash flows, selling the financial assets, or both.

Purchases or sales of financial assets that require delivery of assets within a time frame established by regulation or convention in the market place (regular way trades) are recognised on the trade date, i.e., the date that the Group commits to purchase or sell the asset.

本集團管理金融資產的業務模式是指本集團如何管理其金融資產以產生現金流。商業模式決定了現金流是來自於合同現金流的收取，還是來自於金融資產的出售，或者兩者兼而有之。

金融資產的購買或出售於交易日確認，即本集團承諾購買或出售該資產的日期，並要求資產的交付需要在市場上的法規或慣例規定的時間範圍內（常規交易）。

Subsequent measurement

The subsequent measurement of financial assets depends on their classification as follows:

Financial assets at amortised cost (debt instruments)

The Group measures financial assets at amortised cost if both of the following conditions are met:

- The financial asset is held within a business model with the objective to hold financial assets in order to collect contractual cash flows.
- The contractual terms of the financial asset give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding.

Financial assets at amortised cost are subsequently measured using the effective interest method and are subject to impairment. Gains and losses are recognised in the income statement when the asset is derecognised, modified or impaired.

Financial assets at fair value through profit or loss

Financial assets at fair value through profit or loss include financial assets held for trading, financial assets designated upon initial recognition at fair value through profit or loss, or financial assets mandatorily required to be measured at fair value. Financial assets are classified as held for trading if they are acquired for the purpose of selling or repurchasing in the near term. Derivatives, including separated embedded derivatives, are also classified as held for trading unless they are designated as effective hedging instruments. Financial assets with cash flows that are not solely payments of principal and interest are classified and measured at fair value through profit or loss, irrespective of the business model. Notwithstanding the criteria for debt instruments to be classified at amortised cost, as described above, debt instruments may be designated at fair value through profit or loss on initial recognition if doing so eliminates, or significantly reduces, an accounting mismatch.

A derivative embedded in a hybrid contract, with a financial liability or non-financial host, is separated from the host and accounted for as a separate derivative if the economic characteristics and risks are not closely related to the host; a separate instrument with the same terms as the embedded derivative would meet the definition of a derivative; and the hybrid contract is not measured at fair value through profit or loss. Embedded derivatives are measured at fair value with changes in fair value recognised in the income statement. Reassessment only occurs if there is either a change in the terms of the contract that significantly modifies the cash flows that would otherwise be required or a reclassification of a financial asset out of the fair value through profit or loss category.

Derecognition

A financial asset (or, where applicable, a part of a financial asset or part of a group of similar financial assets) is primarily derecognised (i.e., removed from the Group's consolidated statement of financial position) when:

- the rights to receive cash flows from the asset have expired; or
- the Group has transferred its rights to receive cash flows from the asset or has assumed an obligation to pay the received cash flows in full without material delay to a third party under a "pass-through" arrangement; and either (a) the Group has transferred substantially all the risks and rewards of the asset, or (b) the Group has neither transferred nor retained substantially all the risks and rewards of the asset, but has transferred control of the asset.

When the Group has transferred its rights to receive cash flows from an asset or has entered into a pass-through arrangement, it evaluates if, and to what extent, it has retained the risks and rewards of ownership. When it has neither transferred nor retained substantially all of the risks and rewards of the asset, nor transferred control of the asset, the Group continues to recognise the transferred asset to the extent of its continuing involvement. In that case, the Group also recognises an associated liability. The transferred asset and the associated liability are measured on a basis that reflects the rights and obligations that the Group has retained.

Continuing involvement that takes the form of a guarantee over the transferred asset is measured at the lower of the original carrying amount of the asset and the maximum amount of consideration that the Group could be required to repay.

Financial liabilities are classified, at initial recognition, as financial liabilities at fair value through profit or loss, loans and borrowings, or payables, as appropriate.

All financial liabilities are recognised initially at fair value and, in the case of loans and borrowings and payables, net of directly attributable transaction costs.

The Group's financial liabilities include creditors, other payables and accrued expenses, and interest-bearing borrowings.

Subsequent measurement

After initial recognition, interest-bearing loans and borrowings are subsequently measured at amortised cost, using the effective interest rate method unless the effect of discounting would be immaterial, in which case they are stated at cost. Gains and losses are recognised in the income statement when the liabilities are derecognised as well as through the effective interest rate amortisation process. Amortised cost is calculated by taking into account any discount or premium on acquisition and fees or costs that are an integral part of the effective interest rate. The effective interest rate amortisation is included in finance costs in the profit or loss.

Derecognition

A financial liability is derecognised when the obligation under the liability is discharged or cancelled, or expires. When an existing financial liability is replaced by another from the same lender on substantially different terms, or the terms of an existing liability are substantially modified, such an exchange or modification is treated as a derecognition of the original liability and a recognition of a new liability, and the difference between the respective carrying amounts is recognised in profit or loss.

初始確認後，計息貸款和借貸後續採用實際利率法按攤餘成本計量，除非折現的影響無關緊要，在此情況下，則按成本列示。當負債終止確認以及通過實際利率攤銷過程時，損益在損益表中確認。攤餘成本是通過考慮收購的任何折扣或溢價以及作為實際利率組成部分的費用或成本來計算的。實際利率攤銷計入損益中的財務成本。

Impairment of financial assets

IFRS 9 requires the Group to record an allowance for ECLs for all loans and other debt financial assets not held at FVTPL using a forward-looking ECL approach.

The ECL allowance is based on the difference between the contractual cash flows due in accordance with the contract and all the cash flows that the Group expects to receive. The shortfall is then discounted at an approximation to the asset's original effective interest rate (“EIR”).

For contract assets and trade receivables, the Group has applied the standard's simplified approach and has calculated ECLs based on lifetime expected credit losses. The Group has established a provision matrix that is based on the Group's historical credit loss experience, adjusted for forward-looking factors specific to the debtors and the economic environment.

Other receivables are assessed for impairment based on 12-month expected credit losses: 12-month ECLs are the portion of lifetime ECLs that result from default events that are possible within 12 months after the reporting date (or a shorter period if the expected life of the asset is less than 12 months). However, when there has been a significant increase in credit risk since origination, the allowance will be based on the lifetime ECL.

The Group considers a financial asset in default when contractual payments are 90 days past due. However, in certain cases, the Group may also consider a financial asset to be in default when internal or external information indicates that the Group is unlikely to receive the outstanding contractual amounts in full before taking into account any credit enhancements held by the Group.

國際財務報告準則第9號要求本集團就並非持作按公允價值計量且其變動計入損益的所有貸款及其他債務金融資產的預期信貸虧損計提撥備。

預期信貸虧損撥備乃基於根據合同到期的合同現金流量與本集團預期收取的所有現金流量之間的差額。該差額後續按與資產原有實際利率相近的數值折現。

對於合約資產及應收賬款，本集團已採用該準則的簡化方法及根據可使用期內預期信貸虧損計算預期信貸虧損。本集團已建立基於本集團的過往信貸虧損記錄的撥備矩陣，可就債務人及經濟環境特有的前瞻性因素而予以調整。

其他應收賬款根據12個月之預期信貸虧損作出減值評估：12個月之預期信貸虧損是指因報告日後12個月內（或倘該資產預計使用年期少於12個月，則以較短期間為準）可能發生之違約事件而導致部分可使用期內預期信貸虧損。然而，如信貸風險自產生以來大幅增加，則將根據可使用期內預期信貸虧損作出撥備。

本集團將合同付款逾期90日的金融資產視作違約。然而，於若干情況下，當內部或外部信息表明本集團不可能全數收回未償還合同金額時，本集團亦可能認為金融資產違約。

Offsetting of financial instruments

Financial assets and financial liabilities are offset and the net amount is reported in the statement of financial position if there is a currently enforceable legal right to offset the recognised amounts and there is an intention to settle on a net basis, or to realise the assets and settle the liabilities simultaneously.

Inventories

Inventories, mainly comprise raw materials and consumables used in the repairs and maintenance of the waste water treatment plants, are stated at the lower of cost and net realisable value. Cost is determined on the first-in, first-out basis. Net realisable value is based on estimated selling prices less any estimated costs to be incurred to completion and disposal. When inventories are consumed, the carrying amount of those inventories is recognised as an expense in profit or loss.

Cash and cash equivalents

Cash and cash equivalents comprise cash balances, short-term deposits and short-term balances in financial institutions with maturities of three months or less from the date of acquisition that are subject to an insignificant risk of changes in their fair value, and are used by the Group in the management of its short-term commitments.

For the purpose of the consolidated statement of cash flows, restricted bank balances are excluded whilst bank overdrafts that are repayable on demand and that form an integral part of the Group's cash management are included in cash and cash equivalents.

Provisions

A provision is recognised when a present obligation (legal or constructive) has arisen as a result of a past event and it is probable that a future outflow of resources will be required to settle the obligation, provided that a reliable estimate can be made of the amount of the obligation.

When the effect of discounting is material, the amount recognised for a provision is the present value at the end of the reporting period of the future expenditures expected to be required to settle the obligation. The increase in the discounted present value amount arising from the passage of time is included in profit or loss.

倘現時存在可執行合法權利抵銷已確認金額，且有意以淨額結算，或同時變現資產及清償負債，則金融資產與金融負債抵銷後，以淨額於財務狀況表呈報。

存貨

存貨（主要包括修理及維護污水處理廠所用的原材料及消耗品）按成本與可變現淨值之較低者列賬。成本為採用先進先出法釐定。可變現淨值根據預計售價扣減完成及出售將產生之任何預計成本計算。消耗存貨時，該等存貨的賬面價值於損益中確認為開支。

現金及現金等價物

現金及現金等價物包括現金結餘、短期存款及金融機構中公允價值變動風險不大且自購買日期起三個月或以內到期的短期結餘，而該等現金及現金等價物被本集團用於管理其短期承擔。

就綜合現金流量表而言，不包括受限制的銀行結餘，但須按要償還且組成本集團現金管理必不可少一部分的銀行透支則計入現金及現金等價物。

撥備

倘因過往事件須承擔現時責任（法定或推定），而履行該責任可能導致未來資源外流，且該責任所涉金額能夠可靠估計，則確認撥備。

倘折現影響重大，則確認撥備的金額為預期履行責任所需未來開支於報告期末的現值。折現現值隨時間而增加的金額計入損益。

Income tax

Income tax comprises current and deferred tax. Income tax relating to items recognised outside profit or loss is recognised outside profit or loss, either in other comprehensive income or directly in equity.

Current tax assets and liabilities are measured at the amount expected to be recovered from or paid to the taxation authorities, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period, taking into consideration interpretations and practices prevailing in the countries in which the Group operates.

Deferred tax is provided, using the liability method, on all temporary differences at the end of the reporting period between the tax bases of assets and liabilities and their carrying amounts for financial reporting purposes.

Deferred tax liabilities are recognised for all taxable temporary differences, except:

- when the deferred tax liability arises from the initial recognition of goodwill or an asset or liability in a transaction that is not a business combination and, at the time of the transaction, affects neither the accounting profit nor taxable profit or loss; and
- in respect of taxable temporary differences associated with investments in subsidiaries and an associate, when the timing of the reversal of the temporary differences can be controlled and it is probable that the temporary differences will not reverse in the foreseeable future.

Deferred tax assets are recognised for all deductible temporary differences, the carryforward of unused tax credits and any unused tax losses. Deferred tax assets are recognised to the extent that it is probable that taxable profit will be available against which the deductible temporary differences, the carryforward of unused tax credits and unused tax losses can be utilised, except:

- when the deferred tax asset relating to the deductible temporary differences arises from the initial recognition of an asset or liability in a transaction that is not a business combination and, at the time of the transaction, affects neither the accounting profit nor taxable profit or loss; and
- in respect of deductible temporary differences associated with investments in subsidiaries and an associate, deferred tax assets are only recognised to the extent that it is probable that the temporary differences will reverse in the foreseeable future and taxable profit will be available against which the temporary differences can be utilised.

The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profit will be available to allow all or part of the deferred tax asset to be utilised. Unrecognised deferred tax assets are reassessed at the end of each reporting period and are recognised to the extent that it has become probable that sufficient taxable profit will be available to allow all or part of the deferred tax asset to be recovered.

Deferred tax assets and liabilities are measured at the tax rates that are expected to apply to the period when the asset is realised or the liability is settled, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period.

Deferred tax assets and deferred tax liabilities are offset if and only if the Group has a legally enforceable right to set off current tax assets and current tax liabilities and the deferred tax assets and deferred tax liabilities relate to income tax levied by the same taxation authority on either the same taxable entity or different taxable entities which intend either to settle current tax liabilities and assets on a net basis, or to realise the assets and settle the liabilities simultaneously, in each future period in which significant amounts of deferred tax liabilities or assets are expected to be settled or recovered.

Government grants

Government grants are recognised at their fair value where there is reasonable assurance that the grant will be received and all attaching conditions will be complied with. When the grant relates to an expense item, it is recognised as income on a systematic basis over the periods that the costs, which it is intended to compensate, are expensed.

Where the grant relates to an asset, the fair value is credited to a deferred income account and is released to profit or loss over the expected useful life of the relevant asset by equal annual instalments or deducted from the carrying amount of the asset and released to profit or loss by way of a reduced depreciation charge.

Revenue recognition

Revenue from contracts with customers

Revenue is measured based on the consideration specified in a contract with a customer and excludes amounts collected on behalf of third parties. The Group recognises revenue when it transfers control over a product or service to a customer.

The Group has satisfied a performance obligation and recognises revenue over time, if one of the following criteria is met:

- (a) The customer simultaneously receives and consumes the benefits provided by the Group's performance as the Group performs

If none of the above conditions are met, the Group recognises revenue at the point in time at which the performance obligation is satisfied.

If control of the asset transfers over time, revenue is recognised over the period of the contract by reference to the progress towards complete satisfaction of that performance obligation. Otherwise, revenue is recognised at a point in time when the customer obtains control of the asset.

The progress towards complete satisfaction of the performance obligation is measured based on the Group's efforts or inputs to the satisfaction of the performance obligation, by reference to the surveyors' assessment of work performed and the costs incurred up to the end of reporting period as a percentage of total estimated costs for each contract.

When the Group provides more than one service in a service concession arrangement, the transaction price will be allocated to each performance obligation by reference to their relative stand-alone selling prices. If the stand-alone selling prices are not directly observable, they are estimated based on expected cost plus a margin or adjusted market assessment approach, depending on the availability of observable information.

In determining the transaction price, the Group adjusts the promised amount of consideration for the effect of a financing component if it is significant.

Construction service revenue

The Group's performance in respect of construction services creates or enhances an asset or work in progress that the customer controls as the asset is created or enhanced, thus the Group satisfies a performance obligation and recognises revenue from construction service over time, by reference to completion of the specific transaction assessed on the basis of the surveyors' assessment of work performed and the costs incurred up to the end of the reporting period as a percentage of total estimated costs for each contract.

Revenue from the construction services under a service concession agreement is estimated on a cost-plus basis with reference to a prevailing market rate of gross margin at the date of the agreement applicable to similar construction services rendered.

Operation revenue

The Group recognises revenue from environmental water project operation services when the related services are rendered. The operation revenue from reusable water supply service is recognised at a point in time when the Group has delivered water to the customer; the customer has accepted the water; the Group has the present right to payment and the collection of the consideration is probable. The other operation revenue from service concession arrangements is recognised over the period of time that the services are rendered and the benefits are received and consumed simultaneously by the customers.

Finance and interest income

Finance and interest income is recognised on an accrual basis using the EIR method by applying the rate that exactly discounts the estimated future cash receipts over the expected life of the financial instrument or a shorter period, when appropriate, to the net carrying amount of the financial asset.

就建造服務而言，本集團之履約行為創造或改良了客戶在資產被創造或改良時已控制的資產或在建工程，因此本集團履行履約責任後隨時間推移確認建造服務收入並參考測量師就已進行之工作量之評估及截至報告期末已產生的成本佔合同之估計總成本之百分比。

來源於服務特許經營權安排的建造服務收入經參考於協議日期提供類似建造服務適用之現行市場毛利率後以成本加成法進行估計。

運營收入

於提供相關服務時，本集團確認來自水環境項目運營服務的收入，而中水回用供應服務的收入為於某個時點確認，即本集團已向客戶交付水；客戶已接收水；本集團有現時權利可支付及收取代價時，予以確認。服務特許經營權安排其他運營收入均於提供服務的期間及客戶同時收到且消耗利益時確認。

財務及利息收入

財務及利息收入乃按應計基準採用實際利率法透過應用有關利率（即於金融工具預計年期或（倘適用）較短期間內將估計未來現金收入準確貼現至財務資產賬面淨值之利率）計算確認。

Contract assets and contract liabilities

Upon entering into a contract with a customer, the Group obtains rights to receive consideration from the customer and assumes performance obligations to transfer goods or provide services to the customer. The combination of those rights and performance obligations gives rise to a net asset or a net liability depending on the relationship between the remaining rights and the performance obligations. The contract is an asset and recognised as contract assets if the measure of the remaining rights exceeds the measure of the remaining performance obligation. Conversely, the contract is a liability and recognised as contract liabilities if the measure of the remaining performance obligations exceeds the measure of the remaining rights.

The Group recognises the incremental costs of obtaining a contract with a customer within contract assets if the Group expects to recover those costs.

Other employee benefits - pension schemes

The Group operates a defined contribution Mandatory Provident Fund retirement benefit scheme (the “**MPF Scheme**”) under the Mandatory Provident Fund Schemes Ordinance for those employees employed under the jurisdiction of the Hong Kong Employment Ordinance and are eligible to participate in the MPF Scheme. Contributions are made based on a percentage of the employees’ basic salaries and are charged to profit or loss as they become payable in accordance with the rules of the MPF Scheme. The assets of the MPF Scheme are held separately from those of the Group in an independently administered fund. The Group’s employer contributions vest fully with the employees when contributed into the MPF Scheme, except for the Group’s employer voluntary contributions, which are refunded to the Group when the employee leaves employment prior to the contributions vesting fully, in accordance with the rules of the MPF Scheme.

The employees of the Group’s subsidiaries which operate in Mainland China are required to participate in a central pension scheme operated by the local municipal government. These subsidiaries are required to contribute a certain percentage of their payroll costs to the central pension scheme. The contributions are charged to profit or loss as they become payable in accordance with the rules of the central pension scheme.

當與客戶訂立合同後，本集團有權收取來自客戶支付的代價，並承擔將貨物或服務轉移至客戶的履約責任。該等權利及履約責任共同產生淨資產或淨負債，並視乎剩餘權利與履約責任之間的關係而定。倘合同計量的剩餘收款權超過剩餘履約責任，則該合同為一項資產，並確認為合約資產。反之，倘剩餘履約責任超過剩餘收款權，則該合同為一項負債，並確認為合約負債。

倘本集團預計為獲得客戶合同而產生的增量成本可收回，則將其確認為合約資產。

其他僱員福利—退休金計劃

根據《強制性公積金計劃條例》，本集團為在香港僱傭條例管轄之司法區域受僱並符合資格參與的僱員設立定額供款強制性公積金退休福利計劃（「**強積金計劃**」）。供款額根據有關僱員的基本薪金按一定比例計算，根據強積金計劃的規則在供款應予支付時，將有關費用計入損益。強積金計劃的資產與本集團的資產分開，並由獨立管理基金持有。根據強積金計劃的規定，除了本集團僱主自願性供款部分外，本集團僱主向強積金計劃的供款於供款時全部歸屬於僱員，倘僱員於有權獲得全數僱主自願性供款前離職，則本集團可收回該供款的未歸屬僱員部分。

本集團在中國內地經營的附屬公司的僱員須參與由地方政府管理的中央退休金計劃。該等附屬公司須就中央退休金計劃作出供款，金額為其工資成本的一定百分比。根據中央退休金計劃的規定，供款於應付時確認為損益。

Borrowing costs

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, i.e., assets that necessarily take a substantial period of time to get ready for their intended use or sale, are capitalised as part of the cost of those assets. The capitalisation of such borrowing costs ceases when the assets are substantially ready for their intended use or sale. Investment income earned on the temporary investment of specific borrowings pending their expenditure on qualifying assets is deducted from the borrowing costs capitalised. All other borrowing costs are expensed in the period in which they are incurred. Borrowing costs consist of interest and other costs that an entity incurs in connection with the borrowing of funds.

Dividends

Final dividends are recognised as a liability when they are approved by the shareholders in a general meeting. Proposed final dividends are disclosed in the notes to the financial statements.

Interim dividends are simultaneously proposed and declared, because the Company's memorandum and articles of association grant the directors the authority to declare interim dividends. Consequently, interim dividends are recognised immediately as a liability when they are proposed and declared.

Foreign currencies

The functional currency of the Company is RMB. This financial statements are presented in Hong Kong dollars ("HK\$"), which is the Company's presentation currency. The Company has used Hong Kong dollars as its presentation currency to be consistent with that of China Everbright Water Holdings Limited, the immediate holding company of the Company. Each entity in the Group determines its own functional currency and items included in the financial statements of each entity are measured using that functional currency. Foreign currency transactions recorded by the entities in the Group are initially recorded using their respective functional currency rates prevailing at the dates of the transactions. Monetary assets and liabilities denominated in foreign currencies are translated at the functional currency rates of exchange ruling at the end of the reporting period. Differences arising on settlement or translation of monetary items are recognised in profit or loss.

因收購、建造或生產合格資產（即需要大量時間方可達到擬定用途或出售的資產）而直接應計的借貸成本，一律資本化作為該等資產的部分成本。當資產大致可供擬定用途或出售，則有關借貸成本停止資本化。特定借貸於用作合資格資產支出前的臨時投資所賺取的投資收入於已資本化的借貸成本中扣減。所有其他借貸成本於發生期間費用化。借貸成本包括實體就借入資金產生的利息及其他成本。

股息

末期股息在股東大會上獲股東批准時確認為負債。擬派末期股息於財務報表附註披露。

中期股息建議及宣派同步進行，此乃由於本公司組織章程大綱及細則授權董事宣派中期股息。因此，中期股息於其建議及宣派時實時確認為負債。

外幣

本公司的功能貨幣為人民幣。財務報表以港元（本公司之呈列貨幣）呈列。本公司已採用與本公司直接控股公司中國光大水務控股有限公司所用一致之港元作為其呈列貨幣。本集團旗下各實體自行確定功能貨幣，且各實體財務報表中的項目均使用該功能貨幣計量。本集團實體已入賬之外幣交易初始按交易日期通行的相關功能貨幣匯率列賬。以外幣計值的貨幣資產與負債按於報告期末按通用的功能貨幣匯率重新換算。結算或換算貨幣項目產生之差異於損益內確認。

Differences arising on settlement or translation of monetary items are recognised in profit or loss with the exception of monetary items that are designated as part of the hedge of the Group's net investment of a foreign operation. These are recognised in other comprehensive income until the net investment is disposed of, at which time the cumulative amount is reclassified to profit or loss. Tax charges and credits attributable to exchange differences on those monetary items are also recorded in other comprehensive income.

Non-monetary items that are measured in terms of historical cost in a foreign currency are translated using the exchange rates at the dates of the initial transactions. Non-monetary items measured at fair value in a foreign currency are translated using the exchange rates at the date when the fair value was measured. The gain or loss arising on translation of a non-monetary item measured at fair value is treated in line with the recognition of the gain or loss on change in fair value of the item (i.e., translation difference on the item whose fair value gain or loss is recognised in other comprehensive income or profit or loss is also recognised in other comprehensive income or profit or loss, respectively).

The functional currencies of the Company, certain overseas subsidiaries and an associate are currencies other than the Hong Kong dollar. As at the end of the reporting period, the assets and liabilities of these entities are translated into Hong Kong dollars at the exchange rates prevailing at the end of the reporting period and their statements of comprehensive income are translated into Hong Kong dollars at the weighted average exchange rates for the year.

The resulting exchange differences are recognised in other comprehensive income and accumulated in the exchange reserve. On disposal of a foreign operation, the component of other comprehensive income relating to that particular foreign operation is recognised in profit or loss.

Any goodwill arising on the acquisition of a foreign operation and any fair value adjustments to the carrying amounts of assets and liabilities arising on acquisition are treated as assets and liabilities of the foreign operation and translated at the closing rate.

按歷史成本列賬、以外幣計量的非貨幣項目，採用初始交易日期的匯率換算。按公允價值列賬、以外幣計量的非貨幣項目，採用計量公允價值日期的匯率換算。換算按公允價值計量的非貨幣項目產生的收益或虧損按與確認項目公允價值變動的收益或虧損一致的方式處理（即公允價值收益或虧損於其他全面收益內確認或損益內確認的項目，其換算差額亦分別於其他全面收益內確認或損益內確認）。

本公司、若干境外附屬公司及聯營公司的功能貨幣為港元以外的貨幣。於報告日期末，該等實體的資產與負債按報告期末的匯率換算為港元，其全面收益表則按年內的加權平均匯率換算為港元。

由此產生的匯兌差額於其他全面收益內確認，在匯兌儲備中累計。出售海外業務時，與該項特定海外業務有關的其他全面收益的部分應轉入損益。

For the purpose of the consolidated statement of cash flows, the cash flows of the Company, certain overseas subsidiaries and an associate are translated into Hong Kong dollars at the exchange rates ruling at the dates of the cash flows. Frequently recurring cash flows of these entities which arise throughout the year are translated into Hong Kong dollars at the weighted average exchange rates for the year.

3. SIGNIFICANT ACCOUNTING JUDGEMENTS AND ESTIMATES

The preparation of the financial statements requires management to make judgements, estimates and assumptions that affect the reported amounts of revenues, expenses, assets and liabilities, and their accompanying disclosures, and the disclosure of contingent liabilities. Uncertainty about these assumptions and estimates could result in outcomes that could require a material adjustment to the carrying amounts of the assets or liabilities affected in the future.

Judgements

In the process of applying the Group's accounting policies, management has made the following judgements, apart from those involving estimations, which have the most significant effect on the amounts recognised in the financial statements:

Service concession arrangements

The Group entered into Build-Operate-Transfer (“**BOT**”), Transfer-Operate-Transfer (“**TOT**”) and Build-Own-Operate (“**BOO**”) arrangements in respect of its environmental water projects.

The Group has concluded that all the BOT and TOT arrangements and certain BOO arrangements are service concession arrangements under IFRIC 12 *Service Concession Arrangements*, because the local government controls and regulates the services that the Group must provide with the infrastructure at a pre-determined service charge. In respect of BOT and TOT arrangements, upon expiry of concession right agreements, the infrastructure has to be transferred to the local government at nil consideration. Infrastructure for BOO arrangements is used in the service concession arrangements for its entire or substantially entire useful life.

服務特許經營安排

本集團就其水環境項目訂立建設—運營—移交（「**BOT**」）、轉讓—運營—移交（「**TOT**」）及建設—擁有一運營（「**BOO**」）安排。

本集團已確定所有BOT及TOT安排以及若干BOO安排均屬國際財務報告詮釋委員會第12號 *服務特許經營安排*，乃由於當地政府機關控制並監管本集團利用基礎設施按預定服務費所須提供之服務。就BOT及TOT安排而言，在特許經營協議到期後，有關基礎設施須無償移交當地政府機關所有。就BOO安排而言，有關服務特許經營安排所涉及之基礎設施於其整個或大致上整個可使用年內使用。

Estimation uncertainty

The key assumptions concerning the future and other key sources of estimation uncertainty at the end of the reporting period, that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year, are described below.

Contract assets and/or intangible assets under IFRIC 12 Service Concession Arrangements

The Group recognises the consideration received or receivable in exchange for the construction services as a contract asset and/or an intangible asset under a service concession arrangement. However, if the Group is paid for the construction services partly by a contract asset and partly by an intangible asset, it is necessary to account separately for each component of the operator's consideration. The consideration received or receivable for both components shall be recognised initially at the fair value.

The segregation of the consideration for a service concession arrangement between the contract asset component and the intangible asset component, if any, requires the Group to make an estimate of a number of factors, which include, inter alia, fair value of the construction services, expected future water treatment volume of the relevant water treatment plant over its service concession period, future guaranteed receipts and unguaranteed receipts, and also to choose a suitable discount rate in order to calculate the present value of those cash flows. These estimates, including revenue recognition under the contract asset and intangible asset components are determined by the Group's management based on their experience and assessment on current and future market conditions. The carrying amounts of the intangible assets ("**concession rights**") and contract assets at the end of reporting period are disclosed in notes 17 and 21, respectively.

本集團根據服務特許經營安排將以建造服務換取的已收或應收代價確認為合約資產及/或無形資產。然而，倘本集團已就建造服務獲付款部分以合約資產及部分以無形資產支付，則需將已收或應收代價的各部分分別入賬。各部分的已收或應收代價按公允價值進行初始確認。

合約資產部分和無形資產部分的服務特許權安排對價的分攤，需要本集團對若干因素作出估計，特別包括建造服務的公允價值、有關污水處理廠於其服務特許經營期內的預期未來污水處理量、未來有擔保收款及無擔保收款，並需選擇適當折現率以計算該等現金流量的現值。該等估計（包括合約資產及無形資產部分的收入確認）由本集團管理層按彼等之經驗以及對現有及未來市場狀況的評估而釐定。無形資產（「**特許經營權**」）及合約資產分別披露於附註17及21。

The Group assesses whether there are any indicators of impairment for all non-financial assets at each reporting date. Non-financial assets are tested for impairment when there are indicators that the carrying amount may not be recoverable.

Estimating the value in use requires the Group to make an estimate of the expected future cash flows from the cash-generating unit and also to choose a suitable discount rate in order to calculate the present value of those cash flows. The carrying amounts of property, plant and equipment and intangible assets (other than goodwill) are disclosed in notes 14 and 17.

Impairment of financial assets at amortised cost

The impairment loss in respect of contract assets, trade and other receivables of the Group is based on the evaluation of collectability and ageing analysis of contract assets, trade and other receivables and on management's judgement. A considerable amount of judgement is required in assessing the ultimate realisation of these receivables, including the current creditworthiness and the past collection history of each debtor. If the financial conditions of debtors of the Group were to deteriorate, resulting in an impairment of their abilities to make payments, additional allowances may be required.

The carrying amounts of the Group's financial assets at amortised cost are disclosed in notes 21, 23, and 25.

Impairment of interests in subsidiaries

The Company assesses at each reporting date whether there is any objective evidence that the interests in subsidiaries are impaired. To determine whether there is objective evidence of impairment, the Company considers factors such as the industry performance, technology changes, operational and financing cash flows. Management will also consider the financial condition and business prospects of the interest.

Where there is objective evidence of impairment, the amount and timing of future cash flows are estimated based on the forecasted performance of the subsidiary. The carrying amounts of the Company's interests in subsidiaries at the reporting date are disclosed in note 20.

Revenue recognition for construction work

The Group recognises contract revenue over time by reference to the progress towards complete satisfaction of the performance obligation at the reporting date. The progress is measured based on the Group's effort or inputs to the satisfaction of the performance obligation, by reference to the surveyors' assessment of work performed and the costs incurred up to the end of the reporting period as a percentage of total estimated costs for each performance obligation in the contract. Significant assumptions are required to estimate the recoverable variation works that will affect the progress towards complete satisfaction of the performance obligation. The Group reviews and revises the estimates in each construction contract as the contract progresses.

Impairment losses for goodwill

As explained in the accounting policy set out in note 2.4 for "Business combinations and goodwill", goodwill is allocated to a cash-generating unit or to a group of cash-generating units that are expected to benefit from the synergies of the combination for the purpose of impairment assessment, which requires significant judgement. The Group determined that the group of cash-generating units to which goodwill was allocated reflected the lowest level at which goodwill was monitored for internal reporting and was not larger than an operating segment in accordance with IAS 36 Impairment of Assets.

The Group determines whether goodwill is impaired at least on an annual basis. This involves an estimation of the value in use of the cash-generating units to which the goodwill is allocated. Estimating the value in use requires the Group to make an estimate of the expected future cash flows from the cash-generating units and also to choose a suitable discount rate in order to calculate the present value of those cash flows. The carrying amount of goodwill at the reporting date is disclosed in note 18.

Income taxes

Determining income tax provisions involves judgement on the future tax treatment of certain transactions. The Group carefully evaluates the tax implications of transactions and tax provisions are set up accordingly. The tax treatment of such transactions is reconsidered periodically to take into account all changes in tax legislation. Where the final tax outcome is different from the amounts that were initially recognised, such differences will impact the income and other taxes and deferred tax provisions in the period in which such determination is made.

4. OPERATING SEGMENT INFORMATION

Operating segments are identified based on the internal reports about components of the Group that are regularly reviewed by the Company's management ("the Management") and the Board for the purpose of resource allocation and performance assessment.

Segment results, assets and liabilities include items directly attributable to a segment as well as those that can be allocated on a reasonable basis. Unallocated items comprise mainly corporate assets and expense, interest-bearing borrowings and related expenses and income and deferred taxes. The Group operates in a single business segment which is the water environment management business. No operating segments have been aggregated to form the following reportable operating segment.

Business segment

The Group had only one operating segment for the years ended 31 December 2021 and 2020, namely the water environment management business, the details of which are set out below:

- Water environment management - Engagement in municipal waste water treatment, industrial waste water treatment, water supply, reusable water, sludge treatment and disposal, sponge city construction, river-basin ecological restoration, waste water source heat pump, leachate treatment, R&D of water environment technologies and engineering construction.

The duration of the cash flows and the specific timing of inflows and outflows are determined by events such as rent reviews, lease renewal and related reletting, redevelopment or refurbishment. The appropriate duration is driven by market behaviour that is a characteristic of the class of property. The periodic cash flow is estimated as gross income less vacancy, non-recoverable expenses, collection losses, lease incentives, maintenance costs, agent and commission costs and other operating and management expenses. The series of periodic net operating income, along with an estimate of the terminal value anticipated at the end of the projection period, is then discounted.

Under market comparison approach, fair value of investment properties is determined by reference to recent sales prices of comparable properties on a price per square metre basis, adjusted for a premium or a discount specific to the quality of the Group's buildings compared to the recent sales and the timing on the comparable transactions. Higher premium for higher quality buildings and a favourable adjustment on the timing of comparable transaction will result in higher fair value measurement.

16. LEASES

The Group as a lessee

The Group has lease contracts for various items of land and buildings, equipment and others used in its operation. Lump sum payments were made upfront to acquire the land lease from the owners with lease periods of fifty years, and no ongoing payments will be made under the terms of these land leases. Lease of land, equipment and others generally have lease terms between two and three years. Generally, the Group is restricted from assigning and subleasing the leased assets outside the Group.

On 15 January 2021, the Company issued the second tranche of RMB-denominated MTN of RMB1 billion, before related expenses of RMB3,000,000, with an interest rate at 3.75% per annum, and a maturity period of 3 years from the issuance date. The interest shall be paid annually from 16 January 2021 and up to the maturity date. On 10 August 2021, the Company issued the first tranche of RMB-denominated SCP of RMB800 million, with an interest rate at 2.40% per annum and redemption date of 8 December 2021. The interest shall be paid on the redemption date together with the principal. The Company has repaid the principal and interest of the first tranche of RMB-denominated SCP on 8 December 2021.

On 4 April 2020, the Company received a notice of registration acceptance issued by National Association of Financial Market Institutional Investors of the People's Republic of China in respect of MTN, with a registered principal amount of RMB3 billion, effective for two years since the notice was issued. On 4 August 2020, the Company issued the first tranche of RMB-denominated MTN with a principal amount of RMB1 billion, before related expenses of RMB3,704,000, with an interest rate at 3.60% per annum, and a maturity period of 3 years from the issuance date. The interest shall be paid annually from 5 August 2020 and up to the redemption date.

The Company submitted the application to the Shanghai Stock Exchange (“SSE”) on 28 November 2019 for a possible issuance of ABS by Everbright Water (Shenzhen) Limited (“Shenzhen Water”), a wholly-owned subsidiary of the Company, to qualified investors in the PRC pursuant to an asset-backed securities scheme (the “Scheme”). On 26 March 2020, the SSE issued a no-objection letter (the “No-objection Letter”) confirming that it has no objections to the potential issuance of ABS. Pursuant to the No-objection Letter, the issuance size of the ABS shall not be more than RMB300 million and the issuance of ABS shall be completed within 12 months from the date of the No-objection Letter.

The preference ABS are classified into five classes based on the maturity dates of such preference ABS, comprising:

- (a) Preference ABS 01 of RMB50,000,000 (“**Preference ABS 1**”);

(i) Foreign currency translation reserve

The foreign currency translation reserve represents exchange differences arising from the translation of the financial statements of the Company and foreign operations whose functional currencies are different from the Group's presentation currency.

(ii) Statutory reserve

In accordance with the Company Law of the People's Republic of China, the subsidiaries in the PRC are required to allocate 10% of the statutory after tax profits to the statutory reserve until the cumulative total of the reserve reaches 50% of the subsidiaries' registered capital. Subject to approval from the relevant PRC authorities, the statutory reserve may be used to offset any accumulated losses or increase the registered capital of the subsidiaries. 32. BUSINESS COMBINATION

On 21 January 2021, one of the wholly-owned subsidiaries of the Company, BEWIM signed an equity transfer agreement, the supplementary agreement to the equity transfer agreement and the cooperation agreement with Tianjin Binhai Environmental Protection Asset Development Co., Ltd. to acquire 65% interest in Tianjin Huantang. Tianjin Huantang is principally engaged in waste water treatment and recycling; pipeline engineering; municipal engineering; construction, management, operation, technical consultation and ancillary services of waste water treatment and reusable water facilities; research and development and operation of environmental protection technology and environmental protection products; renewable resources utilization and operation; sludge dewatering treatment and its application. The acquisition was made as part of the Group's strategy to expand the water business of the Group. The purchase consideration for the acquisition was in the form of cash, with consideration for the acquisition amounting to RMB666,336,000 (equivalent to HK\$800,136,000). The acquisition was completed on 1 March 2021.

As of 31 December 2021, the purchase price accounting for the business combination of Tianjin Huantang was completed. The table below sets forth the fair values of assets acquired and the liabilities assumed recognised at the acquisition date.

At each reporting date, the financial management department analyses the movements in the values of financial instruments and determines the major inputs applied in the valuation. The valuation is reviewed and approved by the chief financial officer. The valuation process and results are discussed with the audit committee twice a year for interim and annual financial reporting.

The fair values of the financial assets and liabilities are included at the amount at which the instrument could be exchanged in a current transaction between willing parties, other than in a forced or liquidation sale. The following methods and assumptions were used to estimate the fair values:

The fair values of the non-current portion of other receivables and borrowings have been calculated by discounting the expected future cash flows using rates currently available for instruments with similar terms, credit risk and remaining maturities. The Group's own non-performance risk for borrowings as at the end of each of the financial year was assessed to be insignificant.

The Group's principal financial instruments comprise borrowings and cash. The main purpose of these financial instruments is to finance the Group's operations. The Group has various other financial assets and liabilities such as trade and other receivables, contract assets and trade and other payables, which arise directly from its operations.

The main risks arising from the Group's financial instruments are interest rate risk, foreign currency risk, credit risk and liquidity risk. The board of directors reviews and agrees policies for managing each of these risks and they are summarised below. The Group's accounting policies in relation to derivatives are set out in note 2.4.

Interest rate risk

The Group's interest rate risk arises primarily from the Group's cash and cash equivalents, borrowings and balances with group companies. Borrowings issued at variable rates and at fixed rates expose the Group to cash flow interest rate risk and fair value interest rate risk, respectively. The Group does not use financial derivatives to hedge against the interest rate risk. The Group's interest rate profile as monitored by management is set out in (i) below.

It is estimated that a general increase/decrease of 1% in interest rates at 31 December 2021 and 2020, with all other variables held constant, would decrease/increase the Group's profit before tax by approximately HK\$109,905,000 and HK\$93,410,000 for the year ended 31 December 2021 and 2020, respectively.

The sensitivity analysis above indicates the instantaneous change in the Group's profit before tax that would arise assuming that the change in interest rates had occurred at the end of the reporting period and had been applied to remeasure those financial instruments held by the Group which expose the Group to fair value interest rate risk at the end of the reporting period. In respect of the exposure to cash flow interest rate risk arising from floating rate non-derivative instruments held by the Group at the end of the reporting period, the impact on the Group's profit before tax is estimated as an annualised impact on interest expense or income of such a change in interest rates. The sensitivity analysis assumes that the change in foreign exchange rates had been applied to remeasure those financial instruments held by the Group which expose the Group to foreign currency risk at the end of the reporting period, including inter-company payables and receivables within the Group which are denominated in a currency other than the functional currencies of the lender or the borrower. The analysis excludes differences that would result from the translation of the financial statements of foreign operations into the Group's presentation currency. The analysis was performed on the same basis throughout the financial year.

Credit risk

Management has a credit policy in place and the exposures to credit risk are monitored on an ongoing basis. Debts are usually due within 30 to 90 days from the date of billing.

Trade receivables of the Group represent receivables in respect of revenue from environmental water project operation services which are settled on a monthly basis. In addition, the Group has contract assets in respect of the Build-Transfer ("BT"), BOT, TOT and certain BOO arrangements.

Capital management

The Group's primary objectives when managing capital are to safeguard the Group's ability to continue as a going concern and to maintain an optimal capital structure so as to maximise shareholders' value.

In order to maintain or achieve an optimal capital structure, the Group may adjust the amount of dividend payment, issue new shares or obtain new borrowings. The Group's strategies are to maintain a prudent balance between the advantage and flexibility afforded by a sound capital position and the higher return on equity that is possible with greater leverage. There was no change in capital management policies during the reporting period.

Consistently, the Group monitors capital based on a net debt against equity ratio. The net debt against equity ratio is calculated by dividing net debt by total equity. Net debt is calculated as total liabilities (as shown in the consolidated statement of financial position of the Group, excluding tax payables and deferred tax liabilities) less cash and cash equivalents. Total equity comprises share capital, reserves and non-controlling interests.

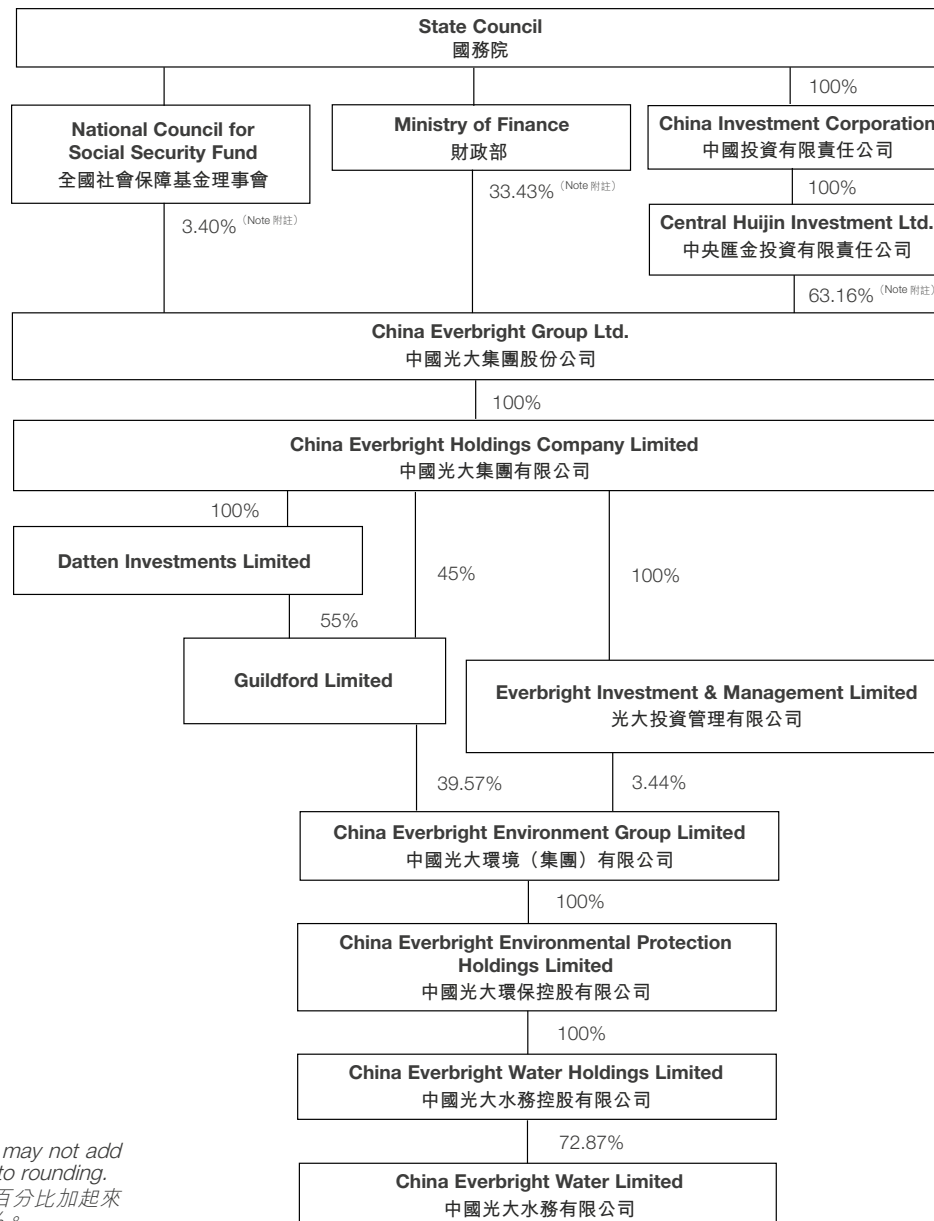

Central Huijin Investment Ltd. (“Huijin”)

Huijin, established in December 2003, is a state-owned investment company incorporated in accordance with the *Company Law of the PRC*, with a mandate to exercise the rights and the obligations as an investor in major state-owned financial enterprises, on behalf of the PRC. Huijin, in accordance with authorisation by the State Council makes equity investments in major state-owned financial enterprises, and shall, to the extent of its capital contribution, exercise the rights and perform the obligations as an investor on behalf of the PRC in accordance with applicable laws, to achieve the goal of preserving and enhancing the value of state-owned financial assets.

China Investment Corporation (“CIC”)

CIC was founded in September 2007 as a wholly state-owned company incorporated in accordance with the *Company Law of the PRC*. CIC was established as a vehicle to diversify China's foreign exchange holdings and seek maximum returns for its shareholder within acceptable risk tolerance. Huijin is a wholly-owned subsidiary of CIC. However, Huijin's principal shareholder rights are exercised by the State Council. Strict operational firewalls exist among CIC's overseas business and the domestic business run by Huijin.

Extract of the articles of association of Huijin and CIC

The articles of association of each of Huijin and CIC provide that each of Huijin and CIC “shall not interfere in the day-to-day business operations of the state-owned major financial enterprises it controls”. The articles of association of CIC further provide that “as a matter of principle, [CIC] shall not actively seek investment in domestic non-financial enterprises, except for purchasing overseas listed stocks, passive shareholdings and other circumstances as approved by the relevant governmental authorities”.

Board of Directors of Everbright Environment and the Company

In addition, neither CIC nor Huijin has any nominees sitting on the board of directors of Everbright Environment. Similarly, neither CIC nor Huijin has any nominees sitting on the board of directors of the Company.

(50%) of the total number of issued Shares excluding treasury shares of the Company, of which the total number of Shares and convertible securities issued other than on a pro-rata basis to existing Shareholders shall not exceed 20 per cent. (20%) of the total number of issued Shares excluding treasury shares of the Company at the time the resolution is passed, for such purposes as they consider would be in the interests of the Company. This authority will, unless revoked or varied at a General Meeting, expire at the next Annual General Meeting of the Company.
- (v) Pursuant to the Special General Meeting of the Company held on 28 October 2005, the Shareholders approved the passing of the ordinary resolution relating to the Scrip Dividend Scheme. In the circular dated 11 October 2005, the Scrip Dividend Scheme provides the Shareholders with the option to elect to receive Shares in lieu of the cash amount of any dividend declared on their holding of Shares. The Ordinary Resolution 7 proposed in item 7, if passed, will empower the Directors to allot and issue Shares in the Company pursuant to the terms and conditions of the Scrip Dividend Scheme.
- (vi) The Company intends to use internal sources of funds, external borrowings or a combination of internal resources and external borrowings, to finance the purchases or acquisitions of its Shares. The amount of financing required for the Company to purchase or acquire its Shares, and the impact on the Company's financial position, cannot be ascertained as at the date of this Notice as these will depend on, inter alia, the manner in which the purchase or acquisition is funded, the aggregate number of Shares purchased or acquired, and the consideration paid at the relevant time. For illustrative purposes only, the financial effects of an assumed purchase or acquisition by the Company of 10 per cent. (10%) of its issued Shares as at 10 March 2022, at a purchase price equivalent to the Maximum Price per Share, based on the audited financial statements of the Company and its subsidiaries for the financial year ended 31 December 2021 and certain assumptions, are set out in the section entitled "Financial Effects" of the Circular.
- (vii) The Ordinary Resolution 9 proposed in item 9 is to approve the renewal of the IPT Mandate to enable the Company, its subsidiaries and associated companies that are entities at risk (as defined in Chapter 9 of the SGX-ST Listing Manual), or any of them, to enter into certain interested person transactions with specified classes of interested persons, as described in the Circular. Please refer to the Circular for more details.
