A person entitled to more than one

 Where there are joint registered holders of any Shares, any one of such persons may vote at the AGM, either electronically during the AGM following valid pre-registration as a shareholder or by appointing the Chairman of the AGM as proxy, in respect of such Shares as if he/she/fit was solely entitled thereto: but if more than one of such joint holders pregister as a shareholder or appoints the Chairman of the AGM as proxy, that one of the joint holders whose name stands first on the register of members in respect of such Shares shall
