Everbright Water Secures Luozhuang Economic Development Zone

Waste Water Treatment Plant and Ancillary Pipeline Network Project Phase I

in Linyi City, Shandong Province

Singapore and Hong Kong, 30 August 2022 – China Everbright Water Limited ("Everbright Water"

or the "Company"; stock codes: U9E.SG and 1857.HK) (中國光大水務有限公司),

an environmental protection company focusing on water environment management, announced

that the Company has entered into a concession agreement with, inter alia, Linyi Luozhuang

Housing and Urban-Rural Development Bureau and Luozhuang Economic Development Zone

Management Committee (as authorised by the People's Government of Luozhuang District,

Linyi City, Shandong Province), and secured Shandong Linyi Luozhuang Economic Development Zone

Waste Water Treatment Plant and Ancillary Pipeline Network Project ("Luozhuang Economic

Development Zone Project") Phase I, which commands an investment of approximately RMB259 million.

Luozhuang Economic Development Zone Project Phase I will be implemented by a wholly-owned

subsidiary of Everbright Water based on a BOT (Build-Operate-Transfer) model, for a concession

period of 30 years (including the construction period). The project will include a semi-underground

waste water treatment plant, which has a designed daily waste water treatment capacity of

20,000 m³, and an ancillary pipeline network of about 37.1 km. Key indicators of the waste water

treatment plant's discharged water will comply with the national Grade 1A standard according to

the Discharge Standard of Pollutants for Municipal Wastewater Treatment Plant (GB18918-2002).

In addition, the concession service area of Luozhuang Economic Development Zone Project Phase I

is in the west of Luogi Road and the south of South Ring Road, which includes Chudun Town,

Fuzhuang Street and Luozhuang Economic Development Zone, with a service area of about 48 km².

Mr. Hu Yanguo, Executive Director and Chairman of Everbright Water, said, "Securing Luozhuang

Economic Development Zone Project Phase I represents Everbright Water's remarkable business
