for the comprehensive deepening reform, and the secretary general of the office of China Everbright

Group Ltd., the indirect controlling shareholder of the Company, the president of Shijiazhuang and

Wuxi Branches, the vice president and risk director of Shenzhen Branch, the assistant to the president

and risk director of Fuzhou Branch, of China Everbright Bank Company Limited ("Everbright Bank"),

the general manager of small and medium enterprises business department and the general manager

of the microfinance business department of Everbright Bank. Mr. Luan holds a Master's Degree in

Accounting from the Department of Accounting of Nankai University and a Doctorate degree in

Political Economics from the Department of Economics of Nankai University. He is also a Certified

Intermediate Accountant in the People's Republic of China.
