As additional time is required for the Company to prepare and finalise certain information to be included in the Circular, including but not limited to the indebtedness statement of the Group and the letter from the Board, the date of despatch of the Circular is expected to be further postponed to on or before 25 August 2014.

Reference is made to the announcement of China Chengtong Development Group Limited (“**Company**”) dated 21 May 2014 on the continuing connected transaction and major transaction in relation to the Financial Services Agreement (“**First Announcement**”) and the announcement of the Company dated 11 June 2014 (“**Second Announcement**”).
