# DISCLOSEABLE TRANSACTION – SALE AND LEASEBACK ARRANGEMENT

On 29 June 2022, Chengtong Financial Leasing, an indirect wholly-owned subsidiary of the Company, entered into the Sale and Leaseback Agreement with the Lessee, pursuant to which Chengtong Financial Leasing will purchase the Leased Assets from the Lessee and will lease the Leased Assets back to the Lessee for a term of four (4) years, subject to early termination in accordance with the terms and conditions of the Sale and Leaseback Agreements.

As the highest applicable percentage ratio (as defined under the Listing Rules) in respect of the Sale and Leaseback Arrangement exceeds 5% but is less than 25%, the Sale and Leaseback Arrangement constitutes a discloseable transaction of the Company and is subject to the notification and announcement requirements under Chapter 14 of the Listing Rules.

On 29 June 2022, Chengtong Financial Leasing, an indirect wholly-owned subsidiary of the Company, entered into the Sale and Leaseback Agreements with the Lessee in respect of the Sale and Leaseback Arrangement, the major terms of which are set out below.

# SALE AND LEASEBACK ARRANGEMENT

#### Date

29 June 2022

# **Parties**

Lessor: Chengtong Financial Leasing

Lessee: The Lessee

To the best of the Directors' knowledge, information and belief having made all reasonable enquiries, (i) the Lessee is a wholly-owned subsidiary of the Guarantor, which is in turn wholly owned by 重慶市榮昌區國有資產監督管理委員會 (unofficial English translation being Chongqing City Rongchang District State-owned Assets Supervision and Administration Commission); (ii) the Lessee and its ultimate beneficial owner are Independent Third Parties; and (iii) the Lessee is principally engaged in the business of production and supply of tap water to Rongchang district of Chongqing City, the PRC.

# **Subject matter**

Subject to the fulfilment of certain conditions as set out in the Sale and Leaseback Agreement (including but not limited to the obtaining of all necessary approvals by the Lessee in relation to the Sale and Leaseback Arrangement, the signing by the Guarantor and the coming into effect of the relevant guarantee agreement, and the payment of the security money (as set out below) by the Lessee), Chengtong Financial Leasing will purchase the Leased Assets from the Lessee at the Purchase Price of RMB100 million (equivalent to HK\$117 million), and the Leased Assets will be leased back to the Lessee for a period of four (4) years ("Lease Term") from the date on which the Purchase Price is paid by Chengtong Financial Leasing.

If any of the conditions are not satisfied on or before 29 July 2022, Chengtong Financial Leasing shall have the right to unilaterally terminate the Sale and Leaseback Agreement.

#### **Purchase Price**

The Purchase Price of RMB100 million (equivalent to HK\$117 million) was agreed between Chengtong Financial Leasing and the Lessee with reference to the appraised value of the Leased Assets as at 16 June 2022 which amounted to approximately RMB119.62 million (equivalent to approximately HK\$139.96 million). The Lessee does not separately account for the profits before tax and after tax of the Leased Assets.

The Purchase Price will be satisfied by the internal resources of the Group and/or borrowings.

# Legal title

Chengtong Financial Leasing owns the legal title of the Leased Assets during the Lease Term.

# Lease payment

The total amount of lease payment over the Lease Term is estimated to be approximately RMB110.33 million (equivalent to approximately HK\$129.09 million) which shall be paid by the Lessee to Chengtong Financial Leasing in sixteen (16) quarterly instalments during the Lease Term.

The total amount of lease payment represents the sum of the lease principal amount (being the amount of Purchase Price to be paid by Chengtong Financial Leasing) and the lease interest which is calculated at the five (5)-year loan prime rate as promulgated by the National Interbank Funding Center under the authority of the People's Bank of China ("LPR") from time to time on the then outstanding lease principal amount. In the event that the LPR changes during the Lease Term, adjustments will be made to such lease interest rate on an annual basis on 1 January every year except in the case where the Lessee has overdue lease payment and has not paid all overdue payments and liquidated damages, the interest rate applied will not be adjusted when the LPR is reduced. The interest rate has been agreed after arm's length negotiations between the parties with reference to the Purchase Price payable by Chengtong Financial Leasing for the purchase of the Leased Assets and the credit risks associated with the Sale and Leaseback Arrangement.

#### Service Fee

The Lessee shall pay a service fee of RMB3.50 million (equivalent to approximately HK\$4.10 million) ("Service Fee") to Chengtong Financial Leasing within three (3) working days after the coming into effect of the Sale and Leaseback Agreements for the preliminary services provided by Chengtong Financial Leasing in respect of the Sale and Leaseback Arrangement. The Service Fee is non-refundable.

# Lessee's right to repurchase the Leased Assets

Upon the expiry of the Lease Term, subject to the Lessee having paid all the lease payment and any other payables (if any) to Chengtong Financial Leasing in accordance with the terms of the Sale and Leaseback Agreement, the Lessee shall have the right to repurchase the Leased Assets at a nominal consideration of RMB1.00.

# **Security money**

The Lessee agrees to pay a sum of RMB5 million (equivalent to HK\$5.85 million) as security money for the performance of its obligations under the Sale and Leaseback Agreement.

If the Lessee fails to fully perform any obligation under the Sale and Leaseback Agreement, Chengtong Financial Leasing has the right to apply the security money to set off against any amount owed by the Lessee to it in the following order: overdue interest, other payables, damages (if any), lease payment and repurchase price. If the Lessee has fully performed all its obligations under the Sale and Leaseback Agreement, Chengtong Financial Leasing shall, return the security money to the Lessee or use the security money to set off against the lease payment for the last corresponding period. The security money shall not bear any interest.

#### Guarantee

The Guarantor, has provided a guarantee in favour of Chengtong Financial Leasing for all amounts payable by the Lessee under the Sale and Leaseback Agreement, including but not limited to the liquidated damages, outstanding and prospective lease payment, repurchase price and other payables. The guarantee is irrevocable and continuing in nature.

To the best of the Directors' knowledge, information and belief having made all reasonable enquiries, (i) the Guarantor is wholly owned by 重慶市榮昌區國有資產監督管理委員會 (unofficial English translation being Chongqing City Rongchang District State-owned Assets Supervision and Administration Commission); (ii) the Guarantor and its ultimate beneficial owner are Independent Third Parties; and (iii) the Guarantor is principally engaged in urban infrastructure construction.

#### REASONS FOR AND BENEFITS OF THE SALE AND LEASEBACK ARRANGEMENT

The Group is principally engaged in leasing, bulk commodity trade, property development and investment and marine recreation services and hotel business. The Group's leasing business is mainly carried out through Chengtong Financial Leasing as its principal business.

The entering into of the Sale and Leaseback Arrangement is in the ordinary and usual course of business of Chengtong Financial Leasing and it is expected that Chengtong Financial Leasing will earn an income of approximately RMB13.83 million (equivalent to approximately HK\$16.18 million), being the aggregate of the Service Fee and the difference between the estimated total lease payment under the Sale and Leaseback Arrangement and the Purchase Price.

The Directors are of the view that the terms of the Sale and Leaseback Arrangement are fair and reasonable and are in the interests of the Company and the shareholders of the Company as a whole.

#### IMPLICATION UNDER THE LISTING RULES

As the highest applicable percentage ratio (as defined under the Listing Rules) in respect of the Sale and Leaseback Arrangement exceeds 5% but is less than 25%, the Sale and Leaseback Arrangement constitutes a discloseable transaction of the Company and is subject to the notification and announcement requirements under Chapter 14 of the Listing Rules.
