# THE SALE AND LEASEBACK ARRANGEMENT

On 26 August 2022, Chengtong Financial Leasing, an indirect wholly-owned subsidiary of the Company, entered into the Sale and Leaseback Agreements with the Lessee, pursuant to which Chengtong Financial Leasing will purchase the Leased Assets from the Lessee and will lease the Leased Assets back to the Lessee for a term of four (4) years, subject to early termination in accordance with the terms and conditions of the Sale and Leaseback Agreements.

# IMPLICATIONS UNDER THE LISTING RULES

Since the Previous Transaction was still subsisting at the time when the Sale and Leaseback Agreements were entered into, the Sale and Leaseback Arrangement is aggregated with the Previous Transaction for the purpose of calculating the relevant percentage ratios (as defined under the Listing Rules).

As the highest applicable percentage ratio (as defined under the Listing Rules) in respect of the Sale and Leaseback Arrangement, both when calculated individually and when aggregated with the Previous Transaction, exceeds 5% but is less than 25%, the Sale and Leaseback Arrangement constitutes a discloseable transaction of the Company and is subject to the notification and announcement requirements under Chapter 14 of the Listing Rules.

On 26 August 2022, Chengtong Financial Leasing, an indirect wholly-owned subsidiary of the Company, entered into the Sale and Leaseback Agreements with the Lessee in respect of the Sale and Leaseback Arrangement, the major terms of which are set out below.

# SALE AND LEASEBACK ARRANGEMENT

# **Date of the Sale and Leaseback Agreements**

# **Parties**

Lessor: Chengtong Financial Leasing

Lessee: The Lessee

To the best of the Directors' knowledge, information and belief having made all reasonable enquiries, (a) the Lessee is (i) directly owned as to approximately 89.69% by 長興南太湖投資開發有限公司 (unofficial English translation being Changxing South Taihu Investment Development Co., Ltd.), which is a subsidiary of the Guarantor, and approximately 10.31% by 長興興吉投資合夥企業(有限合夥) (unofficial English translation being Changxing Xingji Investment Limited Partnership); and (ii) ultimately controlled by Changxing People's Government; (b) each of the Lessee and its ultimate beneficial owners are Independent Third Parties; and (c) the Lessee is principally engaged in the business of the management of logistics park, supply chain trading and sale of gravel.

# **Subject matter**

Subject to the fulfilment of the conditions as set out in the Sale and Leaseback Agreements (including but not limited to the provision by the Lessee of all necessary documents or information evidencing its ownership in the Leased Assets, the obtaining of all necessary approvals by the Lessee in relation to the Sale and Leaseback Arrangement, the payment of security money (as set out below) and the signing and the coming into effect of the relevant security agreements), Chengtong Financial Leasing will purchase the Leased Assets from the Lessee at the Purchase Price of RMB150 million (equivalent to HK\$172.50 million), and the Leased Assets will be leased back to the Lessee for a period of four (4) years ("Lease Term") from the date on which the Purchase Price is paid by Chengtong Financial Leasing, subject to early termination in accordance with the terms and conditions of the Sale and Leaseback Agreements.

If any of the conditions under the Sale and Leaseback Agreements are not satisfied on or before 30 September 2022, Chengtong Financial Leasing shall have the right to unilaterally terminate the Sale and Leaseback Agreements.

#### **Purchase Price**

The Purchase Price of the Leased Assets was agreed between Chengtong Financial Leasing and the Lessee with reference to the appraised value of the Leased Assets as at 30 June 2022 which amounted to approximately RMB170.70 million (equivalent to approximately HK\$196.31 million).

The Purchase Price will be satisfied by the internal resources of the Group and/or general bank borrowings.

# Legal title

Chengtong Financial Leasing owns the legal title of the Leased Assets during the Lease Term.

# Lease payment

The total amount of lease payment over the Lease Term is estimated to be approximately RMB166.29 million (equivalent to approximately HK\$191.23 million) which shall be paid by the Lessee to Chengtong Financial Leasing in sixteen (16) quarterly instalments during the Lease Term.

The total amount of lease payment represents the sum of the lease principal amount (being the amount of Purchase Price to be paid by Chengtong Financial Leasing) and the lease interest which is calculated on the then outstanding lease principal amount with a floating interest rate to be determined at a premium over the five-year loan prime rate as promulgated by the National Interbank Funding Center under the authority of the People's Bank of China ("LPR") from time to time. In the event that the LPR changes during the Lease Term, adjustments will be made to such lease interest rate on an annual basis on 1 January every year except in the case where the Lessee has overdue lease payment and has not paid all overdue payments and liquidated damages, the interest rate applied will not be adjusted when the LPR is reduced.

The interest rate has been agreed after arm's length negotiations between the parties with reference to the Purchase Price payable by Chengtong Financial Leasing for the purchase of the Leased Assets and the credit risks associated with the Sale and Leaseback Arrangement.

# **Security money**

The Lessee agrees to pay a sum of RMB2 million (equivalent to HK\$2.30 million) as security money for the performance of its obligations under the Sale and Leaseback Agreements.

If the Lessee fails to fully perform any obligation under the Sale and Leaseback Agreements, Chengtong Financial Leasing has the right to apply the security money to set off against any amount owed by the Lessee to it in the following order: liquidated damages, other payables including but not limited to damages (if any), outstanding and prospective lease payments and repurchase price. If the Lessee has fully performed all its obligations under the Sale and Leaseback Agreements, Chengtong Financial Leasing shall return the security money to the Lessee upon the Lessee's presentation of the receipt of the security money.

When the amount payable by the Lessee under the Sale and Leaseback Agreements is less than the balance of the security money, the Sale and Leaseback Agreements may be early terminated upon the Lessee's application. The Lessee shall then present the receipt of the security money to Chengtong Financial Leasing upon which the security money shall be used to set off the lease payments and other payables under the Sale and Leaseback Agreements and any remaining balance of the security money shall be returned to the Lessee.

# Lessee's right to repurchase the Leased Assets

Upon the Lessee having paid all the lease payments and other payables (if any) to Chengtong Financial Leasing in accordance with the terms of the Sale and Leaseback Agreements, the Lessee shall have the right to repurchase the Leased Assets at a nominal consideration of RMB1.00.

#### Guarantee

The Guarantor has provided a guarantee in favour of Chengtong Financial Leasing for all amounts payable by the Lessee under the Sale and Leaseback Agreements, including but not limited to liquidated damages, outstanding and prospective lease payment, repurchase price and other payables. The guarantee is irrevocable and continuing in nature.

To the best of the Directors' knowledge, information and belief having made all reasonable enquiries, (a) the Guarantor is directly owned as to 90% by 長興縣交通運輸局 (unofficial English translation being Changxing County Transportation Bureau), which is in turn ultimately controlled by Changxing People's Government; (b) each of the Guarantor and its ultimate beneficial owners are Independent Third Parties; and (c) the Guarantor is principally engaged in the business of entrusted construction of engineering projects, land development and trading.

# REASONS FOR AND BENEFITS OF THE SALE AND LEASEBACK ARRANGEMENT

The Group is principally engaged in leasing, bulk commodity trade, property development and investment, and marine recreation services and hotel business. The Group's leasing business is mainly carried out through Chengtong Financial Leasing as its principal business.

The entering into of the Sale and Leaseback Arrangement is in the ordinary and usual course of business of Chengtong Financial Leasing and it is expected that Chengtong Financial Leasing will earn an income of approximately RMB16.29 million (equivalent to approximately HK\$18.73 million), being the difference between the estimated total lease payment under the Sale and Leaseback Arrangement and the Purchase Price.

The Directors are of the view that the terms of the Sale and Leaseback Arrangement are fair and reasonable and are in the interests of the Company and the shareholders of the Company as a whole.
