SUBSCRIPTION OF NEW SHARES UNDER GENERAL MANDATE

The Board is pleased to announce that on 17 June 2015 (after trading hours of the Stock Exchange), the Company entered into the Subscription Agreements separately with each of the Subscribers for the subscription of an aggregate 39,800,000 Subscription Shares at the Subscription Price of HK\$2.43 per Subscription Share.

The Subscription Shares represent approximately 2.06% of the existing issued share capital of the Company and approximately 2.02% of the Company's issued share capital as enlarged by the Subscription. The Subscription is conditional upon the Stock Exchange granting the listing of, and permission to deal in, the Subscription Shares.

The Subscription Agreements are not inter-conditional upon one another.

Shareholders and potential investors who wish to deal in the securities of the Company should note that the Subscription may or may not proceed and therefore are advised to exercise caution when dealing in the securities of the Company.

INTRODUCTION

The Board is pleased to announce that on 17 June 2015 (after trading hours of the Stock Exchange), the Company entered into the Subscription Agreements separately with each of the Subscribers for the subscription of an aggregate 39,800,000 Subscription Shares at the Subscription Price of HK\$2.43 per Subscription Share.

THE SUBSCRIPTION AGREEMENTS

Date

17 June 2015

Parties

- (1) the Company as the issuer; and
- (2) the Subscribers

Not less than six Subscribers of which some of them are existing Shareholders holding an aggregate of approximately 0.07% of the existing issued share capital of the Company and for those Subscribers who are existing Shareholders, each of them holds less than 5% of the existing issued share capital of the Company, being individuals, institutional or other professional investors. Based on the information provided by the Subscribers, their principal activities, for the Subscribers which are corporations, are investments holding.

To the best of the Directors' knowledge, information and belief and having made all reasonable enquiries, each of the Subscribers and its ultimate beneficial owners (for those Subscribers which are corporations) is an Independent Third Party. It is expected that none of the Subscribers will become a substantial shareholder (as defined in the Listing Rules) of the Company immediately upon completion of the Subscription.

Number of Subscription Shares

An aggregate of 39,800,000 Subscription Shares, representing approximately 2.06% of the existing issued share capital of the Company and approximately 2.02% of the issued share capital of the Company as enlarged by the Subscription. The aggregate nominal value of the Subscription Shares is HK\$3,980,000.

Ranking of Subscription Shares

The Subscription Shares, when issued and fully paid, will rank *pari passu* in all respects with the Shares in issue on the completion date of the Subscription, including the right to any dividends or distribution after the date of completion of the Subscription.

Subscription Price

The Subscription Price of HK\$2.43 per Subscription Share represents:

- (i) a discount of approximately 19.00% to the closing price of HK\$3.0 per Share as quoted on the Stock Exchange on 17 June 2015, being the date of the Subscription Agreements; and
- (ii) a discount of approximately 18.35% to the average closing price of HK\$2.976 per Share as quoted on the Stock Exchange for the last five trading days up to and including 16 June 2015, being the date immediately preceding the date of the Subscription Agreements.

The Subscription Price was determined after arm's length negotiation between the Subscribers and the Company on the date of the Subscription Agreements with reference to the recent trading performance of the Shares and business prospects of the Group. The Directors consider that the Subscription Price is fair and reasonable under the current market conditions and the Subscription is in the interest of the Company and the Shareholders as a whole.

The Subscription Shares have a market value of approximately HK\$119.4 million, based on the closing price of HK\$3.00 per Share on 17 June 2015, being the date of the Subscription Agreements.

Based on the net proceeds of approximately HK\$96.7 million, the net price per Subscription Share is HK\$2.4275.

General Mandate

The Subscription Shares will be allotted and issued under the General Mandate. As at the date of this announcement, the Company has not fully utilised the General Mandate and the General Mandate can issue up to 158,938,975 new Shares. The issue of Subscription Shares is not subject to the approval of the Shareholders.

Condition Precedent

Completion of the Subscription is conditional upon the listing of and permission to deal in the Subscription Shares being granted by the Listing Committee of the Stock Exchange.

In the event that the condition to the Subscription is not fulfilled on or before Long Stop Date, the Subscription Agreements and all rights and obligations thereunder will cease and terminate.

The Subscription Agreements are not inter-conditional upon one another.

Completion

Completion of the Subscription will take place within two Business Days (or such other time as the Company and the Subscribers may agree) immediately after the fulfillment of the condition of the Subscription set out above.

Lock-up Period

Under the terms of the Subscription Agreements, the Subscribers and their respective nominee shall neither (i) dispose of, (ii) enter into any agreement to dispose of, nor (iii) otherwise create any encumbrances in respect of any direct or indirect interest in the Subscription Shares at any time within the period of 6 months from the date of completion of the Subscription.

Application for listing

The Company will apply to the Listing Committee of the Stock Exchange for the listing of and permission to deal in the Subscription Shares.

REASONS FOR THE SUBSCRIPTION AND USE OF THE PROCEEDS

The Group is principally engaged in sale and distribution of wine and liquor; and production and sale of forages, wholesaling and retailing business.

The Directors consider that the Subscription represents an opportunity to raise additional funding for the Group's business operation and it will also strengthen the capital base and financial position for the Group's future business developments and broaden the Shareholder base of the Company. Furthermore, the Directors consider that the Subscription is a preferred method of fund raising as compared with other equity fund raising exercises based on time and costs involved.

Gross proceeds from the Subscription will be approximately HK\$96.7 million. The net proceeds from the Subscription, after deducting the expenses payable by the Company is expected to be approximately HK\$96.6 million. It is expected that the net proceeds from the Subscription will be used by the Company for the Group's business development, investments, acquisition, repayment of loans and general working capital purposes.

The Directors (including the independent non-executive Directors) consider the terms of the Subscription Agreements, which were negotiated on an arm's length basis and agreed on normal commercial terms between the parties involved, are fair and reasonable, and the Subscription is in the interests of the Company and the Shareholders as a whole.
