PROPOSED GENERAL MANDATES TO REPURCHASE AND ISSUE SHARES AND PROPOSED RE-ELECTION OF DIRECTORS

1. INTRODUCTION

The purpose of this circular is to provide you with information in respect of the resolutions to be proposed at the AGM for (i) the granting of the Repurchase Mandate and the Issue Mandate and (ii) the re-election of Directors.

2. PROPOSED GENERAL MANDATE TO REPURCHASE SHARES

An ordinary resolution will be proposed at the AGM to grant to the Directors the Repurchase Mandate, details of which are set out in item 4 of the notice of AGM. The Shares which may be repurchased pursuant to the Repurchase Mandate is limited to a maximum of 10% of the issued share capital of the Company at the date of passing of the resolution approving the Repurchase Mandate. An explanatory statement as required under the GEM Listing Rules, giving certain information regarding the Repurchase Mandate, is set out in Appendix I to this circular.

3. PROPOSED GENERAL MANDATE TO ISSUE NEW SHARES

It will also be proposed at the AGM two ordinary resolutions for granting to the Directors a general mandate to allot, issue and deal with not exceeding 151,171,000 Shares or 20% of the issued share capital of the Company as at the date of passing the resolution set out in item 5 of the notice of AGM and adding to such general mandate so granted to the Directors any Shares representing the aggregate nominal amount of the Shares repurchased by the Company under the general mandate to repurchase Shares pursuant to the Repurchase Resolution set out in item 4 of the notice of AGM.

4. PROPOSED RE-ELECTION OF DIRECTORS

In accordance with the Articles of Association, Dx. Xu Zhiming and Mr. Zhang Ying will retire from office as Directors at the AGM and Mr. Yip Heon Ping will hold office of a Director until the AGM and all of the Directors, being eligible, will offer themselves for re-election at the AGM.

5. ANNUAL GENERAL MEETING

Whether or not you intend to be present at the AGM, you are requested to complete the enclosed form of proxy and return it to the Company's branch share registrar in accordance with the instructions printed thereon not less than 48 hours before the time fixed for holding that meeting. The lodging of the enclosed form of proxy will not preclude Shareholders from attending and voting at the AGM or any adjourned meeting if they so wish.

6. VOTING BY POLL

APPENDIX I

The following is the explanatory statement required to be sent to Shareholders under the GEM Listing Rules in connection with the proposed Repurchase Mandate:

1. SHARE CAPITAL

As at the Latest Practicable Date, the issued share capital of the Company comprised 755,855,000 Shares.

Subject to the passing of the ordinary resolution set out in item 4 of the notice of AGM respect of the granting of the Repurchase Mandate and on the basis that no further Shares are issued or repurchased by the Company prior to the date of the AGM, the Directors would be authorised under the Repurchase Mandate to repurchase a maximum of 75,585,500 Shares, representing 10% of the issued share capital of the Company as at the date of passing of the resolution approving the Repurchase Mandate, during the period up to (i) the conclusion of the next annual general meeting of the Company is required by the Articles of Association or any applicable laws of the Cayman Islands to be held; or (iii) the revocation, variation or renewal of the Repurchase Mandate by ordinary resolution of the Shareholders in general meeting, whichever occurs first.

2. REASONS FOR REPURCHASES

The Directors believe that the granting of the Repurchase Mandate is in the interests of the Company and the Shareholders.

Repurchases of Shares may, depending on market conditions and funding arrangements at the time, lead to an enhancement of the net assets and/or earnings per share. The Directors are seeking the granting of the Repurchase Mandate to give the Company the flexibility to do so if and when appropriate. The number of Shares to be repurchased on any occasion and the price and other terms upon which the same are repurchased will be decided by the Directors at the relevant time, having regard to the circumstances then pertaining.

3. FUNDING OF REPURCHASES

In repurchasing Shares, the Company may only apply funds legally available for such purpose in accordance with its Memorandum and Articles of Association, the GEM Listing Rules and the applicable laws of the Cayman Islands. The Company may not purchase Shares on GEM for a consideration other than cash or for settlement otherwise than in accordance with the trading rules of the Stock Exchange from time to time.

There might be a material adverse impact on the working capital or gearing position of the Company (as compared with position disclosed in the audited accounts contained in the annual report of the Company for the year ended 31 March 2010) in the event that the proposed repurchase of Shares was to be carried out in full at any time during the proposed repurchase period. However, the Directors do not propose to exercise the Repurchase Mandate to such extent as would, in the circumstances, have a material adverse effect on the working capital requirements of the Company or the gearing levels which in the opinion of the Directors are from time to time appropriate for the Company.

As at the Latest Practicable Date, Greenford Company (PTC) Limited, Century Technology Holding (PTC) Limited, Bakersfield Global (PTC) Corporation and First League Investments Limited were interested in an aggregate of 314,354,000 Shares, together representing approximately 41.58% of the issued share capital of the Company. Based on such shareholding, and in the event that the Directors exercised in full the Repurchase Mandate, the aggregate interests of Greenford Company (PTC) Limited, Century Technology Holding (PTC) Limited, Bakersfield Global (PTC) Corporation and First League Investments Limited in the issued share capital of the Company would be increased to approximately 46.21% of the issued shared capital of the Company. The Directors are not aware of any consequences which may arise under the Takeover Code as a consequence of any purchase made under the Repurchase Mandate. However, the Company may not repurchase Shares which would result in the amount of Shares held by the public being reduced to less than 16.9%, which is the minimum public float as prescribed by the prospectus of the Company.

7. SHARES PURCHASE MADE BY THE COMPANY

The Company has not purchased any of the Shares (whether on GEM or otherwise) in the previous six months prior to the Latest Practicable Date.

APPENDIX II

The details of the retiring directors proposed to be re-elected at the AGM are set out as follows:

1. **Mr. Yip Heon Ping**, aged 52, was appointed as an executive Director and an authorised representative of the Company in August 2009. Mr. Yip is also a founder of the Group, an executive Director of the Company from March 2000 to June 2007 and the general manager of the Group from December 1992 to March 2000, in charge of the Group's overall management function. Mr. Yip holds certain directorships in other members of the Group and is also the sole director and holds entirely 100% interest in Greenford Company (PTC) Limited, a substantial shareholder of the Company within the meaning of Part XV of the SFO. Mr. Yip holds a bachelor's degree in electrical engineering from Iowa State University in the USA. Prior to joining the Group in 1992, Mr. Yip worked for the China business in Hewlett Packard for 10 years.

Mr. Yip is a son of Mr. Yip Seng Mun, a former executive Director of the Company, and a brother of Mr. Heon Keung, the current Chairman of the Board and Mr. Yip Heon Wai, the former Chairman of the Board. Save as disclosed above, Mr. Yip does not have any relationship with any other Directors, senior management, management shareholders, substantial shareholders or controlling shareholders of the Company within the meaning of the GEM Listing Rules.

As at the latest practicable date, 296,534,619 shares are held through the substantial shareholders of the Company, namely Greenford Company (PTC) Limited, Century Technology Holding (PTC) Limited and Bakersfield Global (PTC) Corporation as trustees of The Greenford Unit Trust, The Century Unit Trust and The Bakersfield Unit Trust, respectively. All the units of which are held by Ace Central Group (PTC) Limited as the trustee of The New Millennium Trust, a discretionary family trust established with Mr. Yip as one of the discretionary objects for the time being. In addition, Mr. Yip is also entitled to his share options to subscribe for 6,300,000 shares of the Company at an exercise price of HK\$0.40 per share.

Mr. Yip has entered into a service contract with the Company for an initial term of three years commencing from 6 August 2009 and expiring on 5 August 2012. His appointment is subject to retirement by rotation and re-election in accordance with the provisions of the Articles of Association. Dr. Xu is currently a partner of CBC Partners, L.P., which is not a public listed company. From 2002 to 2005, Dr. Xu was a senior advisor of Tom Group Limited, a public listed company and an executive director and chief operating officer of Tom Online Inc., a public listed company. Dr. Xu has extensive experience in investment banking and corporate management. Save as disclosed above, Dr. Xu did not hold any directorships in any other public listed companies in Hong Kong or overseas in the last three years.
