1. INTRODUCTION

The purpose of this circular is to provide you with information in respect of the resolutions to be proposed at the AGM for (i) the granting of the Repurchase Mandate and the Issue Mandate and (ii) the re-election of Directors.

2. PROPOSED GENERAL MANDATE TO REPURCHASE SHARES

An ordinary resolution will be proposed at the AGM to grant to the Directors the Repurchase Mandate, details of which are set out in item 4 of the notice of AGM. The Shares which may be repurchased pursuant to the Repurchase Mandate is limited to a maximum of 10% of the issued share capital of the Company at the date of passing of the resolution approving the Repurchase Mandate. An explanatory statement as required under the GEM Listing Rules, giving certain information regarding the Repurchase Mandate, is set out in Appendix I to this circular.

3. PROPOSED GENERAL MANDATE TO ISSUE NEW SHARES

The following is the explanatory statement required to be sent to Shareholders under the GEM Listing Rules in connection with the proposed Repurchase Mandate:

1. SHARE CAPITAL

As at the Latest Practicable Date, the issued share capital of the Company comprised 756,355,000 Shares.

Subject to the passing of the ordinary resolution set out in item 4 of the notice of AGM respect of the granting of the Repurchase Mandate and on the basis that no further Shares are issued or repurchased by the Company prior to the date of the AGM, the Directors would be authorised under the Repurchase Mandate to repurchase a maximum of 75,635,500 Shares, representing 10% of the issued share capital of the Company as at the date of passing of the resolution approving the Repurchase Mandate, during the period up to (i) the conclusion of the next annual general meeting of the Company; (ii) the expiration of the period within which the next annual general meeting of the Company is required by the Articles of Association or any applicable laws of the Cayman Islands to be held; or (iii) the revocation, variation or renewal of the Repurchase Mandate by ordinary resolution of the Shareholders in general meeting, whichever occurs first.

2. REASONS FOR REPURCHASES

The Directors believe that the granting of the Repurchase Mandate is in the interests of the Company and the Shareholders.

Repurchases of Shares may, depending on market conditions and funding arrangements at the time, lead to an enhancement of the net assets and/or earnings per share. The Directors are seeking the granting of the Repurchase Mandate to give the Company the flexibility to do so if and when appropriate. The number of Shares to be repurchased on any occasion and the price and other terms upon which the same are repurchased will be decided by the Directors at the relevant time, having regard to the circumstances then pertaining.

3. FUNDING OF REPURCHASES

In repurchasing Shares, the Company may only apply funds legally available for such purpose in accordance with its Memorandum and Articles of Association, the GEM Listing Rules and the applicable laws of the Cayman Islands. The Company may not purchase Shares on GEM for a consideration other than cash or for settlement otherwise than in accordance with the trading rules of the Stock Exchange from time to time.

There might be a material adverse impact on the working capital or gearing position of the Company (as compared with position disclosed in the audited accounts contained in the annual report of the Company for the year ended 31 March 2012) in the event that the proposed repurchase of Shares was to be carried out in full at any time during the proposed repurchase period. However, the Directors do not propose to exercise the Repurchase Mandate to such extent as would, in the circumstances, have a material adverse effect on the working capital requirements of the Company or the gearing levels which in the opinion of the Directors are from time to time appropriate for the Company.

5. UNDERTAKING

The Directors have undertaken to the Stock Exchange that, so far as the same may be applicable, they will exercise the powers of the Company to make repurchases pursuant to the Repurchase Mandate in accordance with the GEM Listing Rules, the Memorandum and Articles of Association of the Company and the applicable laws of the Cayman Islands.

None of the Directors nor, to the best of their knowledge having made all reasonable enquiries, their associates have any present intention to sell any Shares to the Company under the Repurchase Resolution if such is approved by the Shareholders.

6. TAKEOVER CODE

If as a result of a share repurchase a Shareholder's proportionate interest in the voting rights of the Company increases, such increase will be treated as an acquisition for the purposes of Rule 32 of the Takeover Code. Accordingly, a Shareholder or a group of Shareholders acting in concert, depending on the level of increase of the Shareholder's interest, could obtain or consolidate control of the Company and may become obliged to make a mandatory offer in accordance with Rule 26 of the Takeover Code and the provision may apply as a result of any such increase.

As at the Latest Practicable Date, Greenford Company (PTC) Limited, Century Technology Holding (PTC) Limited, Bakersfield Global (PTC) Corporation and First League Investments Limited were interested in an aggregate of 304,354,000 Shares, together representing approximately 40.24% of the issued share capital of the Company. Based on such shareholding, and in the event that the Directors exercised in full the Repurchase Mandate, the aggregate interests of Greenford Company (PTC) Limited, Century Technology Holding (PTC) Limited, Bakersfield Global (PTC) Corporation and First League Investments Limited in the issued share capital of the Company would be increased to approximately 44.71% of the issued shared capital of the Company. The Directors are not aware of any consequences which may arise under the Takeover Code as a consequence of any purchase made under the Repurchase Mandate. However, the Company may not repurchase Shares which would result in the amount of Shares held by the public being reduced to less than 25%, which is the minimum public float as required under the GEM Listing Rules.

7. SHARES PURCHASE MADE BY THE COMPANY

The Company has not purchased any of the Shares (whether on GEM or otherwise) in the previous six months prior to the Latest Practicable Date.

The details of the retiring directors proposed to be re-elected at the AGM are set out as follows:

1. **Mr. Yip Heon Keung**, aged 42, is the Chairman of the Board and an executive Director of the Company, in charge of the overall corporate strategies and business development of the Group. He is also the Compliance Officer, an authorised representative, a member of the remuneration committee and the Chairman of the nomination committee of the Company. Mr. Yip holds certain directorships in other members of the Group. Mr. Yip is a graduate of Program for Management Development from Harvard University and holds a bachelor degree in electrical engineering from the University Wisconsin-Madison, USA. Prior to joining the Group, Mr. Yip worked in a software-consulting firm as a consultant in the USA. He has been with the Group since October 1996. Save as disclosed above, Mr. Yip did not hold any directorships in any other public listed companies in Hong Kong or overseas in the last three years.

Mr. Yip is a son of Mr. Yip Seng Mun, a former executive Director of the Company and a brother of Mr. Yip Heon Wai, the former Chairman of the Board and Mr. Yip Heon Ping, a current executive Director of the Company. Save as disclosed above, Mr. Yip does not have any relationship with any other Directors, senior management, substantial shareholders or controlling shareholders of the Company (within the meaning of the GEM Listing Rules).

As at the latest practicable date, an aggregate of 181,682,918 shares of the Company are held through the substantial shareholders of the Company, namely Greenford Company (PTC) Limited and Bakersfield Global (PTC) Corporation as trustees of The Greenford Unit Trust and The Bakersfield Unit Trust, respectively. All the units of which are held by Ace Central Group (PTC) Limited ("Ace Central") as the trustee of The New Millennium Trust, a discretionary family trust established with Mr. Yip is the sole director and sole shareholder of Ace Central. By virtue of Part XV of the SFO, Mr. Yip is deemed to be interested in 181,682,918 shares of the Company held by Ace Central.

Pursuant to the supplemental agreement entered into between the Company and Mr. Yip on 1 April 2010 (which is supplemental to the service contract made between the same parties on 1 April 2003 (the "Service Contract")), the terms of the Service Contract were extended for a fixed term of three years commencing from 1 April 2010 and expiring on 31 March 2013, subject to retirement by rotation and re-election in accordance with the Articles of Association. Otherwise than as amended by the supplemental agreement, all other provisions of the Service Contract remain in full force and effect. Under the Service Contract, Mr. Yip is entitled to an annual fixed salary of HK\$2,000,000 which is determined by the Board on the basis of his performance and working experience, the Company's results as well as the prevailing market conditions.

Save as disclosed above, there is no information to be disclosed pursuant to any of the requirements of the provisions under Rules 17.50(2)(h) to 17.50(2)(v) of the GEM Listing Rules, and there are no other matters that need to be brought to the attention of the Shareholders pursuant to Rule 17.50(2)(w) of the GEM Listing Rules.

2. **Mr. Yip Heon Ping**, aged 54, was appointed as an executive Director and an authorised representative of the Company in August 2009. Mr. Yip is also a founder of the Group, an executive Director of the Company from March 2000 to June 2007 and the general manager of the Group from December 1992 to March 2000, in charge of the Group's overall management function. Mr. Yip holds certain directorships in other members of the Group and is also the sole director and holds entirely 100% interest in Greenford Company (PTC) Limited, a substantial shareholder of the Company within the meaning of Part XV of the SFO. Mr. Yip holds a bachelor's degree in electrical engineering from Iowa State University in the USA. Prior to joining the Group in 1992, Mr. Yip worked for Hewlett Packard Asia Limited for 10 years.

Mr. Yip is a son of Mr. Yip Seng Mun, a former executive Director of the Company and a brother of Mr. Heon Keung, the current Chairman of the Board and Mr. Yip Heon Wai, the former Chairman of the Board. Save as disclosed above, Mr. Yip does not have any relationship with any other Directors, senior management, substantial shareholders or controlling shareholders of the Company within the meaning of the GEM Listing Rules.

As at the latest practicable date, 181,682,918 shares are held through the substantial shareholders of the Company, namely Greenford Company (PTC) Limited and Bakersfield Global (PTC) Corporation as trustees of The Greenford Unit Trust and The Bakersfield Unit Trust, respectively. All the units of which are held by Ace Central Group (PTC) Limited as the trustee of The New Millennium Trust, a discretionary family trust established with Mr. Yip as one of the discretionary objects for the time being.

Mr. Yip has entered into a service contract with the Company for an initial term of three years commencing from 6 August 2009 and expiring on 5 August 2012 (the "Service Contract"). His appointment is subject to retirement by rotation and re-election in accordance with the Articles of Association. Under the Service Contract, Mr. Yip is entitled to an annual fixed salary of HK\$2,000,000 which is determined by the Board on the basis of his performance and working experience, the Company's results as well as the prevailing market conditions.

Save as disclosed above, there is no information to be disclosed pursuant to any of the requirements of the provisions under Rules 17.50(2)(h) to 17.50(2)(v) of the GEM Listing Rules, and there are no other matters that need to be brought to the attention of the Shareholders pursuant to Rule 17.50(2)(w) of the GEM Listing Rules.

3. **Ms. Lai May Lun**, age 62, was appointed as an independent non-executive Director of the Company in March 2006. Ms. Lai had been the administration manager of a charitable foundation in Hong Kong. - (a) subject to paragraph (c) of this Resolution and pursuant to the Rules Governing the Listing of Securities on GEM of the Stock Exchange, the exercise by the Directors during the Relevant Period (as hereinafter defined) of all the powers of the Company to allot, issue and deal with additional shares in the share capital of the Company and to make or grant offers, agreements and options (including bonds, warrants and debentures convertible into shares of the Company) which would or might require the exercise of such powers be and is hereby generally and unconditionally approved;
