- (2) to receive the printed English version of all future Corporate Communication only; or
- (3) to receive the printed Chinese version of all future Corporate Communication only; or
- (4) to receive both the printed English and Chinese versions of all future Corporate Communication.

A printed notification of the publication of the Corporate Communication on the Company's website will be sent to you in the future.

You have the right at any time by reasonable notice in writing to the Company c/o the H share registrar to change the choice of language and means of receipt of all future Corporate Communication. You may also send such a notice by email to <a href="mailto:chinaccs@computershare.com.hk">chinaccs@computershare.com.hk</a>. Even if you have chosen (or are deemed to have consented) to receive Website Version only but for any reason have difficulty in receiving or gaining access to the Corporate Communication, the Company will upon your request send the Corporate Communication to you in printed form free of charge as soon as possible.
