1.	THAT the consolidated financial statements of the Company, the report of the Directors, the report of the Supervisory Committee and the report of the international auditors for the year ended 31 December 2016 be considered and approved, and the board of directors of the Company (the "Board") be authorized to prepare the budget of the Company for the year 2017.		
2.	THAT the proposal on profit distribution and dividend declaration and payment for the year ended 31 December 2016 be considered and approved.		
3.	THAT the appointment of Deloitte Touche Tohmatsu and Deloitte Touche Tohmatsu Certified Public Accountants LLP as the international auditors and domestic auditors of the Company, respectively, for the year ending 31 December 2017 be considered and approved, and the Board be authorized to fix the remuneration of the auditors.		
4.	THAT the appointment of Mr. Shao Guanglu as a non-executive director of the Company be and is hereby considered and approved, with effect from the date on which this resolution is passed until the annual general meeting of the Company for the year 2017 to be held in 2018; THAT any director of the Company be and is hereby authorized to sign on behalf of the Company the director's service contract with Mr. Shao Guanglu.

5.	To consider and approve each of the following resolutions in relation to the granting of a general mandate to the Board to issue debentures:		
5.1	THAT the grant of a general mandate to the Board to issue debentures denominated in local or foreign currencies, in one or more tranches in the PRC and overseas, including but not limited to, short-term commercial paper, medium term note, company bond and corporate debts, with a maximum aggregate outstanding repayment amount of up to RMB6.0 billion be considered and approved.		
5.2	THAT the Board or any two of three directors of the Company duly authorized by the Board, namely Mr. Sun Kangmin, Mr. Si Furong and Ms. Hou Rui, taking into account of the specific needs of the Company and market conditions, be and are hereby generally and unconditionally authorized to determine the specific terms and conditions of, and other matters relating to, the issue of debentures, and do all such acts which are necessary and incidental to the issue of debentures.		
5.3	THAT the grant of the general mandate under this resolution shall come into effect upon approval from the general meeting and will be valid for 12 months from that date.		
6.	THAT the grant of a general mandate to the Board to allot, issue and deal with the additional shares of the Company not exceeding 20% of each of the Company's existing domestic shares and H shares (as the case may be) in issue be considered and approved.		
7.	THAT the Board be authorized to increase the registered capital of the Company to reflect the issue of shares in the Company authorized under special resolution 6, and to make such appropriate and necessary amendments to the Articles of Association of the Company as they think fit to reflect such increases in the registered capital of the Company and to take any other action and complete any formality required to effect such increase of the registered capital of the Company.
