An interest free convertible bonds in the principal amount of HK\$797.5 million (the "Convertible Bonds") was issued to Mr. Leung on 27 August 2010 as part of the consideration in relation to the very substantial acquisition and connected transaction as disclosed in the Company's circular dated 30 July 2010. The Convertible Bonds can be converted into shares of the Company at an initial conversion price of HK\$0.24 per share, which has been adjusted to HK\$1.20 per share due to the share consolidation effective on 27 February 2012, during its conversion period for a period of five years from 27 August 2010. As at the date hereof, HK\$144.1 million of the Convertible Bonds remain outstanding.

Convertible Preferred Shares

1,563,333,333 convertible preferred shares at an issue price of HK\$0.60 per share were allotted and issued to Mr. Leung on 17 December 2012 for capitalising the outstanding amount of HK\$938,000,000 due by the Company to Mr. Leung pursuant to the promissory note issued by the Company on 27 August 2010 as disclosed in the Company's circular dated 29 October 2012.
