# Convertible Bond

An interest free convertible bond in the principal amount of HK\$797.5 million (the "Convertible Bond") was issued to Mr. Leung Ngai Man on 27 August 2010 as part of the consideration in relation to the very substantial acquisition and connected transaction as disclosed in the Company's circular dated 30 July 2010. The Convertible Bond can be converted into shares of the Company at an initial conversion price of HK\$0.24 per share, which has been adjusted to HK\$1.20 per share due to the share consolidation effective on 27 February 2012, during its conversion period for a period of five years from 27 August 2010. On 24 August 2015, the Company entered into a supplemental deed (the "Supplemental Deed") with Mr. Leung Ngai Man pursuant to which the Company and Mr. Leung Ngai Man agreed to extend the maturity date of the Convertible Bond for 5 years from the date falling on the fifth year to the date falling on the tenth year from the date of issue of the Convertible Bond, subject to the conditions precedent contained in the Supplemental Deed being satisfied. On 3 November 2015, the resolution to extend the maturity date of the Convertible Bond was duly passed by the independent shareholders of the Company at an extraordinary general meeting. As at the date hereof, HK\$68.016 million of the Convertible Bond remain outstanding.
