## MONTHLY ANNOUNCEMENT RELATING TO OUTSTANDING CONVERTIBLE NOTES

References were made to the Company's announcement dated 22 March 2007 and circular dated 11 April 2007. The Board would like to report that conversions of the Convertible Notes were made by the noteholders which resulted in a total number of 1,176,470,588 Conversion Shares being issued during the period from 1 November 2007 to 30 November 2007.

References were made to an announcement of Wonson International Holdings Limited (the "Company") dated 22 March 2007 and a circular of the Company dated 11 April 2007 in relation to, inter alia, the entering into by the Company of the Convertible Notes Placing Agreement (the "Circular"). The Convertible Notes Placing Agreement was completed on 18 May 2007, pursuant to which the Convertible Notes with aggregate principal value of HK\$150,000,000 were issued by the Company. Capitalised terms used in this announcement shall have the meanings as defined in the Circular unless otherwise defined.

The Company is required to make this announcement to keep the Shareholders informed of the level of dilution of shareholding and details of conversions by the noteholders of the Convertible Notes during the month of November 2007 as follows:
