ANNOUNCEMENT RELATING TO CONVERSION OF CONVERTIBLE NOTES

The Board would like to report that 2,400,000,000 conversion shares, representing approximately 9.62% of the total issued share capital of the Company as disclosed in the Last Monthly Announcement, as a result of conversion of the Convertible Notes Due 2011 were issued on 8 December 2008 in a principal amount of HK\$360,000,000 made by a note holder.

Reference was made to the circular of Wonson International Holdings Limited (the "**Company**") dated 6 February 2008 in relation to, among others, the convertible notes due 2011 (the "**Convertible Notes Due 2011**") which were issued by the Company on 16 April 2008.As one of the conditions of the listing approval in relation to the Convertible Notes Due 2011 granted by the Stock Exchange of Hong Kong Limited, the Company is required to make this announcement in respect of, amongst other things, the details of the conversion of the Convertible Notes Due 2011 if the cumulative amount of conversion shares issued pursuant to the conversion of the Convertible Notes Due 2011 reaches 5% of the issued share capital of the Company as at 30 November 2008, being the date as disclosed in the last monthly announcement (the "**Last Monthly Announcement**") dated 4 December 2008.
