Power Generation and Electricity Sold for the First Three Quarters of 2014

China Power International Development Limited (the "Company") announces that based on the Company's preliminary statistics, for the nine months ended 30 September 2014, the combined total power generation of the Company and its subsidiaries (collectively, the "Group") amounted to 48,736,989MWh, representing an increase of 15.46% over the same period last year while its combined total electricity sold amounted to 46,593,234MWh, representing an increase of 16.13% over the same period last year.

The increase in the power generation for the first three quarters of 2014 as compared to the corresponding period last year was mainly due to the additional contribution from (1) the new generating units that commenced operation successively from mid-last year, (2) the acquisition of Wuhu coal-fired power plant that completed at the end of last year, and (3) the surge in hydropower generation during the third quarter of 2014 as compared with the corresponding period last year.

The respective total power generation and total electricity sold of the Group's main generating units for the nine months ended 30 September 2014 are as follows:

- (1) The merger of the two power plants, Yaomeng and Yaomeng II came into effect in the fourth quarter of 2013. Therefore, Yaomeng II's power generation and electricity sold included that of Yaomeng and the comparative figures for the first three quarters of 2013 have been adjusted accordingly.
- (2) The two coal-fired power generating units of Shentou I of total installed capacity of 400MW ceased commercial operation on 1 January 2014.
- (3) The Company completed the acquisition of Wuhu on 25 November 2013. Its power generation and electricity sold were incorporated into the Group thereafter.

- (4) For Wan Mi Po hydropower plant, its electricity sold for the first three quarters of 2014 was higher than that of its power generation because of some electricity sales rewarded by the grid corporation during the period.
- (5) The six new hydropower generating units of Tuokou of total installed capacity of 830MW commenced commercial operation in March 2014.
- [#] The new power plants (generating units) that commenced operation successively from mid-last year.
