## Power Generation and Electricity Sold for the Year 2014

China Power International Development Limited (the "Company") announces that based on the Company's preliminary statistics, for the year ended 31 December 2014, the combined total power generation of the Company and its subsidiaries (collectively, the "Group") amounted to 61,692,480MWh, representing an increase of 10.99% year on year while its combined total electricity sold amounted to 58,957,127MWh, representing an increase of 11.67% year on year.

The increase in the cumulative power generation for the year 2014 as compared to the year 2013 was mainly due to (1) the additional power contribution from the coal-fired power generating units of large installed capacity that commenced production and that newly acquired, and (2) the surge in hydropower generation in the second half of 2014.

The respective total power generation and total electricity sold of the Group's main generating units for the year ended 31 December 2014 are as follows:

## Notes:

- (1) The merger of the two power plants, Yaomeng and Yaomeng II came into effect in the fourth quarter of 2013. Therefore, Yaomeng II's power generation and electricity sold included that of Yaomeng and the comparative figures for the year 2013 have been adjusted accordingly.
- (2) The two coal-fired power generating units of Shentou I of total installed capacity of 400MW ceased commercial operation on 1 January 2014.

- (3) The Company completed the acquisition of Wuhu on 25 November 2013. Its power generation and electricity sold were incorporated into the Group thereafter.
- (4) For Wan Mi Po hydropower plant, its electricity sold for the year 2014 was higher than that of its power generation because of some electricity sales rewarded by the grid corporation during the year.
- (5) The six new hydropower generating units of Tuokou of total installed capacity of 830MW commenced commercial operation in March 2014.
- (6) The first eighteen new wind power generating units of Yaoposhan of total installed capacity of 36MW commenced commercial operation during November to December 2014.
- The new power plants (generating units) that commenced operation successively from mid-2013.
