## Power Generation and Electricity Sold for the First Half of 2016

China Power International Development Limited (the "Company") announces that based on the Company's preliminary statistics, for the six months ended 30 June 2016, the combined total power generation of the Company and its subsidiaries (collectively, the "Group") amounted to 33,823,021MWh, representing an increase of 14.97% over the same period last year while its combined total electricity sold amounted to 32,550,127MWh, representing an increase of 15.35% over the same period last year.

During the first half of 2016, the Group's hydropower plants principally located in Hunan Province recorded significant growth in power generation was mainly due to the abundant rainfall during the period and optimization of watershed management. In addition, the contribution from the new large capacity coal-fired power generating units as well as the new wind power plant and photovoltaic power stations that commenced operation, led to the increased total power generation and electricity sold in the first half as compared with the corresponding period last year.

The respective total power generation and total electricity sold of the Group's main power generating units for the six months ended 30 June 2016 are as follows:
