Electricity Sold for the First Quarter of 2017

China Power International Development Limited (the “Company”) announces that based on the Company’s preliminary statistics, for the three months ended 31 March 2017, the combined total electricity sold of the Company and its subsidiaries (collectively, the “Group”) amounted to 14,878,524MWh, representing a decrease of 2.84% year on year.

The electricity sold in the first quarter of 2017 was lower than that of the corresponding period last year, mainly due to the low rainfall during the period in the river basins where the Group’s hydropower plants are located, resulting in a decline in power generation. However, the production contributions from the new wind power plants and photovoltaic power stations that narrowed the decrease in the overall electricity sales in the first quarter year on year.
