China Power Announced its Gross Generation and Total Net Generation in 2011

(6 Jan 2012, Hong Kong) China Power International Development Limited (the "Company", Stock Code: 2380) today announced its gross generation and total net generation for the the year ended 31 December 2011.

According to its preliminary statistics, the consolidated gross generation of the Company (excluding the power plant of its associated company) amounted to 50,132,564MWh for the the year ended 31 December 2011, representing a year-on-year increase of 3.28% while its consolidated net generation totalled to 47,391,185MWh, representing a year-on-year increase of 3.14%.

Benefiting from strong power demand, coal-fired power plant generation increased by 10.06% year on year, while hydro power plant generation decreased by 20.08% year-on-year due to unusual drought in history.

The respective gross generation and total net generation figures of the power plants of the Company for the year ended 31 December 2011 are as follows:

The shares of the Company have been listed on the Main Board of The Stock Exchange of Hong Kong Limited since 15 October 2004. The Company is the flagship company of China Power Investment Corporation (one of the five national power generation groups in China) and its principal business is to develop, construct, manage and operate power plants in China. The Company has 100% or controlling interest in its six large-capacity coal-fired power plants under commercial operation and 50% equity interest in the associated company, Changshu Power Plant. The Company also owns a 63% controlling interest in Wuling Power Corporation, which is one of the leading hydropower companies in China. In addition, the Company owns a 18.86% stake in Shanghai Electric Power Co., Ltd., which is listed on the Shanghai Stock Exchange. Currently, the Company has an attributable installed capacity of approximately 11,495MW, among which the hydropower installed capacity is approximately 2,528MW and hence the Company has the highest percentage of hydropower capacity among the overseas listed Chinese independent power producers.
