If a proxy is attending the Meeting on your behalf, such proxy shall produce his/her own identity paper.
- d. If you wish to vote for the resolution set out above, please tick ("~") the boxes marked "For". If you wish to vote against the resolution, please tick ("~") the boxes marked "Against". If this form returned is duly signed but without specific direction on the proposed resolution the proxy will vote or abstain at his discretion in respect of the resolution. A proxy will also be entitled to vote at his discretion on any resolution properly put to the meeting other than those set out in the notice convening the meeting.
- e. This form of proxy must be signed by you or your attorney duly authorised in writing or, in the case of a corporation must be either executed under its common seal or under the hands of an officer or attorney or other person duly authorised.

In order to be valid, this form of proxy together with any power of attorney or other authority under which it is signed must be lodged with the Company's branch share registrar and transfer office in Hong Kong, Computershare Hong Kong Investor Services Limited, at 17M Floor, Hopewell Centre, 183 Queen's Road East, Wan Chai, Hong Kong by not less than 48 hours before the time appointed for holding the Meeting.
- g. Completion and return of this form of proxy shall not preclude you from attending and voting in person at the Meeting should you so wish.
- h. In the case of joint holders, the vote of the senior who tenders a vote, whether present in person or by proxy, will be accepted to the exclusion of the vote(s) of the other joint holder(s), and for this purpose seniority shall be determined by the order in which the names stand in the register of members of the Company in respect of the joint holding.
