On 25 December 2017, China Unicom signed business cooperation framework agreements respectively with Kuang-Chi Technologies and KuangChi Science, both of which are listed subsidiaries of Kuang-Chi Group, one of its mixed-ownership reform strategic investors. China Unicom and KuangChi Science will become strategic partners in the area of smart cities. The two companies will engage in in-depth cooperation in smart city planning, construction, operation, data and services, etc. and jointly commence deep operation services targeted at smart cities.



In addition, China Unicom and KuangChi Science will engage in smart transportation cooperation by integrating artificial intelligence technology, communications services and smart operation, aiming to develop future-proof and comprehensive integrated smart transportation solutions. The two companies will also share customer resources and channels, and jointly develop the relevant markets.
