Remarks (if any):

The capital reorganisation of the Company (the “**Capital Reorganisation**”) became effective on 30 July 2020 (Hong Kong time) which involves, among others, the following :-

- a) the reduction of the par value of each issued share from HK\$0.05 to HK\$0.0001;
- b) the sub-division of each authorised but unissued share into 500 new shares of HK\$0.0001 each (each a “**New Share**”); and
- c) the consolidation of the New Shares on the basis that every 10 issued and unissued New Shares of HK\$0.0001 each consolidated into one share of HK\$0.001 each.

Details of the Capital Reorganisation are set out in the circular and dated 30 March 2020 and announcements dated 22 April 2020 and 10 July 2020.
