1. INTRODUCTION

The purpose of this circular is to notify shareholders of the Company the convening of the Annual General Meeting and to provide you with information in connection with the proposals to: (i) grant the general mandates to issue Shares and to repurchase Shares; and (ii) re-elect the retiring Directors.

2. PROPOSED GENERAL MANDATES TO ISSUE SHARES AND TO REPURCHASE SHARES

At the annual general meeting of the Company held on 25 May 2016, approval was given by the Shareholders for the granting of, inter alia, the general mandates to the Directors (i) to allot, issue and otherwise deal with Shares not exceeding 20% of the aggregate nominal amount of the issued share capital of the Company as at 25 May 2016; and (ii) to repurchase Shares on the Stock Exchange up to 10% of the aggregate nominal amount of the issued share capital of the Company as at 25 May 2017. This Appendix serves as an explanatory statement required to be sent to Shareholders under the Listing Rules in connection with the proposed Repurchase Mandate.

1. SHARE CAPITAL

As at the Latest Practicable Date, the issued share capital of the Company comprised 4,350,313,206 Shares.

Subject to the passing of the Repurchase Resolution and on the basis that no further Shares are issued or repurchased prior to the Annual General Meeting, the Company would be allowed under the Repurchase Resolution to repurchase a maximum of 435,031,320 Shares (representing 10% of the issued share capital of the Company as at the date of passing the Repurchase Resolution).

2. SHAREHOLDERS' APPROVAL

The Listing Rules provide that all proposed repurchases of securities by a company with a primary listing on the Stock Exchange must be approved in advance by an ordinary resolution, either by way of a general mandate or by a specific approval of a particular transaction.

Such authority may only continue in force during the period from the passing of the resolution until whichever is the earlier of: (i) the conclusion of the next annual general meeting of the company, (ii) the expiration of the period within which the next annual general meeting of the company is required by law to be held, or (iii) the passing of an ordinary resolution by shareholders in general meeting of the company revoking or varying such mandate.

3. **REASONS FOR REPURCHASES**

The Director believe that it is in the best interests of the Company and the Shareholders to seek a general authority from Shareholders to enable the Directors to repurchase the Shares on the market.

Repurchases of Shares will only be made when the Directors believe that such a repurchase will benefit the Company and its Shareholders. Such repurchases may, depending on market conditions and funding arrangements at the time, lead to an enhancement of the value of the net assets and/or earnings and/or dividend per share.

6. TAKEOVERS CODE

If as a result of a repurchase of Shares, a Shareholder's proportionate interest in the voting rights of the Company increases, such increase will be treated as an acquisition of voting rights for the purposes of the Takeovers Code. PARTICULARS OF RETIRING DIRECTORS STANDING FOR RE-ELECTION

Mr. Shang Jianguang

Mr. Shang, aged 65, has been appointed as an Executive Director and Chief Executive Officer of the Company since 18 November 2004 and he is also a member of the Company's Remuneration Committee and Nomination Committee. He is the General Manager of Zhuhai Rossini Watch Industry Limited and a director of various subsidiaries of the Group including Bendura Bank AG. He was graduated in Fuzhou University majoring in Chemistry and is a qualified senior engineer in Mainland China. Prior to joining the Group, he assumed senior posts in various large companies, and was General Manager and Director of Min Xin Holdings Limited (stock code: 222), a company listed on the main board of the Stock Exchange. He also serves as a director of Citychamp Dartong Company Limited (stock code: 600067) in Mainland China, the shares of which are listed on the Shanghai Stock Exchange. Mr. Shang has extensive knowledge and experience in corporate and investment management.

Mr. Shang has entered into a service agreement with the Company for a term of 3 years commencing from 18 November 2011 and is subject to termination by either party by giving not less than three months' written notice.
