The Company strongly encourages you to exercise your rights to attend the Annual General Meeting by appointing the chairman of the Annual General Meeting as your proxy to vote according to your indicated voting instructions and viewing a live webcast of the Annual General Meeting. In particular, Shareholders (other than those who are required to attend the Annual General Meeting physically to form a quorate meeting) will NOT be able to attend in person, but may view and listen to the Annual General Meeting and submit questions online.
