During the period from the granting of the IBC Disposal Mandate by the Shareholders on 10 March 2017 up to 14 February 2018, the Company disposed of an aggregate of 43,936,000 IBC A Shares pursuant to the IBC Disposal Mandate and the net proceeds arising from the disposal amounted to RMB775.02 million. As at the date of this announcement, the Company does not beneficially own any of IBC A Shares.
