VOLUNTARY ANNOUNCEMENT ACQUISITION OF LAND

Tonic Industries Holdings Limited (the “**Company**”) is pleased to announce that, on 7 November 2013, Foshan Yi Yun Property Development Co., Ltd (佛山依雲房地產有限公司), a non wholly-owned subsidiary of the Company, has obtained the Land Transfer Confirmation (土地成交確認書) for the land use right of the land parcel in Foshan City, Guangdong Province, the People’s Republic of China (the “**Land**”) for a total consideration of RMB920.26 million.

The Land is situated at the north to Jihua Bridge and west to Tung Ping River, Shancheng District, Foshan City (佛山市禪城區季華大橋北側、東平河西側). The Land has a total site area of approximately 59,363 sq.m. and its permitted plot ratio is not more than 2.5. The Land is designated for a mix of residential usage and commercial usage. The term for residential usage is 70 years and for commercial usage is 40 years.

The Company and its subsidiaries (the “**Group**”) is engaged in the development, sale, lease, investment and management of properties in the PRC.

In view of the location and the designated use of the Land, the directors of the Company (the “**Directors**”) consider that the acquisition of the Land is in line with the business development strategy and plan of the Group. The Directors further consider that the acquisition is a transaction of revenue nature and is carried out in the ordinary and usual course of business and are on normal commercial terms which are fair and reasonable and in the interests of the shareholders of the Company as a whole.

This announcement is made by the Company on a voluntary basis.
