The board of Directors is pleased to announce that on 6 April 2016 (after trading hours), the Group and the Supplier entered into the Purchase Contract regarding the purchase of additional wind power electricity generation equipment amounting to a total consideration of RMB205,440,000 (equivalent to approximately HK\$246,528,000) by the Group from the Supplier for the wind farm project of the Group in Anhui province (安徽省), the PRC. The Supplier is an Independent Third Party.

#### **PURCHASE CONTRACT 3**

The payment of consideration to be made by the Group by instalment will be based on the stages of completion of the Purchase Contract 3. The consideration will be payable in cash or by way of issuing acceptance bill of exchange.
