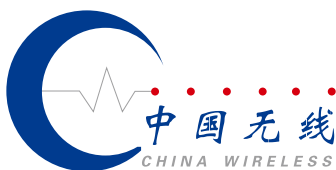

### **ANNOUNCEMENT**

This announcement is made pursuant to Rule 13.09 of the Listing Rules to provide information on a framework agreement entered into between Yulong Computer Telecommunications Scientific (Shezhen) Co., Ltd (“Yulong Shenzhen”), an indirect wholly-owned subsidiary of the Company, and a sales agent — Beijing PYPO Technology Group (“PYPO”) dated 9 August 2007 (the “PYPO Framework Agreement”) and a custom made terminal device sales framework agreement entered into between Yulong Shenzhen and China Mobile Communications Corporation (“China Mobile”) dated 9 August 2007 (the “China Mobile Framework Agreement”).

This announcement is made pursuant to Rule 13.09 of the Rules Governing the Listing of Securities (the “Listing Rules”) on The Stock Exchange of Hong Kong Limited (the “Stock Exchange”).

#### **THE PYPO FRAMEWORK AGREEMENT**

The board (the “Board”) of directors (the “Directors”) of China Wireless Technologies Limited (the “Company”) is pleased to announce that Yulong Shenzhen, an indirect wholly-owned subsidiary of the Company, entered into a framework agreement with a sale agent — PYPO, on 9 August 2007, pursuant to which PYPO had agreed to purchase from Yulong Shenzhen custom made handsets “Coolpad 8260” which will be ultimately sold to the subsidiaries of China Mobile at the provincial level under separate sales agreement to be entered into between China Mobile’s subsidiaries and PYPO. It is estimated that 150,000 “Coolpad 8260” handsets valued at approximately RMB 600 million will be sold under the PYPO Framework Agreement.

#### **THE CHINA MOBILE FRAMEWORK AGREEMENT**

The Board is glad to announce that Yulong Shenzhen has entered into a custom made terminal device sales framework agreement with China Mobile on 9 August 2007. Pursuant to the China Mobile Framework Agreement, China Mobile will organize nationwide merchandizing activities in the PRC with Yulong Shenzhen with regard to its custom made handsets and terminal devices.

As a result, the subsidiaries of China Mobile at the provincial level will enter into sales agreements with Yulong Shenzhen to purchase custom made handsets and terminal devices developed by Yulong Shenzhen. The Directors believe that the China Mobile Framework Agreement has significant implications to the business development of the Company in the future.

Save and except for the information set out in this announcement, the Board is not aware of any other matter disclosable under the general obligation imposed by Rule 13.09 of the Listing Rules, which is or maybe of price-sensitive nature. Neither is the Board aware of any other negotiations or agreements relating to intended acquisitions or realizations which are disclosable under Rule 13.23 of the Listing Rules.
