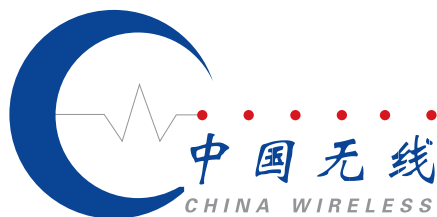

GRANT OF SHARE OPTIONS

This announcement is made pursuant to Rule 17.06A of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”).

The board of directors (the “**Board**”) of China Wireless Technologies Limited (the “**Company**”) hereby announces that on 30 June 2010, 65,880,000 options (the “**Options**”) to subscribe for the ordinary shares of HK\$0.01 each of the Company (the “**Shares**”) were granted, subject to the acceptance of the grantees (the “**Grantees**”), under the share option scheme adopted by the Company on 21 November 2004.

Each Option shall entitle the holder of the Option to subscribe for one Share upon exercise of such Option at an exercise price of HK\$3.24 per Share, which is (i) the highest of the nominal value of the Shares; (ii) the closing price of HK\$2.95 per Share as stated in the daily quotation sheet issued by the Stock Exchange on the date of grant; and (iii) the average closing price of HK\$3.24 per Share as stated in the daily quotation sheet issued by the Stock Exchange for the five business days immediately preceding the date of grant.

Among the total 65,880,000 Options, 2,000,000 Options were granted to each of Mr. Li Bin and Mr. Li Wang, who are the executive directors of the Company.

The Grantees shall exercise the Options during the following vesting period:

- (a) The Grantees who were granted in aggregate 16,904,000 Options shall exercise the Options during a period commencing on 28 June 2011 and expiring on 27 June 2015.
- (b) The Grantees who were granted in aggregate 19,704,000 Options shall exercise the Options during a period commencing on 28 June 2012 and expiring on 27 June 2016.
- (c) The Grantees who were granted in aggregate 15,772,000 Options shall exercise the Options during a period commencing on 28 June 2013 and expiring on 27 June 2017.

- (d) The Grantees who were granted in aggregate 13,500,000 Options shall exercise the Options during a period commencing on 28 June 2014 and expiring on 27 June 2018.
