The Board of Directors (the "Board") of the Company wishes to inform the shareholders of the Company (the "Shareholders") and potential investors that based on a preliminary review of the unaudited management accounts of the Group for the year ended 31 December 2023 ("FY2023"), the Group expects to record a loss attributable to owners of the Company for FY2023 of not more than US\$4.5 million as compared to the profit of approximately US\$1.1 million recorded for the year ended 31 December 2022 ("FY2022"). Such turnaround of the Group's results is mainly the combined effect of (i) the decrease in profit contribution from the Group's marine transportation operation to approximately US\$2.2 million (FY2022: US\$5.4 million); (ii) the loss on disposal of a subsidiary of approximately US\$2.1 million (FY2022: nil) as announced by the Company on 26 September 2023; (iii) the decrease in allowance for credit losses on debt instruments at fair value through other comprehensive income to approximately US\$1.1 million (FY2022: US\$1.4 million); and (iv) the increase in impairment loss recognised on vessels of approximately US\$1.0 million (FY2022: US\$0.8 million).

The Company is in the process of finalising the annual results of the Group for FY2023. The information contained in this announcement is only based on a preliminary assessment by the Board according to the unaudited management accounts of the Group for FY2023 which have not been reviewed or audited by the auditor of the Company. Accordingly, the Group's actual results for FY2023 may differ from the information contained in this announcement.

Further details of the Group's financial results and performance will be disclosed in the annual results announcement of the Company for FY2023 which is expected to be announced before the end of March 2024.
