ORDINARY RESOLUTIONS

- 1. To receive, consider and adopt the audited consolidated financial statements of the Company and the report of the directors and of the auditor for the year ended 31 December 2019.
- 2. To re-elect the retiring director and to authorise the Board of Directors to fix the remuneration of the directors of the Company.
- 3. To re-appoint Deloitte Touche Tohmatsu as auditor of the Company and to authorise the Board of Directors to fix its remuneration.

- (b) the approval in paragraph (a) above shall authorise the Directors during the Relevant Period (as hereinafter defined) to make or grant offers, agreements or options (including bonds, warrants, debentures, notes and other securities which carry rights to subscribe for or are convertible into Shares) which would or might require the exercise of such powers after the end of the Relevant Period;

- (b) the total number of shares of the Company (the "Shares") which the Company is authorised to repurchase pursuant to the approval in paragraph (a) above during the Relevant Period (as hereinafter defined) shall not exceed 10% of the total number of Shares in issue as at the date of the passing of this resolution and the said approval shall be limited accordingly; and

Where there are joint holders of any share(s), any one of such joint holders may vote, either in person or by proxy, in respect of such share(s) as if he/she/it were solely entitled thereto, but if more than one of such joint holders are present at the AGM, whether in person or by proxy, the joint registered holder present whose name stands first on the register of members in respect of the share(s) shall be accepted to the exclusion of the votes of the other registered holders.
- 10. To prevent and control the spread of Coronavirus disease 2019 pandemic (COVID-19), the Company will implement the following precautionary measures:
 - (i) mandatory body temperature screening at the entrance of the meeting venues for each attendee. Any person with a body temperature over 37.5°C shall not be permitted to enter the meeting venues;
 - (ii) compulsory use of surgical face masks;

- (iii) no distribution of corporate souvenirs/gifts or refreshments; and
- (iv) appropriate distancing and spacing between seats.

Any attendee who does not comply with the precautionary measures or is subject to quarantine or such other stay-at-home notices with any flu-like symptoms, who has had close contact with any person under quarantine or such other stay-at-home notices, or has travelled overseas within 14 days immediately before the AGM shall not be permitted to enter the meeting venues. All shareholders of the Company are strongly encouraged to appoint the Chairman of the AGM as his/her/its proxy as an alternative to attending the AGM in person.
