In 2020, the Group entered into the 2021 Leases with the Connected Landlords controlled by connected persons, specifically Mr. Lo, Mrs. Lo and Mr. Andrew Lo. Pursuant to the 2021 Leases, the Connected Landlords agreed to lease certain premises to the Group for office, warehouse and living quarters' purposes.

All the 2021 Leases will expire on 31 December 2021. The Board announces that on 16 December 2021, among the 2021 Leases, certain lease agreements are to be renewed for a term of one year.

Each of Mr. Lo (executive director), Mrs. Lo (executive director) and Mr. Andrew Lo (executive director), who control the Connected Landlords, has a material interest in the connected transactions under the 2022 Leases and, therefore, abstained from voting on the resolutions of the Board in respect of the approval of the 2022 Leases.

Pricing Policy: The monthly rentals under the 2022 Leases reflect prevailing market rates, based on valuations made by the property valuer of the Company, which shall be payable in cash on a monthly basis and in advance on the first day of each calendar month. To the best of the directors' knowledge, information and belief, having made all reasonable enquiries, at the date of this announcement, the issued share capital of Happy Field Company Limited is indirectly wholly-owned by Mr. Lo and Mrs. Lo, the issued share capital of Tanbo Development Limited is directly wholly-owned by Mr. Lo and Mrs. Lo, and the issued share capital of Joint Access Limited is indirectly owned as to 50% by Mr. Andrew Lo and 50% by his spouse, Mrs. Lo Lam So Lai Irene.
