The SDHG Group adhered to the concept of long-term value investment and continued to be optimistic about the positive development of China's economy. It actively integrates its business into the new development pattern in the clean energy field and actively promotes projects in this field which is strongly supported by the Chinese government under the 14th Five-Year Plan to achieve carbon dioxide emissions peak in 2030 and carbon neutrality in 2060. Each of SHNE and SDHG is of the view that implementation of the Project would promote the use of clean energy, provide a continuous supply of clean electricity through photovoltaic power generation, and to store the surplus electricity to improve energy conversion efficiency and reduce energy costs for local residents.

Basis of Consideration

The SHNE Group invited public tender for the Construction Work I and the Construction Work II. The SHNE Group selected China Power Construction Group and Shandong Luqiao as the tender winners for both Construction Work I and Construction Work II after conducting relevant evaluation procedures. Having taking into consideration of various factors, including but not limited to technical experience, professional qualifications, business reputation and project management abilities of all the tenderers, and total expected expenses, the advice from independent tender consultants and internal staff with solid industry experience, long established relationship between the SDHG Group and Shandong Hi-Speed Group and the project resources would be obtained with the assistance of Shandong Hi-Speed Group, the SHNE Board and the SDHG Board considered that the contractors selected are appropriate choices to carry out the relevant works under the General Construction Contracts. The total contracting fees under each of the General Construction Contract I and the General Construction Contract II was determined after arm's length negotiation between the parties on normal commercial terms with reference to, inter alia, (i) relevant services required by the SHNE Group and the SDHG Group, (ii) the relevant design, procurement and construction costs, (iii) the prevailing market price for the similar services, and (iv) the price of similar service contracts that the SHNE Group procured from other Independent Third Parties.
