6．The instrument appointing a proxy and the power of attorney or other authority，if any，under which it is signed or a notarially certified copy of that power or authority shall be deposited at the principal place of business of the Company in Hong Kong at 29／F．，China United Centre，No． 28 Marble Road，North Point，Hong Kong not less than 48 hours before the time appointed for holding the meeting or adjourned meeting or poll （as the case may be）at which the person named in such instrument proposes to vote，and in default，the instrument of proxy shall not be treated as valid．Delivery of an instrument appointing a proxy shall not preclude a member from attending and voting in person at the meeting or poll concerned．
7．In the case of joint holders，the vote of the senior who tenders a vote，whether in person or by proxy or by representative，shall be accepted to the exclusion of the votes of the other joint holders；and for this purpose seniority shall be determined by the order in which the names stand in the register．
