The Board wishes to inform the Shareholders and potential investors that the Group is expected to record a loss for the six months ended 30 June 2019 comparable to the loss of HK\$17,074,000 recorded for the six months ended 30 June 2018.

This announcement is made by Daido Group Limited (the "Company", together with its subsidiaries, the "Group") pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the "Listing Rules") and the Inside Information Provisions (as defined under the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571, Laws of Hong Kong) (the "SFO").

Based on the information available for the time being, the board of directors (the "Board") of the Company wishes to inform the shareholders of the Company (the "Shareholders") and potential investors that the Group is expected to record a loss for the six months ended 30 June 2019 comparable to the loss of HK\$17,074,000 recorded for the six months ended 30 June 2018. The Board considers that the expected loss is primarily attributable to share of loss of an associate and the operating loss incurred in the operation of the new warehouse which was not in full operation.

The information contained in this announcement is only based on the preliminary assessment by the Board with reference to the latest available consolidated management accounts of the Group, which have not been reviewed by the Company's auditor. Details of the Group's financial performance will be disclosed in the interim results announcement of the Group which will be issued in August 2019.
