Based on the information available for the time being, the board of directors (the "Board") of the Company wishes to inform the shareholders of the Company (the "Shareholders") and potential investors that the Group is expected to record a net profit attributable to the Shareholders of approximately not less than HK\$2,200,000 for the six months ended 30 June 2022 (the "First Half of 2022"), as compared to a net loss attributable to the Shareholders of approximately HK\$38,990,000 recorded for the six months ended 30 June 2021 (the "Prior Period").

The Board considered that the turnaround from loss to profit position of the Group was primarily attributable to an internal business restructuring during 2021 including the disposal of interest in an associate, resulting in significant increase in the revenue and net profit from cold storage and related services business by approximately 42% and 161% respectively in the First Half of 2022 as compared to the Prior Period.
