Up to the date of this announcement, no agreement has been reached. Hence, the Group's intention alone does not constitute a notifiable transaction under The Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the "Listing Rules") for the moment. However, it is likely that any agreement reached in this respect subsequently may constitute a major transaction under the Listing Rules and the Board will comply with the applicable Listing Rules, including the making of further announcement and the obtaining of approval from the shareholders of the Company ("Shareholders").

The intention to dispose of the Investment may or may not be realised. In the meantime, Shareholders and potential investors are advised to exercise caution when dealing in the listed securities of the Company.
