1. INTRODUCTION

By the resolutions passed at the 2013 Annual General Meeting, the Directors were granted a general mandate to repurchase the Shares and a general mandate to allot, issue and deal with the Shares and the extension of the share issue mandate. These mandates will expire at the conclusion of the forthcoming Annual General Meeting. Ordinary resolutions will be proposed at the Annual General Meeting to seek Shareholders' approval for the renewal of these general mandates.

The purpose of this circular is to provide you with information regarding the Repurchase Mandate, the Share Issue Mandate, the extension of Share Issue Mandate and the re-election of Directors to enable you to make an informed decision on whether to vote for or against the proposed resolutions at the Annual General Meeting.

2. ANNUAL RESULTS AND ANNUAL REPORT

Reference is made to the Company's announcements dated 25 September 2014 and 30 October 2014 (the "Delay Results Announcements") regarding, among others, the delay in publication of annual results and dispatch of annual report of the Company for the year ended 30 June 2014. Unless otherwise specified, terms used herein shall have the same meanings as those defined in the Delay Results Announcements.

As mentioned in the Delay Results Announcements, the audit in respect of the 2014 Annual Results has not yet finished, the publication of the 2014 Annual Results will be delayed and it is expected that the 2014 Annual Results would be published at around the end of December 2014. Moreover, the dispatch of the 2014 Annual Report will also be delayed and it is expected that the 2014 Annual Report will be dispatched at around the end of January 2015.

Accordingly, the audited financial statements, the report of the Directors and the auditor's report for the year ended 30 June 2014, which will be contained in the 2014 Annual Report, would not be available to the Shareholders for their consideration and adoption at the Annual General Meeting.

3. GENERAL MANDATE TO REPURCHASE SHARES

An ordinary resolution will be proposed at the Annual General Meeting which, if passed, will give the Directors a general and unconditional mandate to exercise the powers of the Company to repurchase Shares at any time until the next annual general meeting of the Company following the passing of the resolution or such earlier date as stated in the resolution up to maximum of 10% of the aggregate nominal amount of the issued share capital of the Company at the date of passing the resolution. Assuming no further Shares are issued and repurchased prior to the Annual General Meeting and based on the issued share capital of the Company of 1,001,765,216 Shares as at the Latest Practicable Date, the Company would be allowed under the Repurchase Mandate to repurchase a maximum of 100,176,521 Shares.

An explanatory statement as required under the Listing Rules to provide the requisite information regarding the Repurchase Mandate is set out in the Appendix I to this circular.

4. GENERAL MANDATE TO ISSUE SHARES

An ordinary resolution will be proposed at the Annual General Meeting which, if passed, will give the Directors a general mandate to allot, issue and deal with new Shares at any time until the next annual general meeting of the Company following the passing of the resolution or such earlier date as stated in the resolution representing up to 20% of the aggregate nominal amount of the issued share capital of the Company at the date of passing the resolution. Assuming no further Shares are issued and repurchased prior to the Annual General Meeting

and based on the issued share capital of the Company of 1,001,765,216 Shares as at the Latest Practicable Date, the Company would be allowed under the Share Issue Mandate to allot and issue a maximum of 200,353,043 Shares.

In addition, if the Repurchase Mandate is granted, an ordinary resolution will be proposed at the Annual General Meeting providing that any Shares repurchased under the Repurchase Mandate (up to maximum of 10% of the aggregate nominal amount of the issued share capital of the Company as at the date of the granting of the Repurchase Mandate) will be added to the total number of Shares which may be allotted and issued under the Share Issue Mandate.

5. RE-ELECTION OF DIRECTORS

In accordance with Article 87 of the Articles of Association, Mr. Wu Shaoning and Ms. Chen Xiao Fang will retire from office and be eligible for re-election at the Annual General Meeting.

In accordance with Article 86 of the Articles of Association, Mr. Zhang Liang, an Executive Director appointed by the Board on 20 October 2014, Ms. Zhao Jianhua, an Independent Non-executive Director appointed by the Board on 14 November 2014, and Mr. Xu Jiangtao, an Executive Director appointed by the Board on 21 November 2014, shall hold office until the next following annual general meeting of the Company and shall then be eligible for re-election at the Annual General Meeting.

Biographical details in respect of Mr. Wu Shaoning, Ms. Chen Xiao Fang, Mr. Zhang Liang, Mr. Xu Jiangtao and Ms. Zhao Jianhua who are required to be disclosed by the Listing Rules are set out in Appendix II to this circular. Separate resolutions for re-election of these Directors will be put forward at the Annual General Meeting.

Pursuant to code provision A.5.5 of the CG Code, where the board proposes a resolution to elect an individual as an independent non-executive director at the general meeting, it should set out in the circular to shareholders why it believes he/she should be elected and the reasons why it considers him/her to be independent. Ms. Zhao Jianhua, being an Independent Non-executive Director, is eligible for re-election at the Annual General Meeting. Ms. Zhao has provided her annual confirmation of independence to the Company pursuant to Rule 3.13 of the Listing Rules. During her appointment, Ms. Zhao has not been involved in the daily management of the Company nor in any relationships which interfere with her independent judgment, and she has demonstrated her abilities to provide independent, balanced and objective view to the Company's affairs. The Nomination Committee is of the view that Ms. Zhao meets the independence guidelines set out in Rule 3.13 of the Listing Rules and is regarded as independent in accordance with the terms of the guidelines. The Board, with the recommendation from the Nomination Committee, recommends Ms. Zhao for re-election at the Annual General Meeting.

6. ANNUAL GENERAL MEETING

The notice of Annual General Meeting, which contains, inter alia, ordinary resolutions to approve the Repurchase Mandate, Share Issue Mandate and the extension of the Share Issue Mandate is set out in this circular.

Pursuant to Rule 13.39(4) of the Listing Rules, any vote of Shareholders at a general meeting must be taken by poll except where the chairman of the meeting, in good faith, decides to allow a resolution which relates purely to a procedural or administrative matter to be voted on by a show of hands. The chairman of the Annual General Meeting will therefore demand all resolutions proposed to be approved at the Annual General Meeting to be taken by poll pursuant to Article 66 of the Articles of Association. An announcement will be made by the Company after the Annual General Meeting on the results of the Annual General Meeting.

On a poll, every Shareholder present in person (or, in the case of a Shareholder being a corporation by its duly authorized representative) or by proxy shall have one vote for every fully paid Share registered in his name. This explanatory statement contains the information required under Rule 10.06(1)(b) of the Listing Rules. Its purpose is to provide Shareholders with information reasonably necessary to enable them to make an informed decision on whether to vote for or against the resolution approving the Repurchase Mandate.

1. SHARE CAPITAL

As at the Latest Practicable Date, the issued and fully-paid share capital of the Company was 1,001,765,216 Shares.

Subject to the passing of the ordinary resolution granting the Repurchase Mandate and on the basis that no further Shares are issued or repurchased prior to the Annual General Meeting, the Company would be allowed under the Repurchase Mandate to repurchase a maximum of 100,176,521 Shares (representing 10% of the Shares in issue as at the Latest Practicable Date) during the period from the date on which such resolution is passed until the date of (i) conclusion of the next annual general meeting; (ii) expiration of period within which the next annual general meeting is required by the Articles of Association or any applicable laws of the Cayman Islands to be held; (iii) the revocation, variation or renewal of the Repurchase Mandate by an ordinary resolution of the Shareholders in general meeting, whichever occurs first.

2. REASONS FOR REPURCHASES

The Directors believe that the Repurchase Mandate is in the best interests of the Company and the Shareholders. Whilst it is not possible to anticipate in advance any specific circumstance in which the Directors might think it appropriate to repurchase Shares, they believe that an ability to do so would give the Company additional flexibility that would be beneficial to the Company and the Shareholders as such repurchases may, depending on market conditions and funding arrangements at that time, lead to an enhancement of the net asset value per Share and/or earnings per Share. 5. UNDERTAKING

The Directors have undertaken to the Stock Exchange that, so far as the same may be applicable, they will exercise the powers of the Company to make repurchases pursuant to the Repurchase Mandate in accordance with the Listing Rules, the Memorandum and Articles of Association of the Company and the laws of the Cayman Islands.

None of the Directors nor, to the best of their knowledge having made all reasonable enquiries, their associates, have any present intention to sell any Shares to the Company in the event that the Repurchase Mandate is approved by the Shareholders.

He graduated from the University of Xiamen with a bachelor's degree in politics and economics. Thereafter, Mr. Wu attended the Hong Kong Macau Economics Study Programme at the University of Hong Kong for one year and obtained a master's degree in economics from the University of Xiamen. Mr. Wu has over 22 years of experience in trading business and the agricultural chemicals industry in Mainland China. Mr. Wu had been nominated as the director of 中國農作物化控專業委員會 (the Professional Crop Chemical Control Committee of China) in 1999. He was also elected as the deputy chairman of 福建省農業產業化龍頭企業協會(the Fujian Agricultural Industrialisation Association)in 2004.
