There is not and it is currently not intended for there to be any public offering of securities of the Company in the United States.

In connection with the Global Offering, Credit Suisse (Hong Kong) Limited (the “Stabilising Manager”) or any person acting for it, on behalf of the International Underwriters, may to the extent permitted by applicable laws of Hong Kong, over-allocate and/or effect short sales or any other stabilising transactions with a view to stabilising or maintaining the market price of the Shares at a level higher than that which may otherwise prevail in the open market for a limited period commencing from the Listing Date and ending on the 30th day after the last day for the lodging of applications under the Hong Kong Public Offering and Preferential Offering, being Wednesday, 3 November 2010.

We will not receive any of the proceeds from the sale of the Sale Shares by the Selling Shareholder from the Offer for Sale or pursuant to the exercise of the portion of the Over-allotment Option granted by the Selling Shareholder. In the event that such Over-Allotment Option is exercised, an announcement will be made on the Company's website at www.kosmohotels.com and on the Stock Exchange's website at www.hkexnews.hk.

The stabilisation period is expected to expire on Wednesday, 3 November 2010 after which announcement will be made pursuant to section 9 and schedule 3 of the Securities and Futures (Price Stabilising) Rules made under the SFO, and after such expiry, no further stabilising action may be taken. After this date, when no further stabilisation action may be taken, demand for Shares, and therefore its market price, could fall.

SUMMARY

The total net proceeds from the Global Offering after deducting the underwriting commissions and the estimated offering expenses are estimated to be approximately HK\$1,123 million before any exercise of the Over-allotment Option. The net proceeds to the Company and the Selling Shareholder from the Global Offering after deducting the underwriting commissions and the estimated offering expenses are estimated to be approximately HK\$558 million and HK\$565 million, respectively, before any exercise of the Over-allotment Option.

USE OF NET PROCEEDS OF THE GLOBAL OFFERING

The total net proceeds from the Global Offering after deducting the underwriting commissions and the estimated offering expenses are estimated to be approximately HK\$1,123 million before any exercise of the Over-allotment Option. The net proceeds to the Company and the Selling Shareholder from the Global Offering after deducting the underwriting commissions and the estimated offering expenses are estimated to be approximately HK\$558 million and HK\$565 million, respectively, before any exercise of the Over-allotment Option.

The Company estimates that the aggregate net proceeds from the Global Offering payable to it (after deducting underwriting fees and estimated expenses payable by us in connection with the Global Offering), based on the Offer Price of HK\$2.20 per Share, will be approximately HK\$558 million. The Company currently intends to apply these net proceeds for the following purposes:

- approximately HK\$446 million (approximately 80% of the net proceeds payable to the Company) to continue the expansion of our hotel portfolio.

The Company is in the process of identifying hotel sites and other hotel or project acquisition opportunities in Hong Kong, China, Singapore and other regions in the Asia Pacific. The Company expects to pursue one or more of these opportunities within six months of the Listing Date. The actual opportunities pursued will depend on, among other things, whether the Company is successful in any public tender or bidding processes (where applicable) and the final pricing of the sites or projects involved. The Company currently expects that any hotels developed pursuant to such acquisitions, if not existing hotels, will be completed within two to three years from the date of acquisition.

- approximately HK\$112 million (approximately 20% of the net proceeds payable to the Company) for the purposes of our expansion into the hotel management business, which will incorporate its rebranding initiative.

Part of the funding will be directed towards investments in hotels that it will operate for independent third parties, which is necessary to secure long term management contracts. The form of investment may either be through minority equity investments or hotel refurbishment/rebranding costs. Additionally, the Company will create a number of showcase properties as part of its rebranding initiative, namely Hotel Kosmopolito City Centre, Chengdu, Lan Kwai Fong Hotel @ Kau U Fong, Dorsett Regency Hotel Kuala Lumpur, Cosmopolitan Hotel and Dorsett Seaview Hotel.

The Company does not currently have any intention to expand into Japan or the Maldives because it believes that Japan has higher operating costs and a substantially different operating environment to our other markets and the Maldives is geographically distant from our other operating markets. For further information regarding the Company's use of proceeds see the section headed "Future Plans and Use of Proceeds" in the Prospectus. To the extent that the net proceeds from the Global Offering are not sufficient to fund the uses set forth above, the Company intends to fund the balance through a variety of means including cash generated from our operations and bank financing. The Company currently believes that the net proceeds from the issue of new Shares, when combined with such alternate sources of financing, are sufficient for the uses set forth above.

The Company will not receive any of the proceeds from the sale of the Sale Shares by the Selling Shareholder from the Offer for Sale or pursuant to the exercise of the portion of the Over-allotment Option granted by the Selling Shareholder. Assuming the Over-allotment Option is not exercised and the Offer Price is HK\$2.20 per Share, the Selling Shareholder will receive total net proceeds of approximately HK\$565 million. If the Over-allotment Option is exercised in full, the Selling Shareholder's total net proceeds will increase to HK\$651 million based on the Offer Price of HK\$2.20 per Share.

The Offer Shares initially offered under the International Offering have been over-subscribed. Apart from the 457,374,000 Offer Shares initially available under the International Offering, the number of Offer Shares allocated to placees under the International Offering includes an over-allocation of 81,000,000 Shares. The settlement of such over-allocation will be effected by the stock borrowing arrangement entered into between Credit Suisse (Hong Kong) Limited and Ample Bonus Limited.

The Directors confirm that no Hong Kong Offer Shares have been allocated to applicants who are connected persons of the Company within the meaning of the Listing Rules and save for their Assured Entitlements under the Preferential Offering, none of the Directors or substantial shareholders have been allocated Hong Kong Offer Shares. The International Offering is in compliance with the placing guidelines for equity securities as set out in Appendix 6 to the Listing Rules. None of the International Offer Shares (excluding the Reserved Shares which are allotted to Qualifying FEC Shareholders only) has been placed with any connected person, director or existing shareholder of the Company or any of their respective associates within the meaning of the Listing Rules, whether in their own names or through nominees. None of the Joint Global Coordinators, the Joint Sponsors, the Joint Bookrunners, the Underwriters or their connected clients has taken up any Offer Shares for its own benefit under the Global Offering.
