- 處理 閣下的申請及退款支票/電子退款指示(如適用)、核實是否符合本申請表格及招股章程載列的條款和申請程序以及公佈發售股份的分配結果;

- (如證券申請人要求將證券存於中央結算 系統)香港結算或香港結算代理人;彼等 將會就中央結算系統的運作使用有關個 人資料;
- 向本公司或香港證券登記處提供與其各 自業務營運有關的行政、電訊、電腦、 付款或其他服務的任何代理人、承包商 或第三方服務供應商;
- 聯交所、證監會及任何其他法定監管機 關或政府部門或遵照其他法例、規則或 法規;及
- 證券持有人與其進行或擬進行交易的任何人士或機構,例如彼等的銀行、律師、會計師或股票經紀等。

# 4. 個人資料的保留

本公司及其香港證券登記處將按收集個人資料所需的用途保留證券申請人及持有人的個人資料。無需保留的個人資料將會根據條例銷毀或處理。
