On 19 January 2021, the Company and POLY-GCL Petroleum Group Holdings Limited (the "Subscriber") entered into the Subscription Agreement pursuant to which the Subscriber has conditionally agreed to subscribe for and the Company has conditionally agreed to allot and issue a total of 45,000,000 Subscription Shares at the Subscription Price of HK\$0.381 per Subscription Share. Completion of the Subscription is subject to fulfilment of the conditions under the Subscription Agreement. For details, please refer to the Company's announcements dated 19 January 2021 and 28 January 2021.
- 2. On 19 January 2021, the Company entered into the Placing Agreement with Emperor Securities Limited (the "Placing Agent"), pursuant to which the Placing Agent has conditionally agreed to place, on a best efforts basis, a maximum of up to 100,000,000 Placing Shares to not less than six independent Places at the Placing Price of HK\$0.381 per Placing Share. Completion of the Placing is subject to the satisfaction of the conditions in the Placing Agreement. For details, please refer to the Company's announcements dated 19 January 2021 and 28 January 2021.
