The waiver is subject to the following conditions:

- 1. Mr. Wang Lijun ("Mr. Wang"), the Company's Qualified Accountant, is able to meet all the requirements set out in Rule 3.24 of the Listing Rules, except that he is not a fellow or associate member of HKICPA or a similar body of accountants recognised by HKICPA for the purpose of granting exemptions from the examination requirement for membership of HKICPA; and
